#### **STAFF RECOMMENDATION:**

Provide direction on Park User Fee Schedule.

#### **EXECUTIVE SUMMARY:**

•

The City Council approved reduction of the city's park user fees to no fee last year in April 2022. As a part of this action the City Council also asked that the park fees be re-evaluated annually. Discussion by the City Council in April of 2022, was spurred by interest to assist sports leagues to reduce their registration fees.

After this action was taken by the City Council only one of the four sports leagues using the city's park facilities decreased their registration fees. Based on these results staff is recommending returning park use fees to the 2011 park use fees listed below:

As part of the April 2023 City Council action, the below fields at Bagdouma Park and Rancho Las Flores Park were set aside for only non-league rentals so that non-league recreational use is protected. This would be in addition to community field use lighting days already established.

- Bagdouma Park Field 4 (soccer and baseball fields) would be set aside for only non-league field rentals on Fridays all day, Saturday after 2pm and Sunday after 2pm.
- Rancho Las Flores Park Field 1 would be set aside for only non-league field rentals on Wednesdays (all day), Saturday after 2pm and Sunday after 2pm. On the identified days the identified fields would not be rented to any league for regular season league play.

Staff is requesting feedback on the continuation of Public Field Use Days as identified above.

#### FISCAL IMPACT:

The recommended action will result in an estimated \$150,000 increase in estimated revenues annually.

#### **ALTERNATIVES:**

- 1. Recommend park fee schedule remain as it exists and continuance of established Public Field Use Days.
- 2. Recommend updating park fee schedule to reflect all park use rentals at 100%.
- 3. Recommend reducing park fee schedule to reflect another fee percentage.

#### **STAFF RECOMMENDATION:**

Update 2022 Coachella Parks and Recreation Foundation activity.

#### **EXECUTIVE SUMMARY:**

The Coachella Parks and Recreation Foundation has one program, established in 2017, a Scholarship Program. The Foundation Scholarship Program is available to support youth (18 years of age and younger) programming on a reimbursement basis and the program guidelines are listed below:

- An applicant is eligible once annually
- Scholarships are approved on a first come first serve basis as long as funding allows starting in January of each calendar year;
- Approved scholarships will be for 50% of the recreation program submitted for, with a maximum award of \$75.00
- To ensure all programs have equal access to the scholarship program each program can be approved up to 20 scholarships annually.

In calendar year 2022, the total number of approved scholarships was 32. The total award for these scholarships was \$1,500; these were the only expenditures for the Foundation in 2022. The 32 scholarships awarded in 2022 were awarded to youth in the following recreation programs: Desert Recreation District (3), Little Arabs (16) and Coachella Youth Baseball Softball Association (13). The Foundation has a fund balance of \$16,786.

#### **STAFF RECOMMENDATION:**

Recommend Coachella Youth Sports Association Soccer (CYSAS) be removed as a lessee of the City and CYSAS Sublease Agreement for use of the Armtec Defense property, due to default of Section 7 of the Sublease Agreement.

#### **BACKGROUND:**

On July 13, 2016, the City Council entered into a Lease Agreement with Artmec Defense and a Sublease Agreement with CYSAS. These agreements leased the City 11 acres of undeveloped land, owned by Armtec Defense, and also subleased this same property to CYSAS. Armtec Defense asked the City be the intermediary lessor with the sports league; for while Armtec supported the property be used by the league(s), they did not want to manage ensuring the league(s) would maintain the property required by both the Lease and Sublease Agreements.

The Sublease Agreement was amended on February 23, 2022 as the city's second soccer league (Coachella Valley Soccer League (CVSL)) showed interest in also using the Armtec Defense property. The leased property has four soccer fields on it and as a result of the Amended Sublease the four soccer fields were split; two were Subleased to CYSAS and two were Subleased to CVSL. Based on the allocated property subleased to each sport league a separate water meter was installed to monitor and bill each league based on their water use; water is the only utility that is paid for in the maintenance of the leased/subleased property.

CYSAS has been delinquent on their water billing for most of their subleased term, but the City has worked with placing them on payment plan arrangements to manage the amounts owed. During COVID, CYSAS' amount due ballooned up to \$54,168.20 in January 2022; no shutoffs were being conducted due to COVID. In January 2022, Coachella Water Authority commercial accounts were applied state grant funds for the amounts that they may have gone negative during COVID; this account is a commercial account and was credited \$33,549.44.

The customer has been receiving their regular monthly bill notifying them of the amount owed each month. The amount owed in February 2023, was \$40,005.85. Staff reached out to the customer in February 2023 and offered them a payment plan that would require they pay the amount owed in 17 months, while also making their full monthly payments moving forward; default of either would result in a default of the payment plan. Staff did not receive a response to the proposed payment plan option and the customer was shut off on April 3, 2023.

#### **DISCUSSION/ANALYSIS:**

CYSAS is in default of Section 7 of the Sublease agreement. Section 7 of the Sublease agreement requires CYSAS pay all utility billing required to maintain the property leased. Staff is recommending the Sublease Agreement be amended to remove CYSAS as a party to the lease and amend the Lease Agreement to reflect only the property still being leased by CVSL.

Staff is also requesting feedback regarding the Sport League MOU as CYSAS is a party to this MOU and currently owes the Coachella Water Authority \$40,005.85. Staff is looking at funding sources available to try to repay the utility using grant funds that may still be available for utility billing but nothing has been obtained at this time.

#### **FISCAL IMPACT:**

The City/Coachella Water Authority has a \$40,005.85 unpaid debt.

#### **ALTERNATIVES:**

- 1. Recommend the Sublease Agreement be amended to remove CYSAS as a party to the lease and amend the Lease Agreement to reflect only the property still being leased by CVSL.
- 2. Recommend the Sublease Agreement be amended to remove CYSAS as a party to the lease and amend the Lease Agreement to reflect only the property still being leased by CVSL; revisit Sport League MOU participation by CYSAS.
- 3. Provide alternate direction.
