- 11/14/2019 PDT Meeting No. 7, and meeting minutes were distributed on 11/18/2019
- 11/14/2019 Dillon Road Joint Powers Authority held a Special Meeting to adopt a Project Funding Strategic Plan
- 11/25/2019 Caltrans SMI informed City of Indio and JPA that the loading rating analysis completed, which required to post weight limits signs.
- 11/25/2019 Caltrans HQ accepted City of Coachella as the project lead agency. A FPN was assigned using the City's locoed. FPN is STPL 5294 (019).
- 11/27/2019 Bridge eligible for total replacement. Bridge sufficiency rating (unofficial) = 26.4 < 50
- 11/27/2019 Submitted HBP fund application.
- 12/5/2019 Received revised bridge inspection report from Caltrans Structure Maintenance and Investigations (SMI). Bridge Sufficiency Rating drops to 26.4, which is eligible for HBP fund full replacement.

Upcoming Activities:

- 1. Follow-up with Caltrans Local Assistance
 - a. Caltrans SMI on revised Bridge inspection report with Sufficiency Rating
- 2. Alignment Study Seeking directions from PDT members and final decision by the JPA
 - a. Alternative 2A Symmetrical widening holding existing centerline.
 - Holding existing centerline alignment will impact all four billboards along Dillon. Two on the northwest must be relocated. The "A" overhang of other billboards on southeast will encroach into proposed right of way (about public sidewalk). Typically, privately owned billboards are located outside the street ROW, unless Cabazon tribe approve a variance allowing the overhang encroachment above sidewalk. Vertical clearance from sidewalk to bottom of "A" frame should meet or exceed 8-foot minimum clearance requirement. Proposed solutions are:
 - i. Cabazon tribe approve a variance allowing the overhang encroachment above sidewalk.
 - ii. Relocate two additional billboards (a total of all four billboards).
 - b. Alternative 2B Southeast billboards avoidance alternative Offset centerline by 16-foot westerly. Nonsymmetrical widening. It requires more right of way takes from the parcels on northwest side.

This alternative has two notable advantages:

- i. It avoids two billboards on the Southeast side. Project only requires to relocate two billboards on the northwest side.
- ii. Southbound traffic lanes lineup properly on straight tangent line from the new proposed bridge.

However, they are reluctant to change it now. They are still waiting on load rating and hydraulics analyses. With the SF of 53, the bridge is eligible for HBP retrofit. However, the project should wait until all analyses are completed and the full report is released, in order to determine if they document the bridge as structurally deficient. If the SF remains unchanged in October, then the project has no choice but to apply for HBP for retrofit, with support justifications for a total replacement as necessary. Good morning Andy,

The LAPG 6A HBP Application has been reviewed for eligibility. Unfortunately we've been informed that it cannot be reviewed for the following reasons:

- The current bridge inspection report (BIR) dated 1/17/19 does not show that the bridge is eligible for HBP funding. For a bridge to be eligible, it must have any NBI item 58, 59, or 60 rated at a 4 or less. To be coded as structurally deficient, one of these three NBI items must be rated 4 or less <u>and</u> the sufficiency rating less than 80 or when one of its NBI items, 67— Structural Evaluation or 71—Waterway Adequacy, is 2 or less. Currently, the application indicates NBI item 67 to be 4.
- 2. The bridge was posted in a letter from SM&I to the City of Indo dated 12/2/19. The City should contact the SM&I inspector to re-inspect the bridge and publish at revised BIR since the latest BIR is dated prior to the posting.
- 3. The bridge project is a capacity increasing project and must be in the RCTC 20-year regional transportation plan.

It is recommended to re-submit the updated LAPG 6A once the bridge is eligible assuming a new BIR will show that it is eligible as structurally deficient. Provide the RCTC 20-year plan showing that this bridge is included in the capacity increasing air quality analysis for 6-lanes. If the 6-lane capacity increasing bridge is not in the RCTC plan, the bridge may still be eligible for replacement and placed on the prioritization list as a 2-lane bridge replacement assuming that it is structurally deficient and the sufficiency rating is less than 80.

In addition, HQ has brought to my attention that the FPN assigned to this project is invalid. Caltrans exercises its FHWA delegated authority by further delegating federal authority to local agencies to the greatest extent possible for those federal-aid projects that are located off of the State Highway System. The local agency is responsible for the conception, planning, programming, environmental investigation, design, right of way, construction and maintenance of the projects on their local transportation system. Unfortunately, the project limits are out of the City of Coachella's transportation system. Coachella may act as the implementing agency on behalf of the responsible agency. However, the Joint Powers of Authority would need to apply for a new Locode and Master Agreement. For more information please refer to Chapters 2 and 4 of the LAPM.

STAFF RECOMMENDATION:

Direct staff to work with the Bureau of Indian Affairs (BIA), California Department of Transportation (Caltrans), Coachella Valley Association of Governments (CVAG), and Riverside County Transportation Commission (RCTC) to explore multiple funding opportunities for the project, with attention to leveraging local and "applicant's" matching contributions for advancing final design work.

BACKGROUND:

The sufficiency rating (SF) of the existing Dillon Road bridge over the CVSC is only 16.6 out of 100. Securing replacement funds before complete deterioration of the bridge is of the utmost priority.

Consistent with Resolution No. DR-2019-03 and the Special JPA Board meeting on May 11, 2020, an application for the Fiscal Year (FY) 2020 discretionary grant funding through the Better Utilizing Investments to Leverage Development (BUILD) Transportation Discretionary Grants program has been submitted for the project.

The maximum funding amount of the BUILD Grant is \$25,000,000. The total project cost is approximately \$50,000,000 for bridge replacement, roadway widening, regional storm drainage systems, CVSC channel lining, and a portion of the CV/Link under the proposed bridge.

The project needs to seek more funding sources. All available funding sources for such a large amount are very competitive. Without local and "applicant's" matching share contributions the project is not expected to compete well with other projects.

DISCUSSION/ANALYSIS:

In order to be more competitive for federal funds and expediting project delivery, securing local and "applicant's" funding for the final design work as early as possible and concurrent with the

environmental studies prior to finishing a National Environmental Policy Act (NEPA) environmental document would have the following significant advantages:

- 1. Enhance the project's eligibility and competitiveness for funding by
 - a. Expediting the project development phase of getting the project to shovel-ready status.
 - b. Showing serious regional commitment to the bridge replacement striving for public safety.
 - c. Satisfying criteria in federal grant applications specifically requesting disclosure of the applicant's contributions for the project.
- 2. Reduce the overall project delivery schedule by 1 to 2 years.
- 3. In Caltrans' terminology, "Advance Construction (AC) authorization" can be submitted for the project by utilizing local resources to fund the final design work and claim credit as local matching shares.

Allocation of other local funding sources and contributions with identifiable monetary value, such as right of way dedications, can also be used as credits.

If directed by the Board, consistent with Resolution No. DR-2019-03, the City of Coachella will continue to act as the contract administrator on behalf of the JPA working with CVAG to advance funding for the final design work. Appraisal work for right of way dedications can also be initiated at this stage.

FISCAL IMPACT:

No fiscal impact.

STAFF RECOMMENDATION:

Cancel direction for a second public hearing for weight limits restriction signs.

BACKGROUND:

During the Special JPA Board meeting on January 30, 2020, the JPA Board directed staff to hold two public hearings to inform truckers on weight limits restriction signs for the Dillon Road Bridge over Coachella Valley Stormwater Channel.

DISCUSSION/ANALYSIS:

Caltrans Structure Maintenance and Investigations (SMI) Unit has performed numerous bridge inspections and load rating analysis in 2019. Caltrans SMI conducted a couple routine bridge inspections on January 15 and February 9, 2020. The sufficiency rating (SF) was further reduced 26.4 to 16.6 out of 100.

Because the bridge no longer has the capacity to carry normal truck loads, posting weight limits restriction signs was required by federal laws for "Public Road" open to public travel, which means the public authority (facility owner, Twenty-Nine Palms) has the responsibility to ensure public safety per 23 U.S. Code § 101, 23 CFR Part 655 other, etc. As a compliance measure, two sets each of regulatory (R12-5) and warning [W-20 (CA)] signs were installed on January 7, 2020 to inform truckers to use alternate routes per California Vehicle Codes, Article 5. Bridges and Other Structures [35750 - 35755].

The Code also requires notification by public hearing. Because of the cancellation of the March 2020 JPA Board meeting due to the COVID-19 pandemic, only one public hearing could be held within the 90-day period at the Coachella City Council Meeting on March 25, 2020. Since this Meeting met the public hearing requirement, holding a second public hearing is no longer applicable.

FISCAL IMPACT:

STAFF RECOMMENDATION:

Approve Resolution No. DR-2020-01, a Resolution of the Dillon Road Joint Powers Authority (JPA) to adopt using a new construction centerline at 16' offset toward northwest side from existing street centerline, in lieu of using the existing centerline for symmetrical corridor widening.

BACKGROUND:

As previously presented and discussed at the JPA Board Special meeting on January 30, 2020, JPA Board Members required more time for evaluation before approving this resolution.

DISCUSSION/ANALYSIS:

There are six (6) billboards within the project limits from Cabazon Road/Avenue 48 intersection to CVSC. As part of the preliminary engineering and environmental document efforts, the project performed alignment study and evaluated three alternatives below:

- 1. Billboard "A" frames overhang encroachment over sidewalk: This was evaluated but deemed not desirable. Privately owned structures typically shall not encroach in public street right of way.
- Widen Symmetrically: Holding symmetrical corridor widening would impact a total of four (4) billboards located in middle segment of Dillon Road, except two (2) billboards located at the Cabazon Road/Avenue 48 intersection, resulting in significantly higher relocation costs.
- 3. Set new construction centerline at 16' offset toward northwest side: With the same landowners on both sides of the street, the right of way acquisitions (areas) would have the same impact. The primary notable advantage is avoiding the relocation of two billboards on southeast side. Thus, relocate only two billboards on northwest side.

The right of way requirements and remnants are summarized in the attached tables.

The resolution is to document JPA's concurrence and approval to use alternative no. 3 for final engineering design and to disclose the decision in the environmental document.

FISCAL IMPACT:

Alternative 3 is the most effective solution for minimizing overall impacts and project costs.





A RESOLUTION OF THE DILLON ROAD JOINT POWERS AUTHORITY TO ADOPT THE ALIGNMENT STUDY FOR THE DILLON ROAD BRIDGE OVER COACHELLA VALLEY STORMWATER CHANNEL (CVSC) PROJECT, PROJECT # 2019-ST-109 AND SELECT A CONSTRUCTION CENTERLINE AS THE PROPOSED PROJECT FOR FURTHER ANALYSIS.

WHEREAS, the Board of Directors of the Dillon Road Joint Powers Authority ("Board of Directors") would like to adopt the alignment study for the Dillon Road Bridge over Coachella Valley Stormwater Channel Project ("Project"); and

WHEREAS, there are six (6) billboards within the Project limits and the alignment study evaluated three (3) alternatives for the Project's centerline; and

WHEREAS, the Board of Directors acknowledge that setting the new construction centerline at a 16' offset toward the northwest side from the existing street centerline is the most sensible solution because it minimizes the overall impacts on the existing billboards and saves Project costs; and

WHEREAS, the Board of Directors therefore selects the new construction centerline at a 16' offset toward the northwest side from the existing street centerline as the proposed Project for the final engineering design and for analysis in the environmental documentation.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED by the Dillon Road Joint Powers Authority, as follows:

<u>SECTION 1.</u> The Board of Directors hereby finds and determines that the foregoing recitals are true and correct, are incorporated herein and by this reference made an operative part hereof.

SECTION 2. The Board of Directors hereby adopts the alignment study and selects the new construction centerline at a 16' offset toward the northwest side from the existing street centerline as the proposed Project for engineering design and environmental documentation for the Dillon Road bridge over the Coachella Valley Storm Water Channel, Project # 2019-ST-109.

SECTION 3. This Resolution shall take effect immediately upon its adoption by the Board of Directors, and the Clerk of the Dillon Road Joint Powers Authority shall attest to and certify the vote adopting this Resolution.
