## **STAFF RECOMMENDATION:**

Adopt resolution adopting fiscal year 2022/2023 budget.

#### **EXECUTIVE SUMMARY:**

The total tonnage for 2021 was 180,971. This is an increase of 12,180 tons, from the 2020 tonnage (168,791) received by the Coachella Valley Transfer Station. In 2021, the revenue received totaled approximately \$1,109,721.47. Please see below year tonnage history:

Based upon the steady upward trend of the tonnage being received at the Coachella Valley Transfer Station, the fiscal year 2022/2023 recommended budget establishes \$1,600,000 in appropriations. Additionally, the recommended budget for fiscal year 2022/2023 also identifies other use of funds similar to the previous fiscal years and include an appropriation for: consultant fees (\$40,000), standard operating legal fees (\$10,000), and administrative fees (\$10,000).

## FISCAL IMPACT:

The recommended action will establish an expenditure plan for the Joint Powers Authority totaling \$1,660,000 for fiscal year 2022/2023.

## **STAFF RECOMMENDATION:**

Conduct a public hearing and approve a six percent increase to the gate fee at the Coachella Valley Transfer Station for fiscal year 2022/23.

#### **EXECUTIVE SUMMARY:**

Burrtec Waste Industries, Inc., (Burrtec) operates the Coachella Valley Transfer Station through a Sublease Agreement with the Coachella Indio Joint Powers Authority (JPA). The Sublease Agreement provides annual adjustments to the components of the gate fee based on service cost increases equal to the percentage change in the Consumer Price Index (CPI) and disposal cost increases.

## **CPI** Increase

This year, the CPI change as reported by the Bureau of Labor Statistics for the Riverside-San Bernardino-Ontario area was 10 percent; however, Burrtec is requesting an increase less than CPI at 6%.

#### **Disposal Increase**

Disposal costs charged by the Salton Landfill will increase from \$32.71/ton to \$34.67/ton effective July 1, 2022.

As noted above and shown in Attachment A, this year the CPI service cost increase is 6 percent and the disposal component charged by the Salton Landfill increase is also 6 percent. Taking both the CPI and disposal increases into account the total Gate Fee will increase from \$64.98 to \$68.82, an increase of \$3.84 or 5.9 percent.
