SUBJECT: Recommend approval resolution recommending approval of an Adopt-A-Park

and Adopt-A-Street Program.

STAFF RECOMMENDATION:

Staff recommends the proposed resolution be recommended for approval for an Adopt-A-Park and Adopt-A-Street Program.

EXECUTIVE SUMMARY:

Staff has received several requests from businesses and residents for ways to contribute through volunteerism and contribute their efforts to sustain our community. Many cities throughout the nation have Adopt-A-Park and Adopt-A-Street Programs that serve as opportunities to foster and develop civic stewardship. An Adopt-A Park Program is a beautification program to enhance the condition and quality of parks/trails/green spaces through volunteer service. An Adopt-A-Street Program is a litter reduction campaign designed to remove litter and debris from City roads and improve the quality of the environment.

Both programs are recommended by staff to have the similar guidelines outlined below:

- Eligible Participants:
 - civic and non-profit groups, families, schools, service clubs and organizations, volunteers from commercial and private enterprises.
- Participant Commitment:
 - o 2 year period; a minimum of four clean-ups per year (quarterly)
 - Return a Clean-up Report
- Program Waiver and Application.
- Adopt-A-Street activities:
 - o remove trash/debris/weeds along both sides of the adopted street.
- Adopt-A-Street segment:
 - o any one-mile city street segment not adopted at time of application submittal.
- Adopt-A-Park activities:
 - o raking leaves/spreading mulch/removal of weeds/reporting graffiti/cleaning playgrounds/litter removal/gum removal/tree planting.
- Adopt-A-Park available:
 - o all parks not already adopted at time of application submittal.

- Equipment provided by City:
 - o trash bags, safety vests, litter pik-stix, gloves.
- Volunteer Recognition:
 - o installation of Adopt-A-Street sign at street segment limits/installation of Adopt-A-Park sign at adopted park; Coachella Adopt-A-Street/Coachella Adopt-A-Park T-Shirt for applicants that completed the 2 year commitment/Certificates of Participation from the City Council.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA ESTABLISHING AN ADOPT-A-PARK AND AN ADOPT-A-STREET PROGRAMS.

WHEREAS, the City of Coachella owns and maintains various parks, trails, green spaces and roadways for use by its residents and visitors; and

WHEREAS, the City of Coachella desires to provide volunteer opportunities for local citizens to participate in the care and maintenance of the City's public spaces including: parks, trails, green spaces and streets; and

WHEREAS, an Adopt-A-Park and Adopt-A-Street programs is a model for volunteer participation that has been used successfully in many other communities; and

WHEREAS, an Adopt-A-Park and Adopt-A-Street programs will help improve and beautify the City's parks, trails, green spaces and streets; and

WHEREAS, an Adopt-A-Park and Adopt-A-Street programs will increase civic involvement and participation, pride in the community, and sense of stewardship in helping to care for the City's public spaces; and

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA, AS FOLLOWS:

- 1. Establish an Adopt-A-Park Program and an Adopt-A-Streets Program as described in Exhibit A.
- 2. Authorize city staff to administer the Adopt-A-Park and Adopt-A-Streets Programs, including but not limited to: processing applications, providing volunteer orientation, coordination with volunteers, collecting volunteer reports and program marketing.

SUBJECT: Recommend support of installation of two tegball tables at Bagdouma Park

STAFF RECOMMENDATION:

Recommend support of installation of two tegball tables at Bagdouma Park.

EXECUTIVE SUMMARY:

On July 31, 2023, staff received a correspondence from Teqball USA LLC relaying its interest in providing Coachella a free Teqball Teq One Table. Teqball is a soccer-based sport that is played on a curved table and can be played as a singles game (1 vs. 1) or a doubles game (2 vs. 2). In an effort to bring more awareness of this sport Teqball USA LLC is making tables available to high traffic areas such as local sports parks.

As Bagdouma Park is our largest sports park and soccer is an extremely popular sport is Coachella, staff is recommending installation of two of the Teqball Teq One Tables at Bagdouma Park. The recommended location is near the volleyball courts at Bagdouma Park near Avenue 51 – please see below recommended placement of two (2) Teqball Teq One Tables.



Staff has shared the recommended placement of the two free Teqball Teq One Tables and Teqball USA LLC has approved donation of two tables for placement at Bagdouma Park. Staff is recommending acceptance of the \$7000 value donation for the two Teqball Teq One Tables (\$3500 each) and approval of their installation at Bagdouma Park.



FISCAL IMPACT:

The installation cost of the tables is estimated at \$2,500; the tables and shipping will be donated by Teqball USA LLC.
