V. Statement of Closed Meeting

1. Summary Statement of closed meetings held October 8 and October 15, 2019

Mayor Morriss announced that Closed Meetings had been held on October 8, 2019 at 5:35 p.m., and October 15, 2019 at 5:30 p.m. and read into the record summaries of those sessions, which are attached hereto and made a part of these minutes as required under Section 3-306 (c) (2) of the General Provisions Article of the Annotated Code of Maryland.

VI. Presentation

1. Recognition of Police Chief Charles H. Hinnant upon his retirement from the Cumberland Police Department

Mr. Rhodes provided background on Chief Hinnant's 48 total years in law enforcement across the state, with 13 years in the City of Cumberland, and commented on his work with the City Police Department.

Sheriff Craig Robertson commented on how well the County and City Police Departments worked together, expressed his appreciation of the Chief's work with the Sheriff's office, and presented the Chief with a gift.

Lt. Buskirk from the City of Frostburg commented on Chief Hinnant's career and said he would always have a friend in Frostburg.

State's Attorney Michael Twigg commented on his years of knowing Chief Hinnant and noted that as a young prosecutor he sought a lot of counsel from the Chief.

Captain Ternent read a note of from State Police Lt. Martz who was unable to attend, stating that it had been a privilege and an honor to serve with Chief Hinnant for almost ten years. The Chief was given a gift of a recognition plaque from the Cumberland barracks. The Captain expressed appreciation from the Police Department staff for the many years of mentorship and leadership that was given them and Chief Hinnant was presented with a U.S. flag that was flown over the Police Department on September 11, 2019.

Chief Hinnant expressed his appreciation and thanks to everyone and commented on his years of serving in law enforcement. He stated that public service is a calling, saying he has been blessed to have had a fantastic career and to have been associated with so many wonderful people along the way. He also recognized those in attendance who had supported him throughout the years.

The Mayor, Council, and Staff all commented on the Chief's tireless work in the community and with the City Police Department, thanked him for his many years of service, and wished him a long and wonderful retirement. Chief Hinnant was presented with a retirement cake and a personalized gift from the City.

Mr. Rhodes provided background on the Ordinance and Mr. Cohen stated that the FCC has issued a mandate for this Ordinance that helps with the rollout of the 5G communications network.

SECOND READING: The Ordinance was presented in title only for its Second Reading. The reading was interrupted and motion to suspend the Second Reading and move to the third after comment was made by Councilman Bernard, seconded by Councilman Frazier, and was passed on a vote of 4-0.

The Mayor opened the floor for comments. Being none, the Ordinance moved to its third reading.

THIRD READING: The Ordinance was presented in title only for its Third Reading and was passed on a vote of 4-0.

Order 26,542 - authorizing the Chief of Police to accept a FY19 Bureau of Justice Assistance Award in the amount of \$5,136.39, requiring a 50% match from the City, for the replacement of outdated body armor vests

Order 26,543- authorizing the Chief of Police to accept a FY19 Edward Byrne Memorial Justice Assistance Grant (BJAG) in the amount of \$12,278.00 for the purchase of additional less-lethal equipment in the form of Tasers or conducted electrical weapons, to be utilized by the Cumberland Police Department and the Allegany County Sheriff's Office

Order 26,544 - accepting the Final Design and Bidding Services-60% to Bid Ready Agreement with Whitman, Requardt and Associates, LLP for City Project 78" Pipeline From Mill Race to CSO Storage Facility (19-16-S) in the amount of \$947,527.00 to include additional coordination, permitting, field investigation, and finalization of plans and specs through bid ready

Order 26,545- to approve an Amended and Restated Promissory Note related to a loan originally awarded on April 23, 2003 to David F. Romero and Margaret A. Romero for the acquisition and rehabilitation of real property located at 55 Baltimore Street

Item Title:

Order accepting the sole source proposal from CI Thornburg to perform a valve insertion on a 16" water line on Willowbrook Road for the amount not to exceed \$28,473.67

Summary:

The current valve on a 16" waterline on Willowbrook Road is broken and needs replaced. The replacement can't happen without shutting down the 36" transmission main, which is inadvisable due to the number of issues that would result.

Certain companies do have the means to perform a valve insertion without shutting down the main transmission line. Only two companies could be found to perform this work and we obtained quotes from both. CI Thornburg quoted a price of \$28,473.67 and Koppl Pipeline Services quoted a price of \$28,450, however they would require a 2" tap to be taken separately before they could perform their work, which would add approximately \$1,500 to the base cost.

We have used Thornburg in the past with success and based on the difference in the pricing, would recommend proceeding with Thornburg.

Jeff Rhodes, City Administrator, approved this work as a sole source proposal due to the technical nature of the work and the limited number of companies available to perform the work.
