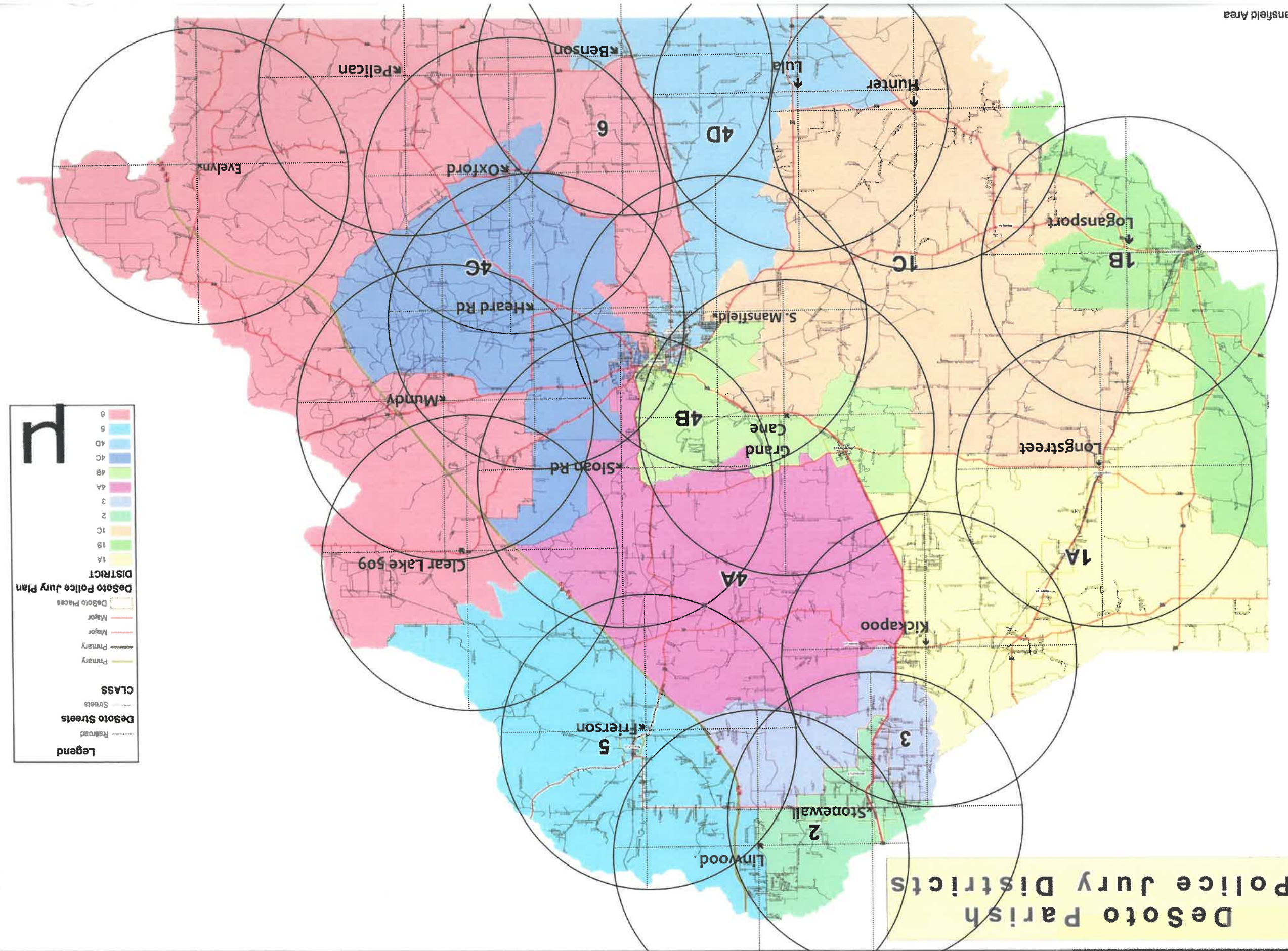

606 Mileage Reimbursement for Compactor Site Floaters

It is the policy of the Police Jury for compactor site operators who are hired as a floater (“Floater”) to receive mileage reimbursement when traveling to compactor sites outside of the Floater’s home radius circle. The attached map, Exhibit 1, displays a radius circle for each compactor site and is used in determining whether the Floater is entitled to mileage reimbursement. If the Floater’s home is within the circle of the compactor site worked, there is no entitlement to receive mileage reimbursement.

Mileage reimbursement will only be paid to a Floater when the Floater’s home is located outside of the circle of the compactor site worked. Mileage is calculated round trip from the Floater’s home address to the compactor site worked based on the dates assigned to work and state mileage rates applicable during the dates of the assigned work.
