Subject: Partial Abandonment of Bice Road

Dear Mr. Rister:

The Dolet Hills Lignite Company is requesting that the northern part of Bice Road, indicated in yellow on the attached exhibit, be abandoned and not reconstructed. This segment of Bice Road resides on two tracts owned by SWEPCO/CLECO and reconstruction of the road through the middle of these tracts would provide no benefit as access is available from Henry Williams Road and which parallels the Bice alignment.

The portion of Bice Road from its current closure point to the southern boundary of the SWEPCO/CLECO tracts (in red on exhibit 1) will be reconstructed on the original alignment as requested by the landowners. A turnaround will be constructed at the termination of the reconstructed road.
















#### Resolution

WHEREAS, The DeSoto Parish Police Jury agrees to accept ownership of whatever rights the State of Louisiana, through the Department of Transportation and Development ("DOTD" or "Department"), may own, with the exception of any and all mineral rights, in and to the following described property and agrees to accept all future rights, obligations and liabilities, including, but not limited to, all future operation, maintenance, and repairs associated therewith, for its operation and maintenance as a parish road:

The service road known as Park Road in its entirety in the western quadrant of the intersection of interstate I-49 and state route LA 175 from its intersection with state route LA 175 proceeding northwest approximately 0.78 miles to its terminus and continuation as a parish road, inclusive of the bridge across Rambin Bayou, and further described as:

A 3.984 ACRE ROAD RIGHT OF WAY LYING IN SECTIONS 8 AND 9, TOWNSHIP 14 NORTH, RANGE 13 WEST, DESOTO PARISH, LOUISIANA. COMMENCING FROM A POINT ON THE CENTERLINE OF STATE PROJECT NO. 455-07-03, FAP NO. I-49-4(009)193, BOYCE-SHREVEPORT HIGHWAY, (JUCTION LA 175-CADDO PARISH LINE) AT STATION 40+90.00, PROCEED N78°47'13"W A DISTANCE OF 144.7 FEET TO A SET 5/8 INCH REBAR FOR THE POINT OF BEGINNING. THENCE PROCEED N09°53'24"E A DISTANCE OF 10.00 FEET TO A FOUND BROKEN OFF CONCRETE DOTD RIGHT OF WAY MONUMENT; THENCE PROCEED N03°26'25"E A DISTANCE OF 343.94 FEET TO A FOUND BROKEN OFF CONCRETE DOTD RIGHT OF WAY MONUMENT; THENCE PROCEED N85°55'43"E A DISTANCE OF 15.45 FEET TO A FOUND BROKEN OFF CONCRETE DOTD RIGHT OF WAY MONUMENT; THENCE PROCEED N02°50'36"W A DISTANCE OF 110.15 FEET TO A FOUND BROKEN OFF CONCRETE DOTD RIGHT OF WAY MONUMENT; THENCE PROCEED N41°20'15"W A DISTANCE OF 211.03 FEET: THENCE PROCEED N30°53'00"W A DISTANCE OF 208.47 FEET; THENCE PROCEED N28°03'32"W A DISTANCE OF 622.03 FEET TO A FOUND BROKEN OFF CONCRETE DOTD RIGHT OF WAY MONUMENT; THENCE PROCEED N27°12'12"W A DISTANCE OF 296.81 FEET; THENCE PROCEED N38°41'02"W A DISTANCE OF 977.80 FEET; THENCE PROCEED N47°52'46"W A DISTANCE OF 536.22 FEET; THENCE PROCEED N49°10'43"W A DISTANCE OF 138.95 FEET; THENCE PROCEED N51°17'31"W A DISTANCE OF 474.64 FEET; THENCE PROCEED N89°15'46"W A DISTANCE OF 175.23 FEET; THENCE PROCEED N40°07'42"E A DISTANCE OF 51.73 FEET: THENCE PROCEED S89°13'12"E A DISTANCE OF 156.32 FEET; THENCE PROCEED S51°17'31"E A DISTANCE OF 489.18 FEET TO A FOUND 4X4 CONCRETE DOTD RIGHT OF WAY MONUMENT; THENCE PROCEED ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 11289.16 FEET, LONG CHORD AND DISTANCE- S48°08'47" E – 679.76 FEET, AND ARC DISTANCE OF 679.83 FEET (CURVE RUNNING THROUGH A FOUND 4X4 CONCRETE RIGHT OF WAY MONUMENT AT 105.19 FEET ALONG THE CURVE). THENCE PROCEED S38°41'02"E A DISTANCE OF 985.04 FEET; THENCE PROCEED S27°38'17"E A DISTANCE OF 610.88 FEET; THENCE PROCEED S28°03'32"E A DISTANCE OF 310.37 FEET; THENCE PROCEED ALONG A CURVE TO THE LEFT HAVING A RADIUS OF A DISTANCE OF 744.81 FEET, LONG CHORD AND DISTANCE- S30°53'00"E - 203.82 FEET, AND ARC DISTANCE OF 204.46 FEET; THENCE PROCEED S41°20'15"E A DISTANCE OF 221.34 FEET; THENCE PROCEED S02°50'36"E A DISTANCE OF 282.21 FEET; THENCE PROCEED S11°22'05"W A DISTANCE OF 211.22 FEET: THENCE PROCEED N78°47'13"W A DISTANCE OF 44.77 FEET

# BACK TO THE POINT OF BEGINNING. THIS DESCRIPTION IS BASED ON THE SURVEY AND MAP MADE BY HARPER CARAWAY, PLS DATED 3-21-2024 AND FURTHER IDENTIFIED IN ATTACHED VICINITY MAP AND SPECIAL MAP AS EXHIBITS "A & B".

BE IT RESOLVED, That the DeSoto Parish Police Jury shall accept ownership of whatever rights the Department may own in and to the aforesaid described property as a binding agreement between the Department and the DeSoto Parish Police Jury and in accordance with the following specific conditions and limitations:

- I. The DeSoto Parish Police Jury agrees to accept the permanent drainage servitude which the Department reserves on, over, and across the described property and agrees that no portion of the property subject to the servitude will be disposed of, no drainage ditches or any structures associated with the servitude will be altered, and no driveway or other right of way permits will be issued without the express written consent of the Department.
- III. The DeSoto Parish Police Jury agrees that the Department has the right, at its discretion, to reclaim fee title ownership at no cost to the Department, to the portion of the aforesaid property described herein, as necessary to provide sufficient right of way to operate and maintain I-49.

BE IT FURTHER RESOLVED, That the DeSoto Parish Police Jury authorizes the presiding President of the DeSoto Parish Police Jury to execute any and all documents necessary to effect the transfer of the aforesaid described property at the proper time.

BE IT FURTHER RESOLVED, That the DeSoto Parish Police Jury hereby represents that it has received approval from a majority of the state legislative delegation from DeSoto Parish of the actions contemplated herein.
