RESOLUTION NO. 11 OF 2026

A RESOLUTION AUTHORIZING THE PRESIDENT OF THE POLICE JURY AND THE PARISH TREASURER TO SIGN CHECKS RELATED TO THE CAPITAL OUTLAY FUNDS ASSOCIATED WITH THE DESOTO PARISH FIVE YEAR ROAD PROGRAM

WHEREAS, the Police Jury has received funding for the DeSoto Parish Five Year Capital Road Plan through the State of Louisiana Capital Outlay Program, as allocated in HB-2; and

WHEREAS, These funds are administered by the Facility, Planning, and Control of the Division of Administration for the State of Louisiana; and

WHEREAS, it is necessary to designate authorized signatories for the disbursement of funds and the request for disbursement, to ensure timely payment of expenses and obligations; and

WHEREAS, the Police Jury finds it to be in the best interest of the Parish to authorize the President and Parish Treasurer to execute checks and to process request for disbursements related to these funds.

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of DeSoto, State of Louisiana, that:

Section 1. Authorization

The President of the Police Jury, Trina Boyd-Simpson, and the Parish Treasurer, Liliana Garcia, are hereby authorized to sign all checks and financial documents necessary to administer the capital outlay funds associated with the Desoto Parish Five Year Road Program.

Section 2. Scope

This authorization shall apply solely to, expenditures and disbursements associated with the capital outlay funds associated with the Desoto Parish Five Year Road Program as approved by the Police Jury.

Section 3. Effective Date

This Resolution shall become effective immediately upon adoption.

BE IT FURTHER RESOLVED that a copy of this Resolution be maintained in the official records of the Parish and provided to all necessary financial institutions and agencies as required.
