Pursuant to Chapter 551, Title 5 of the Texas Government Code and Texas Open Meetings Act, notice is hereby given that the City of Donna, Texas will convene a Donna Economic Development Corporation (4A) Special Meeting at 307 S. 12th Street, on Monday, September 30, 2019 at 11:30 AM for the purpose of discussing the following items:

- 1. Discussion, consideration and possible action to terminate the professional services agreement and/or relationship with the Donna Economic Development Corporation bond attorney.
- 2. Discussion, consideration and possible action to approve the hiring and/or appointing of a Donna Economic Development Corporation Bond Attorney and enter into a professional services agreement with the newly hired, and/or appointed Bond Attorney.
- 3. Consideration and approval approving The Donna Economic Development Corporation Plan of Finance pertaining to the contemplated issuance of Obligations to be designated as "Donna Economic Development Corporation Sales Tax Refunding Bonds, Series 2019".
- 4. Consideration and approval of a Resolution for the issuance of "Donna Economic Development Corporation Sales Tax Refunding Bonds, Series 2019", and authorizing other matters related to the foregoing financing.
- 5. Consideration, Discussion, and possible action on Fiscal Year 2019-2020 Proposed Budget.

Executive Session

Executive Session as authorized by Ch. 551 of the Texas Government Code:

Pursuant to Sec. 551.074, the City may convene in a closed, non-public meeting to discuss any matters related to appointment, employment, evaluation, reassignment, duties and discipline or dismissal of a public officer or employee and to hear any complaints or charges against an officer or employee. The City and its attorney may also discuss such issues with the appropriate staff including members so as to obtain necessary and relevant information so that such discussion is informative and developed.

Pursuant to Sec. 551.071, the City may convene in a closed, non-public meeting with its attorney and discuss any matters related to legal advice on pending or contemplated litigation, settlement offer, and/or on a matter in which the duty of the attorney to the governmental body under the Texas

Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter. The City and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.

Pursuant to Sec. 551.072, the City may convene in a closed, non-public meeting to discuss any matters related to real property and deliberate the purchase, exchange, lease, or value of real property as such would be detrimental to negotiations between the City and a third party in an open meeting. The City and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.

Pursuant to Sec. 551.087, the City may convene in a closed, non-public meeting to (1) to discuss or deliberate regarding commercial or financial information that the governmental body has received from a business prospect that the governmental body seeks to have locate, stay, or expand in or near the territory of the governmental body and with which the governmental body is conducting economic development negotiations; or (2) to deliberate the offer of a financial or other incentive to a business prospect described by Subdivision (1). The City and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.
