REGULAR MEETING MINUTES

May 2, 2022

The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on May 2, 2022. 2nd Vice-Chairman Russell Gray presided and called the meeting to order at 10 a.m. Present were Commissioners Victor Edwards, Gloria Gaines, Anthony Jones, and Ed Newsome. Also present were County Administrator Michael McCoy, Assistant County Administrator Scott Addison, County Attorney Spencer Lee, County Clerk Jawahn Ware, and other staff. The public and representatives of the media participated in person and via live streaming of the meeting on the County's Facebook page and the government public access channel. Chairman Christopher Cohilas and Commissioner Clinton Johnson were absent.

Attorney Lee said that under normal procedures when the Chairman and Vice-Chair are both absent, the next person to hold the gavel would chair the meeting. He added that out of an abundance of caution, he suggested that the Board make a motion to allow Commissioner Russell Gray to serve as Vice-Chairman.

Commissioner Gaines moved for approval for Commissioner Russell Gray to serve as Vice-Chairman. Upon a second by Commissioner Edwards, the motion for approval passed unanimously.

After the invocation and Pledge of Allegiance, the 2nd Vice-Chairman called for approval of the minutes for the April 4th Regular Meeting and April 11th Work Session.

Commissioner Jones moved for approval. Upon a second by Commissioner Newsome, the minutes were unanimously approved.

The 2nd Vice-Chairman recognized Dana Glass, CEO of Aspire Behavioral Health and Developmental Disability Services, to provide an update on services. She provided an overview of services offered. During the pandemic, the number of individuals served did decrease; noting that they typically serve close to 10,000 people. She mentioned that about 70% of the population served was within Dougherty County and that all case management funding was removed by the state about four years ago. She requested continuation of the

current \$60,201.96 funding in addition to \$66,750 to provide an engagement specialist position for a total request of \$126,951.96. She shared that the opioid settlement is coming and 75% will go to the state and 25% will go to the counties that opted in the lawsuit. Ms. Glass answered questions of the Board.

The 2nd Vice-Chairman called for consideration to accept the quote for the repair design of the existing structure for the Radium Springs Water Tower from TAE, Inc. (Raleigh, NC) in the amount of \$15,000. This recommendation will be Phase 2 of the project. Funding will be provided by the Special Services District.

Commissioner Edwards moved for approval. Upon a second by Commissioner Jones, the motion for approval passed unanimously.

The 2nd Vice-Chairman called for consideration of the resolution providing for acceptance and execution of the contract to accept the bid to provide Drainage Improvements for Dougherty County Public Works from Jim Boyd Construction (Albany, GA) in the amount of \$196,595.60 subject to execution of the contract by the County Administrator. Funding is budgeted in SPLOST VII.

Commissioner Jones moved for approval. Upon a second by Commissioner Edwards, the motion for approval passed unanimously. Resolution 21-024 is entitled:

A RESOLUTION ENTITLED A RESOLUTION PROVIDING FOR THE APPROVAL AND ACCEPTANCE OF A BID FROM JIM BOYD CONSTRUCTION (ALBANY, GA) IN THE AMOUNT OF \$196,595.90 FOR THE PURPOSE OF PROVIDING DRAINAGE IMPROVEMENTS AS SPECIFIED BY DOUGHERTY COUNTY PUBLIC WORKS, REPEALING RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

The 2nd Vice-Chairman called for consideration of the proposed board appointment. Upon nomination by Commissioner Gaines, the recommendation for Simon T. Abela to replace Joanne Conger was unanimously accepted for the Keep Albany Dougherty Beautiful to serve a three-year unexpired term ending December 31, 2024.

The 2nd Vice-Chairman called for consideration of the resolution providing for the approval and execution of an amendment to Dougherty County's Legal Services Agreement with the law firm of Blasingame, Burch, Garrard & Ashley, P.C. relative to the law firms pursuing all civil remedies against manufacturers of prescription opiates on Dougherty County's behalf. County Attorney Spencer Lee addressed. Attorney Lee said that the case has proceeded and there was not going to be a fee if there was no settlement. The amendment was provided by the Georgia Rules of Professional Conduct which provides disclosure of fees if any are paid.

Commissioner Gaines moved for approval. Upon a second by Commissioner Jones, the motion for approval passed unanimously. Resolution 21-025 is entitled:

A RESOLUTION ENTITLED A RESOLUTION PROVIDING FOR THE APPROVAL AND EXECUTION OF AN AMENDMENT TO DOUGHERTY COUNTY'S LEGAL SERVICES AGREEMENT WITH THE LAW FIRM OF BLASINGAME, BURCH, GARRARD & ASHLEY, P.C. RELATIVE TO THE LAW FIRMS PURSUING ALL CIVIL REMEDIES AGAINST MANUFACTURERS OF PRESCRIPTION OPIATES ON DOUGHERTY COUNTY'S BEHALF; REPEALING RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

Mr. McCoy shared that Commissioner Jones received his leadership and intergovernmental relations speciality certificates from ACCG at the recent annual conference. Commissioner Johnson also received his leadership specialty certificate and was installed as the 3rd Vice President of ACCG. Mr. McCoy announced that Chairman Cohilas received the Emory Greene Leadership Award; the highest award provided by ACCG.

The 2nd Vice-Chairman called for a discussion relative to Dougherty County, Georgia vs. 1000 Liberty Expressway SE, Dougherty Superior Court Civil Action File No. 21 CV 644 -3 (Complaint In Rem For Nuisance Abatement). Attorney Lee provided the history of the property which included disclosure of bankruptcy and ownership of another entity. There are now new owners and they were present to request that the Board provide an extension for time to be in compliance and begin construction. Attorney Lee requested direction from the Board and the representative requested an extension to May 27th. Commissioner Jones was against the extension and requested that the County be reimbursed for all fees paid. Attorney Lee stated that the County would seek the reimbursement and outlined the process if the County continued with the current legal proceedings. After a very lengthy discussion, it was agreed that the owners will be given an opportunity to complete the beautification request and the County will delay filing until May 13th; and may drop the lawsuit contingent upon the new owners due diligence. There was also discussion about the County continuing the lawsuit as a dual process. Commissioner Gaines asked about the status of the company hired to complete the antigen test study and Mr. McCoy will follow up. Commissioner Gray reminded the Board that early voting started that today.

There being no further business to come before the Commission, the meeting adjourned at 11:26 a.m.

WORK SESSION MEETING MINUTES

May 9, 2022

The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on May 9, 2022. Vice-Chairman Clinton Johnson presided and called the meeting to order at 10:00 am. Present were Commissioners Victor Edwards, Gloria Gaines, Russell Gray, Anthony Jones and Ed Newsome. County Administrator Michael McCoy participated via the audio-conferencing feature. Assistant County Administrator Scott Addison, County Attorney Spencer Lee, County Clerk Jawahn Ware and other staff were also present. The public and representatives of the media participated in person via live streaming of the meeting on the County's Facebook page and the government public access channel. Chairman Christopher Cohilas was absent.

The Vice-Chairman asked the Commission to review the minutes of the April 18th Regular Meeting and April 25th Work Session.

The Vice-Chairman recognized Keep Albany Dougherty Beautiful Chairman, Jeanette Henderson to introduce the new KADB Executive Director, Jwana Washington to the Board.

The Vice-Chairman recognized Frank Wilson, Albany Dougherty Juneteenth Committee Representative, to discuss plans for the 2022 Juneteenth Celebration Weekend and to petition for County sponsorship. Vice-Chairman Johnson asked Mr. Addison to work with Attorney Lee and Mr. McCoy to determine if the County could legally provide funding.

The Vice-Chairman recognized Facilities Management Director Heidi Minnick to accept the Proclamation recognizing May 9-15, 2022 as Facilities Management Week in Dougherty County. Commissioner Jones provided positive comments about leadership and staff. The proclamation read as follows:

WHEREAS, facilities management is a vital unit for county government; and

WHEREAS, the members of the facilities management teams are ready to provide services to maintain county units 24 hours a day, seven days a week, and

WHEREAS, the facilities management team is responsive, proactive, and costefficient, working together with many county units to provide services; and

WHEREAS, the facilities management team functions in a service-oriented aspect, promoting civility, mentoring, innovation, excellence coupled with dedication and pride; and

WHEREAS, the facilities management team consists of a staff of custodians, building superintendents, repair and maintenance technicians, administrators, and others who have gone above and beyond through the COVID-19 Pandemic; and

WHEREAS, the members of the facilities management teams, work together to ensure safety, striving for excellence in every task they perform daily; and

WHEREAS, it is appropriate to recognize the value and the accomplishments of the Dougherty County Facilities Management division by designating Facilities Management Week; now

THEREFORE, we, the Board of Commissioners of Dougherty County, Georgia in recognition of this event do hereby proclaim the week of May 9-15, 2022 as

The Vice-Chairman recognized District 6 Residents Dr. James Hill, Ms. Elizabeth Lovett and Mr. Chris Quinn to support the demolition of property on US 19/Liberty Expressway. Attorney Lee outlined the legal process and Commissioner Gray shared that the property had a previous owner and reminded the Board of the agreement made with the new owner.

The Vice-Chairman recognized William Wright, representative of Afram Tech, Inc. to request money to support his efforts to commemorate the Juneteenth Holiday and his New Deal/Main Street program to educate the community. Mr. Wright will continue his presentation the following week.

The Vice-Chairman called for a discussion of the zoning application for Fish House Campgrounds, Inc., owner and Lanier Engineering (22-021), applicant, request to rezone 73.261 acres from C-2 (General Mixed-Used District) and C-7 (Mixed Use Planned-Development District) to C-1 (Neighborhood Mixed-Use Business District). The property is located at 2908 Gillionville Road. The Planning Commission recommended approval. Angel Gray, Planning Manager, addressed. The Public Hearing and Action are scheduled for May 16, 2022.

The Vice-Chairman called for a discussion of the zoning application for Fish House Campgrounds, Inc, owner and Lanier Engineering, Inc., applicant (22-022) request for Special Approval to operate a Women's Recovery Center in a C-1 (Neighborhood Mixed-Use Business District). The parcel is a 73.261 acre developed parcel. The property is located at 2908 Gillionville Road. The Planning Commission recommended approval. Angel Gray, Planning Manager, addressed. The Public Hearing is only scheduled for May 16, 2022. Due to the zoning procedure for a Women Recovery Center, action will have to be taken six months after the public hearing is conducted. She shared that this center will be an extension of services provided by The Anchorage.

The Vice-Chairman called for a discussion to purchase 400 sign posts and anchors for the Public Works Department from Big Green Sign Company (Dublin, GA) in the amount of \$29,440. Three quotes were obtained with only two vendors being able to provide all material; the highest quote received was \$34,300. Funding is available in TSPLOST. Assistant County Administrator Scott Addison and Public Works Director Chuck Mathis addressed. Mr. Mathis clarified for Commissioner Edwards that the vendor we used previously has completed his task and was used to replace the signs damaged from the storms.

The Vice-Chairman called for a discussion to purchase forty body-worn cameras and supporting cloud storage software from single source vendor Motorola Solutions (Allen, TX) in the amount of \$253,760. Funding is available in the American Rescue Plan Act (ARPA). Assistant County Administrator Scott Addison addressed. Assistant DCP Chief Takesha Irving was present.

The Vice-Chairman called for a discussion to accept the proposal for ARPA Grant Administration and Management Services for Dougherty County from Government Services Group (GSG – Tallahassee, Florida) in a not to exceed amount of \$350,000. Twelve vendors submitted proposals. Funding is available in ARPA funds. Assistant County Administrator Scott Addison addressed. The proposal analysis group consists of Scott Addison, EMS Director Sam Allen, Assistant Finance Director Wendy Vogel and Compliance Officer Tina Strassenberg were present. Mr. Addison also expanded on the additional services of the vendor and the fee structure for billing.

The Vice-Chairman called for a discussion to approve the alcohol application from Sandhu Bro LLC., Faisal Ijaz licensee, dba Pace Car Express, at 3503 Sylvester Hwy for Package- Beer and Wine. The Albany-Dougherty Marshal's Office recommended approval. Chief Deputy Anthony Donaldson, Code Enforcement Department addressed.

The Vice-Chairman called for a discussion to accept the proposed amendment to the Dougherty County American Rescue Plan Act (ARPA) Project Spending Plan for Fiscal Year 22. Assistant County Administrator Scott Addison addressed. The changes reflected the actual numbers for the premium pay raise in the Special Service District, which decreased eight percent and included technology and safety vehicles. Commissioners Gray and Mr. Addison answered questions of the Board. Upon a specific request regarding broadband, it was shared that staff knew that money will not be spent this fiscal year, so funding could be amended to be included in the new FY.

Commissioner Edwards asked Planning and Development Services Director Paul Forgey about the status of plans for Paradise Village. Upon the consent of the Vice-Chairman, per the request of the Board, Mr. Forgey will invite the company to come and provide an update. Commissioner Edwards also shared that Commissioner Johnson submitted Chairman Cohilas' name for the ACCG Emory Greene award.

There being no further business to discuss the Commission the meeting adjourned at 11:22 a.m.

BACKGROUND INFORMATION:

Bid Ref. #22-065 was advertised on April 14, 2022 and the bid opening was held on May 13, 2022. One week later (05/20/2022), Ford Mo. Company shut down the order bank, causing a shortage of units available for the bid process. This resulted in the lowest Bidders not being able to meet the requirements of the Bid. Wade Ford of Smyrna Ga. had several hundred units in the order bank prior to the cutoff. After research, it was determined the unit should be purchased from Wade Ford because of the lack of availability from other vendors.
