DOUGHERTY COUNTY COMMISSION

REGULAR MEETING MINUTES

October 17, 2022

The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on October 17, 2022. Chairman Christopher Cohilas presided and called the meeting to order at 10:05 a.m. Present were Commissioners Victor Edwards, Gloria Gaines, Russell Gray, Clinton Johnson, Anthony Jones, and Ed Newsome. Also present were County Administrator Michael McCoy, Assistant County Administrator Scott Addison, County Attorney Alex Shalishali, County Clerk Jawahn Ware, and other staff. The public and representatives of the media participated in person and via live streaming of the meeting on the County's Facebook page and the government public access channel.

After the invocation and Pledge of Allegiance, the Chairman called for approval of the minutes of the September 26th Work Session and September 26th Special Called Meeting.

Commissioner Jones moved for approval. Upon a second by Commissioner Johnson, the minutes were unanimously approved.

The Chairman recognized citizen Arthur K. Williams who presented his concern on asking the Commission to address issues with the courts and the Sheriff. The concern was referencing the security ingress and egress for citizens. He mentioned that he was not pleased that citizens have to remove their belts to enter the courthouse. The second concern was about why the local Elks Lodge #633, which is a 501c3, in Dougherty County had to pay property taxes. Throughout the state, all other lodges are exempt and he requested that the Commission review this. The Chairman directed Attorney Shalishali to work with the Board of Assessors to determine why the organization was denied exemption. Commissioner Edwards requested that the Sheriff's Office front staff consider more effective public relations alternatives and look at examples of how other entities provide security services. Commissioner Edwards also asked Attorney Shalishali to determine from a legal perspective if another entity could provide the security service. Chairman Cohilas said that it is best to give the Sheriff the professional courtesy to address.

The Chairman recognized citizen Calvin Hill who echoed the same sentiments regarding removing belts to enter the courthouse. He also shared a risk management concern that occurred in the City of Albany. He wanted to express the issue to the County Commission about a flooding concern. Chairman Cohilas asked Mr. McCoy to contact the City Manager regarding the concern received.

The Chairman opened the public hearing for Bryan & Cynthia Wingate; owner and applicant (22-068) request to rezone 9.91 acres from AG (Agricultural District) to R-2 (Single Family Residential District). The rezoning would allow for the owners to subdivide portions of the property to sell to the adjacent property owners. The property currently holds two zoning designations R-2 and AG. The property is located at 3520 Thomas Road. The Planning Commission recommended approval. Angel Gray, Planning Manager, addressed. There being no one present to speak in favor or against the proposed matter, the Chairman closed the public hearing.

The Chairman called for consideration to purchase one John Deere 6110M Cab Tractor from state contract vendor Deere & Company (Cary, NC) for Solid Waste in the amount of \$89,222.98. Funding is budgeted in the Solid Waste Enterprise Fund.

Commissioner Jones moved for approval. Upon a second by Commissioner Newsome, the motion for approval passed unanimously.

The Chairman called for consideration of the resolution providing for the acceptance and execution of the contract to accept the bid for the 2021 LMIG Resurfacing and Safety Action Plan from the lowest responsive and responsible vendor meeting specifications, Oxford Construction Company (Albany, GA) in the amount of \$3,013,073.10 subject to execution by the County Administrator. Funding is budgeted in SPLOST VII (\$425,000), TSPLOST (\$2,149,250), 2021 LMIG (\$380,125) and 2021 LMIG SAP (\$42,000).

Commissioner Jones moved for approval. Commissioner Johnson seconded the motion. Under discussion, Mr. Mathis confirmed that Spurlock St. will be considered in future listing. There being no further discussion, the motion passed unanimously. Resolution 22- 046 is entitled:

A RESOLUTION ENTITLED A RESOLUTION PROVIDING FOR THE ACCEPTANCE AND EXECUTION OF THE CONTRACT TO ACCEPT THE BID FOR THE 2021 LMIG RESURFACING AND SAFETY ACTION PLAN FROM THE LOWEST RESPONSIVE AND RESPONSIBLE VENDOR MEETING SPECIFICATIONS, OXFORD CONSTRUCTION COMPANY; REPEALING RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

The Chairman called for consideration of the resolution providing for the acceptance of the revised Public Works Park Policy as recommended by the Recreation Committee effective November 1, 2022.

Commissioner Jones moved for approval. Upon a second by Commissioner Edwards, the motion for approval passed unanimously. Resolution 22-047 is entitled:

A RESOLUTION ENTITLED A RESOLUTION PROVIDING FOR THE ACCEPTANCE OF THE REVISED PUBLIC WORKS PARK POLICY AS RECOMMENDED BY THE RECREATION COMMITTEE; REPEALING RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

The Chairman called for the zoning consideration for Bryan & Cynthia Wingate; owner and applicant (22-068) request to rezone 9.91 acres from AG (Agricultural District) to R-2 (Single Family Residential District). The rezoning would allow for the owners to subdivide portions of the property to sell to the adjacent property owners. The property currently holds two zoning designations R-2 and AG. The property is located at 3520 Thomas Road. The Planning Commission recommended approval.

Commissioner Jones moved for approval. Upon a second by Commissioner Gaines, the motion for approval passed unanimously.

The Chairman called for a discussion of the proposed County's response to the Mayor's letter dated March 15, 2022 relative to the former National Guard Armory property. County Administrator Michael McCoy and County Attorney Alex Shalishali addressed. Commissioner Johnson confirmed that the letter conforms with the Recreation Committee's recommendation. County Clerk Jawahn Ware confirmed that it appeared to be a unanimous consensus from the Board to proceed with the letter. The Chairman shared that he will work with Attorney Shalishali to redraft the letter and recirculate it with the Board for review and possible approval at the next meeting. County members provided feedback on revisions.

Mr. McCoy gave an update on his recent meeting with the Public Works staff. Upon review of the payroll records, it was found that the County is in compliance with the Fair Labor Standards Act (FLSA) and all employees have been paid correctly. Commissioner Edwards shared that he would like a process that will prevent "silent" retaliation against staff. He also wanted an effective way for employees to voice their complaints addressed. Chairman Cohilas shared that the County has a process and policies in place which Mr. McCoy confirmed. Chairman Cohilas also said it is best to redirect staff to Human Resources and provide an update to Mr. McCoy regarding complaints received from a policy perspective. He asked Mr. McCoy to obtain a report from Human Resources on what is available to employees and re-educate employees on the process.

Commissioner Jones asked that the Board discuss in a Work Session how amending variances should be addressed. He shared that he felt that the problem is outdated ordinances.

Commissioner Jones clarified that he wanted directions on how to move forward with this request. Commissioner Johnson recapped for the Chairman the discussion from last week due to his absence. After clarification, Chairman Cohilas directed Attorney Shalishali and Mr. McCoy to provide an updated discussion at the next Work Session. Commissioner Gaines announced the passing of activist Charles Sherrod. Chairman Cohilas confirmed that a resolution [proclamation] can be drafted for Mr. Sherrod. Commissioner Gray provided updates from the Health Board meeting and shared that Covid numbers have been reduced in our community. As a result, he wanted to see if Mr. McCoy could meet with the City of Albany to see if they agreed on being less restrictive and removing the partitions and seat covers. It was a unanimous consensus from the Board that the administration staff will return to the dais.

County Administrator Michael McCoy reminded the Board that there will be no Commission meeting on Monday, October 24, 2022. The next meeting will be a Work Session on Monday, October 31, 2022 in Room 100.

There being no further business to come before the Commission, the meeting adjourned at 11:15 a.m.

WORK SESSION MEETING MINUTES

October 31, 2022

The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on October 31, 2022. Chairman Christopher Cohilas presided and called the meeting to order at 10:00 am. Present were Commissioners Victor Edwards, Gloria Gaines, Clinton Johnson, Anthony Jones and Ed Newsome. Also present were County Administrator Michael McCoy, County Attorney Alex Shalishali, County Clerk Jawahn Ware and other staff. Commissioner Russell Gray participated via the audio-conferencing feature. The public and representatives of the media participated in person via live streaming of the meeting on the County's Facebook page and the government public access channel.

The Chairman asked the Commission to review the minutes of the October 3rd Regular Meeting and the October 10th Work Session.

The Chairman recognized Consultant Phil Sutton to update the Commission on the Homestead Option Sales Tax (HOST). Mr. Sutton discussed what happens if LOST negotiations are not successful. He shared that the new distribution form must be submitted to the Department of Revenue no later than December 30, 2022. He added that the City and County would lose \$18,297,682 if LOST is not negotiated. He provided two options which were to increase the millage rate or implement a HOST. The HOST is a 1% sales tax and the primary purpose of it is to provide relief on homestead exempt properties. The secondary purpose is for capital expenditures (up to 20%) and there is no requirement to share revenue with the City under most circumstances. He shared that HOST has been adopted by Dekalb County and Rockdale County. A comparison between LOST and HOST was done with an overview of the tasks and timeline for implementation. It was noted that a referendum will be required and if successful, collections would not be until April 2024. He added that this would cause the County to be without sales tax collections for 15 months.

Other considerations pertaining to an alternative solution were shared. A lengthy discussion ensued. It was noted by Mr. Sutton that you cannot implement a HOST if a LOST or ELOST is in place. The consultant recommended not considering HOST unless "LOST is lost." Attorney Shalishali will provide legal guidance if the County should continue with the LOST process or meetings.

Recess was from 11:28 am- 11:36 am.

The Chairman recognized James Morgan, County Extension Coordinator, to update the Commission with the quarterly report. Mr. Morgan provided a handout of the 3rd quarter report and gave an update on filling vacancies. Upon the request of Commissioner Jones, an update on a recent contest at the fair was shared.

The Chairman recognized William Wright, representative for AFRAM Tech, Inc. to discuss an issue of unfair practices with ARPA funding. Mr. Wright started his presentation by sharing information to help the Commission with potential mediation or arbitration for LOST. He shared concerns in regards to the County collecting money but the population is being lost. He will bring more information, including details about the Taft-Hartley Act, to the Commission.

The Chairman recognized Alex Shalishali, County Attorney and Paul Forgey, Director of Planning and Development Services to provide an update on the "Variance Policy" for Zoning Considerations and the ability of amendment by the Dougherty County Board of Commissioners. Attorney Shalishali provided an overview of the current ordinance and shared that the governing body has full control of the zoning ordinance which they can amend. Practical considerations were provided. He added that most variances are noncontroversial. If the Board of Commissioners decided to start adjudicating requests, training will be required. He shared that most areas in the state delegate the variance process to a separate board such as the Planning Commission to handle it. After a recap by the Chairman, he suggested that an apprisal to the County Commission be provided in the motion regarding future decisions. Commissioner Jones requested education for homeowners be provided moving forward. Chairman Cohilas would like to digest the request of Commissioner Jones and have a substantive discussion at the next Work Session. Commissioner Edwards clarified that he is only concerned about an update on variances that the County Board of Commissioners denied.

The Chairman called for a discussion to accept the Memorandum of Agreement with Albany Technical College on behalf of the Dougherty County Sheriff's Office authorizing assistance to each other during a local emergency. Chief Deputy Terron Hayes addressed. Chief Hayes recommended approval and said this will allow them to respond in extenuating circumstances.

The Chairman called for a discussion to accept the proposal from the City of Albany for improvements to the basketball courts at Robert Cross Park in the amount of \$55,151.22. This request for maintenance and improvements to the park is consistent with the approved Service Delivery Strategy for Recreation. Funding is available in the FY 23 American Rescue Plan Act (ARPA) Spending Plan. County Administrator Michael McCoy addressed. Public Works Director Chuck Mathis was present. Mr. McCoy recommended approval after finding out that facilities are not up to par. Upon a question by Commissioner Johnson, Mr. McCoy shared that our park's funding is very limited. He also provided an update on the approximate balance of the ARPA funding and will provide details of expenditures at a future meeting. Commissioner Jones shared his concerns about funding not being made available for Putney Park via ARPA. Mr. Mathis and Mr. McCoy addressed by sharing with Commissioner Jones that the initial presentation was for use of SPLOST and contingency funds [for Putney Park]; and it was recently discovered that there is funding available in ARPA that could be directed to this current project. Chairman Cohilas asked that an update be provided at the next Work Session. The Chairman also stressed that a presentation can be provided to the local legislation and make a funding request. Commissioner Johnson reminded the Board that our recreation vendor is the City of Albany and shared that the best process is to have the City of Albany view Putney Park and make a presentation to the Recreation Committee with input from Commissioner Jones. Commissioner Jones also shared that consultant Ron Huffman did provide a park concept and Commissioner Johnson reminded the Board of grants denied.

The Chairman called for a discussion to exercise the renewal option from December 4, 2022 to December 3, 2023 with an adjustment to the hourly rates based on the CPI-U Base Price Adjustment Calculation with Tetra Tech. The option is for the Professional Debris Monitoring Services for Disasters and Financial Recovery. County Administrator Michael McCoy addressed.

The Chairman called for a discussion to declare the listed vehicle as surplus and authorize the disposal of or sale of same via an online auction. County Administrator Michael McCoy addressed. Mr. McCoy confirmed the Chairman's recap of the need to proceed and for Commissioner Johnson that we only pay when services are utilized.

The proposed project is approximately 0.4 miles long, with the Preliminary Engineering Phase currently underway.

GENERAL INFORMATION:

The applicant is requesting Special Approval to operate a Recovery Residence. The property is currently zoned C-2 & C-7 and if granted approval will be rezoned to C-1, and that zoning classification permits Recovery Residence by Special Approval.

SPECIAL APPROVAL CRITERIA

The Albany Dougherty Zoning Ordinance recommends that the Planning Commission consider the following factors for special approval requests:

1. The effect of the proposed activity on the adjacent transportation network.

Trip Generation:

Gillionville Road is an Urban Minor Arterial.

- Gillionville Rd between Westover and Lockett Station had an Average Daily Traffic (AADT) count of 14,400 in 2020.
- Based on Trip Generation's 10th Edition (2018) information, a recovery residence could generate 1-2 trips per day for each dwelling unit. Applicant proposes 10 rooms that will accommodate 2 women per unit. (Residents will not have personal vehicles)

Analysis: No adverse impact to the surrounding transportation network should result from the proposed use.

2. The location of off-street parking facilities.

Accessible parking spaces are required per code, but this proposal requires a low amount of parking. The applicant proposes 22 parking spaces. The residents will not have vehicles. There will be approximately four (4) employees on site. According to the applicant the location is secluded for the residents. Staff confirmed on a site visit to the location the lot size is sufficient to provide adequate parking and offer the proposed seclusion for the residents.

3. The number, size, and type of signs proposed for the site.

Signs must comply with the City of Albany Sign Ordinance. According to the applicant, this phase will include a site identification sign near the entrance to the site.

4. The amount and location of open space.

A generous landscape buffer is to be located around the site's perimeter aesthetically separating this development from the adjoining properties, according to the applicant.

5. Protective Screening.

Buffers will be provided in accordance with the County Zoning Ordinance. Currently there is a partial fence and gate at the entrance.

6. Hours and manner of operation of the proposed use.

According to the applicant, the facility will be in operation 24 hours a day as a residence. One employee will be onsite 24 hours a day. Additional employees will be onsite during regular hours from approximately 8:00 am to 5:00 pm.

7. Outdoor lighting.

According to the applicant, lighting will be provided, but it will be minimal and low intensity for security purposes only.

8. Ingress and egress to the property.

According to the applicant, the property will be accessed from a single driveway off Gillionville. Signed distance is not a problem at this location. The applicant states the existing drive will be upgraded to 24' wide proposed asphalt driveway. A permit will be required from the Georgia Department of Transportation.

9. Compatibility with surrounding land use.




10. Consistency with the Comprehensive Plan.









We are working with the Anchorage in an effort to develop a women's recovery center on a 73.261 acre tract of land located at 2908 Gillionville Road in Dougherty County, Ga. The property is currently zoned C-2 and C-7. Rezoning to C-1 has been requested. We are submitting a request to obtain special approval for the residential recovery center use. This letter is to clarify the proposed intent for the property addressing items as required by the County's zoning ordinance. Plans include the initial construction of an approximately 7300 sf building which would have the potential for future expansion. This building will contain residential, administrative, and counseling components.

- 1. Traffic generated this development will be low. The residents will not have vehicles, and there will only be approximately four employees. The site is located off of Gillionville Road. Gillionville Road is a five lane urban section roadway at this location with ample capacity for the development of this project.
- 2. Very little onsite parking will be required. 22 paved parking spaces are proposed.
- 3. There will be a site identification sign located near the entrance to the site. The sign will comply with the County Sign Ordinance.
- A generous landscape strip will be provided around the perimeter of the site aesthetically separating this development from the adjoining properties.
- Adjoining properties are comprised of a mixture of zoning districts. The property is quite large for the proposed use in order to provide seclusion for the residents. Buffers will be provided in accordance with the County zoning ordinance.
- 6. The facility will be in operation 24 hours per day as a residence. One employee will be onsite 24 hours per day. Additional employees will be onsite during regular business hours from approximately 8:00 AM to 5:00 PM. Site lighting will be minimal and low intensity for security purposes only.


