### **REGULAR MEETING MINUTES**

#### April 5, 2021

The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on April 5, 2021. Chairman Christopher Cohilas presided and called the meeting to order at 10 a.m. Commissioner's present were Victor Edwards, Gloria Gaines, Russell Gray, Clinton Johnson, Anthony Jones, and Ed Newsome. Also present were County Administrator Michael McCoy, County Attorney Spencer Lee, County Clerk Jawahn Ware, and other staff. The public and representatives of the media participated in person and via live streaming of the meeting on the County's Facebook page and the government public access channel. Assistant County Administrator Scott Addison was absent.

After the invocation and Pledge of Allegiance, the Chairman called for approval of the March 1st Regular Meeting and March 8th Work Session minutes.

Commissioner Newsome moved for approval. Upon a second by Commissioner Johnson, the minutes were unanimously approved.

The Chairman called for consideration of the purchase of two 2021 Dodge Ram 1500 Pickup Trucks for the Public Works Department from Albany Chrysler-Dodge-Jeep-Ram (Albany, Ga) in the amount of \$52,880. Two bidders submitted bids with the highest being \$64,534. Funding is budgeted in SPLOST V – Storm Drainage Improvements/Equipment.

Commissioner Jones moved for approval. Upon a second by Commissioner Gray, the motion for approval passed unanimously.

The Chairman called for consideration of the resolution providing for the acceptance and execution of the contract to accept the bid from the lowest responsive and responsible bidder Reeves Construction, Inc. (Albany, GA) to perform Street Resurfacing and Full Depth Reclamation in the amount of \$2,636,024.45 for the 2020 Resurfacing Project, subject to the execution of the contract by the County Administrator. Funding is available in SPLOST VII 2020 Resurfacing (\$425,000), 2020 LMIG (\$435,823.69) and TSPLOST Road Resurfacing (\$2,000,000).

Commissioner Jones moved for approval. Upon a second by Commissioner Gray, the motion for approval passed unanimously. Resolution 21-017 is entitled:

Commissioner Gray moved for approval. Upon a second by Commissioner Newsome, the motion for approval passed unanimously. Resolution 21-018 is entitled:

Washington St. for a total expenditure of \$54,353, subject to the execution of the contract by the County Administrator. Funding is budgeted in SPLOST VI for \$115,000.

Commissioner Gray moved for approval. Upon a second by Commissioner Johnson, the motion for approval passed unanimously. Resolution 21-019 is entitled:

The Chairman called for consideration to rescind the award made on November 2, 2020, to Smith-Built Buildings (Dawson, Ga) in the amount of \$23,879.49 to install an equipment shed at the Solid Waste Landfill. The vendor defaulted on the bid.

Commissioner Jones moved for approval. Upon a second by Commissioner Johnson, the motion for approval passed unanimously.

The Chairman called for consideration to accept the quote to install an equipment shed at the Solid Waste Landfill from the next lowest responsive and responsible vendor meeting specifications that is available to complete the project, R&M Construction (Albany, Ga) in the amount of \$32,500. The initial vendor defaulted on the award made on November 2, 2020. Funding is budgeted in Solid Waste Capital Outlay for \$50,000.

Commissioner Johnson moved for approval. Upon a second by Commissioner Jones, the motion for approval passed unanimously.

The Chairman called for consideration to accept the bid from the lowest quoted vendor, Quality Painting Contractors (Albany, GA) in the amount of \$36,300 to upgrade the Horace King Overlook roof and deck and paint surrounding areas near Turtle Park. Funding is available in SPLOST VII.

Commissioner Jones moved for approval. Upon a second by Commissioner Johnson, the motion for approval passed unanimously.

The Chairman called for consideration to approve the alcohol application from Pretoria Field Farms, LLC., Joe Harris Morgan III licensee, dba Pretoria Field Farm, at 5626 Walker Ducker Station Road for Beer, Brewers. The Albany-Dougherty Marshal's Office recommended approval.

Commissioner Gray moved for approval. Upon a second by Commissioner Jones, the motion for approval passed unanimously.

The Chairman called for consideration of the resolution accepting the proposed Ordinance allowing Dougherty County to be a broadband-ready community.

Commissioner Johnson moved for approval. Upon a second by Commissioner Jones, the motion for approval passed unanimously. Resolution 21-020 is entitled:

The Chairman called for consideration of the resolution the use of the Dougherty County Nuisance Abatement Resolution Number 20-034 to address one purported dilapidated structure located at 3422 Sweetbrier Road.

Commissioner Johnson moved for approval. Upon a second by Commissioner Edwards, the motion for approval passed unanimously. Resolution 21-021 is entitled:

Commissioner Newsome welcomed Commissioners Gaines and Jones back to the Chambers. Commissioner Jones said that he was excited that there were a lot of local vendors awarded today. Commissioner Edwards asked about the status of the nuisance abatement for the property on Barbragale Avenue. Attorney Lee said that the nuisance abatement could not be used for the property in question. However, it could be taken to court for being in violation of Code Enforcement. Code Enforcement is completing another analysis on the property and he is awaiting a response. Attorney Lee shared that the property on Thrasher may be able to qualify for nuisance abatement and the others are awaiting an analysis from Code Enforcement. It was mentioned that Code Enforcement is a little behind because the officer that did the inspections resigned. Attorney Lee made it very clear that the property that has the tree on it could not be moved by the County. He also shared with Commissioner Jones that a lawsuit could occur if someone attempted to move the tree. He added that the biggest obstacle was attempted to locate the property owner and not being successful in the search. Attorney Lee provided an update on the commercial structure located on Holly Drive that was damaged during the storms. He stated that it would be costly, but the process used for residential properties could be an option. Based on the request from Commissioner Gaines, Mr. McCoy said that available sources of funding will be sought for demolishing the building. He added if there are none, the Board could amend the budget.

After a very lengthy discussion, Chairman Cohilas asked for a comprehensive report within 120 days of (1) the number of buildings in the unincorporated area that fall in the dilapidated category, (2) the projected cost to be demolished by Public Works. Chairman Cohilas later clarified the request by asking for those buildings to be identified that could not [have repairs] completed by private owners. He suggested that a comprehensive plan be developed for several years on how to

address these properties. Commissioner Gaines asked that all Commissioners have input and Commissioner Jones asked that the properties be prioritized. Chairman Cohilas shared that this will create a proactive approach. Attorney Lee reminded the Board that the County works on complaints and this request would be a huge task for Public Works and one Code Enforcement Officer. He added that our process helps if we went to court [to prevent a claim] for selective prosecution. Chairman Cohilas yielded for the staff to make a recommendation on the process that will give a report with a cost.

Mr. McCoy suggested Commissioner Gaines' recommendation be utilized and each Commissioner provide a list of properties that are concerns in their respective areas and staff would address. Commissioner Edwards asked that Public Works be allowed to get a waiver from the property owner to remove the tree on Barbragale Avenue. Commissioner Gaines agreed as long as the County Attorney could agree that action was taken within the law; noting there still was a greater problem [pertaining to depilated properties] that needed to be addressed. Chairman Cohilas shared that he will take a week to think about the concerns so a fair and effective process can be created. He ended the discussion by asking Mr. McCoy to provide a cost estimate for Barbragale Avenue.

Commissioner Johnson thanked the Commission for their support for Heath Park and shared that there will be an upcoming recommendation to the Board next week for the tennis center. Commissioner Gray shared some positive comments received about the Radium Springs cleanup, trails, and proposed tennis center.

There being no further business to come before the Commission, the meeting adjourned at 10:57 a.m.

#### WORK SESSION MEETING MINUTES

#### April 12, 2021

The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on April 12, 2021. Chairman Christopher Cohilas presided and called the meeting to order at 10:00 am. Commissioners present were Victor Edwards, Gloria Gaines, Russell Gray, Clinton Johnson, Anthony Jones and Ed Newsome. Also present were County Administrator Michael McCoy, Assistant County Administrator Scott Addison, County Attorney Spencer Lee, County Clerk Jawahn Ware, and other staff. The public and representatives of the media participated in person, via live streaming of the meeting on the County's Facebook page and the government public access channel.

The Chairman asked the Commission to review the minutes of the March 15th Regular Meeting and March 29th Work Session.

The Chairman called for a discussion of the recommendation to accept the proposed location of Tift Park for the Albany Tennis Center, as recommended by the Recreation Committee. Recreation Committee Chairman Clinton Johnson addressed. County Administrator Michael McCoy, Albany Tennis Association Representative Wes Sadler, USTA Senior Consultant, Facility Services Robin Jones, USTA Business Development Consultant Jonathan Fralick, Boys & Girls Club of Albany representative Jason Belk and City of Albany interim Recreation Director Michael Potter were present. Mr. McCoy shared that property will be needed from the City of Albany and Boys & Girls Club and a recommendation will be made later for the County to retain the maintenance of the center.

The Chairman called for a discussion of the recommendation of the Recreation Committee to hire EMC Engineering (Leesburg, GA) for Tennis Center engineering services. The proposed amount is \$202,640 and funding is available in SPLOST V. Recreation Committee Chairman Clinton Johnson addressed. County Administrator Michael McCoy, Public Works Director Larry Cook and Project Engineer Jeremy Brown were present. Commissioner Johnson clarified that \$202,640 included the south zone pickleball court of \$82,500 but the amount will be paid by the City of Albany. The amount will be revised for the Commissioner's approval. Mr. Fralick addressed items for Commissioner Johnson.

The Chairman called for a discussion to approve the Alcohol Application Transfer of Ownership for VV Trading LLC, Venkateshwar Guntuka licensee, dba VV Food Mart, at 4324 Radium Springs Rd for Beer and Wine Package. The Albany-Dougherty Marshal's Office recommended approval. County Clerk Jawahn Ware addressed.

The Chairman called for a discussion to approve the Alcohol Application Transfer of Ownership for Bagain LLC, Ayaz Ahmad licensee, dba Stop N Shop, at 2201 Liberty Expressway SE for Beer, Package. The Albany-Dougherty Marshal's Office recommended approval. Chief Anthony Donaldson, Business and License Support Department and County Clerk Jawahn Ware, addressed. Mrs. Ware clarified that applicants for transfer of ownership still have a thorough background check completed.

The Chairman called for a discussion of the recommendation from Human Resources to accept the 2021 Georgia County Internship Program (GCIP) Grant from the ACCG Georgia Civic Affairs Foundation in the amount of \$2,607.60. The grant will provide a summer internship for the CDBG Disaster Recovery Program. The County received the award in 2020; however due to the pandemic, ACCG transferred the award to this year. County Administrator Michael McCoy and HR Director Dominique Hall addressed. There was a discussion pertaining to dividing or matching the grant funding to offer additional opportunities to more students. As a point of procedure, Commissioner Gray reminded the Board that the matter on the table was for the ACCG grant. The Chairman asked that staff provide a recommendation on a County internship program.

The Chairman called for a discussion of the recommendation to approve the renewal of the Intergovernmental Support Agreement with the Marine Corp Logistics Base (MCLB) to provide canal maintenance. The initial agreement was approved in the May 8, 2017 Regular Meeting. County Administrator Michael McCoy addressed by sharing that the value of the contract is \$75,000 for 3 years; the document is the same agreement but a different format. Public Works Director Larry Cook and Project Engineer Jeremy Brown were present.

The Chairman called for a discussion of the Planning and Development Update for the Dougherty County Morgue. Assistant County Administrator Scott Addison, Coroner Michael Fowler and Architect David Maschke addressed. The conceptual plan was shown. One proposed site is the location of the old Dougherty County Public Works sign shop. There will be space allocated for student training and construction. Mr. Addison identified potential land for a crime lab location if Albany State University pursues [the request]. The proposed plan cost for option A is \$822,942. Option B with the construction site on Habersham will be \$947,052. There will be a funding shortfall on each. Mr. McCoy shared that the plans were presented for the Commission to determine the site of the morgue. The Corner's preference is option B. After discussion, the Chairman requested all parties meet and present a revised scope at the next work session with staff recommendation on how to find any short falls. Mr. Maschke clarified that the proposal is for the project cost that included additional costs (i.e., furniture and signage) which is different than construction cost. The Commission asked if there could be a proposal closer to budget and Mr. Addison shared that it would be option A because the location has infrastructure currently in place. As alluded by the Chairman, Mr. Maskche shared that due to the increase in construction prices, both proposals for the building alone have absorbed the budget.

The Chairman called for a discussion of the recommendation of the Government Affairs Committee that current plans continue for the county morgue ensuring to the degree possible that sufficient land is available at or near the selected site for the addition of a functional forensic science lab to be developed at some future date in partnership with Albany State University. Further, it is recommended that the Governmental Affairs Committee continue to work with Albany State University to assist where possible in development of the lab. Government Affairs Committee Chairwoman Gloria Gaines addressed. County Administrator Michael McCoy was present. Chairwoman Gaines clarified that if there is expansion, then it would be an ASU cost.

The Chairman called for a discussion of a recommendation to review and discuss a proposed draft of a Management, Operations and Maintenance Agreement for the Government Center between Dougherty County and the City of Albany. County Attorney Spencer Lee and County Administrator Michael McCoy addressed. Commissioner Gray would like a subleasing clause included where the other entity will have approval. Additionally, he wanted the administration team to be clearly identified and add a clause for operations cost utilization.

The Chairman called for a discussion of a recommendation to take appropriate action to either demolish or bring up to Code one dilapidated structure located at 1000 Liberty Expressway. County Attorney Spencer Lee and County Administrator Michael McCoy addressed. Attorney Lee shared some concerns and Mr. McCoy shared that the cost estimate in the private sector is approximately \$90,000 but most of it will be absorbed because staff will do the work. Even after cost absorption, the request exceeds the budget for the Special Services District. Any action taken will require a budget amendment. EPD will need to be contacted for additional guidance. The Chairman was clear that he does not desire for the County to own a gas station, even though he is in favor of cleaning up the area. Commissioner Edwards expressed frustration regarding action on Barbragale Avenue. The Chairman shared that the home does not meet the condition of dilapidated property. Commissioner Jones provided an update that the property owners have been identified and Code Enforcement is taking action to include how the mortgage company may be able to remove the tree.

The Chairman called for a discussion of a recommendation from Public Works to apply for a Local Maintenance & Improvement Grant (LMIG) - Safety Action Plan (SAP) from the Georgia Department of Transportation for a 70% grant that requires a 30% match. Funding is available in TSPLOST and will be used or the installation of new signage and/or the repair of existing signage along 6 roads (~24.6 miles). Assistant County Administrator Scott Addison, Public Works Director Larry Cook and Project Engineer Jeremy Brown addressed. Action on this item was scheduled in the following Special Called Meeting because the grant application is due Wednesday, April 14, 2021.

Commissioner Johnson requested an update from the Tax Commissioner about homestead exemptions for seniors.

There being no further business to come before the Commission, the meeting adjourned to a Special Called Meeting at 11:21 a.m.

# **Study purpose**

- Study assesses need for continued/future programs to assist MBE/WBEs in Consortium procurement
  - Last Consortium disparity study conducted in 2001
- Consortium agencies have operated race- and gender-based programs
  - U.S. Supreme Court established "strict scrutiny" as the legal standard for race-conscious programs
  - Courts have since struck down a number of local MBE/WBE programs
- Results pertain to locally-funded procurement, not implementation of Federal DBE Program (e.g., Airport DBE Program)



# **Study background**

- Study began in summer 2007 and completed in August 2008
- Quantitative analysis of:
  - More than 74,000 Consortium purchases
  - > Bidding processes



Note: Based on analysis of 19,036 procurements totaling \$141 million. Includes non-certified minority- and women-owned firms.




- From some MBE/WBEs: seldom contacted for bids on non-goals contracts

# Share of procurement dollars staying within local market, July 2004 – June 2007



Results of the analysis of weighted MBE/WBE availability. BBC's analysis indicates that MBEs and WBEs would receive 10.4 percent of prime contract and subcontract dollars for Consortium agency contracts for 2004 through 2007: This means that 10.4 percent of dollars on Consortium agency contracts would go to minority- and women-owned firms (MBE/WBEs) if available MBE/WBEs received the same amount of work as similarly-situated majority-owned firms available for such work. This analysis considered the type of work, contract role and size of work involved in each prime contract and subcontract and the types, contract roles, and contract sizes for work performed by available firms.

Consistent with the non-weighted availability reported in Figure D-6, white women-owned firms comprise the largest portion of the overall dollar-weighted availability. As shown in Figure D-8, dollar-weighted availability of WBEs across all types of Consortium procurement included in the disparity study is 7.3 percent. Dollar-weighted availability of African American-owned firms is 2.6 percent. Native American-owned firms and Hispanic American-owned firms show dollar-weighted availability of 0.4 percent and 0.1 percent, respectively.

WHEREAS, there exists in the unincorporated area of the County certain real property that is unfit for human habitation and not in compliance with applicable County codes and state laws and constitutes an endangerment to the public health and safety as a result of unsanitary and unsafe conditions; and

**SECTION II** The Public Officer is hereby requested to have filed in a Civil Court with jurisdiction a Complaint In Rem against the above-stated lots, tracts or parcels of real property found to be in violation of said Resolution.

**SECTION III** The County Attorney is hereby directed to take appropriate action on behalf of Dougherty County relative to the above-stated properties to abate any nuisance found to be in violation of Dougherty County Nuisance Abatement Resolution Number 02-034.

**SECTION IV** The County Attorney, Public Officer and County Administrator are hereby authorized to expend funds necessary to have the violations abated, including demolition costs.
