The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on January 23, 2023. Chairman Lorenzo Heard presided and called the meeting to order at 10:00 a.m. Present were Commissioners Victor Edwards, Gloria Gaines, Russell Gray, Anthony Jones, Clinton Johnson and Ed Newsome. Also present were County Administrator Michael McCoy, County Attorney Alex Shalishali, County Clerk Jawahn Ware, and other staff. The public and representatives of the media participated in person and via live streaming of the meeting on the County's Facebook page and the government public access channel.

The Chairman provided the invocation and Pledge of Allegiance.

The Chairman recognized Deerfield-Windsor Varsity Football team, Cheer Squad and Head Coaches for their recent accomplishments by Head of School, Allen Lowe and accept the proclamation from the Board of Commissioners commemorating the season. The proclamation read as follows:

The Chairman recognized Jana Dyke, President & CEO, Albany-Dougherty Economic Development Commission, to provide the quarterly update. Ms. Dyke introduced her new staff member Rodrick Gilbert to the Board and said that he specialized in economic development. She shared that Jessica Zurheide specialized in business relations but she was not present due to prior engagements. She mentioned the areas that they planned to strengthen were: recruitment of the industries, retail development with partners, retail strategies, business retention and expansion implementation. Community outreach and other marketing strategies were shared. Commissioner Gaines wanted to develop ways to define the quality of life with hopes to resume the efforts with comparison and community involvement. Ms. Dyke shared that key components have been identified and that she will send them to Commissioner Gaines. Commissioner Johnson mentioned a potential joint development authority with other partners to assist the community. He wanted an update on the discussion of the inner center development authority and asked that Ms. Dyke share the flyer that provided data from the Payroll Development Authority. Commissioner Johnson stressed that he wanted to make sure that all

business have full opportunities to avoid an error that occurred last year. Commissioner Jones suggested that rebranding occurs for the EDC and thanked them for the accessibility. Commissioner Edwards asked Ms. Dyke to obtain ranking records for Dougherty County and asked to see dynamics in unfamiliar areas in the community.

The Chairman recognized Eric Schwalls, GBI Special Agent In Charge, to provide the annual report for 2022. Mr. Schwalls requested that Dougherty County accept the 2023 grant. He shared that 164 cases were open and 143 arrests were made with almost \$6 million in contrabands as of 2022.

The Chairman called for consideration to purchase vehicle pursuit equipment for ADDU in the amount of \$47,217.20 from Dana Safety Supply (Preston, GA). Three pursuit vehicles will need equipment to be placed into service. The recommended company is the county's vendor for law enforcement vehicle pursuit equipment. Funding is budgeted in ARPA. County Administrator Michael McCoy addressed. Major Ryan Ward was present.

Commissioner Johnson moved for approval. Commissioner Newsome seconded the motion. Under discussion, Mr. McCoy provided clarity for Commissioner Gaines by informing her that the ARPA had to be allocated by FY 2024 and expended by FY 2026. There being no further discussion, the motion for approval passed unanimously.

The Chairman called for consideration to accept the Edward Byrne Memorial Justice Assistance Grant for the 2023 calendar year in the amount of \$248,000. The grant is provided by the Georgia Criminal Justice Coordinating Council for the operation of the Southwestern Regional Drug Enforcement Office. The grant acceptance is required annually. County Administrator Michael McCoy and GBI Special Agent in Charge Eric Schwalls addressed. Mr. McCoy recommended approval.

Commissioner Johnson moved for approval. Upon a second by Commissioner Newsome, the motion for approval passed unanimously.

The Chairman called for consideration of the resolution providing for the acceptance and execution of the contract with Cell Tower Solutions (Watkinsville, GA) to value cell towers in Dougherty County on behalf of the Board of Tax Assessors in the amount of \$170,000. Services will be effective for the 2023 budget and 2023 tax year. William Ashberry, Chairman of the Board of Tax Assessors and Larry Thomas, Interim Chief Appraiser addressed. Mr. Ashbery shared the Tax Assessors board approved the contract for the cell towers on January 17, 2023 and they have agreed to start no later than March 2023. They will identify all the cell towers within Dougherty County and payments will be done incrementally as the work gets done. Mr. McCoy shared that this was an unbudgeted expense and the Board will need to amend the budget to include the payment of up to \$170,000. Mr. Thomas added that a cell tower valuation has not been done in over 9 years and 90% of counties outsource the valuation processes.

Commissioner Johnson moved for approval. Upon a second by Commissioner Newsome, the motion for approval passed unanimously. Resolution 23-001 is entitled:

A RESOLUTION ENTITLED

A RESOLUTION PROVIDING FOR THE ACCEPTANCE AND EXECUTION OF THE CELL TOWER SOLUTIONS SERVICES AGREEMENT BETWEEN DOUGHERTY COUNTY, GEORGIA AND CELL TOWER SOLUTIONS, LLC, TO VALUE CELL TOWERS IN DOUGHERTY COUNTY ON BEHALF BOARD OF TAX ASSESSORS, REPEALING RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH;

AND FOR OTHER PURPOSES.

Commissioner Edwards asked Mr. McCoy for a list of all the SPLOST and LOST accounts and balances. Commissioner Johnson wanted an update on the opioid reimbursement and Mr. McCoy shared that Dougherty County plans to receive \$17,000. The proposal is to purchase narcan for the EMS department with the funds unless the Board desires otherwise. Commissioner Johnson also asked for an update on the judgeship funding. Attorney Shalishali confirmed that the state law prohibits blanket donations. However, he recommended that asks pertaining to the gratuity clause be evaluated case by case and Mr. McCoy encouraged the Board to adopt a policy. The Board was reminded that no funding was allocated [for community asks] and that the best time to consider is during the budget process.

There being no further business to come before the Commission, the meeting adjourned at 11:54 a.m.

ANNUAL RETREAT MINUTES

January 27, 2023

The Dougherty County Commission met at the Hotel Indigo, 21 14th Street, Columbus, Ga on January 27, 2023 for the annual commission retreat. UGA, Carl Vinson Institute of Government (CVIOG) Facilitator Jennifer Nelson provided opening remarks followed by Chairman Heard at 9:10 a.m. Commissioners present were Victor Edwards, Russell Gray, Clinton Johnson, Anthony Jones and Ed Newsome. Commissioner Gloria Gaines participated via an audio-conferencing feature. Also present were County Administrator Michael McCoy, County Attorney Alex Shalishali, County Clerk Jawahn Ware and Public Information Officer Wendy Howell.

Chairman Heard introduced Rockdale County Board of Commissioner Chairman Oz Nesbitt to provide the Board with some encouraging tips.

Mr. McCoy highlighted recent accomplishments and informed the Board that the TSPLOST renegotiation with the City of Albany was drawing near. He also introduced a new work order process that would allow the Commission to submit requests for staff.

Attorney Shalishali reviewed the travel policy and shared portions should be revised. Upon the request of Commissioner Johnson, the Chairman consented to the policy being updated. The Chairman asked for clarity to be provided regarding boards the individuals chair or participate on. Mr. McCoy said that updates can be provided in a future Work Session and consideration can be made to change the per diem and mileage rates.

Consultant Nelson asked for suggestions on areas to help Dougherty County grow by leading the group in a SWOT analysis. The Board provided various ideas to make the County more effective and the suggestions were used to identify priorities.

Commissioner Johnson left the retreat approximately 2:15 pm and Commissioner Gaines left the audio conference approximately 2:38 pm.

The five goal/priority categories identified were: community development, TSPLOST, marketing and communication, youth engagement, and county projects implementation.

After a lengthy discussion, several projects were suggested and were narrowed down. The top five priorities for 2023 are completing the morgue, having a housing assessment, developing Putney Park, creating a tennis center, and finalizing TSPLOST. Mr. McCoy also suggested that the County's policies and procedures manual be updated.

These ideas have been benchmarked for	or an update in six months.

WORK SESSION MEETING MINUTES

January 30, 2023

The Dougherty County Commission met in Room 100 of the Albany-Dougherty Government Center on January 30, 2023. Chairman Lorenzo Heard presided and called the meeting to order at 10:00 am. Present were Commissioners Victor Edwards, Gloria Gaines, Russell Gray, Clinton Johnson, Anthony Jones, and Ed Newsome. Also present were County Administrator Michael McCoy, County Attorney Alex Shalishali, Deputy County Clerk Bristeria Hope and other staff. County Clerk Jawahn Ware participated in the audio conference feature. The public and representatives of the media participated in person via live streaming of the meeting on the County's Facebook page and the government public access channel.

The Chairman asked the Commission to review the minutes of the January 9, 2023 Regular Meeting.

The Chairman recognized citizen Frank Wilson to request funding from the Board to support The Black History concert. Mr. Wilson provided a brief history of the music and funding sources and shared how previous funding sources are no longer available. His ask from the Board was for \$1000. Dr. Andrew Wulf, Executive Director of the Albany Museum of Art was introduced and shared that he was present for support. Commissioner Edwards suggested that the County Attorney and County Administrator get together to discuss this request for action. Attorney Shalishali stated that the Board of Commissioners is prohibited from making private donations to nonprofit or private entities but requests should be reviewed on a case-by-case basis. A response wil be provided to Mr. Wilson before February 16, 2023.

The Chairman called for a discussion to accept the bid from the lowest, most responsive and responsible vendor Preventia Security (Albany, Ga) to replace the fire alarm system for the Department of Human Services in the amount of \$72,333.73. Three bids were received with the highest being \$112,080.04. Funding is budgeted in DHS CIP. County Administrator Michael McCoy and Facilities Management Director Heidi Hailey addressed. Mr. McCoy recommended approval.

The Chairman called for a discussion to accept the bid from the most responsive and responsible vendor Metro Waterproofing (Scottdale, Ga) to weatherproof and restore the exterior wall for the Dougherty County Health Department in the amount of \$135,000. Six bids were received with the highest being \$297,000. The apparent low bidder was not deemed the most responsive. Funding is budgeted in SPLOST VII. County Administrator Michael McCoy and Facilities Management Director Heidi Hailey addressed. Consultant Jody Usry and City of Albany Buyer Ricky Gladney were present. Mr. McCoy recommended approval. Mr. Usry shared that it is not in the best interest of the County to accept the lowest bid and the vendor understood. It was also stated that this is routine maintenance with an approximate 15-year life cycle.

The Chairman called for a discussion to accept the bid from the most responsive and responsible vendor Crosby Roofing and Gutter, LLC (Macon, Ga) to provide roof restoration services for the Albany Rescue Mission in the amount of \$57,500. Four bids were received with the highest being \$159,700. The apparent low bidder was not responsive. Funding is budgeted in ARPA. County Administrator Michael McCoy and Facilities Management Director Heidi Hailey addressed. City of Albany Buyer Ricky Gladney was present. Mr. McCoy recommended approval and projected that this would be beneficial for the homeless people in the community. It was shared that additional funding will be needed to remove the residents and provide lodging for them during the restoration process. The projected amount should be within the County Administrator's authorization to approve.

The Chairman called for a discussion of the recommendation to amend section II-4: Compensation Administration of the Dougherty County Board of Commissioners Personnel Policies & Procedures manual. County Administrator Michael McCoy and Interim HR Director Erica Potts addressed. Mrs. Potts shared that policy revision was made to reflect a continuation of pay equity and competitive salary study that the Board approved.

The Chairman called for a discussion of the recommendation to declare the listed vehicles and equipment as surplus and authorize the disposal of or sale of same via an online auction. County Administrator Micheal McCoy addressed. Mr. McCoy recommended approval and confirmed that the surplus funds return to the general fund.

The Chairman called for a discussion of the proposed board appointments. Deputy County Clerk Bristeria Hope was present to address.

Golden Triangle RC & D Council – There are three appointments with a two-year unexpired term ending December 31, 2024. There are three new applicants: Earnest Christian Sr., David Gregors and Julian Marcus. There is one vacancy.

<u>Retirement Fund Committee</u> – There is one appointment with a four-year unexpired term ending December 31, 2026, the position must be a citizen appointee. There is one new applicant: Rhonda Stewart. The Commission Chairman makes all appointments.

Commissioner Johnson said that he enjoyed the recent retreat with his colleagues and suggested building a partnership with Turner Job Corps for internship opportunities. Mr. McCoy shared that there are existing partnerships within the Public Works and Solid Waste departments that have been active in allowing students to work. Commissioner Gray thanked the staff and the host for the retreat dinner. He wants to take action on input and collaborations that were shared. Upon question of Commissioner Gaines, it was announced that the facilitator will have the outlined goals to the Commission no later than 30 days [from the event]. Commissioner Jones echoed similar thoughts from the retreat. Commissioner Edwards wanted information relative to whether the bid for lawn services will be a sole contractor or multiple. Mr. McCoy shared the Board approved funding to contract services for private vendors to keep up with the

maintenance of the parks. In addition, park space has expanded which increased the workload and the need for more assistance. Chairman Heard thanked Page and Scrantom for hosting dinner in Columbus and congratulated Commissioner Jones on being appointed as the Chairman of the Southwest Georgia Regional Commission.

There being no further business to discuss the Commission the meeting adjourned at 10:54 a.m.
