 - **a. Staff Report** Keenan Smith presented the staff report which is on file. Staff recommends approval of a COA with the following conditions of approval:
 - 1) Approval in Concept: Architectural Design Development and Construction Documents shall be reviewed by the Historic Preservation Commission for consistency with this COA prior to issuance of Building Permits.
 - 2) Staff Review and Assistance: Staff review, and assistance is recommended to provide support as needed during discovery process and building rehab, to review found conditions and make supportive recommendations which are consistent with the City's Historic Preservation Program, goals, and Implementation Manual.
 - **b. Public Hearing** No one spoke during the Public Hearing.
 - **c.** Certificate of Appropriateness A motion was made by Commissioner Bobel to approve consideration by City Council for a Certificate of Appropriateness for the Stephenson Building, located at 101 Old Fitzhugh Road, Dripping Springs, Texas with the conditions recommended by staff. Commissioner Hunt seconded the motion which carried unanimously 6 to 0.

Chair Erickson took items #3 and #4 out of sequence. Item #4 was taken first.
