Laura Mueller presented the staff report which is on file. Staff recommends the Board establish a committee and appoint no more than three (3) TIRZ Board members.

A motion was made by Board Member Smith to establish a subcommittee to review priority projects, new projects, and new or expanded areas of the Tax Increment Reinvestment Zones, and to appoint Vice Chair Manassian, and Board Members Smith and Fischer to the subcommittee. Vice Chair Manassian seconded the motion which carried unanimously 6 to 0.

### 4. Discuss and consider possible staff direction regarding expiring terms for members of the TIRZ No. 1 & No. 2 Board.

Andrea Cunningham presented the staff report which is on file.

The Board directed staff to advertise for the seat on the city's website and on social media platforms if applicable and deemed appropriate by the Communications & Marketing Director.




