Architecture & Engineering

- a. Facilities Master Plan Curtis reported:
 - Scoping of the Master Plan has been completed. Septic system evaluation has been added to the scope. Negotiations can now begin.
 - Regarding electrification, the energy consultant visited the Middletown property in December; upgrades will be necessary to fully charge the buses.

Right of Way Aquistion

- a. Shoreline Facility –Curtis reported that the seller has been elusive so he has contacted the developer of the property and his awaiting his repsonse. Curtis has met with the Town of Westbrook to review the wetlands situation; wetlands reidentification has been added to the scope.
- *b. Middletown Terminal Renovation* Comerford reported that CTDOT has requested an evaluation of the property adjacent to the terminal to present to the new Bureau Chief who takes office in January 2023.
- *c. Environmental Study* Phase II which includes additional testing on the N. Main Street property has been funded and is now underway.

Curtis answered questions from committee members.
