III. INTRODUCTION OF GUESTS

Board President Hooey welcomed the City of Rancho Cordova and City of Folsom Councils.

Board President Hooey shared a brief historical summary for the purpose of the special joint meeting tonight that is a follow-up from the June 8, 2023, Special Joint Meeting, to review and discuss information provided on the Feasibility Study Report and District Re-Organization, no action will be taken at this meeting.

Board President Hooey welcomed opening remarks by Mayor Sander, City of Rancho Cordova Council, and Vice Mayor Aquino, City of Folsom Council. Mayor Sander and Vice Mayor Aquino, shared opening remarks.

IV. DISCUSSION

a. Review of District Re-Organization and Feasibility Study Report

Superintendent Koligian introduced this item and shared it represented a request by the two city councils, City of Folsom, City of Rancho Cordova; and Folsom Cordova USD Board of Trustees, at the June 8, 2023, Special Joint Board Meeting, to move forward with a reorganization feasibility study report. The District hired School Services of California (SSCAL) to complete this study. She introduced Sean Martin, Assistant Superintendent of Business Services, to introduce consultants from SSCAL.

Mr. Martin introduced Brianna García, Vice President; and Matt Phillips, CPA, Director, Management Consulting Services from SSCAL, to present this item. He shared the intent for tonight's meeting was to review the analysis report based on current data of the nine statutory criteria governing reorganizations, required by the California Department of Education (CDE).

Ms. García shared the report is only a feasibility study, hired by the District to do a feasibility study of the potential of splitting the District into two unified school districts. She shared a summary of the steps to begin a formal process of reorganization if chosen. The report presented tonight is information as to the nine criteria that would be reviewed by both the Sacramento County Office of Education (SCOE) and the State Board of Education (SBE) with regard to a potential reorganization.

Ms. García and Mr. Phillips provided a summary of the purpose of the review, the nine statutory criteria and study conclusions of criteria being substantially met or not substantially met; and results of previous studies over the past 23 years.

Nine Statutory Criteria Study's Conclusions that were substantially met or not substantially met:

Substantially Met

1. Adequate Number of Pupils
2. Community Identity
3. Equitable Division of Property and Facilities
5. No Substantial Increase in State Costs
7. No Substantial Increase in School Facilities Costs
8. Increased Property Values

Not Substantially Met

4. Discrimination/Segregation
6. Sound Educational Program
9. Effect on Fiscal Status and Management

Results from Previous Studies:

- March 2000 Study - Study found that criterion 9 was not met
- June 2001 Study - No conclusion reached regarding criterion 9
- November 2002 Findings - SCC found that criteria 4, 5, 6, and 9 were not met
- July 2004 Study - Study found that criteria 4, 6, and 9 were not met

Ms. García, Mr. Phillips, and Mr. Martin, answered Trustee questions.

FCUSD Trustees, City Council Members from the City of Folsom and Rancho Cordova, shared their thoughts on the Reorganization Feasibility Study presented by SSCAL.

- Report - list of schools for Rancho Cordova USD was re-sorted in Figures 28 and 29 (pages 40/41) so that the counts matched the appropriate corresponding schools; and the Teacher Assignment Monitoring rates for both Rancho Cordova USD and the Alternative Programs were corrected in Figure 30 (page 43) and the corresponding text just above the figure.
