



RECOMMENDATION / CITY COUNCIL ACTION

The Public Works Department recommends that the City Council pass and adopt Resolution No. 10779 - A Resolution Authorizing the City Manager to Execute a Construction Agreement with Graham Contractors, Inc. for the Crack Fill Project FY 2021-22.

BACKGROUND / ISSUE

As part of the City of Folsom Pavement Management Program, the Public Works Department budget includes funding for the repair, resurfacing, and maintenance of various roadways in the City.

This project will fill cracks in the pavement surface of various roadways, as identified in the list below. All work will occur during daytime hours, except for East Bidwell Street, which due to traffic volumes will be performed as night work. Crack Filling is a crucial pavement maintenance procedure that prevents intrusion of water into the pavement structural section; the procedure will deter additional pavement distresses from occurring.

Locations to Receive Crack Filling:

- East Bidwell Street (Iron Point Road to Power Center Drive) NIGHT WORK
- Iron Point Road (Prairie City Road to Oak Avenue Parkway)
- Iron Point Road (Folsom Boulevard to Ingersoll Way)
- Glenn Drive (Folsom Boulevard to Sibley Street)

- American River Canyon Drive (Greenback Lane to Oak Avenue Parkway)
- Oak Avenue Parkway (American River Canyon Drive to Baldwin Dam Road)
- Orangevale Avenue (American River Canyon Drive to City Limits)

Estimating the quantity of crack fill material required for each roadway is difficult due to the various crack widths, depths, and lengths. This project has the option to add additional roadways should the estimated project quantity of crack fill material not be fully utilized on the identified roadways.

Prior to the start of construction, all property owners and businesses on the affected streets will be notified of the proposed work and schedule. This project is expected to begin in April 2022 and be completed by the end of May 2022.

POLICY / RULE

Section 2.36.080 of the <u>Folsom Municipal Code</u> states, in part, that contracts for supplies, equipment, services, and construction with an estimated value of \$66,141 or greater shall be awarded by the City Council.

ANALYSIS

Public Works staff prepared the bid package, and the project was publicly advertised on January 2, 2022. On January 26, 2022, the Public Works Department received the following bids:

1. Graham Contractors, Inc.	\$ 219,500
2. Pavement Coatings Co.	\$ 229,775
3. Pavement Rehab Company	\$ 242,000

The Engineer's Estimate for this project was \$150,000. Staff estimated the project utilizing bid prices from similar work that occurred in 2021. The cost of goods and services, particularly oil prices, has dramatically increased since that time, resulting in higher-than-expected bid prices. The Public Works Department has found the bids to be in order and recommends that the contract be awarded to the low bidder; Graham Contractors, Inc. Staff will use the City's standard agreement in a form acceptable to the City Attorney.

FINANCIAL IMPACT

The contract with Graham Contractors Inc. would be authorized for \$219,500 with the project budgeted for a total of \$241,450, which includes a ten percent contingency amount of \$21,950 for potential change orders.

Funds in the amount of \$241,450 are budgeted and available in the Street Overlay/Pavement Management Project, Project No. 8017, utilizing Measure A funds for Fiscal Year 2021-22.

ENVIRONMENTAL REVIEW



RECOMMENDATION / CITY COUNCIL ACTION

The Public Works Department recommends that the City Council pass and adopt Resolution No. 10808 - A Resolution Authorizing the City Manager to Execute a Design and Consulting Services Contract with Kimley-Horn and Associates, Inc. for the Blue Ravine Road Pavement Condition Investigation and Rehabilitation Analysis.

BACKGROUND/ISSUE

The Public Works Department manages the City of Folsom's Pavement Management Program, which includes funding for the inspection, condition analysis, repair, resurfacing and maintenance of roadways in the City.

This project will analyze the pavement on Blue Ravine Road between Prairie City Road and Oak Avenue Parkway. The Pavement Condition Index (PCI) is a numerical index between 0 and 100 which is used to indicate the general condition of a pavement section, with 0 representing the worst possible condition and 100 representing the best possible condition. On this section of roadway, the PCI ranges between 34 and 85, with most of the pavement in the 40 to 60 range, which equates to fair and poor conditions.

The pavement analysis will consist of a visual inspection, various locations of pavement cores to determine asphalt/subbase thickness, materials testing for asphalt composition and the use of a Falling Weight Deflectometer (FWD) to determine actual pavement strength. Utilizing this data, Kimley-Horn and Associates, Inc. (Kimley Horn) will provide a rehabilitation

recommendation report and will work with City staff to develop project Plans, Specifications and Estimate for a Summer 2022 Pavement Rehabilitation Project. The award for a construction contract will be presented to City Council at that time.

POLICY / RULE

Section 2.36.080 of the <u>Folsom Municipal Code</u> states, in part, that contracts for supplies, equipment, services, and construction with an estimated value of \$66,141 or greater shall be awarded by the City Council.

ANALYSIS

A Request for Proposals to provide Professional Engineering Services was publicly advertised on December 2, 2021. On January 12, 2022, five proposals were received from the following firms: Kimley Horn, REY Engineers, Geocon, NCE and Crawford & Associates.

The proposal review panel consisted of three Public Works staff members. Each panel member individually reviewed and scored the proposals as described in the Proposal Evaluation/Consultant Selection section of the RFP. Each panel member was given a scoring matrix, with the results of those reviews shown below:

Although all firms are qualified to perform this type of work, Kimley Horn was ultimately chosen due to their outstanding project team, which consists of Geocon, Quality Engineering Solutions and Unico Engineering. Geocon will perform pavement coring and materials testing, Quality Engineering Solutions will perform the FWD Non-Destructive Testing and Unico Engineering will perform any needed project surveying. Kimley Horn has recent experience with Cold In-Place Recycling as a pavement rehabilitation method, which this project may likely be a candidate for.

FINANCIAL IMPACT

The City Council's approval of Resolution No. 10794 would authorize the execution of a Design and Consulting Services Contract with Kimley Horn for a total, not-to-exceed contract amount of \$126,322.

Funds for this contract are budgeted and available in the Street Overlay/Pavement Management Project, Project No. 8017, utilizing Measure A and Road Maintenance and Repair funds.



RECOMMENDATION / CITY COUNCIL ACTION

The Public Works Department recommends that the City Council pass and adopt Resolution No. 10800 – A Resolution Authorizing the City Manager to Execute Construction Change Order No. 1 with Sierra National Construction, Inc. for the Duchow Way at Rumsey Way Intersection Drainage Improvement Project and Appropriation of Funds.

BACKGROUND / ISSUE

In December 2021, City Council approved a contract with Sierra National Construction, Inc. (Contract No. 174-21 21-083) to perform the Duchow Way at Rumsey Way Intersection Drainage Improvement Project. The work was completed in January 2022, with additional items of work not identified in the original scope, including the following:

- 1. Additional removal and replacement of curb and gutter at all new drain inlets To account for curb and gutter transitions from the existing gutter width to the wider gutter width at the new inlets, and to address areas of cracked and failing curb and gutter in the vicinity of the new inlets, additional removal and replacement of curb and gutter was determined to be warranted. An additional cost of \$5,300.
- 2. Abandon and plug existing utilities Several unmarked, previously unknown existing utilities were found during construction. These lines included old drainage, sewer and water pipes that were no longer active, and were therefore abandoned in place and

- plugged as appropriate. An additional cost of \$1,500.
- 3. Add one new ADA ramp with sidewalk transitions In part due to the expanded curb and gutter removal, it was determined that adding an ADA ramp with sidewalk transitions to the only corner of the intersection with sidewalk would be a cost-effective benefit to the public. An additional cost of \$7,500.
- 4. Additional trench restoration As construction progressed and additional utilities were encountered, trench excavations were expanded as necessary to complete the construction. Additional trench restoration was incorporated at the original bid price for that item of work. An additional cost of \$9,200.

Other minor quantity adjustments at bid item prices were necessary based upon actual quantities in the field resulting in the final change order total. The total of all extra work identified in the change order request is \$23,734.

POLICY / RULE

Section 2.36.080, Award of Contracts of the Folsom Municipal Code states, in part, that contracts for supplies, equipment, services and construction with an estimated value of \$66,141 or greater shall be awarded by City Council.

ANALYSIS

The costs for the additional items of work are in line with the existing project unit prices and commonly expected costs for the various items of work being done. City staff has reviewed all project changes and recommends the approval of this project change order. The change order would be in the amount of \$23,734.

FINANCIAL IMPACT

The City Council's authorization of Resolution authorized the execution of the original contract with Sierra National Construction, Inc. for \$99,069, with the project budgeted for a total not to exceed amount of \$108,976, which included a ten percent contingency in the amount of \$9,907 for potential change orders. If approved, this change order request would increase the total contract amount by \$13,827 to \$122,803.

There is \$11,338 budgeted and available in the Local Drainage Improvement Project, Project No. 7010, for FY 21-22, utilizing Measure A Funds (Fund 276). Staff is requesting an additional appropriation in the amount \$2,489 from the Measure A Fund for this project.

ENVIRONMENTAL REVIEW

This project has been deemed categorically exempt from environmental review under the California Environmental Quality Act (CEQA) per Section 15301, Existing Facilities, and Section 15302, Replacement or Reconstruction.



RECOMMENDATION / CITY COUNCIL ACTION

The Public Works Department recommends that the City Council pass and adopt Resolution No. 10801 – A Resolution Adopting the 2021 Sacramento County Multi-Jurisdictional Local Hazard Mitigation Plan Update.

BACKGROUND / ISSUE

The federal Disaster Mitigation Act of 2000 requires communities to develop a local hazard mitigation plan (LHMP) to remain eligible for federal hazard mitigation funding, with updates required every five years. Sacramento County and 28 other jurisdictions, including the City of Folsom, prepared the Plan update to the 2016 Sacramento County Local Hazard Mitigation Plan approved by the Federal Emergency Management Agency (FEMA). Sacramento County Department of Water Resources acted as the lead agency for the Plan, but staff from several City departments participated in various stages of the plan development and review including Public Works, Community Development, Fire, and Environmental and Water Resources. In addition, a consultant, Foster Morrison, LLC, was hired to assist with updating the Plan through a FEMA grant and local cost-sharing from the City and County.

The purpose of the Plan is to guide hazard mitigation planning to protect people and property from the effects of hazard events. Examples of the hazard events covered in the plan include flood, fire, earthquake, climate change, drought, and extreme wind events. The Plan was developed, among other things, to ensure continued eligibility for certain federal grants and disaster assistance.

Hazard mitigation planning is the process through which hazards that threaten communities are identified, likely impacts determined, risk mitigation goals set, and appropriate risk mitigation strategies determined, prioritized, and implemented. The Plan documents the hazard mitigation planning process and identifies relevant hazards and vulnerabilities. The Plan also identifies strategies the County, City, and other participating jurisdictions will use to decrease vulnerability and increase resiliency in the community.

The major goals for this 2021 update of the Plan are as follows:

- 1. Minimize risk and vulnerability of the Sacramento County community to the impacts of natural hazards, including consideration of the exacerbation of natural hazards and unique hazards due to climate change; and protect lives and reduce damages and losses to property, public health, economy, and the environment.
- 2. Provide protection for critical facilities, infrastructure, utilities, and services from hazard impacts, including hardening and other efforts to establish redundancy and reliability, to prevent or minimize loss, and to facilitate recovery.
- 3. Enhance public outreach, education, awareness, and preparedness for all hazards to minimize hazard-related losses and to include effective strategies for reaching underserved communities and vulnerable populations.
- 4. Increase community capabilities and leverage interagency and public-private coordination and resources to mitigate losses and to be prepared for, respond to, and recover from a disaster event.
- 5. Assure conformance to federal and state hazard mitigation initiatives and maximize the potential for mitigation implementation.

The California Office of Emergency Services and FEMA, Region IX officials have reviewed the Sacramento County Local Hazard Mitigation Plan and approved it contingent upon this official adoption of the participating governing body. This is a county-wide plan and each of the 28 participating jurisdictions are also adopting the Plan.

A copy of the Plan's Executive Summary is attached. The complete Plan is available at https://waterresources.saccounty.net/stormready/Pages/2021-Local-Hazard-Mitigation-Plan.aspx

POLICY / RULE

The adoption of the Plan by all participating agencies governing bodies is required prior to final approval by FEMA.

ANALYSIS

The Plan is consistent with the City of Folsom's 2035 General Plan's Emergency Preparedness goal to promote public safety through planning, preparedness, and emergency response to natural and human-made disasters.

The adoption of the Plan is necessary to be eligible to receive FEMA Hazard Mitigation Grants.

FINANCIAL IMPACT

There is no direct fiscal impact from approval of this plan; however, if pursued, several of the mitigation measures may need future funding. Maintaining an approved LHMP allows participating jurisdictions to apply for various state and federal grant funding programs.

ENVIRONMENTAL REVIEW

The proposed activity to adopt the Plan update is not a project pursuant to the California Environmental Quality Act (CEQA). The activity is a continuing administrative activity, such as policy and procedure making that would not result in a direct or indirect effect on the environment and is not subject to CEQA.

Executive Summary

This 2021 Local Hazard Mitigation Plan (LHMP) Update serves to update the 2016 Federal Emergency Management Agency (FEMA) approved Sacramento County LHMP. The purpose of hazard mitigation is to reduce or eliminate long-term risk to people and property from hazards. Sacramento County, 7 incorporated communities, and 24 special districts prepared this LHMP Update to the FEMA approved 2016 Sacramento County LHMP, in order to make the County and its residents less vulnerable to future hazard events.

This LHMP Update demonstrates the community's commitment to reducing risks from hazards and serves as a tool to help decision makers direct mitigation activities and resources. This LHMP Update was also developed, among other things, to ensure Sacramento County and participating jurisdictions' continued eligibility for certain federal disaster assistance: specifically, the FEMA Hazard Mitigation Grant Program (HMGP), Pre-Disaster Mitigation Program (PDM), and the Flood Mitigation Assistance Program (FMA).

Each year in the United States, natural disasters take the lives of hundreds of people and injure thousands more. Nationwide, taxpayers pay billions of dollars annually to help communities, organizations, businesses, and individuals recover from disasters. These monies only partially reflect the true cost of disasters, because additional expenses to insurance companies and nongovernmental organizations are not reimbursed by tax dollars. Many natural disasters are predictable, and much of the damage caused by these events can be alleviated or even eliminated. The purpose of hazard mitigation is to reduce or eliminate long-term risk to people and property from hazards.

LHMP Plan Development Process

Hazard mitigation planning is the process through which hazards that threaten communities are identified, likely impacts determined, mitigation goals set, and appropriate mitigation strategies determined, prioritized, and implemented. This LHMP Update documents the hazard mitigation planning process and identifies relevant hazards and vulnerabilities and strategies the County will use to decrease vulnerability and increase resiliency and sustainability in the community.

The County and all participating jurisdictions followed a planning process prescribed by FEMA as detailed in Table ES-1.

The planning process began with the organizational phase to establish the Hazard Mitigation Planning Committee (HMPC) comprised of key County representatives, and other local and regional stakeholders; to involve the public; and to coordinate with other departments and agencies. A detailed risk assessment was then conducted followed by the development of a focused mitigation strategy by all participating jurisdictions or the Sacramento County Planning Area. Once approved by Cal OES and FEMA, this LHMP Update will be adopted and implemented by the County and all participating jurisdictions over the next five years.

Risk Assessment

The HMPC conducted a risk assessment that identified and profiled hazards that pose a risk to the County and participating jurisdictions, assessed the vulnerability of the Sacramento County Planning Area to these hazards, and examined the existing capabilities to mitigate them.

The Sacramento County Planning Area is vulnerable to numerous hazards that are identified, profiled, and analyzed in this Plan. Floods, earthquakes, drought, levee failures, landslides, wildfires, and other severe weather events are among the hazards that can have a significant impact on the County. Table ES-2 details the hazards identified for this Sacramento County LHMP Update.

Mitigation Strategy

Based on the results of the risk assessment, the participating jurisdictions and the HMPC developed a mitigation strategy for reducing the County's and all participating jurisdictions' risk and vulnerability to hazards. The resulting Mitigation Strategy for the Sacramento County Planning Area is comprised of LHMP goals and objectives and a mitigation action plan which includes a series of mitigation action projects and implementation measures. Based on the risk assessment, the HMPC identified goals and objectives for reducing the Sacramento County Planning Area's vulnerability to hazards. The goals and objectives of this multi-hazard mitigation plan are:

GOAL 1: Minimize risk and vulnerability of the Sacramento County community to the impacts of natural hazards, including consideration of the exacerbation of natural hazards and unique hazards due to climate change; and protect lives and reduce damages and losses to property, public health, economy, and the environment.

Goal 2: Provide protection for critical facilities, infrastructure, utilities, and services from hazard impacts, to include hardening and other efforts to establish redundancy and reliability, to prevent or minimize loss, and to facilitate recovery.

GOAL 3: Enhance public outreach, education, awareness, and preparedness for all hazards to minimize hazard related losses and to include effective strategies for reaching underserved communities and vulnerable populations.

GOAL 4: Increase community capabilities and leverage interagency and public-private coordination and resources to mitigate losses and to be prepared for, respond to, and recover from a disaster event.

GOAL 5: Assure conformance to federal and state hazard mitigation initiatives and maximize potential for mitigation implementation.



RECOMMENDATION / CITY COUNCIL ACTION

The Public Works Department recommends that the City Council pass and adopt Resolution No. 10802 - A Resolution Authorizing the City Manager to Execute a Construction Agreement with Sierra Traffic Markings, Inc. for the Pavement Striping Project FY 2021-22

BACKGROUND / ISSUE

The Public Works Department has an annual program to upgrade existing street striping and pavement markings, as well as to install new striping and markings. This program ensures that roadway striping has adequate reflectivity and brightness to maintain safe driving and pedestrian conditions. City staff conducted night-time striping inspections to determine which roadways would most benefit from new striping.

The roadway locations scheduled for long line striping improvements are as follows:

- Wales Drive (Natoma Street to East Bidwell Street)
- Sibley Street (Glenn Drive to Bidwell Street)
- Natoma Station Drive (Blue Ravine Road to Plaza Drive)
- Iron Point Road (Folsom Boulevard to Ingersoll Way)
- Iron Point Road (Empire Ranch Road to Dry Creek Road)

In addition to the long line striping locations listed above, there are various locations where

crosswalks, stop limit lines and miscellaneous markings will be upgraded. In all, the project will enhance over 2,400 linear feet of crosswalks, many near elementary schools, 400 linear feet of stop limit lines, and 1,600 square feet of miscellaneous markings such as stop, stop ahead, arrows and bike lane markings.

This project is expected to begin in April 2022 and be completed by the end of May 2022.

POLICY / RULE

Section 2.36.080 of the <u>Folsom Municipal Code</u> states, in part, that contracts for supplies, equipment, services, and construction with an estimated value of \$66,141 or greater shall be awarded by the City Council.

ANALYSIS

Public Works staff prepared the bid package, and the project was publicly advertised on January 7, 2022. On January 28, 2022, the Public Works Department received the following bids:

1. Sierra Traffic Markings, Inc.	\$ 107,120.75
2. Central Striping Service	\$ 134,946.10
3. Centerline Striping Co. Inc.	\$ 136,581.00
4. Chrisp Company	\$ 169,973.50

The Engineer's Estimate for this project was \$150,000. Staff estimated the project utilizing bid prices from similar work that occurred in 2021. The Public Works Department has found the bids to be in order and recommends that the contract be awarded to the low bidder; Sierra Traffic Markings, Inc. Staff will use the City's standard agreement in a form acceptable to the City Attorney.

FINANCIAL IMPACT

The contract with Sierra Traffic Markings, Inc. would be authorized for \$107,121 with the project budgeted for a total of \$117,833, which includes a ten percent contingency amount of \$10,712 for potential change orders.

Funds in the amount of \$39,915 are budgeted and available in the Street Striping Project No. 8016, and \$77,918 is budgeted and available in the Street Overlay/Pavement Management Project No. 8017, both of which utilize Measure A funds, for Fiscal Year 2021-22.

ENVIRONMENTAL REVIEW

This project has been deemed categorically exempt from environmental review due to the following exemption: Class 1: Existing Facilities (c) Existing Street Maintenance.

RECOMMENDATION / CITY COUNCIL ACTION

Staff recommends approval of Resolution No. 10803 - A Resolution Authorizing the City Manager to Execute Amendment No. 3 to the Operation and Maintenance Agreement with the Murer House Foundation

BACKGROUND / ISSUE

In 1997 the City assumed ownership of the 3 parcels (APN 070-0091-007; 070-0091-008; and 070-0090-012) that constitute the Murer House properties located at 1121 Joe Murer Court; 1125 Joe Murer Court; and 1127 Joe Murer Court, respectively. These properties were previously owned by the Baker Family Trust.

On November 18, 1997, a Purchase and Sale Agreement was recorded between the City and the Baker Family Trust, outlining the terms and conditions of a 40-year agreement that will expire in 2037. This Agreement focused on the purchase and sale details but also included some parameters of how the property would be managed and maintained. One key requirement of the Purchase and Sale Agreement is that the City must maintain the house on the property and the grounds as an historic site and make the property open to the general public until 2037.

The Murer House Foundation (MHF) is a California nonprofit 501(c)(3) that is comprised of citizen volunteers who have made a commitment to assist the City in preserving the site as a historic site open to the general public.

To define the maintenance and management responsibilities between the City and the MHF, a Memorandum of Understanding (MOU) was created in 2003, then a new agreement was created in 2013 which expired in 2016, and then the most recent agreement was created in 2016, which has had two recent amendments (No. 1 and 2) to allow time for discussions with the MHF. The current agreement expires March 31, 2022.

In 2021, the MHF reached out to the City to discuss the Foundation's future plans for enhancing their core operation of protecting and preserving the Giuseppe Murer House and grounds along with promoting public awareness of Folsom's Italian History. A Business Plan (2021-2024) was provided to the City outlining MHF's concepts for raising funds to make improvements and advance the goals of preserving the cultural heritage of the site through programming, gardening, and historical events.

POLICY / RULE

Pursuant to Folsom Municipal Code section 2.36.270, the disposition of real property interests in city property shall be approved by the City Council. A city may lease property owned, held, or controlled by it for a period not to exceed 55 years. Government Code Section 37380.

ANALYSIS

In 2021, the MHF reached out to the City to discuss the Foundation's future plans for enhancing their core principles of protecting and preserving the Giuseppe Murer House and grounds along with promoting public awareness of Folsom's Italian History. A Business Plan (2021-2024) was provided to the City outlining concepts for raising funds to make improvements and advance the goals of preserving the cultural heritage of the site through programming, gardening, and historical events.

The MHF's long-range plan is to improve the Learning Center building. Details of the proposed improvement have not been worked out but could include demolition and reconstruction, significant renovation, or other remodeling of buildings on the site. Any proposed plans to modify any buildings on the site would have to go through the city's standard development application process and reviews.

In order for the Foundation to attract interested investors to participate in the future fund raising efforts, they have asked the City for an agreement that would be in place for 40 years (bringing it to year 2062) with an automatic extension of 15 years (bringing it to year 2077). This total length of the term would therefore be 55 years, which is within the City Council's approval authority.

Language would be added to the agreement that would only allow termination of the agreement by the city for good cause, if MHF moves forward with renovations. Otherwise, no significant changes are proposed to the City's and MHF's existing roles and responsibilities for maintenance and operation of the Site.

FINANCIAL IMPACT

This amendment to the existing agreement does not have a financial impact.

ENVIRONMENTAL REVIEW

This amendment to the agreement is not subject to CEQA. Any future proposal to improve the Learning Center Building or otherwise renovate the property would be subject to CEQA.

RECOMMENDATION / CITY COUNCIL ACTION

Staff recommends the City Council approve Resolution No. 10805 - A Resolution Authorizing the City Manager to Execute an Agreement with Capra Environmental Services Corp for Managed Grazing Services Within the City of Folsom.

BACKGROUND / ISSUE

Over the past 5 years the City of Folsom's Parks and Recreation Department has been incorporating goat grazing as part of our annual weed abatement program. This year we are expanding the areas where goats will be used and will have them grazing property that has been historically controlled with mechanical removal (crews with weed eaters). In having these areas grazed as opposed to traditional methods the City saves on labor and fuel costs that are at an all-time high. Beyond the cost savings, grazing produces a better end-product by completely removing combustible materials rather than just cutting the weeds and leaving it in place.

POLICY / RULE

In accordance with Chapter 2.36.090 (A)(1) and 2.36.120 of the Folsom Municipal Code, professional services are not subject to competitive sealed bidding requirements, and those costing \$66,141 or greater shall be awarded by City Council.

ANALYSIS

On December 20, 2021, the Parks and Recreation Department advertised a Request for Proposal for managed grazing services. The RFP was posted on CIPList.com as well as the City of Folsom website with responses due back to the City by 4:00 pm January 28, 2022. An internal review team was assembled of Parks and Recreation Staff. The criteria for ranking the qualifications were based on the following areas: relevant experience and staff resources, project understanding, and ability to complete work in allocated time frame. In total three responses were received (Capra, Intergrazers, and Blue Tent Farms LLC) and after reviewing their responses, and compiling scores, staff concluded that Capra Environmental Services Corp demonstrated they were the most qualified based on their ability to complete the scope of work in the allotted timeframe and expertise.

FINANCIAL IMPACT

The cost of this contract will be funded through several different funding sources shown in the table below. Funds were budgeted and are currently available in the Fiscal Year 2021-22 budget. The initial term of the contract will be one year and funding for subsequent years beyond Fiscal Year 2021-22 will be addressed in each year's budget process. The Fiscal Year 2021-22 contract amount is estimated to be approximately \$200,000.



Staff recommends the City Council approve Resolution No. 10806 - A Resolution Authorizing the City Manager to Execute Amendment No. 1 to the Agreement with Terracare Associates LLC for the Maintenance of Parks, Trails and Pet Stations, Streetscapes/Public Works areas, Landscaping and Lighting Districts, and Folsom Plan Area for the City of Folsom.

BACKGROUND / ISSUE

In September of 2018, the City advertised multiple landscape maintenance contracts for City Parks, Trails and Pet Stations, Streetscapes, Public Works Areas, Landscaping and Lighting Districts, and the Folsom Plan Area on the City of Folsom Website and CIPList.com. The overall process consisted of the following steps:

RFQs/RFPs available on September 26, 2018
Advertised on September 26, 2018
Mandatory Pre-meeting on October 9, 2018
RFQs/RFPs due to City on October 26, 2018
Internal Evaluation of RFQ's/questionnaire on Friday/Tuesday October 26-30, 2018
Announcement of qualified contractor on October 31, 2018
Interview of qualified contractor on November 9, 2018

Opening of qualified cost proposals on November 9, 2018

Reference Checks – November 12-16,2018

The City received responses from three contractors (Terracare, Environmental Landscape Solutions, BrightView), evaluated each contractors' submitted qualifications, and ranked them accordingly based on their qualifications and responsiveness to the request. Based on Terracare's qualifications, they were the preferred contractor being recommended. At the December 10, 2019 City Council Meeting, Resolution No. 10365 A Resolution Authorizing the City Manager to Execute an Agreement with Terracare Associates for Maintenance of Parks, Trails and Pet Stations, Streetscape/Public Works Areas, Landscaping and Lighting Districts, and Folsom Plan Area Landscapes for the City of Folsom was approved. The City entered into an agreement with Terracare Associates LLC for landscape maintenance services effective January 1, 2020. This agreement allowed for two 1-year extensions based on satisfactory performance. This amendment is utilizing the first of the two aforementioned extensions. Beyond extending the length of the contract, we have also included new maintenance areas in the Folsom Plan Area (FPA). This includes public landscaping in Mangini Ranch, Russell Ranch, and White Rock Springs Ranch.

POLICY / RULE

In accordance with Chapter 2.36.090 (A)(1) and 2.36.120 of the Folsom Municipal Code, professional services are not subject to competitive sealed bidding requirements, and those costing \$66,141 or greater shall be awarded by City Council.

ANALYSIS

Over the last 2 years Terracare has provided satisfactory landscape maintenance. As such, we plan to move forward with a full year extension for three of the five contracts including Parks, Trails and Pet Stations, and Streetscapes/Public Works areas. For the two Landscaping and Lighting and Folsom Plan Area contracts we plan to extend the contracts for only 6-months (rather than a full year extension) due to the need to revise the specifications and scopes as well as stagger the agreement timelines. As such, staff intends to readvertise for these maintenance contracts in the next several months with an intended start of the new contract being July 1, 2022. The additional 6 month cost for the plan area is \$13,662.09 per month for a total over the 6 months of \$81,972.54.

In summary, this proposed Amendment will extend the contracts by one year for the Parks, Trails and Pet Stations, and Streetscapes/Public Works Areas and 6 months for the Landscaping and Lighting Areas and the Folsom Plan Area.

FINANCIAL IMPACT

Adequate funding is currently available in the remainder of Fiscal Year 2021-22 in the General Fund (Fund 010) within the Parks and Recreation Municipal Landscape Services Division, and the Public Works Streets Division for the contract maintenance of the Parks, Trails/Pet Stations, and Public Works Areas. Funds are also available in Fiscal Year 2021-22 in the Landscaping and Lighting and Community Facilities Districts impacted by these contracts. Funding for the continuation of this contract will be addressed through the Fiscal Year 2022-

23 budget process and subsequent Fiscal Years if we choose to use the remaining 1-year extension.



BACKGROUND / ISSUE

On May 25, 2021, The City Council appropriated \$82,000 for the purchase of two trucks for the Parks and Recreation Department in the General Fund.

Staff received three bids for the trucks with the lowest bid received at \$41,770.29 per truck from Downtown Ford Sales.

City Council authorized the City Manager to execute an agreement with Downtown Ford Sales for the purchase of two Ford trucks on December 14, 2021, and a purchase order was completed and submitted to Downtown Ford Sales in January of 2022. Downtown Ford Sales responded saying that they could no longer honor our purchase order as Ford had unexpectedly cutoff orders for the 2022 F150 on December 18, 2021.

POLICY / RULE

Section 2.36.120 of the Folsom Municipal Code states, in part, that contracts for supplies, equipment, services and construction with an estimated value of \$62,657 or greater shall be awarded by the City Council.

ANALYSIS

Staff was informed that while Ford was no longer taking orders for the Ford F150, they were taking orders for the Ford F150 Lightning Pro, an electric vehicle. Three quotes for trucks were obtained and the lowest bid of \$42,026.94 was received from Folsom Lake Ford.

The electric version of this vehicle will provide the same level of service while also saving on fuel costs and reducing the carbon footprint.

FINANCIAL IMPACT

A total of \$82,000 was appropriated in the Fiscal Year 2021-22 Operating Budget for the purchase of two trucks for the Parks and Recreation Department. The Lighting and Landscape Services division had \$40,000 appropriated and can absorb the additional \$2,027 for one vehicle. The Park Maintenance division had \$42,000 appropriated for one vehicle in the General Fund (Fund 010) in Fleet Management and can also absorb the additional \$27. The total purchase price of the two vehicles will be \$84,053.88.

There are sufficient funds available in the Fiscal Year 2021-22 General Fund (Fund 010) Operating Budget for the purchase of two vehicles.



Licensee desires to utilize a 14 foot 1 inch by 18 foot 1 inch portion of Licensor's Real Property with any necessary easements over other portions of Licensor's Real Property and/or shared use of Licensor's easements over other real property necessary for Licensee's access and utilities to the licensed area (altogether the "Premises"), as described on Exhibit "B" attached hereto. Licensor represents and warrants that it has full rights of ingress to and egress from the Premises from a public roadway.
- B. Licensee is a communications carrier that desires to construct and operate a wireless communications site at the Premises as part of its communications network.
- C. Licensor is willing to License the Premises to Licensee for Licensee's proposed use subject to the terms and conditions of this License Agreement.

WHEREFORE, the parties hereto agree as follows:

- 1. Grant of License. Licensor hereby licenses to Licensee the Premises for Licensee's proposed use, subject to the following terms and conditions.
- 2. Permitted Uses. The Premises may be used by Licensee for the operation of a wireless communications site. Under this Licensee Agreement, Licensee may install, place, use, operate, repair, and maintain on the Premises such antennas, radio transmitting and receiving equipment, conduits, wires, batteries, back-up generators, utility lines and facilities, supporting structures, storage facilities, and related equipment as described in Exhibit B for the operation of its wireless communications site at the Premises (collectively "Licensee's Facilities"). Further, Licensee has the right to do all work necessary to prepare, modify and maintain the Premises to accommodate Licensee's Facilities and as required for Licensee's communications operations at the Premises. Once Licensee's Facilities are installed, Licensee shall be required to obtain Licensor's prior written consent to further improvements or installation of additional equipment at the Premises, except that Licensee shall be permitted, without Licensor's consent, to make enhancements, replacements, upgrades or substitutions of equipment and antennas which substantially conform to the physical specifications of the previously installed equipment

- 3. Conditions Precedent: Prior Approvals. This License Agreement is conditioned upon Licensee obtaining, prior to any construction, alteration or use, all governmental licenses, permits and approvals enabling Licensee to construct and operate wireless communications facilities on the Premises. Licensor agrees to cooperate with Licensee's reasonable requests for Licensor's signatures as real property owner on permit applications, for allowing site inspections by governmental agencies required in connection with reviewing permit applications, and for assistance in obtaining such necessary approvals, provided that such cooperation and assistance shall be at no expense to Licensor. Licensee covenants throughout the term of this Agreement, at Licensee's sole cost and expense, to comply with all laws, ordinances, orders, rules, regulations and requirements of all federal, state, county and city governments which may be applicable to Licensee's use of the Premises and Licensee's Facilities.
- 4. Term. The term of this License Agreement shall be five (5) years commencing with the issuance of a local governmental building permit allowing Licensee to construct Licensee's Facilities on the Premises or three (3) months from the date of full execution of this License Agreement, whichever occurs first ("Commencement Date") ("Term"). Licensee shall promptly deliver written notice to Licensor of the Commencement Date. This License Agreement shall automatically be extended for three (3) terms ("Renewal Terms") of five (5) years each for a total of twenty (20) years unless Licensee notifies Licensor in writing of Licensee's intention not to extend this License Agreement at least thirty (30) days prior to the expiration of the initial Term of five (5) years or subsequent renewal Terms.

5. Rent.

- (a) During the term of this Agreement, and in the manner set forth in sub-paragraph (5b) below, Licensee shall pay to Licensor, at the address specified in Paragraph 22, Notices and Deliveries, the sum of One Thousand Dollars (\$1,000.00) per month. Rent shall be payable as indicated in Exhibit "D" attached hereto, in advance to Licensor as specified in sub-paragraph (5b) below.
- (b) Rent shall be Payable in two-year increments with a three percent (3%) annual increase after the first year. The first payment of twenty-four thousand three hundred sixty dollars (\$24,360.00) will consist of \$12,000.00 for year one and \$12,360.00 for year two. Thereafter, rent shall be payable every two (2) years in advance on the anniversary of the Commencement Date as described in Exhibit "D" attached hereto.
- 6. <u>Due Diligence Contingency and Pre-Commencement Date Access to Premises.</u>
 Licensee shall have the right (but not the obligation) at any time following the full execution of this License Agreement and prior to the Commencement Date, to enter the Premises for the purpose of making necessary inspections, taking measurements and conducting engineering surveys (and soil tests where applicable) and other reasonably necessary tests to determine the suitability of the Premises for Licensee's Facilities ("Due Diligence"), and for the purpose of preparing the Premises for the installation or construction of Licensee's Facilities. During any Due Diligence activities or pre-construction work, Licensee shall have and maintain in full force and effect the insurance, set forth in Section16, <u>Insurance</u>. Licensee will notify Licensor, at least 48 hours in advance, of any proposed tests, measurements or pre-construction work and will coordinate the scheduling of such activities with Licensor. If in the course of its Due Diligence Licensee determines that the Premises are unsuitable for Licensee's contemplated use,

- Ongoing Access to Premises. Throughout the Term and any Renewal Term of this License Agreement, Licensee shall have the right of access to the Premises for its employees and agents twenty-four (24) hours a day, seven (7) days per week, at no additional charge to Licensee. In exercising its right of access to the Premises herein, Licensee agrees to cooperate with any reasonable security procedures utilized by Licensor at Licensor's Real Property and further agrees not to unduly disturb or interfere with the business or other activities of Licensor or of other tenants or occupants of Licensor's Real Property. Licensee will be attaching its antennas to an existing tower owned and controlled by Pacific Gas and Electric Company, a California corporation ("PG & E") and located on the Licensor's Property, as shown on Exhibit B hereto ("PG & E's Tower"). PG & E is entitled to place its towers and associated equipment on Licensor's Property pursuant to a right of way and easement agreement (the "PG & E Easement"). Licensor hereby consents to Licensee's use of PG & E's tower and easement area as contemplated in this Agreement; however such consent is contingent upon full compliance with the terms of this Agreement and all necessary governmental licenses, permits and approvals required to construct and operate a wireless communications facility on the Premises.
- Licensee's Work, Maintenance and Repairs. All of Licensee's construction and 8. installation work at the Premises shall be performed at Licensee's sole cost and expense and in a good and workmanlike manner. Licensee shall maintain Licensee's Facilities and the Premises in neat and safe condition and in compliance with all applicable codes and governmental regulations and conditions of approval. Licensee shall not be required to make any repairs to the Premises except for damages to the Premises caused by Licensee, its employees, agents, contractors or subcontractors. Upon the expiration, cancellation or termination of this License Agreement, Licensee shall surrender the Premises in good condition, less ordinary wear and tear; however, Licensee shall not be required to remove, unless specifically requested to by the Licensor, any foundation supports for Licensee's Facilities or conduits, which have been installed by Licensee. Licensee shall not suffer or permit any mechanic's, vendor's, laborer's or materialman's statutory or similar liens (collectively, "Mechanics Liens") to be filed against the Premises or Licensee's Facilities, nor against Licensee's interest in the Premises pursuant to this Agreement, by reason of work, labor, services or materials supplied or claimed to have been supplied to Licensee or anyone holding any interest in the Premises and/or Licensee's Facilities or any part thereof through or under Licensee. If any such mechanic's lien shall be filed, Licensee shall, within thirty (30) days after notice of the filing thereof, cause the same to be discharged of record by payment, deposit, bond, order of a court of competent jurisdiction or otherwise; provided, however, that Licensee shall have the right to contest, with due diligence, the validity or amount of any such lien or claimed lien, if Licensee shall give to Licensor security in an amount equal to one and one-half (1-1/2) times the amount of such lien or claimed lien. Subject to the foregoing provisions, if Licensee shall fail to cause such lien to be discharged within such thirty (30) day period, then, in addition to any other right or remedy of Licensor, Licensor may, but shall not be obligated to, discharge the same either by paying the amount claimed to be due or by procuring the discharge of such lien by deposit or by bonding proceedings. Nothing contained

- Title to Licensee's Facilities. Licensee shall hold title to Licensee's Facilities and any 9. equipment placed on the Premises by Licensee. Licensor acknowledges that Licensee may enter into financing arrangements including promissory notes and financial and security agreements for the financing of Licensee's Facilities (the "Collateral") with a third party financing entity and may in the future enter into additional financing arrangements with other financing entities. In connection therewith, Licensor (i) consents to the installation of the Collateral to the extent that the Collateral is part of the approved Licensee's Facilities; (ii) disclaims any interest in the Collateral, as fixtures or otherwise; and (iii) agrees that the Collateral shall be exempt from execution, foreclosure, sale, levy, attachment, or distress for any Rent due or to become due and that such Collateral may be removed at any time without recourse to legal proceedings.

Subject to Licensor's approval of the location, which approval shall not be unreasonably withheld, Licensee shall have the right to place utilities on (or to bring utilities across) Licensor's Real Property in order to service the Premises and Licensee's Facilities. Upon Licensee's request, Licensor shall execute recordable easement(s) evidencing this right. Licensee shall fully and promptly pay for all utilities furnished to the Premises for the use, operation and maintenance of Licensee's Facilities.
- Interference with Communications. Licensee's Facilities and operations shall not 11. interfere with the communications configurations, frequencies or operating equipment, which exist on Licensor's Real Property on the effective date of this License Agreement ("Pre-existing Communications"), and Licensee's Facilities and operations shall comply with all non-interference rules of the Federal Communications Commission ("FCC"). Upon written notice from Licensor of apparent interference by Licensee with Pre-existing Communications, Licensee shall have the responsibility to promptly terminate such interference or demonstrate to Licensor with competent information that the apparent interference in fact is not caused by Licensee's Facilities or operations. Licensor shall not, nor shall Licensor permit any other tenant or occupant of any portion of Licensor's Real Property to, engage in any activities or operations which interfere with the communications operations of Licensee described in Section 2, above. Licensor will provide Licensee with technical information from the party proposing such installation for review and sign-off by Licensee. Licensor agrees to incorporate equivalent provisions regarding non-interference with Pre-existing Communications into any subsequent leases, licenses or rental agreements with other persons or entities for any portion of Licensor's Real Property.

- 12. <u>Taxes</u>. Licensee shall pay personal property taxes assessed against Licensee's Facilities, and Licensor shall pay when due all real property taxes and all other taxes, fees and assessments attributable to the Premises and this License Agreement.
- Termination. This License Agreement may be terminated without further liability 13. except as set forth herein, on thirty (30) days prior written notice as follows: (i) by either party upon default of any covenant, condition, or term hereof by the other party, which default is not cured within sixty (60) days of receipt of written notice of default; (ii) by Licensee if it does not obtain or maintain, licenses, permits or other approvals necessary to the construction or operation of Licensee's Facilities; (iii) by Licensee if Licensee is unable to occupy or utilize the Premises due to ruling or directive of the FCC or other governmental or regulatory agency, including, but not limited to, a take back of channels or changes in frequencies; or (iv) by Licensee for any reason. Except as set forth herein, upon termination, Licensor shall return to Licensee any prepaid rent. In the event this License Agreement is terminated due to a default by Licensee or Licensee terminates this Agreement pursuant to (ii) or (iv) above, Licensee shall pay Licensor a termination penalty as follows: (a) If such termination occurs during the first five (5) years of the term (years 1-5), there will be a penalty equal to two (2) years of the rent then in effect; (b) If such termination occurs during the second 5-year term (years 6-10), the penalty shall be equal to one (1) year of the rent then in effect; and (c) If such termination occurs during the third or fourth 5-year terms (years 11-20), then no penalty will be imposed.

- portion, which is sufficient to render the Premises unsuitable for Licensee's ongoing operation of a wireless communications site, then this License Agreement shall terminate as of the date when possession is delivered to the condemning authority. In any condemnation preceding each party shall be entitled to make a claim against the condemning authority for just compensation recoverable under applicable condemnation law. Sale of all or part of the Premises to a purchaser with the power of eminent domain in the face of the exercise of its power of eminent domain shall be treated as a taking by a condemning authority.

16. Insurance

- (a.) Licensee shall maintain the following insurance: (1) Commercial General Liability with limits of Five Million Dollars (\$5,000,000.00) per occurrence, (2) Automobile Liability with a combined single limit of One Million Dollars (\$1,000,000.00) per accident, (3) Workers Compensation as required by law, and (4) Employer's Liability with limits of One Million Dollars (\$1,000,000.00) per occurrence.
- (b.) The City and its officers, agents, employees and volunteers shall be named as additional insured with respect to General Liability and Automobile Liability insurance. Licensee shall furnish to Licensor a certificate, or certificates of insurance with original endorsement, with an insurance carrier consistent with the

Subsequent to completion of such construction, and with the prior consent of Licensor, this Agreement and the interest of Licensee under this Agreement may be assigned to any person, firm or corporation, provided that (with the exception of any permitted assignment as described below) to which the following requirements shall not apply): (a) no such assignment shall be effective for any purpose unless and until (i) the assignor's interest in Licensee's facilities shall be transferred to the assignee of this

Notwithstanding anything set forth above to the contrary, Licensee shall have the right, without Licensor's consent, to sublicense or assign its rights under this Agreement to any of its subsidiaries, affiliates or successor legal entities or to any entity acquiring substantially all of the assets of Licensee.

18. Co-location. Licensee shall have the right to permit other communications providers (Additional Providers) to occupy space in any equipment enclosure installed by Licensee on the Premises with Licensor's prior written consent, which consent shall not be unreasonably withheld, provided that any such Additional Provider shall be bound by all the duties and obligations of this License Agreement and that Licensee shall be primarily liable to Licensor for such sSublicensee's performance under this License Agreement (Sublicense). In any such Sublicense, Licensee shall be entitled to charge the Sublicensee rent or fees in order to recover a prorata portion of the expenses which Licensee advanced to develop Licensee's Facilities at the Premises and to provide utilities to the Premises. As a condition precedent to the effectiveness of any Sublicense agreement with any Additional Provider, Licensee agrees that such Additional Provider shall be obligated, prior to installation of their facilities, to enter into a separate license agreement with Licensor.

19. Nondisturbance and Quiet Enjoyment;.

(a) So long as Licensee is not in default under this License Agreement, Licensee shall be entitled to quiet enjoyment of the Premises during the term of this License Agreement or any Renewal Term, and Licensee shall not be disturbed in its occupancy and use of the Premises.

20. Indemnification.

- (a) <u>Licensee's Indemnity</u>. Licensee hereby agrees to indemnify and hold Licensor and Licensor's officers, directors, partners, shareholders, employees, agents, volunteers, contractors or subcontractors harmless from and against any and all losses, claims, liabilities, damages, costs and expenses (including reasonable attorney's fees and costs) and injuries (including personal injuries or death) arising from or in connection with Licensee's use, operation, maintenance or repair of Licensee's Facilities at the Premises or access over Licensor's Real Property or Licensee's shared use of Licensor's easements for access to the Premises.
- (b) <u>Survival of Indemnity Provisions</u>. The indemnity provisions of this section shall survive the cancellation or expiration of this License Agreement.
- 21. Environmental Issues; Historic Preservation; Hazardous Materials. Licensee shall not bring any hazardous materials onto the Premises except for those contained in its back-up power batteries (lead acid batteries) and common materials used in telecommunications operations, such as cleaning solvents. Licensee shall handle any hazardous materials it brings onto the Premises in accordance with all applicable federal, state and local laws and regulations.

The failure of either party to insist in any one or more cases upon the strict performance of any of the covenants of this Agreement or to exercise any option in this Agreement shall not be construed as a waiver or a relinquishment for the future of such covenant or option. A receipt by Licensor of Rent with knowledge of the breach of any covenant of this Agreement shall not be deemed a waiver of such breach, and no waiver either party of any provision of this Agreement shall be deemed to have been made unless expressly in writing and signed by each party.
- (k) This Agreement cannot be changed orally, but only by an agreement in writing signed and acknowledged by Licensee and Licensor.

FROM:	City Attorney's Office

RECOMMENDATION / CITY COUNCIL ACTION

Staff recommends that the City Council continue with the fourth public hearing under Section 10010 of the Elections Code to: (1) receive community input on the two draft "preferred" maps prepared by the City's demographer with input from the City Council and the public on February 15, 2022, (2) select a "preferred" map, (3) continue to discuss election sequencing if necessary, and (4) provide direction for the next public hearing scheduled for March 8, 2022.

BACKGROUND / ISSUE

On July 27, 2021, the City Council adopted a Resolution of Intention to transition from atlarge to by-district elections. The City Council conducted the fourth of five required public hearings on February 8, 2022 and moved to continue the hearing to a special meeting on February 15, 2022 in order for the community to have an opportunity to provide input on the draft "preferred" map prepared by the City's demographer with City Council input on February 8, 2022.

At the Special Meeting on February 15, 2022, the City Council selected 2 draft "preferred maps" prepared by the City's demographer with input from the City Council and the public for final review and selection on February 22, 2022, and voted to further continue Public Hearing No. 4 to February 22, 2022.

POLICY / RULE

California Government Code Section 34886 authorizes the legislative body of a city to adopt an ordinance that requires the members of the legislative body to be elected "by district". The change must be made in furtherance of the purposes of the California Voting Rights Act.

ANALYSIS

1. SUMMARY OF PAST PUBLIC HEARINGS

The process to transition to by-district election requires five public hearings where the community is invited to provide input regarding the composition of future City Council districts. Pursuant to California Elections Code Section 10010, the first two public hearings to inform the public about the districting process (held on September 14 and October 12, 2021) are required before any map of district boundaries for the proposed voting districts can be drawn. The Council reviewed proposed maps at the third public hearing on January 11, 2022 and identified 8 focus maps.

The City Council held the fourth public hearing on February 8, 2022, reviewed the focus maps, worked on a draft "preferred" map with the City's demographer, and discussed election sequencing. Following preparation of a draft "preferred" map, the City Council discussed election sequencing and tentatively determined that members of the City Council from Council Districts 1, 3, and 5 shall be elected on a by-district basis beginning with the General Municipal Election in 2022, and members of the City Council from Council Districts 2 and 4 shall be elected on a by-district basis beginning with the General Municipal Election in 2024.

The City Council voted to continue the fourth public hearing to February 15, 2022 to give the community an opportunity to provide input on the draft "preferred" map. At the February 15th meeting, the City Council selected 2 draft "preferred maps" prepared by the City's demographer with input from the City Council and the public for final review and selection on February 22, 2022.

The City Council will adopt a final district map at the fifth public hearing scheduled for March 8, 2022.

2. ELECTION SEQUENCING

As the City transitions from at-large to by-district elections, the City Council must set a "sequence of elections" as required by the Elections Code so that the terms of the Councilmembers remain staggered pursuant to the City Charter, with 3 Councilmembers elected for a four-year term in 2022 and every 4 years thereafter, and 2 Councilmembers elected for a four-year term in 2024 and every 4 years thereafter.

Accordingly, when the City Council adopts a final district map, the Council will also have to identify which 3 Council Districts will be up for election in 2022 and which 2 Council

Districts will be up for election in 2024. In determining the sequence of the district elections, the City Council is required to give special consideration to the purpose of the California Voting Rights Act (i.e., not to impair the ability of voters who are members of a race, color or language minority group to elect candidates of their choice or their ability to influence the outcome of an election) and shall take into account the preferences expressed by members of the districts.

In a Council District sequenced for election in 2022 or 2024 that has no currently serving Councilmember, any eligible registered voter in that Council District may run for election in that District.

A Councilmember whose term ends in 2022 residing in a Council District sequenced for the 2022 election can run for election in 2022 to represent that Council District. Similarly, a Councilmember whose term ends in 2024 residing in a Council District sequenced for the 2024 election can run for election in 2024 to represent that Council District.

A Councilmember whose term ends in 2022 residing in a Council District sequenced for the 2024 election will leave office at the end of his or her term in 2022, and can run for election when that District is up for election in 2024.

A Councilmember whose term ends in 2024 residing in a Council District sequenced for the 2022 election has the option to either serve out his or her term representing the City at-large until 2024, or run for election in 2022 to represent that Council District for a new four-year term. If the Councilmember chooses to run in 2022 and wins a new four-year term representing the District, a vacancy for the remaining two years of that Councilmember's at-large term will be filled by the City Council by appointment or special election.

3. MAPPING CRITERIA

Cities must comply with the following legally required criteria under federal and state law:

- 1. Each district must have substantially equal population as determined by the census.
- 2. Race cannot be the predominant factor or criteria when drawing districts.
- 3. Council districts shall not be adopted for the purpose of favoring or discriminating against a political party.
- 4. Incarcerated persons may not be counted toward a city's population, except if their last known place of residence is assigned to a census block in the city.
- 5. The districting plan must comply with the Federal Voting Rights Act, which prohibits districts from diluting minority voting rights and encourages a majority-minority district if the minority group is sufficiently large and such a district can be drawn without race being the predominant factor.

- 6. The City Council shall adopt district boundaries using the following criteria as set forth in the following order of priority:
 - A. To the extent practicable, council districts shall be geographically contiguous. Areas that meet only at the points of adjoining corners are not contiguous. Areas that are separated by water and not connected by a bridge, tunnel, or regular ferry service are not contiguous.
 - B. To the extent practicable, the geographic integrity of any local neighborhood or local community of interest shall be respected in a manner that minimizes its division. A "community of interest" is a population that shares common social or economic interests that should be included within a single district for purposes of its effective and fair representation (e.g., school district boundaries, neighborhood boundaries, homeowners' associations, retail/commercial districts, etc.). Communities of interest do not include relationships with political parties, incumbents, or political candidates.
 - C. Council district boundaries should be easily identifiable and understandable by residents. To the extent practicable, council districts shall be bounded by natural and artificial barriers, by streets, or by the boundaries of the city.
 - D. To the extent practicable, and where it does not conflict with the preceding criteria, council districts shall be drawn to encourage geographical compactness in a manner that nearby areas of population are not bypassed in favor of more distant populations.

To increase public awareness of the transition to district elections, the City has activated a variety of public communication channels to engage the Folsom community. Districting information is featured on the City's website and City newsletters. Numerous frequently asked questions have been posted on the dedicated districting webpages on the City's website.

5. NEXT PUBLIC HEARING

At the fifth public hearing scheduled for March 8, 2022, the City Council will adopt a final district map and introduce an Ordinance to complete the transition process. The public is encouraged to provide input via emails to attydept@folsom.ca.us. Input may also be dropped off at City Hall. The City Council is the final decision-making body on adopting district boundaries.

FINANCIAL IMPACT

The services of a demographer are required to assist the City transition to a by-district election system under specific aggressive timelines as required by the California Elections Code. Staff anticipates the cost to be approximately \$40,000.

ENVIRONMENTAL REVIEW



The Council's decision regarding by-district elections meets the above criteria and is not subject to CEQA. No environmental review is required.





RECOMMENDATION / CITY COUNCIL ACTION

Staff recommends that the City Council nominate a representative to serve as a citizen representative to the Citizens' Advisory Committee for Folsom Prison for a two-year term ending in 2024.

BACKGROUND / ISSUE

California Penal Code mandates the formation of a citizens' advisory committee for each state prison. The committee consists of members appointed by the prison warden, including representatives nominated for appointment by the local assembly member, local senator, local city council, local county board of supervisors, local chief of police, and local county sheriff. The purpose of the committee is to improve the public's understanding of correction programs and suggest ways to improve and participate in inmate programming.

The City of Folsom participates on this committee with one representative from the Folsom Police Department and two citizen representatives who are nominated by the Folsom City Council and then appointed by the Warden of Folsom State Prison.

The two citizen representatives serve in staggered terms. The first citizen representative seat is currently occupied by Folsom resident William Hutto and his term will expire in March 2023. The second citizen representative seat is currently vacant as of January 2022. City staff advertised the vacant position in the Folsom Telegraph, posted it on the bulletin boards at City Hall and on the city's webpage. Cynthia Gibbs and Jim Silva have submitted applications for the position.

POLICY / RULE

California Penal Code section 5056 establishes the membership structure of the committee and states, in part, that two persons shall be appointed to the committee for a two-year term by the prison warden from nominations submitted by the city council of the city containing or nearest to the institution.

ANALYSIS

Two applications have been received from Folsom residents Cynthia Gibbs and Jim Silva expressing interest in serving on the committee. Staff is requesting the City Council nominate a representative. Once the nomination is made by the City Council, it will be forwarded to the Prison Warden for final appointment.

As explained in Section 3, I worked in the Department of Corrections and Rehabilitation for 32 years, and saw what impact (both positive and negative) a prison can have on the surrounding community both economically and politically. In fact, I often times represented my prison when interacting with community leaders on issues that the prison created for the community, such as parking and inmate work assignments.

I have been retried for several years, but I would like to bring my unique perspective to the Committee of being both a resident/homeowner and someone who intimately understands how a prison operates. I will be a positive member of the Committee.

2. What do you think is(are) the top issue(s) facing this commission or committee:

The correctional facilities in Folsom are somewhat secluded from the population centers and tend to only come within the community's consciousness when they are in the news, or there is some sort of incident. By comparison, at other prisons I have worked at, like Mule Creek and Solano, the facilities are much more visible and elicit a lot of community attention. Regardless, the Folsom correctional facilities are incredibly important to the community, if for no other reason than because many Folsom residents are directly tied to them either through employment or because of a relationship with someone incarcerated there.

Working with an immense entity such as a prison could be difficult for many people. Luckily, I am very familiar with the prison system. Ultimately, to be an effective Committee, it is vital that communications and trust go both ways, and that the parties are comfortable engaging in open dialogue. The Committee needs to generate clear and concise directives after thorough discussions, and consider the agreements that have been reached in the past.

I bring the unique perspective of working at all levels of corrections and paroles during my 32 year career with the Department of Corrections and Rehabilitation. After returning from the Vietnam War, I commenced working for the Department in 1973 as an entry level Correctional Officer at San Quentin. Throughout the next several decades, I was promoted several times and worked in various capacities at several prisons including San Quentin, Soledad, Solono, Mule Creek, and the California Medical Facility. I also served in paroles, and held administrative posts at Headquarters and a special assignment at Aerojet. I eventually was promoted to Associate Warden at Mule Creek. In this role, I was at one time responsible for the prison's budget of \$68 million and supervised 300 employees.

Throughout my career, I managed all functions of a correctional institution including food services, plant operations, personnel, housing, discipline and classification. I served at all levels from entry level correctional officer to upper management. I received specialized training in leadership, communications (with emphases on media), report writing and budgets. I also represented the Department at local colleges during recruiting drives. Finally, I have the benefit of seeing how different prison operate in different and diverse communities.

After retirement, I was an elected official with my tribe: the Dry Creek Rancheria Band of Pomo Indians. That Board governed the Tribe (composed of over a thousand members) and its multi-million dollar commercial activities, including a gaming facility.



BACKGROUND / ISSUE

On February 8, 2022, the City Council held a public workshop to consider strategies to close the City's future funding gap. Input was received from Councilmembers, City staff, and residents. At the conclusion of the workshop, a suggestion was made that the City Council may want to create subcommittees to evaluate certain areas of interest. The Council requested that staff bring back an action item to consider the creation of ad hoc City Council subcommittees to analyze and make recommendations regarding (1) unutilized/underutilized City properties, (2) retail recruitment, and (3) Folsom economy/the economics of land planning.

It was also suggested that the subcommittees could include Joe Gagliardi from the Greater Folsom Partnership and member(s) of one or more of Folsom's commissions/committees.

POLICY / RULE

Section 2.04(G) of the Folsom City Charter authorizes the Mayor to establish ad hoc committees, subject to the approval of the City Council, for a term not to exceed one year.

ANALYSIS

Consistent with the suggestion made during the public workshop, staff has prepared resolutions for the Council to consider the creation of three ad hoc subcommittees.

If the City Council decides to pursue these subcommittees, staff will need further direction and clarification from the Council regarding a defined purpose and scope of work for each subcommittee, an identified method of selecting Folsom commission/committee members to serve on the subcommittees, and an identified timeline for completion of the subcommittees' work. The City Council will need to identify up to two Councilmembers to assign to each subcommittee. The City Council will need to confirm the appointment of Joe Gagliardi from the Greater Folsom Partnership and identify any other additional appointees.

In addition, the City Manager will need to evaluate available staff resources to provide administrative support and subject matter expert services to the subcommittees.

FINANCIAL IMPACT

The precise financial impact is undetermined at this time and will depend upon the time and scope of work identified for each subcommittee, the resources needed to support that work, and staff assigned to support the subcommittee. Funds will be used from the City's General Fund to cover expenses related to subcommittee meetings.

ENVIRONMENTAL REVIEW

This action is exempt from environmental review pursuant to California Environmental Quality Act Guidelines §15061(b)(3).

- 6. The Committee is tasked to study and make recommendations regarding Folsom's economy and land planning economics.
- 7. The Committee will submit a report and recommendations to the City Council no later than 12 months from the first Committee meeting.
