# **Background**

On August 23, 2021, the Fridley City Council passed a resolution to begin a three-year process to recodify the City Code. Ordinance No. 1399 was adopted on February 28, 2022 adopting the new Chapter 1 of the City Code and revisions to Chapter 2 are currently underway. Soon, staff will begin working on Chapter 3 which will include revisions to the existing:

- Chapter 101 Animal Control
- Chapter 104 Tree Management
- Chapter 105 Landscape Maintenance
- Chapter 109 Air Quality
- Chapter 113 Solid Waste
