Call to Order

Mayor Lund called the City Council Meeting of June 12, 2023, to order at 7:00 p.m.

Pledge Of Allegiance

1. Proclamation: Women of Today Founder's Day – July 1, 2023

Mayor Lund presented the proclamation declaring July 1, 2023 as Women of Today Founder's Day.

Kathy Rodel-Mezzenga, President of Fridley Women of Today, thanked the City for the proclamation. She provided information on the organization and highlighted upcoming events.

2. Proclamation Congratulating Al-Amal School and Certificate of Achievement to Muminah N. Mohammed

Mayor Lund presented the proclamation congratulating the Al-Amal School.

Ishrat Islam, Vice Principal of Al-Amal School, stated that the school is proud to be the only K-12 Islamic school in Minnesota. She provided additional information on the school and its near perfect graduation rate. She thanked the City for supporting the school and embracing their values.

Mayor Lund presented the Certificate of Achievement to Muminah N. Mohammed.

Muminah N. Mohammed introduced herself and expressed gratitude to the City staff and Council for their support. She shared some of the achievements and awards of the students of Al-Amal School in the areas of science and history.

Adoption of Regular Agenda

Motion made by Councilmember Bolkcom to adopt the regular agenda. Seconded by Councilmember Tillberry.

Upon a voice vote, all voting aye, Mayor Lund declared the motion carried unanimously.

Open Forum, Visitors: (Consideration of Items not on Agenda – 15 minutes.)

A resident of Lucia Lane expressed concern with the speed of vehicles and unsafe behavior of vehicles on the roadway.

Council confirmed that they are aware of the issue and continue to work on that.

Ryan George, Deputy Director of Public Safety, confirmed that they have been working on slowing the speed of traffic for many years and while things have gotten better, it is something they continue to work on. He reviewed some of the methods the department in collaboration with the Islamic University have has used in an attempt to manage the traffic. Another resident of Lucia Lane provided some additional things that could be considered to assist in managing traffic.

Regular Agenda

Public Hearing

Motion made by Councilmember Tillberry to open the public hearing. Seconded by Councilmember Evanson.

Upon a voice vote, all voting aye, Mayor Lund declared the motion carried unanimously.

Joe Starks, Finance Director, provided background information on this development project and the actions taken thus far. He noted that at the last meeting, Council adopted a resolution increasing the not to exceed amount from \$27,000,000 to \$50,000,000. He reviewed the logistics of the financing noting that the City is merely a conduit and the money and obligations flow only between the Trustee and the Borrower.

There were no public comments.

Motion made by Councilmember Tillberry to close the public hearing. Seconded by Councilmember Ostwald.

Upon a voice vote, all voting aye, Mayor Lund declared the motion carried unanimously.

Motion made by Councilmember Tillberry to adopt Resolution No. 2023-63, Approving the Issuance and Sale of Multifamily Housing Revenue Bonds (Moon Plaza Apartments Project), Series 2023, and Approving a Housing Program Pursuant to Minnesota Statutes, Chapter 462C. Seconded by Councilmember Bolkcom.

Upon a voice vote, all voting aye, Mayor Lund declared the motion carried unanimously.

Old Business

14. Interim Ordinance No. 1408, Authorizing a Study and Imposing a Moratorium on the Sale of Cannabinoid Products (Second Reading).

Ryan George, Deputy Director of Public Safety, noted that following the discussion at the first reading of the ordinance, the percentage allowed was changed from .1 to .3 percent. He provided additional background information on the actions of the State legislature since the first reading of the ordinance. He explained that the ordinance would allow the City to authorize a study and impose a moratorium. He reviewed the changes to the draft ordinance following the first reading and the next steps.

A local business owner explained that his products are hemp-derived, not marijuana derived, and are even legal on a Federal level. He stated that he opened his business in April of 2022 and received the approval from Mr. George prior to opening, including confirmation that his business would be grandfathered in if the City were to change its regulations. He noted that his store only sells CBD and hemp-derived products and does not sell tobacco or any illegal products. He stated that if the City agrees to pay his rent during the moratorium, he would agree to it, but otherwise he needs to operate his business. He asked for clarification on whether both CBD and hemp-derived products could be sold under the moratorium.

Mr. George stated the moratorium would allow the business to sell hemp derived CBD products at or below .3 percent. He commented that the Delta-9 and other THC derived products would not be allowed under the moratorium.

The business owner stated that he has complied with all regulations and many of his clientele have shifted to the Delta-9 products which have been legal since 2018. He volunteered to meet with City staff to share his knowledge of these products.

Council asked for more background information, noting that many other cities are following the path of a moratorium. Mr. George confirmed that many other cities, over 80 at this time, are issuing moratoriums, and staff worked with the City Attorney to draft a similar moratorium. He confirmed that the moratorium would allow the business to sell the hemp derived CBD products that are .3 percent or less, but he would not be able to sell Delta-9 or HHC products. He explained that the moratorium would allow the City to study the issue and also allow the State to provide more guidance

on this issue. He stated that while the moratorium would be valid for one year, it could be lifted sooner.

Council acknowledged that the business is selling products that are federally legal. Mr. George stated that THC products were not previously allowed for sale until April, only the sale of hemp derived CBD products were allowed. He confirmed that the products are currently legal for sale under City Code as the intent of the City was to follow the path of licensing. He stated that because of the change made by the legislature, the City would not have the ability to license.

Joe Sathe, City Attorney, explained that the interim ordinance is unique in the sense that it addresses three categories of products under the cannabinoid umbrella and provided further explanation.

Wally Wysopal, City Manager, commented that the Council should consider its compelling interest in why the products that have been allowed to be sold should now not be allowed for sale. Mr. George stated that the new law does bring about concerns but acknowledged that these products can be sold in any gas station at this time where minors would be exposed, and the City would prefer the products to be sold in establishments only serving those 21 and up.

The Council asked if the businesses that have authorization to sell these products could be grandfathered in to allow them to sell those products during the moratorium. Mr. Sathe did not recommend exempting certain businesses but believed the interim ordinance could be drafted in a manner that would state an existing or new business could not begin the sale of these products.

Mr. Wysopal asked if the business is currently licensed. Mr. George replied that it is not because he does not sell tobacco. He noted that there are currently five tobacco license holders, so a total of six businesses that could potentially be grandfathered in.

Mr. Sathe stated that licensing could still be implemented on the 151 products by the City until the time a State license process is enacted for those products.

Mr. George clarified that the tobacco product shops are only allowed to sell tobacco/nicotine products and are not allowed to sell these products, although the concept was to eventually allow those stores to sell those products.

Mr. Sathe stated that if any business could provide proof that they were selling after it was deemed allowed in April, until the interim ordinance, those businesses should be treated the same. He noted that 151 products can be sold at any retailer, and it is not limited to these types of businesses. He recommended that the City use licensing to limit the sale of those products, noting that could occur in conjunction with the moratorium. He noted that he has experience in drafting licensing and could do so within a few days, but that would need to be reviewed to cater to the desires of Fridley.

Council recognized that the moratorium casts a wide net that includes products that have been able to be sold legally. A member expressed that licensing seems to provide the City better control over the sale of the legal products and would also allow this business to continue selling their products legally. A member of the Council suggested that the moratorium move forward, allowing a carve-out for this business and potentially others prior to the enactment date of June 30.

Mr. George commented that this shop would be unique enough to have a carve-out, as it is the only dedicated CBD store in the City, and he does not sell tobacco.

Mr. Sathe stated that he has seen that done through a licensing framework and provided more details.

Mr. Wysopal stated that the Council could move forward with the moratorium as drafted and then staff can be directed to create the licensing process.

Mr. Sathe commented that could be done but they would need to consider what the licensing would allow a business to sell. He provided additional details on anticipated timelines.

Mr. Wysopal asked if the interim ordinance could be adopted with a carve-out for a business that exclusively sells the CBD/hemp-derived products.

A member of the Council suggested adopting the interim ordinance, which would become effective on June 30. It was noted that would allow time for staff to create the framework for limited licensing that could be considered at the June 22 meeting.

Mr. Sathe noted that a second reading would be required, therefore the licensing would take effect mid-July.

Melissa Moore, City Clerk, commented that if a public hearing were desired that would add time as well but confirmed that it is discretionary. It was noted that the second meeting in June is June 26, not June 22.

The business owner expressed appreciation to the Council for its consideration and commented that he would be happy to be part of the licensing.

Pam Reynolds, 1241 Norton Avenue N.E., asked that the ordinance be read before being adopted as allowed by the City Charter and expressed concern that this draft ordinance is meant for edibles and not marijuana. The City Clerk read aloud the draft interim ordinance. The resident asked for additional clarification on terms and answers were provided by the City Attorney. She said she did not believe any other cities were enacting moratoriums of this nature and have moratoriums that soon expire.

Motion made by Councilmember Bolkcom to adopt the second reading and Interim Ordinance No. 1408, Authorizing a Study and Imposing a Moratorium on the Sale of Cannabinoid Products. Seconded by Councilmember Tillberry.

Upon a voice vote, all voting aye, Mayor Lund declared the motion carried unanimously.

New Business

15. Ordinance No. 1409, Amending the Fridley City Code to Add Chapter 35, Mobile Food Units, Amend Chapter 209, Fees and Repeal Chapter 216, Street Vending.

Item 2

Melissa Moore, City Clerk, provided background information noting that the City currently does not have an ordinance regulating food trucks and relies on Chapter 216, street vending. She reviewed the proposed requirements of the food truck license and allowed operations. She also reviewed the ice cream truck license requirements and allowed operations as proposed. She provided an overview of the related fees as proposed and next steps.

The Council asked for clarification on the allowed time a food truck could be operating in Fridley under the City license and County permit.

Stacy Stromberg, Planning Manager, replied that the County allows a permit for 21 days in one location. She stated that because of that limit, the City would follow the same limit at one location. She noted that a food truck could go to another location after that time period and stated that property owner permission must be provided as well.

Motion made by Councilmember Evanson to approve the first reading of Ordinance No. 1409 Amending the Fridley City Code to add Chapter 35, Mobile Food Units, Amend Chapter 209, Fees and Repeal Chapter 216, Street Vending. Seconded by Councilmember Ostwald.

Upon a voice vote, all voting aye, Mayor Lund declared the motion carried unanimously.

16. Resolution No. 2023-61, Approving and Accepting the Annual Comprehensive Financial Report (ACFR) for the Fiscal Year ending December 31, 2022.

Rebecca Petersen, Redpath and Company, presented the results of the 2022 audit noting a clean or unmodified opinion. She stated that the City has received the GFOA Award for excellence in financial reporting every year since 2011 and the 2022 reports will be submitted as well. She stated that there was one internal control finding related to audit adjustments which is an extremely common finding. She noted that there were no findings of legal noncompliance and reviewed the communication to those charged with governance. She also provided a brief review of the different City funds.

Joe Starks, Finance Director, Ms. Peterson and her team along with the finance staff for their hard work.

Motion made by Councilmember Ostwald to adopt Resolution No. 2023-61, Approving and Accepting the Annual Comprehensive Financial Report (ACFR) for the Fiscal Year ending December 31, 2022. Seconded by Councilmember Bolkcom.

Upon a voice vote, all voting aye, Mayor Lund declared the motion carried unanimously.

Title

Ordinance No. 1409, Amending the Fridley City Code to Add Chapter 35, Mobile Food Units, Amend Chapter 209, Fees and Repeal Chapter 216, Street Vending (Second Reading)

Background

In 2021 staff began working on drafting a chapter of the Fridley City Code (Code) that addresses Mobile Food Units, frequently known as "food trucks." The popularity of such services has brought an increase in inquiries regarding the City's rules and regulations. A growing number of cities in the metro area have begun regulating these activities, mainly to ensure compliance with County health regulations for the preparation and handling of food and compliance with State and local fire inspection requirements. Without such a license, the City has minimal regulatory authority to enforce health, fire, or other considerations such as the location of the operation and impact to the surrounding community.

The attached draft proposes to add a new chapter to the Code. The chapter broadly defines a "Mobile Food Unit" as a vehicle that offers food or beverage service. The chapter then offers more specific definitions of "Food Truck" as a stationary vehicle in which food is stored, cooked, or prepared, and an "Ice Cream Truck" is a vehicle that sells pre-packaged ice cream (or similar items) while travelling around the City.

The chapter accomplishes several things for the City:

1. Minnesota Rules 4626.0015 establishes State-wide regulations to safeguard public health and ensure that food is safe for human consumption. The Minnesota Department of Health and Anoka County regulate food establishments by establishing licensure and inspection requirements. This chapter of the Code requires that applicants follow all State and County laws and requires compliance with some of the City's distinct regulations pertaining to fire inspections, prohibited activities (e.g., excessive noise or signage), hours of operation, protecting the right-of-way, etc.

2. The chapter creates a Food Truck License and an Ice Cream Truck License so that the City can ensure such business activities are done in a safe and efficient manner. These licenses, as proposed, are annual licenses following the City's typical renewal cadence (effective May 1 through April 30 of the following year).

Vision Statement

We believe Fridley will be a safe, vibrant, friendly and stable home for families and businesses.

3. The ordinance, when presented to the Council, will recommend Chapter 16, Street Vending, be repealed. This is because the contents of that chapter are largely integrated into the Mobile Food Units chapter.

4. Establishes the fees the City will charge for the two new licenses in Chapter 209, Fees:

- (a) \$50 for a Food Truck License
- (b) \$100 for a Fire Safety Inspection (required for food trucks only)
- (c) \$75 for an Ice Cream Truck License.

Ordinance No. 1409

Amending the Fridley City Code to Add Chapter 35, Mobile Food Units, Amend Chapter 209, Fees and Repeal Chapter 216, Street Vending

The City Council of the City of Fridley does ordain, after review, examination and staff recommendation that the Fridley City Code be amended as follows:

Section 1

That the Fridley City Code be hereby amended by adding Chapter 35, Mobile Food Units as follows:

Fridley City Code Chapter 35 Mobile Food Units

35.01 Purpose

The purpose of this Chapter is to protect the health, safety, and welfare of the community through the establishment of standards for mobile food units to operate in a safe and effective manner in the City of Fridley (City).

35.02 Definitions

Mobile Food Unit: A food or beverage service that is a mounted vehicle, either motorized or trailer, and is readily movable without disassembling for transport to another location. The two distinct types of Mobile Food Units are detailed below:

<u>1. Food Truck: A self-contained unit in which food is stored, cooked, or prepared for direct sale to the consumer while parked or stationary in one location.</u>

<u>2. Ice Cream Truck: A motor vehicle utilized as the point of retail sale of pre-packaged ice cream, frozen yogurt, frozen custard, flavored frozen water, or similar frozen dessert products, while travelling within the City.</u>

35.03 Food Truck License Required

1. All operators of food trucks must obtain a license to operate within the City.

<u>2. No person may operate a food truck within the City without a valid license from Anoka</u> <u>County.</u>

3. No license issued under this Chapter may be transferred to any other person or business.

<u>4. A license issued under this Chapter becomes effective from the date on which the license is issued through April 30 of the subsequent year.</u>

5. A valid license must be openly displayed at all times in the food truck when it is within the <u>City.</u>

<u>6. For the purposes of this Chapter, any food truck equipped with appliances that produce</u> smoke or grease-laden vapors must submit to a Fire Safety Inspection performed by the Fire Division, pursuant to the Mobile Food Preparation Vehicles Chapter of the Minnesota State Fire Code.

35.04 Food Truck License Application

<u>1. No person may operate a food truck within the City without a valid license from the City, which includes the following requirements:</u>

(a) The full legal name of the owner of the food truck;

(b) The full legal name of the operator of the food truck, other commonly known names the operator may use, the operator's date of birth, and a copy of their driver's license;

(c) A list of names of all persons working in the food truck;

(d) A description of the nature of the business and the goods to be sold out of the food truck;

(e) A description of the food truck and valid license plate number for any vehicle associated with a City food truck license;

(f) The name, address and contact information for the restaurant with which the food truck is affiliated, if applicable;

(g) A complete Background Investigation Consent Form;

(h) A Certificate of Insurance proving commercial general liability coverage of not less than \$1 million for each occurrence, or a \$2 million annual aggregate;

(i) Proof of workers' compensation insurance, or evidence of exemption, is required;

(j) A copy of the applicant's State sales tax identification number, with a complete State SP:C1 Form; and

(k) Written consent of each private property owner from which sales from a food truck will be conducted.

(I) A valid permit pursuant to the Rights-of-Way Management Chapter of the Code, if applicable.

35.05 Food Truck Allowed Activities

1. Mobile food trucks are allowed under the following circumstances:

(a) In conjunction with a private party or event located at a City or County park, provided the renter of the park has a valid park rental permit;

(b) In conjunction with an event sponsored by the City taking place on City-owned property with written consent of the City Manager or their designee;

(c) In conjunction with a school-sponsored event taking place on school-owned property with written consent of the school official; or

(d) In conjunction with a private event, on private property with written consent from the property owner.

35.06 Food Truck Prohibited Activities

1. No mobile food truck operators may conduct business in the following manner:

(a) Calling attention to their business or the items to be sold by means of blowing any horn or whistle, ringing any bell, yelling, or by making any other noise that would disturb the peace and enjoyment of the general public.

(b) Obstructing the free flow of traffic, either vehicular or pedestrian, on any street, sidewalk, alleyway, or other public right-of-way. An operator may not park a food truck on any public right-of-way or in residential zoning district except during events permitted under this Chapter and with a valid license.

(c) Conducting business in a way as to create a threat to the health, safety, and welfare of any specific individual or the general public.

(d) Conducting business before 7:00 a.m. or after 10:00 p.m.

(e) Failing to provide license, registration, or identification when requested.

(f) Using the registration of another person or business.

(g) Using false or misleading statements about the products or services being sold, including untrue statements of endorsement. No food truck operator may claim to have the endorsement of the City solely based on the City having issued a license to that person.

(h) Remaining on the property of another when requested to leave.

(i) Operating their business in any manner that a reasonable person would find obscene, threatening, intimidating or abusive.

(j) Operating on the same property more than 21 days in a 60-day period.

(k) Disposing gray water into any City stormwater drain. Gray water must be drained daily and in an appropriate manner.

(I) Failing to provide refuse containers for customers. The operator of a food truck is responsible for removing all refuse associated with the food truck operations.

(m) No overnight storage of a food truck is permitted.

35.07 Food Truck Signs

<u>1. A licensed food truck is not required to obtain a Sign Permit from the City. However, no additional signage is permitted beyond that which is affixed to the food truck unless it meets the following requirements:</u>

(a) One single sandwich board style sign is permitted per food truck;

(b) The maximum sign size is eight square feet;

(c) The sign must be placed on the ground and be within 10 feet of the food truck;

(d) The sign must not be placed in a manner that obstructs passage upon any sidewalk;

(e) The sign must not be placed within the improved travel surface of the public right-ofway.

35.08 Ice Cream Truck License Required

1. All operators of ice cream trucks must obtain a license to operate within the City.

2. No license issued under this Chapter may be transferred to any other person.

<u>3. A license issued under this Chapter becomes effective from the date on which the license is issued through April 30.</u>

4. A valid license must be openly displayed at all times when the food truck is within the City.

35.09 Ice Cream Truck License Application

<u>1. No person may operate an ice cream truck within the City without a valid license from the City, which includes the following requirements:</u>

(a) The full legal name of the owner of the ice cream truck;

(b) The full legal name of the operator of the ice cream truck, other commonly known names the operator may use, the operator's date of birth, and a copy of their driver's license;

(c) A description of the types of confections to be sold out of the ice cream truck;

(d) A description and valid license plate number for any vehicle associated with the license;

(e) A completed Background Investigation Consent Form;

(f) A Certificate of Insurance proving commercial general liability coverage of not less than \$1 million for each occurrence, or \$2 million annual aggregate is required;

(g) Proof of workers' compensation insurance, or evidence of exemption, is required;

(h) A copy of the applicant's State sales tax identification number, with a complete State SP:C1 Form;

35.10 Ice Cream Truck Routes and Hours of Operation

1. Operations may be carried on only between the hours of 10:00 a.m. and 8:00 p.m.

2. The proposed area in which the licensed vehicle will travel each day while within the City.

<u>3. The licensee must only operate on streets as approved by the City Manager or their designee. Changes to a proposed area or route must be submitted to, and approved by, the City Manager or their designee at least 10 days in advance of making any change.</u>

<u>4. At no time, may the licensee operate the ice cream truck outside of the area or route approved by the City Manager or their designee. This section does not apply to emergency situations or travel to and from the approved route.</u>

35.11 Ice Cream Truck Operations

1. When engaged in any vending operations, the ice cream truck must be parked as close to the street curb as practical. All vending must be done only at the curb side of the ice cream truck.

2. Ice cream trucks must not be parked in a manner that encourages unsafe pedestrian behavior, including but not limited to, encouraging the unsafe crossing of busy thoroughfares.

<u>3. Ice cream trucks must be stopped or parked so as to not obstruct or cause a hazard to traffic or create danger of injury to customers or the general public.</u>

4. All ice cream trucks must be equipped with flashing lights on both the front and rear of the vehicle, which must be clearly visible to oncoming traffic in full daylight.

5. No ice cream truck may be moved backward if:

(a) There is a substantial number of people congregated near the ice cream truck.

(b) The ice cream truck operator has reason to believe there are minors or persons with disabilities near the truck.

(c) Movement in such direction threatens injury to any person in or near the ice cream truck.

<u>6. Ice cream trucks must carry signaling or warning devices that enable the attendant to give adequate warnings to pedestrians or other vehicles on the street.</u>

7. Except as permitted by this Chapter, while transiting within their designated area or route, no ice cream truck may operate any device that produces any noise or sound for the purpose of attracting persons to the ice cream truck.

8. Ice cream trucks may sound a manually operated bell in the areas of and the hours established in this Chapter, which produces a noise level measured at 50 feet from the source, no greater than 65 decibels, as defined in the Noise Chapter of the Fridley City Code (Code).

9. Ice cream trucks may not operate within one block of any school zone in the City.

35.12 Suspension, Revocation, or Grounds for Denial

1. Any license issued under this Chapter may be suspended, revoked, or denied renewal by the City Manager or their designee. Grounds include:

(a) Subsequent knowledge by the City of fraud, misrepresentation, or incorrect statements provided by an applicant on the application form;

(b) Fraud, misrepresentation, or false statements in the application process;

(c) Engaging in any prohibited activity as provided under of this Chapter; or

(d) Violation of any other provision of this Chapter or Code, or any provision of State law.

2. The suspension or revocation of a license will apply to the owner of the mobile food unit, the operator of the mobile food unit (if different) and any other person authorized to work in the mobile food unit.

3. Prior to suspending or revoking any license issued under this Chapter, the City will provide the licensee with written notice of the alleged violations and inform them of their right to a hearing on the alleged violation. Notice will be delivered in person or by mail to the permanent residential address listed on the license application, or if no residential address is listed, to the business address provided on the license application.

<u>4. Any person contesting a license suspension or revocation or other decision by the City</u> <u>associated with violations of this Chapter may file an appeal pursuant to the Appeals and</u> <u>Administrative Citations Chapter of the Code.</u>

5. Within 14 business days of a determination by the Hearing Examiner, any person contesting that decision may appeal to the Council by submitting a written appeal to the City Clerk. At its next regular meeting following the Hearing Examiner's decision, the Council will affirm, repeal, or modify that decision.

<u>6. If, in the discretion of the City Manager or their designee, imminent harm to the health or safety of the public may occur because of the actions of any mobile food unit operations licensed under this Chapter, the City Manager or their designee, may immediately suspend the license by notifying the licensee in writing.</u>

35.13 Fees

The fees for this Chapter are set in the Fees Chapter of the Code.

Section 3

That the Fridley City Code be hereby amended by repealing Chapter 16, Street Vending as follows:

FRIDLEY CITY CODE CHAPTER 16. STREET VENDING

16.01. LICENSE REQUIRED

Except under a license as provided herein, no person shall operate a vehicle in the City of Fridley for the purpose of dispensing or vending confections or other goods directly from a vehicle without a license to do so first being obtained, or contrary to the terms of such license. This Chapter does not apply, however, to any person using a vehicle for the delivery of goods or services directly to homes or establishments when the goods are taken by the operator of the vehicle onto private property for such delivery. (Ref. 183)

16.02. APPLICATION

The application for a license shall be made to the City Clerk and shall describe the vehicle or vehicles from which such vending operations are to be carried on, as well as the names and addresses of all persons interested in such business and its operation. The application shall also describe the types of confections or other goods which are to be sold from said vehicle and the areas of the City in which the business is proposed to be carried on. The application shall also set forth the names of the insurers providing liability coverage on the vehicle or vehicles to be used and the amount of the coverage carried. The application shall be accompanied by the annual license fee. If the application for a license is denied, the fee shall be refunded to the applicant.

16.03. ROUTES AND HOURS OF OPERATION

No person licensed under this Chapter shall carry on a vending operation upon any street or public place which is other than as provided under the terms of such license. Such operations may be carried on only between the hours of 10:00 a.m. and 4:30 p.m., and 6:00 p.m. to 8:00 p.m. in any area zoned commercial or industrial, and only between the hours of 1:00 P.M. and 4:30 p.m., and 6:30 to 8:00 p.m. in any area zoned residential or other than commercial or industrial. At least

ten (10) days before the commencement of operations, the licensee shall file with the City for approval by the City Manager, the proposed area in which the vehicles so licensed will travel each day while within the City. The licensee shall at all times operate on streets only as are approved within such areas; and changes in the area shall be filed with the City manager at least ten (10) days in advance of making any change. If the City Manager shall deny use of any street within the area, the licensee may appeal the ruling of the City Manager to the City Council for determination. At no time, however, shall the licensee operate a vehicle on and over any street that is not approved. Only such streets within the area shall be approved as would minimize the danger of injury by hazards of traffic to persons who may be customers of such vehicle, and also as would minimize traffic difficulties which may arise out of the operation of the vehicle for such purposes. A vehicle may be licensed to operate exclusively in areas of the City zoned "Commercial" or "Industrial"; or it may be licensed to operate exclusively in areas zoned "Residential" or "Other than Commercial or Industrial"; or it may be licensed to operate in all areas of the City. No vehicle, however, shall be operated in any area of the City which is zoned. different than that for which the same is licensed. In the absence of proof to the contrary, a vehicle parked or left standing on any street or public place is deemed to be there for business operations.

16.04. FEE

The annual license fee and expiration date shall be as provided in Chapter 11 of this Code.

16.05. SAFETY REQUIREMENTS

1. Insurance.

Every licensee shall maintain liability insurance with respect to the operation of any vehicle used in such business. The liability coverage of such insurance shall be in an amount of at least \$50,000 for single injuries and at least \$100,000 for each accident with respect to personal injuries, together with at least \$5,000 for property damage.

2. Parking.

When engaged in any vending operations, the vehicles used shall be parked at the curb of any street upon which the vehicle stands, and the vending shall be done only at the curb side of vehicle. When the vending is carried on near any school or other similar place, the vehicle used shall be parked at the curb side of the street nearest the school, or at a place next to such school or other similar public place as is safe and makes it reasonably unnecessary for a customer to cross a street or thoroughfare upon which there is traffic to reach such vehicle from the school or such other similar public place. At all times the vehicle used shall be stopped or parked only in such place as will not obstruct or cause a hazard to traffic and which creates no danger of injury to customers of the vehicle. Each vehicle shall be equipped with flashing lights on both the front and rear of the vehicle, which lights shall be clearly visible to oncoming traffic in full daylight.

3. Operators.

No vehicle used in such vending operation shall be moved backward if:

A. There is congregated a substantial number of people.

B. There can reasonably be expected in and about such vehicle persons of minor age, infirmity or disability.

C. Movement in such direction threatens injury to any person in and near such vehicle.

A vehicle operator shall at all times give adequate warnings to keep all persons clear of such vehicle while the same is in movement.

4. Warning.

The vehicle used shall carry such signaling or warning devices as will enable the attendant reasonably at all times to give adequate warnings as required herein. Except as permitted by Section 16.05.5, no vehicle or equipment shall operate any device that shall produce any noise or sound for the purposes of attracting persons to the vending truck. (Ref. 243)

5. Exception for Food/Beverage Vehicles.

Not withstanding any other provision to the contrary, food/beverage vehicles may sound a manually operated bell, between the hours of 10:00 a.m. and 4:30 p.m., and 6:00 p.m. to 8:00 p.m. in any area zoned commercial or industrial, and only between the hours of 1:00 p.m. and 4:30 p.m., and 6:30 p.m. to 8:00 p.m. in any area zoned residential or other than commercial or industrial, which produces a noise level measured at a distance of 50 feet from, the source no greater than 65 decibels, as defined in Fridley City Code Chapter 124, "Noise". (Ref. 836)

16.06. ADDITIONAL REQUIREMENTS

All vehicles used for street vending shall be subject to the applicable requirements of Chapter 11 of this Code.

16.07. ADDITIONAL PENALTY

Any licensee who violates any provision of this Chapter or who drives or operates his or her vehicle in a careless and negligent fashion may, in addition to the usual penalties, have his or her license revoked after hearing before the City Council, upon reasonable notice.

16.08. PENALTIES

Any violation of this Chapter is a misdemeanor and is subject to all penalties provided for such violations under the provisions of Chapter 901 of this Code.

City of Fridley Summary Ordinance No. 1409

Amending the Fridley City Code to Add Chapter 35, Mobile Food Units, Amend Chapter 209, Fees and Repeal Chapter 216, Street Vending

The City of Fridley does ordain, after review, examination, and staff recommendation that the Fridley City Code (Code) be amended by adopting Ordinance No. 1409. A summary of the amendments to the Code made by Ordinance No. 1409 are as follows:

The Ordinance adds Chapter 35, Mobile Food Units to the Fridley City Code (Code). Section 35.01 is a purpose statement, § 35.02 defines terms related to the chapter, § 35.03 establishes a Food Truck License in the City of Fridley (City), § 35.04 outlines the Food Truck License application requirements, § 35.05 lists allowed activities for Food Trucks, § 35.06 lists prohibited activities for Food Trucks, § 35.07 lists signs requirements for Food Trucks, § 35.08 establishes an Ice Cream Truck License in the City, § 35.09 outlines the Ice Cream Truck License application requirements, § 35.10 describes Ice Cream Truck routes and hours of operations, § 35.11 lists allowed activities for Ice Cream Trucks, § 35.12 describes the City's response to license suspensions, revocations and denials of licenses, § 35.13 refers to the Fees Chapter of the Code for such licenses. The ordinance amends the Fees Chapter of the Code by establishing a fee for a Food Truck License at \$50, a Food Truck Fire Safety Inspection at \$100 and an Ice Cream Truck License at \$75. The ordinance repeals the fee for a Street Vending License. The ordinance repeals the Street Vending Chapter of the Code.

Ordinance No. 1409 was passed and adopted by the City Council of the City of Fridley on June 26, 2023. The full text of the Ordinance is available on the City website or for inspection by any person during regular office hours at the Office of the City Clerk.

Resolution No. 2023-71, Declaring Costs to be Assessed, Ordering Preparation of the Proposed Assessment Roll and Directing Publication of the Public Hearing Notice for the Street Rehabilitation Project No. ST-2022-01

Background

Pursuant to Minnesota Statue § 429.021 and City Charter § 8.03, the City Council (Council) may finance certain public improvement projects using special assessments. Generally, special assessments are a form of tax levied by a local government against a property that benefits from the improvement(s). To further govern this process, the Council also adopted Fridley City Code Chapter 7 and a Roadway Major Financing Policy.

Consistent with these regulations, the Council followed the below process for the use of special assessments regarding the Street Rehabilitation Project (Project) No. ST-2022-01:

- Ordered the preliminary report, plans and specifications (Resolution No. 2021-84);
- Received the preliminary report, called for a public hearing (Resolution No. 2022-04);
- Conducted the public hearing (Monday, January 24,2022);
- Accepted feasibility report, ordered the final plans and specifications, called for bids (Resolution No. 2022-10); and
- Receive bids and awarded contract to S.M. Hentges & Sons, Inc. of Jordan, MN (June 13, 2022).

Based on the construction costs, the proposed special assessment for Project No. ST–2022-01 will include 144 properties totaling approximately \$311,964. Benefitting property owners will be permitted to repay the applicable amount over at 10–year period at an interest rate of 4.25%.

Financial Impact

The Adopted 2022 and 2023 Budgets included and anticipated the use of the above-mentioned special assessments to support Project No. ST-2022-01.

Resolution Declaring Costs to be Assessed, Ordering the Preparation of the Proposed Assessment Roll and Directing Publication of a Public Hearing Notice for Street Rehabilitation Project No. ST-2022-01

Whereas, a contract has been let for Street Rehabilitation Project No. ST-2022-01 and the contract priced for such improvement is \$827,435, and the expenses incurred or to be incurred in the making of such improvement amount to \$117,595 so that the total cost of the improvement will be \$945,030; and

Whereas, by resolution passed by the City Council (Council) on June 26, 2023, the City Clerk, with the assistance of the City Engineer and City Treasurer, was directed to prepare a proposed assessment of the cost of Street Rehabilitation Project No. ST-2022-01; and

Whereas, the City Clerk, with the assistance of the City Engineer and City Treasurer, has notified the Council that such proposed assessment has been completed and filed by their office for public inspection.

Now, therefore be it resolved, by the City Council of the City of Fridley, Minnesota:

- 1. The portion of the cost of such improvement to be paid by the City is hereby estimated to be \$633,066 and the portion of the cost to be assessed against benefited property owners is declared to be \$311,964 for a total cost of \$945,030.
- Assessments shall be payable in installments extending over a period of 10 years, the first of the installments to be payable on or before the first Monday in January, 2024 and shall bear interest at the rate of 4.25 percent per annum from the date of the adoption of the assessment resolution.
- 3. The City Clerk, with the assistance of the City Engineer and City Treasurer, shall forthwith calculate the proper amount to be specially assessed for such improvement against every assessable lot, piece or parcel of land within the district affected, without regard to cash valuation, as provided by law, and they shall file a copy of such proposed assessment in their office for public inspection.

Be it further resolved:

1. A hearing shall be held at 7:00 p.m. on July 24, 2023 in the City Hall located at 7071 University Avenue Northeast to pass upon such proposed assessment. All persons owning property affected by such improvement will be given an opportunity to be heard with reference to such assessment.

- 2. The City Clerk, with the assistance of the City Engineer and City Treasurer, is hereby directed to cause a notice of the hearing on the proposed assessment to be published once in the official publication at least two weeks prior to the hearing and they shall state in the notice the total cost of the improvement. They shall also cause mailed notice to be given to the owner of each parcel described in the assessment roll not less than two weeks prior to the hearings.
- 3. The owner of any property so assessed may, at any time prior to certification of the assessment to the County, make one payment of at least one hundred dollars (\$100.00), to the City of Fridley; no interest shall be charged if the entire assessment is paid within 30 days from the adoption of the assessment.

Upon receipt of any such prepayment, the City Clerk, with the assistance of the City Treasurer, shall note the same upon the records of the City, credit the payee therefore, and reduce the assessment as originally made in the amount of the prepayment received. The balance remaining shall then be noted as the amount due and may then be certified to the county together with and as a part of the assessment roll in which the original amount due was contained.

A property owner may at any time, thereafter, pay to the City of Fridley the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 or interest will be charged through December 31 of the succeeding year.


Written or oral objections will be considered at the meeting. No appeal may be taken as to the amount of an assessment unless a signed, written objection is filed with the City Clerk prior to the hearing or is presented to the presiding officer at the hearing. The City Council may, upon such notice, consider any objection to the amount of a proposed individual assessment at an adjourned meeting, upon such further notice to the affected property owners, as it deems advisable.

A property owner who has properly objected to the assessment may appeal an assessment to district court pursuant to Minnesota Statutes Section 429.081 by serving notice of the appeal upon the Mayor or City Clerk of the City within 30 days after the adoption of the assessment and filing such notice with the District Court within ten days after service upon the Mayor or City Clerk.





Title

Resolution No. 2023-68, Awarding 53rd Avenue Trail and Walk Improvements Project No. ST2023-21

Background

On Thursday, June 22 at 9:00 a.m., bids were publicly opened online via the virtual platform available on QuestCDN and Microsoft Teams for the 53rd Avenue Trail and Walk Improvements Project No. ST2023-21. Four responsive bids were received.

The City's Capital Investment Plan includes rehabilitation on 53rd Avenue from Main Street (County Road 102) to Trunk Highway 65 (Central Avenue). The total project length is approximately 0.95 miles. The area is majority residential properties with a mix of commercial and high-density housing. On 53rd Avenue from University Avenue (Trunk Highway 47) to Central Avenue (Trunk Highway 65), the roadway is shared between the cities of Fridley and Columbia Heights. This project was submitted for eligible Minnesota Department of Transportation (MnDOT) Local Road Improvement Program (LRIP) funding for the trail, sidewalk, and resurfacing improvements in 2021 and received \$1,250,000 in State funding.

Proposed street rehabilitation will include asphalt reclaiming, asphalt paving, concrete curb and gutter relocation on the south side of 53rd Avenue, concrete curb and gutter spot replacement on the north side of 53rd Avenue, and miscellaneous utility repairs. The segment of 53rd Avenue from Main Street to Trunk Highway 47 will be paved with 4-inch asphalt pavement while the segment of 53rd Avenue from Trunk Highway 47 to Monroe Street will be paved with 4.5-inch asphalt pavement. Spot replacement of concrete curb and gutter will only occur along segments that are severely damaged, settled, or restrict the conveyance of storm water.

Trail improvements include adding a new shared asphalt trail on the south side of 53rd Avenue from Main Street to Central Avenue (Trunk Highway 65). The location of the trail will require the concrete curb to be bumped out 10-feet towards the centerline of the roadway. The existing roadway is 40 feet in width with an eight-foot parking shoulder on both sides of 53rd Avenue. The proposed roadway will be 30 feet in width eliminating the existing south side parking lane to accommodate for the new off-street 10-foot shared use trail. The trail will connect to existing trail facilities on Main Street, 7th Street, and Trunk Highway 65.

Vision Statement

Sidewalk improvements include adding a six-foot concrete sidewalk on the north side of 53rd Avenue from University Avenue (Trunk Highway 47) to the existing sidewalk on the east side of Monroe Street near the Target/Petco property. The existing sidewalk continues from Monroe Street east to Central Avenue (Trunk Highway 65).

Proposed water main improvements will include the replacement of approximately 550 lineal feet of sixinch watermain and existing valves within the project area will either be replaced or repaired. Staff has identified the portion of the water main on 53rd Avenue near Monroe Street to be replaced. The water main work will include replacement of the main and a portion of the services. Two hydrants will need to be relocated due to the location of the trail and sidewalk.

As noted, four bids were received. The low bid was received from Park Construction Company of Fridley, Minnesota in the amount of \$1,776,297.26, which is 15.5% below the final engineer's estimate of \$2,051,581.85 (Exhibit A). The two lowest bids were very competitive and within \$79,524 of one another. Of the four bids, the high bid received was \$2,006,836.87.

The City of Columbia Heights will be providing funding for a portion of the project through a Joint Powers Agreement. They have been advised of our recommendation and concur with the recommended award.

The City of Fridley has worked with Park Construction Company in the past on the 2019 Street Rehabilitation Project (the streets near the Civic Campus). Staff believes they are a knowledgeable and reputable contractor and will deliver the project within the requisite quality specified in the bid documents.

Based on the low bid, special assessments are expected to be within projections. Property owners will receive notification of project advancement this July presuming the City Council awards the project at this meeting. A project information sheet will provide a tentative work schedule, work description and contact information. During the project, staff will distribute weekly project updates via email and the project-specific page on the City's website to minimize disruption to the residents. We expect the work to begin in August with substantial completion in October of this year.

Financial Impact

Funding for this project is derived from several sources including the Local Road Improvement Program Grant, the City of Columbia Heights through a cost-share project Joint Powers Agreement, Municipal State Aid street funding, special assessments, and Utility CIP funds (water, sanitary sewer, and storm sewer).

Recommendation

Staff recommends the approval of Resolution No. 2023-68.

Title

Resolution No. 2023-69, Approving Change Order No. 2 (Final) for 2022 Street Rehabilitation Project No. ST2022-01

Background

Attached is Change Order No. 2 (Final) for the 2022 Street Rehabilitation Project No. ST2022-01. This project is part of the City of Fridley's (City) regular street maintenance program and includes pavement, utility and other miscellaneous improvements. The work is being performed under a contract with S.M. Hentges & Sons, Inc. of Jordan, MN (Contractor).

The amount of this change order is \$104,013.25. Total work included in Change Order No. 2 would increase the contract by 12.6%. Cumulative change orders to this project including Change Order No. 2, would total 14.2% of the original contract.

In September 2022, the Contractor began construction activities on Hartman Circle. Due to a combination of private utility relocation delays, shortage of cementitious material necessary for concrete items and deleterious material encountered on site, the Contractor was unable to complete the scope of work outlined in the contract for Hartman Circle in 2022.

To preserve the roadway integrity and maintain emergency access to public utilities along the roadway through winter, staff directed the Contractor to complete work through the installation of the initial pavement lift along Hartman Circle, with the remaining contracted work to be completed in 2023.

The items detailed in Change Order No. 2 include all additional work and base quantity overruns required for the winter preparation of Hartman Circle and the completion of the remaining scope of work for the project in 2023. The project is currently substantially complete with no additional anticipated changes to the contract. A summary of the changes is included below:

Subgrade Soil Correction - Hartman Circle 2023 (CO2.01)

During preparation of the roadway base along Hartman Circle in October 2022 a localized segment of the roadway base failed compaction testing and showed signs of instability. Locations with poor subgrade material typically require soil correction or other rehabilitation methods to be suitable for

paving. In order to provide a base course of pavement across the roadway for winter, the Contractor was directed by staff to pave over the location of unsuitable material with the understanding that a soil correction would be completed the following spring.

In May 2023, the Contractor completed a subgrade soil correction across the area before installing a bituminous patch and the final pavement lift along Hartman Circle. The correction method employed by the Contractor included the excavation and disposal of unsuitable material to a depth one foot across the impacted area and replacement with imported aggregate base.

CO2.01 accounted for \$8,721 of the change order and will be funded by the Water Utility Fund.

Temporary Bituminous Patch Removal – Hartman Circle (CO2.02)

In conjunction with the subgrade soil correction detailed in CO2.01, the Contractor performed bituminous patch removals in 2023 as directed by staff to expose the location of unsuitable roadway base material. Additional bituminous removals were also performed for the installation of concrete valley gutter along the southwest corner of Hartman Circle per the contract. The concrete valley gutter was not installed in 2022 with the base pavement course so as not to create an obstacle for winter plowing operations.

CO2.02 accounted for \$5,420.25 of the change order and will be funded by the Water Utility Fund.

Bituminous Patching – Hartman Circle (CO2.03)

Following the subgrade soil correction detailed in CO2.01 and installation of concrete valley gutter along Hartman Circle in 2023, the Contractor installed bituminous patching of identical mix and depth to the pavement removal area to match the existing base pavement course. Following bituminous patching, the Contractor installed the final pavement wear course per the contract.

CO2.03 accounted for \$9,600 of the change order and will be funded by the Water Utility Fund.

Manhole/Gate Valve Adjustments – Hartman Circle (CO2.04)

In order to maintain emergency access to water, sanitary sewer, and storm sewer utility structures in the roadway along Hartman Circle over the winter, the Contractor was directed by staff to adjust all utility structures in the roadway to the grade of the first bituminous pavement lift.

When construction resumed in May 2023, the Contractor performed additional adjustments to the roadway utility structures along Hartman Circle to achieve the grade of the final lift of bituminous pavement per the contract. Where applicable, the Contractor utilized riser rings as a cost-effective means to adjust roadway utilities without the need for additional excavation and patching.

CO2.04 accounted for \$6,476 of the change order and will be funded by a combination of the Sanitary Sewer and Water Utility Funds.

Vision Statement

Bituminous Base and Wear Course (CO2.05)

Due to the construction delays as previously discussed, the Contractor was only able to install the initial bituminous pavement lift along Hartman Circle during the 2022 construction season. The remaining wear course lift and all paving operations on the remaining project streets were completed in May/June 2023.

Final quantities for wear and base courses exceeded the base contract quantities, with an overrun of 18% and 13% for wear course and base course, respectively. These values do not vary substantially from a typical +/- 15% tolerance for bituminous paving operations along rehabilitated streets. This tolerance in paving tonnage can primarily be attributed to variations in the existing curb profiles that prevent a consistent depth of mat installation as well as minor areas discrepancies from the use of aerial satellite data in lieu of preliminary topographical survey data.

CO2.05 accounted for \$48,902 of the change order and will be funded by the Street Improvement Fund.

Subgrade Preparation (CO2.06)

Subgrade preparation is a contract item included with the City's street rehabilitation projects that encompasses the final grading of the roadway base in preparation for bituminous pavement. Payment for subgrade preparation is made based upon the length of roadway base graded, measured in road stations (RDST).

The total quantity for subgrade preparation across all project streets was accurately reflected in the construction plan (46.32 RDST) but was misrepresented with the base contract bidding (16.42 RDST). CO2.06 would adjust the base contract to include the remaining subgrade preparation quantity and match the total quantity as reflected in the construction plan.

CO2.06 accounted for \$16,146 of the change order and will be funded by the Street Improvement Fund.

Concrete Curb and Gutter Spot Replacement (CO2.07)

Spot removal and replacement of existing concrete curb and gutter is included with the City's street rehabilitation projects as a means to address severely damaged curb and gutter and surface drainage issues that can accelerate roadway deterioration. During construction, staff identified a need for additional spot replacement of concrete curb and gutter to address severely damaged sections along 71st Way and Riverview Terrace. As directed by staff, the Contractor completed the additional spot curb and gutter replacement in May 2023.

CO2.07 accounted for \$8,748 of the change order and will be funded by the Storm Water Utility Fund.

Vision Statement

Financial Impact

Funding for this project is derived from a combination of Municipal State Aid street funding, utility CIP funds (water, sanitary sewer and storm sewer) and special assessments. The amount of this change order exceeds the normal project allowance of 5% but is within budget for the project.

Recommendation

Staff recommend the approval of Resolution No. 2023-69.

Title

Resolution No. 2023-70, Authorizing a Safe Streets and Roads for All Grant Application to Create a Safe Action Plan

Background

The "Safe Streets and Roads for All" is a competitive federal grant that provides local governments funding to create comprehensive safety action plans to address and prevent traffic fatalities. Between 2017-2021, there were 12 fatal motor vehicle crashes in Fridley and 107 motor vehicle crashes involving a pedestrian, bicycle, or motorcycle of which eight were noted to be fatal.

This grant will allow the City of Fridley (City) to conduct a full multi-modal roadway safety analysis to determine underlying issues within its transportation network and then strategically prioritize projects to address those issues within the context of risk, equity, and existing transportation plans. By creating this plan, the City will be positioned to apply for future grants to implement identified projects. Grant funds will be used to hire a consultant to assist in the creation of the safety action plan.

Financial Impact

The estimated project cost is \$265,150. The City's application is for the maximum percentage of project costs (80%) equaling \$212,128. The City will be required to provide the remaining 20% match.

1. Supports the pursuit of Safe Streets For All (SS4A) Discretionary Program funding and authorizes staff to prepare and submit the necessary application materials.

Resolution No. 2023-74, Awarding 53rd Avenue Roundabout Safety Project No. ST2023-22

Background

On Thursday, June 15 at 1:00 p.m., bids were publicly opened online via the virtual platform available on QuestCDN and Microsoft Teams for the 53rd Avenue Roundabout Safety Project No. ST2023-22. Four responsive bids were received.

The City of Fridley's (City) Capital Investment Plan includes street rehabilitation and safety improvements on 53rd Avenue from Central Avenue (Trunk Highway 65) to 1,200 feet to the west. The total project length is approximately a quarter mile. On 53rd Avenue, for this portion of the roadway, it is shared between the City and city of Columbia Heights. On August 10, 2020 a Joint Powers Agreement between the City and Columbia Heights was fully executed by the Fridley City Council (Council) and the Columbia Heights City Council. Both cities were successful in applying for funding under MnDOT's Highway Safety Improvement Program (HSIP), which will fund up to 90% of estimated construction.

Proposed street rehabilitation will include asphalt milling and asphalt removal, asphalt paving, and concrete curb and gutter spot replacement. The existing pavement east of the proposed roundabout will receive a two-inch mill and asphalt overlay. Spot replacement of concrete curb and gutter will only occur along segments that are severely damaged, settled, or restrict the conveyance of storm water.

In addition to the pavement improvements proposed along 53rd Avenue, the project also includes safety improvements including a continuous concrete safety barrier median to eliminate left turning conflicts and will provide access to and from adjacent businesses through a roundabout. The existing pavement in this section would be removed and new travel lanes would be constructed through the roundabout.

No planned water main improvements with this project. Sanitary sewer and storm sewer improvements will include minor work for manhole and inlet adjustments as well as casting replacement, if necessary, in conjunction with roadway paving operations. The existing system structures are generally in good condition and are expected to exceed the service life of the proposed pavement rehabilitation. New storm catch basins and manhole structures will be required as part of the concrete curb and gutter relocation for the construction of the roundabout.

Vision Statement

We believe Fridley will be a safe, vibrant, friendly and stable home for families and businesses.

As noted, four bids were received. The low bid was received from Forest Lake Contracting, Inc. of Forest Lake, Minnesota in the amount of \$1,384,132, which is 5.1% above the final engineer's estimate of \$1,316,489 (Exhibit A). The second and third lowest bids were \$1,627,540.00 and \$1,647,806.11. Of the four bids, the high bid received was \$1,822,173.08.

The City has worked with Forest Lake Contracting, Inc. in the past. Most recently, Forest Lake Contracting, Inc was a subcontractor for the City's West Moore Lake Drive Trail and Street Resurfacing project that was constructed in 2019, where they installed the pedestrian light bollards near Fridley High School. Staff believe they are a knowledgeable and reputable contractor and will deliver the project within the requisite quality specified in the bid documents.

Based on the low bid, special assessments are expected to be within projections. Property owners will receive notification of project advancement this July presuming the Council awards the project at this meeting. A project information sheet will provide a tentative work schedule, work description and contact information. During the project, staff will distribute weekly project updates via email and the project-specific page on the City's website to minimize disruption to the residents. We expect the work to begin in July with substantial completion in October of this year.

Financial Impact

Funding for this project is derived from several sources including MnDOT's Highway Safety Improvement Program (HSIP) Grant, the City of Columbia Heights through a cost-share project Joint Powers Agreement, Minnesota State Aid Street funding, special assessments and Utility CIP funds (water, sanitary sewer, and storm sewer).

Interim Ordinance No. 1408, Authorizing a Study and Imposing a Moratorium on the Sale of Cannabinoid Products (Reconsideration and Approval)

Background

On June 12, 2023, the Fridley City Council (Council) directed staff to provide the Council with actions that would result in the City of Fridley (City) allowing businesses that are currently selling products authorized under Minnesota Statutes, section 151.72 (e.g., edibles/gummies, beverages, and external application products containing tetrahydrocannabinol (THC)) (151 Hemp Products) to continue doing so and to establish a licensing framework for the 151 Hemp Products.

Also on June 12, 2023, the Council voted to enact Interim Ordinance No. 1408, which temporarily prohibits the sale of any product containing THC within the City. Interim Ordinance 1408 is set to be effective on June 30, 2023.

To allow businesses currently selling 151 Hemp Products to continue to do so, the Council can "reconsider" its approval of Interim Ordinance No. 1408 prior to its effective date. Doing so will delay the effective date of the ordinance from June 30, 2023 to July 14, 2023, but will allow businesses to continue selling 151 Hemp Products and will also allow the City to enact a licensing ordinance for the sale of 151 Hemp Products without impacting the ordinance. Additional information on reconsidering Interim Ordinance No. 1408 can be found in the attached memo: Hemp and Cannabis Business Moratoria and Licensing.

The memo also addresses adopting licensing for 151 Hemp Products, which is on tonight's agenda as found in Ordinance No. 1410, as well as a separate Interim Ordinance No. 1411 (attached) that will supplement the current Interim Ordinance No. 1408 and is related to businesses selling cannabis (i.e., non-hemp) THC products that can be considered at the City Council meeting on July 10, 2023.

Interim Ordinance No. 1408

Authorizing a Study and Imposing a Moratorium on the Sale of Cannabinoid Products

The City Council of the City of Fridley does ordain, after review, examination and staff recommendation that a moratorium on cannabinoid products be enacted as follows:

Section 1. Purpose

The Fridley City Council (Council) finds that an interim ordinance placing a moratorium on the retail sale of cannabinoids is necessary to protect the health, safety general welfare of the citizens of the City of Fridley (City).

The City further finds that an ordinance establishing a moratorium on the retail sale of cannabinoids will allow the City time to study the issue and determine what, if any, additional licensing and/or regulations for these cannabinoid products are appropriate.

Section 2. Definitions

Cannabinoids: any product containing tetrahydrocannabinol (THC), tetrahydrocannabinol acetate (THC-O), Tetrahydrocannabivarin (THC-V), hexahydrocannabinol (HHC), tetrahydrocannabiphorol (THC-P or THC-Heptyl), tetrahydrocannabioctyl (THCjd), tetrahydrocannabihexol (THC-H), and cannabinol (CBN). This term excludes products that are not intended to be eaten or consumed by humans or that are marketed as being a cannabidiol (CBD) product which contains less than 0.3% of any tetrahydrocannabinol (THC) by dry weight.

Trace amount: a product that contains no more than a trace amount of THC if the manufacturer is not required by any State or Federal law to identify the amount of any tetrahydrocannabinol on the product label or the product label indicates the product contains less than 0.3% of any tetrahydrocannabinol by dry weight.

Section 3. Legislative Findings

1. There is a great deal of uncertainty regarding the effect of Minnesota Laws 2022, Chapter 98 amending M.S. § 151.72 (Act) to allow the sale of certain cannabinoid products.

2. Because the proposal to allow the sale of cannabinoids received little publicity until the Act went into effect on July 1, 2022, the City did not have an opportunity to study and consider the potential impacts of the Act on the City. Nor did the Council have sufficient time to engage in policy discussions regarding the regulations the Council may elect to impose on the sale of cannabinoids and now wishes to do so to ensure responsible and adequate regulations are implemented.

3. The Act authorizes the Minnesota Board of Pharmacy to enforce the Act, but the Act does not provide for any licensing of manufacturers or of those who sell cannabinoids. The Act is also silent regarding the enactment of local regulations related to cannabinoids.

4. The Legislature did not expressly prohibit or limit local regulations, and the regulations established in the Act clearly do not constitute the Legislature having occupied the field of regulation regarding the sale of cannabinoids.

5. The Council finds the uncertainties associated with sale of cannabinoids, and the options for local regulation compels the need for a study to develop information the Council can rely on as it engages in policy discussions related to potential regulation of cannabinoids through the adoption of licensing and zoning controls.

6. Pursuant to M.S. § 462.355, subd. 4(a), the Council is authorized to adopt an interim ordinance "to regulate, restrict, or prohibit any use...within the jurisdiction or a portion thereof for a period not to exceed one year from the date it is effective."

7. The Council is also authorized as part of its general police powers to adopt business licensing requirements related to the sale of cannabinoids.

8. The Minnesota Supreme Court in *Almquist v. Town of Marshan*, 245 N.W.2d 819 (Minn. 1976) upheld the enactment of a moratorium despite the lack of express statutory authority as being a power inherent in a broad legislative grant of power to municipalities. In most cases, the enactment of business licensing requirements is based on a city's police powers, which is the broadest grant of power to cities. Inherent in that broad grant of authority is the power to temporarily place a moratorium on a business activity to study and potentially implement licensing regulations on that business activity.

9. There are both business licensing and zoning issues associated with the sale of cannabinoids that the Council determines it needs time to study in order to consider the development and adoption of appropriate local regulations. In order to protect the planning process and the health, safety, and welfare of the residents while the City conducts its study and the Council engages in policy discussions regarding possible regulations, the Council determines it is in the best interests of the City to impose a temporary moratorium on the sale of cannabinoids.

10. The City anticipates considering enacting a licensing framework for certain products containing cannabinoids authorized under M.S. § 151.72 and a separate moratorium on the establishment or operation of cannabis businesses as authorized under M.S. § 342.13 (e) and intends the actions in this Ordinance to be unaffected and continue in unison with the adoption of such licensing ordinance or moratoria unless explicitly stated otherwise.

Section 4. Study

City staff will conduct a study regarding cannabinoids and provide the Council a report on the potential regulations of such products. The report must include the staff's recommendations on whether the Council should adopt regulations and, if so, the recommended types of regulations. The study will consider, but is not limited to, the following:

1. The potential impacts of the sale of cannabinoids within the City;

2. Licensing the sale of cannabinoids and related regulations; and

3. Zoning regulations related to the sale, manufacture, and distribution of cannabinoids as uses within the City.

Section 5. Moratorium

A moratorium is hereby imposed to prohibit any business, person, or entity from offering for sale or selling cannabinoids to the public within the jurisdictional boundaries of the City. The City will not accept, process, or act on any application, site plan, building permit, or other zoning approval for a business proposing to engage in the sale of cannabinoids.

Section 6. Exceptions

This moratorium does not apply to the selling of products containing THC related to the Medical Cannabis Program as administered by the Minnesota Department of Health, provided that such activity is done in accordance with the regulations and laws of Minnesota regarding Medical Cannabis.

This moratorium does not apply to the sale of edible cannabinoid products or nonintoxicating cannabinoids authorized under M.S. § 151.72 by businesses lawfully selling edible cannabinoids products or nonintoxicating cannabinoids authorized under M.S. § 151.72 prior to the effective date of this Ordinance.

However, nothing in this Ordinance exempts a business, person, or entity from complying with all other requirements and prohibitions of applicable laws and ordinances related to such exemptions.

Section 7. Violations

During the term of the moratorium, it is a violation of this Ordinance for any business, person, or entity to offer for sale, or to sell cannabinoid products within the City.

Section 8. Enforcement

A violation of this Ordinance is a misdemeanor. In addition, the City may enforce this Ordinance by mandamus, injunction, other appropriate civil remedy in any court of competent jurisdiction,

or through the City's administrative penalties program under Section 203.05 of the Fridley City Code (Code).

Section 9. Severability

Every section, provision, and part of this Ordinance is declared severable from every other section, provision, and part of this Ordinance. If any section, provision, or part of this Ordinance is held to be invalid by a court of competent jurisdiction, such judgment will not invalidate any other section, provision, or part of this Ordinance.

Section10. Effective Date and Term

This Ordinance will have a term of 12 months. This Ordinance will remain in effect until June 30July 14, 2024, or until it is expressly repealed by the Council or until the effective date of an ordinance amending the Code to address the sale of cannabinoid products, whichever occurs first. Unless explicitly provided otherwise, this Ordinance will not terminate upon the effective date of a licensing ordinance related to the sale of edible cannabinoid products and nonintoxicating cannabinoids authorized under M.S. § 151.72 or the effective date of an interim ordinance related to the establishment or operation of cannabis businesses as authorized under M.S. § 342.13 (e).

Section 11. Notice

This Ordinance has been published to clearly inform the public of the intent and effect of the Council. A copy of this Ordinance is available for inspection by any person during regular business hours at the office of the City Clerk at Fridley City Hall (7071 University Ave N.E.).

City of Fridley Summary Interim Ordinance No. 1408

Authorizing a Study and Imposing a Moratorium on the Sale of Cannabinoid Products

The City of Fridley does ordain, after review, examination and staff recommendation that a moratorium on cannabinoid products be enacted. A summary of the moratorium made by Interim Ordinance No. 1408 is as follows:

Section one of the ordinance declares that the Fridley City Council (Council) finds that a moratorium on the retail sale of cannabinoid products is necessary to protect the health, safety and welfare of citizens. Section two defines "cannabinoids" and "trace amount." Section three summarizes the State legislature's changes to Minnesota Statute § 151.72 to allow for the sale of certain cannabinoid products and summarizes the Council's authority to enact such a moratorium pursuant to State law. Section four authorizes a study of the issue to gauge impacts to the City, licensing and business regulations and zoning regulations. Section five imposes a moratorium. Section six provides exceptions to the moratorium for business selling products related to the Medical Cannabis Program and for businesses selling edible cannabinoid products authorized under Minnesota Statutes § 151.72 prior to July 14, 2023. Section seven declares it a violation of the ordinance for any business or person to sell cannabinoids within the City. Section eight declares any violation of the ordinance is a misdemeanor. Section nine declares every section of the ordinance to be separate from any other section. Section 10 establishes a 12-month term for the moratorium, which will expire June 30 July 14, 2024, or sooner and clarifies that the moratorium will not expire or terminate if the City adopts licensing related to edible cannabinoid products or an interim ordinance related to cannabis busineesses. Section 11 declares that the ordinance was properly notices to the public as required by State law and the City Charter.

Ordinance No. 1408 was passed and adopted by the City Council of the City of Fridley on June <u>1226</u>, 2023. The full text of the Ordinance is available on the City website or for inspection by any person during regular office hours at the Office of the City Clerk.

On June 12, 2023, the City Council adopted an interim ordinance establishing a moratorium on certain products that contain tetrahydrocannabinol ("THC"). The City Council also directed staff to present further options for the Council to consider with respect to businesses that were legally selling edibles and beverages authorized under Minnesota Statutes Section 151.72 ("151 Hemp Products") prior to the effective date of the moratorium that would allow those businesses to continue selling those products. The City Council also directed staff to draft a licensing ordinance for its consideration for 151 Hemp Products.

Based on Council direction, our recommendation is for the Council to take three actions:

- 1) Amend the current interim ordinance to:
 - a. Explicitly exempt businesses currently selling 151 Hemp Products to continue doing so; and
 - b. Provide that the interim ordinance will not automatically terminate if the City adopts a licensing ordinance for 151 Hemp Products or a moratorium on cannabis businesses businesses that will be licensed by the state to sell cannabis products including edibles, beverages, flower and other statutorily authorized products ("Cannabis Businesses").
- 2) Consider adopting a licensing ordinance for businesses that were legally selling 151 Hemp Products prior to the effective date of the interim ordinance. The licensing ordinance would require these businesses to apply for a city license in order to be able to continue to operate. The first reading of the licensing ordinance is on the agenda for the June 26, 2023, City Council meeting.

3) Adopt a second interim ordinance, as authorized under the recently signed Cannabis Act, that specifically prohibits Cannabis Businesses and that may be effective until January 1, 2025. Staff propose having the first reading on July 10, 2023.

I. <u>Impact of Three Proposed Actions</u>

A) Amend the Current Interim Ordinance

The current interim ordinance applies to sales of all products that contain THC except for any products that contain trace amounts of THC and are marketed as a CBD product.

The proposed amendment would allow the current "umbrella" prohibiting THC products to stay in place but would allow the City to specifically enact licensing of 151 Hemp Products and enact a moratorium on Cannabis Businesses in other actions without impacting the umbrella.

Amending the interim ordinance on June 26, 2023, will result in the effective date being delayed until July 14, 2023. The interim ordinance will only be effective for 12 months, until July 14, 2024.

B) Adopt 151 Hemp Product Licensing Ordinance

Adopting a licensing ordinance for businesses selling 151 Hemp Products would provide the City with the ability to regulate the sale of 151 Hemp Products in the City until March 1, 2025.

During the period of the moratorium in Section A, the only businesses that could apply for a license are those businesses that were legally selling 151 Hemp Products prior to July 14, 2023.

However, after July 14, 2024, or sooner if the moratorium is sooner repealed by the City, any business that meets the definition of a hemp products shop or tobacco products shop would be able to apply for a license that could last until March 1, 2025.

The City should hold a public hearing prior to adopting the licensing ordinance since the proposed licensing ordinance contains provisions that could be considered to be "zoning" in nature (e.g., requiring distance from particular uses).

C) Adopt Cannabis Business Moratorium

The Act authorizes an extended moratorium that may last until January 1, 2025, which is longer than the normal one-year timeline for other moratoria, to temporarily prohibit Cannabis Businesses from establishing or operating within the City.

A public hearing is required prior to adoption of a Cannabis Business moratorium.

Staff recommend holding the first reading on the Cannabis Business Moratorium on July 10, 2023. No official action is required on June 26, 2023.

II. Actions on June 26, 2023

- A) Amending the Interim Ordinance
 - a. Move to suspend Rosenberg's Rules of Order's rule regarding "reconsideration" to allow reconsideration at a subsequent meeting. *Requires a 2/3rds Vote*.
 - b. Move to reconsider the action on June 12, 2023. Requires a majority vote.
 - c. Move to approve the Interim Ordinance, as amended.
- B) Approve the First Reading of the Licensing Ordinance

Interim Ordinance No. 1411

Authorizing a Study and Imposing a Moratorium on the Establishment and Operation of Cannabis Businesses Within the City of Fridley

The City Council of the City of Fridley does ordain, after review, examination and staff recommendation that a moratorium on cannabis businesses be enacted as follows:

Section 1. Legislative Findings and Authority

1. The Minnesota Legislature recently enacted, and the Governor signed, 2023 Minnesota Session Laws, Chapter 63 – H.F. No. 100 (Act), which is comprehensive legislation relating to cannabis including, but not limited to, the establishment of the Office of Cannabis Management (OCM), legalizing and limiting the possession and use of cannabis and certain hemp products by adults, providing for the licensing, inspection, and regulation of cannabis and hemp businesses, taxing the sale of cannabis flower, cannabis products, and certain hemp products, establishing grant and loan programs, amending criminal penalties, providing for expungement of certain convictions, and providing for the temporary regulation of Edible Cannabinoid Products and Nonintoxicating Cannabinoids.

2. The Act provides local units of government certain authority related to Cannabis Businesses, including the authority to (i) require local registration of certain Cannabis Businesses operating retail establishments, (ii) adopt reasonable restrictions on the time, place, and manner of the operation of Cannabis Businesses, provided that such restrictions do not prohibit the establishment or operation of a Cannabis Business, (iii) limit the number of certain Cannabis Businesses based on the population of the community, and (iv) prohibit the operation of a Cannabis Business within 1,000 feet of a school, or 500 feet of a day care, residential treatment facility, or an attraction within a public park that is regularly used by minors, including a playground or athletic field.

3. The Act requires the OCM, which was established effective July 1, 2023, to work with local governments to develop model ordinances for reasonable restrictions on the time, place, and manner of the operation of Cannabis Businesses. The Act also requires the OCM to establish additional rules and regulations relating to the operation of Cannabis Businesses. It is anticipated that the City of Fridley (City) will benefit from reviewing and analyzing the OCM's model ordinances, rules and regulations before making any decisions related to the regulation of Cannabis Businesses in the City.

4. The Act (Minnesota Statutes (M.S.) § 342.13(e)) expressly allows a local unit of government that is conducting studies or has authorized a study to be conducted or has held or scheduled a hearing for the purpose of considering adoption or amendment of reasonable restrictions on the time, place and manner of the operation of Cannabis Businesses to adopt an interim ordinance applicable to all or part of its jurisdiction for the purpose of protecting the planning process and the health, safety, and welfare of its citizens. The interim ordinance may regulate,

restrict, or prohibit the operation of Cannabis Businesses within the jurisdiction or a portion thereof until January 1, 2025.

5. Given the uncertainty regarding the model ordinances to be developed by the OCM and the broad scope of the changes to Minnesota law brought about by the Act, the Fridley City Council (Council) desires to adopt an interim ordinance for the purpose of protecting the planning process and the health, safety, and welfare of its citizens.

6. The Council desires to conduct a study for the purpose of considering the adoption or amendment of reasonable restrictions on the time, place and manner of the operation of Cannabis Businesses as well as the other regulations local units of government may adopt under the Act.

7. On July 10, 2023, after providing at least 10 days published notice, the Council held a public hearing regarding the consideration and adoption of an interim ordinance prohibiting the operation of Cannabis Businesses within the City until January 1, 2025.

Section 2. Definitions

Act: 2023 Minnesota Session Laws, Chapter 63 (H.F. No. 100).

Cannabis Business: the meaning given the term in M.S. § 342.01, subd. 14.

City: City of Fridley, a Minnesota municipal corporation.

Edible Cannabinoid Product: has the meaning given the term in M.S. § 151.72, subd. 1(f).

Nonintoxicating Cannabinoid: has the meaning given the term in M.S. § 151.72, subd 1(k).

OCM: the Office of Cannabis Management, established as set forth in M.S. § 342.02, subd. 1.

Ordinance: this interim ordinance, which is adopted pursuant to M.S. § 342.13(e).

Section 3. Study Authorized

The Council hereby authorizes and directs City staff to conduct a study regarding the adoption or amendment of reasonable restrictions on the time, place, and manner of the operation of Cannabis Businesses, as well as other potential local regulations allowed under the Act, and report to the Council on the potential regulation of Cannabis Businesses. The study may include a review of any model ordinances that OCM is directed to draft under M.S. § 342.13(d), an analysis of potential setback regulations allowed under M.S. § 342.13(c), and such other matters as staff may determine are relevant to the city council's consideration of this matter. The report may also include City staff's recommendations on whether the Council should adopt regulations and, if so, the recommended types of regulations.

Section 4. Moratorium

A moratorium is hereby imposed on the operation of any Cannabis Business within the City. During the term of this Ordinance, no business, person, or entity may establish or operate a Cannabis Business within the jurisdictional boundaries of the City. Accordingly, during the period that this Ordinance is in effect, the City shall not accept, process, or act on any application, site plan, building permit, zoning request, or other approval, including any requested confirmation, certification, approval, or other request from the OCM or other governmental entity requesting City review of any application or proposal for a business proposing to engage in the operation of a Cannabis Business. During the term of the moratorium, it is a violation of this Ordinance for any business, person, or entity to establish or operate a Cannabis Business within the City.

Section 5. Exceptions

The moratorium imposed by this Ordinance does not apply to: (i) the continued operation of a duly established business as part of the Medical Cannabis Program administered by the Minnesota Department of Health; or (ii) the sale of Edible Cannabinoid Products and Nonintoxicating Cannabinoids, provided, however, that nothing in this Ordinance exempts a business, person, or entity from complying with all other requirements and prohibitions of applicable laws and ordinances related to such exceptions. For example, as of the effective date of this Ordinance, the sale of certain cannabinoids is currently prohibited within the City pursuant to Interim Ordinance 1408 and the City requires a license to sell certain Edible Cannabinoid Products and Nonintoxicating Cannabinoids pursuant to the Hemp THC Products Chapter of the Fridley City Code (Code).

Section 6. Enforcement

Violation of this Ordinance is a misdemeanor. The City may also enforce this Ordinance by mandamus, injunction, or other appropriate civil remedy in any court of competent jurisdiction. A violation of this Ordinance is also subject to the City's general penalties prescribed in the Code and may further result in the City reporting violations to the OCM, if relevant to OCM licensing. The Council hereby authorizes City staff and consultants to initiate any legal action deemed necessary to secure compliance with this Ordinance.

Section 7. Severability

Every section, provision, and part of this Ordinance is declared severable from every other section, provision, and part. If any section, provision, or part of this Ordinance is held to be invalid by a court of competent jurisdiction, such judgment shall not invalidate any other section, provision, or part of this Ordinance.

Section 8. Effective Date and Term

This Ordinance shall become effective on August 11, 2023. This Ordinance will remain in effect until January 1, 2025, or until the Council expressly repeals it, whichever occurs first.

Ordinance No. 1410, Amending the Fridley City Code to Add Chapter 310, Hemp THC Products and Amend Chapter 209, Fees

Background

On June 12, 2023, the City Council directed staff to draft a licensing ordinance to regulate the sale of edibles/gummies, beverages, and products that are meant for external application and which contain tetrahydrocannabinol (THC) and which are authorized under Minnesota Statutes § 151.72 (151 Products).

The proposed ordinance allows businesses that meet the definition of a tobacco products shop or the proposed City-defined "Hemp THC Product Shop" to apply for a license from the City to sell 151 Products. Tobacco products shops and hemp products shops are unique in that they are required to have an entrance directly to the outside, prohibit persons under the age of 21 from entering without being accompanied by someone who is 21 years of age, and which meet certain gross revenue requirements. For tobacco products shops, 90% of revenue must be from the sale of tobacco products and for Hemp THC Product Shops, 90% of revenue must be from 151 Products.

The proposed ordinance limits the number of licenses that the City may issue to six and prohibits issuing a license within 400 feet of a public or private elementary, middle, or high school, or state-licensed child or day care program with more than 10 children.

The proposed ordinance is drafted to exist in unison with the City's interim ordinance establishing a moratorium on the sale of cannabinoids and will not impact the moratorium.

This Code amendment creates a Hemp THC Product license, which will be issued upon successful completion of an application and background investigation. As with all other City licenses, this license will be an annual license that expires April 30. If a licensee chooses to renew their license

they must submit a renewal application. This Chapter of the Code will be repealed in March of 2025 when M.S. 151.72 is repealed and no longer exists.

Amending the Fridley City Code to Add Chapter 310, Hemp THC Products and Amend Chapter 209, Fees

The City Council of the City of Fridley does ordain, after review, examination and staff recommendation that the Fridley City Code be amended as follows:

Section 1

That the Fridley City Code be hereby amended by adding Chapter 310, Hemp THC Products as follows:

Fridley City Code Chapter 310 Hemp THC Products

310.01 Purpose

The purpose of this Chapter is to establish regulations for the sale of edible cannabinoid products and nonintoxicating cannabinoids, as authorized in Minnesota Statues (M.S.) § 151.72, in the City of Fridley (City). The Fridley City Council (Council) finds as follows:

<u>1. The Minnesota Legislature's decision to amend Minnesota Statutes § 151.72 to expressly</u> <u>allow the sale of certain products derived from hemp, some of which contain</u> <u>tetrahydrocannabinol (THC), created a regulatory gap regarding the licensing and sale of</u> <u>products allowed to be sold under M.S. § 151.72 (Hemp THC Products).</u>

2. The City recognizes that, based on the most reliable and up-to-date scientific evidence, the largely unregulated Hemp THC Products presents a potential threat to the public health, safety, and welfare of the residents of the City.

<u>3. The City has the opportunity to make decisions that will mitigate this threat, reduce exposure of young people to Hemp THC Products, curtail the marketing of Hemp THC Products to young people, and improve retailer compliance with existing laws related to Hemp THC Products.</u>

<u>4. A local regulatory system for retailers of Hemp THC Products is appropriate to ensure that</u> such retailers comply with laws and business standards of the City to protect the health, safety, and welfare of youth and other vulnerable residents.

5. M.S. § 151.72 requires Hemp THC Product retailers to check the identification of purchasers to verify that they are at least 21 years of age, comply with certain packaging and labeling requirements to protect children and youth, and meet certain potency and serving size requirements.

<u>6. State law does not preempt municipalities from adopting and enforcing local ordinances to regulate retailers of Hemp THC Products</u> including, but not limited to, business licensing

requirements. The Governor signed HF100/SF73 (Cannabis Act) on May 30, 2023, which provides a framework for adult-use cannabis in the State of Minnesota, and also provides that M.S. § 151.72 will automatically repeal on March 1, 2025.

7. The Cannabis Act provides a transition period between Hemp THC Products and other similar products authorized under the Cannabis Act, and the City finds that it is prudent to enact a licensing framework for Hemp THC Products while the State of Minnesota develops and implements the permanent structure for licensing products authorized under the Cannabis Act.

8. A licensing requirement for retailers that desire to sell Hemp THC Products will not unduly burden legitimate business activities of such retailers who sell or distribute Hemp THC Products to adults but will allow the City to effectively regulate the operation of lawful businesses, limit access to persons under the age of 21 years and discourage violations of Hemp THC Product-related laws.

<u>9. Limiting the sale of Hemp THC Products to hemp products shops and to tobacco products shops in the best method for limiting access to persons under the age of 21 years.</u>

10. The Council finds that the sale of Hemp THC Products may lead to the creation of a nuisance situation that threatens the public welfare and limiting the number of licenses issued by the City is in the public interest to ensure that the sale of Hemp THC Products is done in accordance with applicable law, including M.S. § 151.72 and City requirements.

11. In making these findings and enacting this ordinance, it is the intent of the City to facilitate responsible retail activities associated with Hemp THC Products by allowing legal sale and access without promoting increases in use, and to discourage violations of hemp THC product-related laws, especially those which prohibit or discourage the marketing, sale or distribution of Hemp THC Products to persons under the age of 21 years.

310.02 Definitions

CBD: cannabidiol.

<u>CBD products: any edible cannabinoid product or nonintoxicating cannabinoid that is labeled and</u> marketed as a CBD product that contains no more than trace amounts of any tetrahydrocannabinol, that meets the requirements to be sold for human or animal consumption under M.S. § 151.72.</u>

Delivery sales: the sale of any hemp THC product to any person for personal consumption and not for resale when the sale is conducted by any means other than an in-person, over-the-counter sales transaction in a retail establishment. Delivery sale includes, but is not limited to, the sale of any Hemp THC Products when the sale is conducted by telephone, other voice transmission, mail, the internet, or app-based service. Delivery sale includes delivery by licensees or third parties by any means, including curbside pick-up. Edible cannabinoid product: has the meaning as given in M.S. § 151.72, subd. 1(f).

Hemp Products Shop: a retail establishment that:

1. Has an entrance door opening directly to the outside;

2. Greater than 90% of the retail establishment's gross revenue is from the sale of Hemp THC Products and CBD products, and in which the sale of other products is merely incidental;

<u>3. Prohibits persons under the age of 21 years from entering the establishment at any time</u> without being accompanied by someone who is at least 21 years of age; and

4. Is in compliance with all applicable provisions of this Code.

Hemp THC product: any edible cannabinoid product or nonintoxicating cannabinoid that is not a CBD product and that meets the requirements to be sold for human or animal consumption under M.S. § 151.72. The term does not include CBD products or medical cannabis as defined in M.S. § 152.22, subd. 6.

Labeling: has the meaning as given in M.S. § 151.72, subd. 1(i).

Moveable place of business: any form of business operated out of a kiosk, truck, van, automobile, or other type of vehicle or transportable shelter and not a fixed address storefront or other permanent type of structure authorized for sales transactions.

Nonintoxicating cannabinoid: as the same meaning as given in M.S. § 151.72, subd. 1(k).

Product label: has the same meaning given the term "label" in M.S. § 151.72, subd. 1(e).

THC: tetrahydrocannabinol.

Trace amount: a product is considered to have no more than a trace amount of THC if the manufacturer is not required by any federal or state law to identify the amount of any tetrahydrocannabinol on the product label or if the labeling provides that the product may contain residual or trace amounts of THC as part of the manufacturing process.

Self-service merchandising: open displays of Hemp THC Products in any manner where any person has access to the Hemp THC Products without the assistance or intervention of the licensee or the licensee's employee. Assistance or intervention means the actual physical exchange of the hemp THC product between the customer and the licensee or employee.

<u>Tobacco Products Shop: a retail establishment with a current tobacco license issued by the City</u> <u>that:</u> 1. Has an entrance door opening directly to the outside;

2. Prohibits persons under the age of 21 years from entering the establishment at any time;

3. Is in compliance with all applicable provisions of this Code; and

<u>4. Derives more than 90% of its gross revenue from the sale of tobacco, tobacco-related devices, and electronic delivery devices, as defined in M.S. § 609.685, and in which the sale of other products is merely incidental.</u>

5. The term does not include a tobacco department or section of any individual business establishment with any type of liquor, food, or restaurant license.

Vending machine: any mechanical, electric, or electronic, or other type of device that dispenses Hemp THC Products upon the insertion of money, tokens, or other form of payment directly into the machine by the person seeking to purchase the hemp THC product.

Youth oriented facility: a public or private elementary, middle, or high school, or a state-licensed child or day care program with more than ten children.

310.03 License

<u>1. Required. No person may directly or indirectly, or by means of any device, keep for retail</u> <u>sale, sell at retail, offer to sell, or otherwise dispose of Hemp THC Products at retail at any</u> <u>place in the City of Fridley without first having obtained a license from the City to do so.</u>

2. Eligibility. The City shall only issue a license to sell Hemp THC Products to a business gualified as a hemp Products shop or a tobacco products shop that complies with the requirements of this Chapter.

<u>3. Manufacturing Exception. No license is required under this chapter for the manufacturing of Hemp THC Products or the sale by a manufacturer of its products to resalers, provided the manufacturer does not sell Hemp THC Products directly to the public.</u>

4. CBD Products. No license is required under this Chapter to sell CBD products at a retail establishment within the City. Retail establishments selling CBD products may be subject to compliance checks as described in this Chapter. Retail establishments shall not include home occupations.

5. Total Number of Licenses. The total number of licenses issued to sell Hemp THC Products under this Chapter shall be limited to six.

310.04 Ineligible Places and Operations

The City will not issue a license under this Chapter to sell Hemp THC Products to any of the following:

<u>1. A business or operation that does not qualify as a Hemp THC Products Shop or a tobacco products shop;</u>

2. A business providing delivery sales of Hemp THC Products ;

3. A moveable place of business;

4. A vending machine;

5. A premises located within 400 feet of a Youth oriented facility. The distance to be measured in a straight line from the nearest point of building to building;

6. An operation on any premises on which taxes, assessments, or other financial claims of the City are delinquent and unpaid. If an action has been commenced pursuant to the provisions of M.S. Chapter 278, questioning the amount or validity of taxes, the Council may, on application by the licensee, waive strict compliance with this provision; no waiver may be granted, however, for taxes, or any portion thereof, which remain unpaid for a period exceeding one year after becoming due unless such one-year period is extended through no fault of the licensee; or

7. A business that is in violation of one or more provisions of the Code.

310.05 Application Procedures

1. Application for License; Granting of License. Application for a Hemp THC Product License must be made to the City Manager or their designee on a form provided by City, which must include the full name and address of the applicant, the location of the building to be occupied by the applicant in the conduct of the business, and such other information as the City Manager or their designee may require. If the City Manager or designee determines an application is incomplete, the City Manager will provide the applicant notice of the information necessary to make the application complete. The City may not process an application until it is made complete. Upon receipt of a completed application, the City Manager will forward the application to the Public Safety Department to conduct a background investigation.

<u>2. Fees.</u> No license will be processed or issued under this Chapter until the appropriate fees has been paid in full. The fees for a license under this Chapter are set forth in the Fees Chapter of the Code.

3. Background Investigation. The Police Department shall conduct a background check of the applicant and application, including a criminal history check pursuant to M.S. § 299C.72. The

investigation shall consider all facts and information bearing on the question of the applicant's fitness to receive the license and to perform the duties imposed by this Chapter. The City may conduct such other inspections, including an inspection of the premises, as it may determine are needed to verify the information in the application and regarding background of the application and any manager or agent. Failure of an applicant to allow an inspection is grounds for denial of the license. The results of any investigation must be submitted to the City Council prior to action on the application.

4. License Decision. The Council may grant or deny a license application. The Council may also continue its consideration of a license if it determines it needs additional information before making its decision. Any of the following are grounds for denial of a license.

(a) The business does not qualify as a THC Hemp Products Shop or a tobacco products shop.

(b) The applicant is under the age of 21 years old.

(c) The applicant has been convicted within the past five years of any violation of a federal, state, or local law, ordinance provision, or other regulation relating to Hemp THC Products or the operation of the licensed premises.

(d) The applicant has had a license to sell Hemp THC Products suspended or revoked during the 12 months preceding the date of application, or the applicant has or had an interest in another premises authorized to sell Hemp THC Products, whether in the City or in another jurisdiction, that has had a license to sell Hemp THC Products suspended or revoked during the same time period, provided the applicant had an interest in the premises at the time of the revocation or suspension, or at the time of the violation that led to the revocation or suspension.

(e) The applicant provides false or misleading information. Any false statement on an application, or any willful omission of any information called for on such application form, shall cause an automatic refusal of license, or if already issued, shall render any license issued pursuant thereto void and of no effect upon written notice of the City.

(f) The proposed location does not meet all applicable zoning requirements or requirements of this Chapter.

(g) The applicant is prohibited by federal or state law, local ordinance, or other regulation, from holding such a license.

(h) The applicant failed to provide information required by the application or provided false or misleading information.

(i) The proposed location constitutes an ineligible place or operation under this Chapter.

5. Term. All licenses issued under this chapter shall expire on March 1, 2025 unless it is revoked, suspended, or forfeited prior to that date.

<u>6. Non-Transferable. All licenses issued under this Chapter are valid only on the premises for which the license was issued and only for the person or business to whom the license was issued. The transfer of any license to another location, business, or person is prohibited.</u>

310.06 Operational Requirements

<u>1. License Display. All licenses must be posted and displayed in plain view of the general public</u> on the licensed premises.

2. Responsibility. All licensees under this Chapter are responsible for the actions of their employees in regard to the sale of Hemp THC Products on the licensed premises, and the sale of such an item by an employee shall be considered a sale by the license holder.

<u>3. Product Storage and Display. All Hemp THC Products must be stored either behind a counter or other area not freely accessible to customers, or in a locked case or other storage unit not left open and accessible to the general public.</u>

4. Age Posting. Notice of the legal sales age and age verification requirement must be posted prominently and in plain view at all times at each location where Hemp THC Products are offered for sale. The required signage must be posted in a manner that is clearly visible to anyone who is or is considering making a purchase.

5. Age Verification. A licensee's employees shall verify by means of government issued photographic identification that any purchaser of a Hemp THC Product is at least 21 years of age in accordance with M.S. § 151.72, subd. 5c.

<u>6. Sales. Hemp THC Products may only be sold in a direct face-to-face exchange between the licensee's employee and the consumer. The licensee's employees selling Hemp THC Products must be at least 21 years old. It is a violation of this Chapter for a licensee to give away, dispense, sell, or offer to sell any Hemp THC Product in a manner that violates any of the following:</u>

(a) To a person under the age of 21 years old. It will be an affirmative defense to the violation of this section for a person to have reasonably relied upon proof of age;

(b) Through the use of a vending machine or similar automated dispensing device;

(c) In a manner that does not comply with the requirements of M.S. § 151.72 including, but not limited to, the packaging, labeling, and other requirements provided by that section;

(d) At any location outside of the licensed premises;

(e) By self-service, or in open displays which are accessible to the public without the assistance or intervention of a store employee;

(f) By a mobile business, including but not limited to motorized vehicles, moveable sales kiosks, or trailers. Licenses must be issued to fixed location businesses only;

(g) By delivery sales;

(h) By any employee under the age of 21 years;

(i) To a visibly intoxicated person;

(j) By the means of providing samples of any Hemp THC Product free of charge or at a nominal cost; or

(k) To any other person, in any other manner or form prohibited by federal or state law or regulation, or by local ordinance.

7. Inspections. The premises licensed under this Chapter must be open to inspection by the City Manager or their designee during regular business hours for purposes of ensuring compliance with this Chapter.

<u>8. Revocation or Suspension. Any license issued under this Chapter may be revoked or suspended by the Council for a violation of any provision of this Chapter in accordance with this Chapter.</u>

<u>9. Training. Every licensee must implement a training program for employees regarding laws</u> relating to the sale of Hemp THC Products. Every licensee must certify that all employees have been trained to comply with federal, state and City regulations regarding the sale of Hemp THC Products within six months of the date a license is issued and within two weeks of hiring a new employee.

310.07 Other Prohibited Acts

1. Non-Compliant Products. No person may sell or offer for sale a product containing THC, including Hemp THC Products, that does not meet all the applicable requirements in M.S. § 151.72. This prohibition does not apply to a business that has a license issued by the Office of Cannabis Management, has registered with the City as required by M.S. § 342.22, and is otherwise is compliance with state and local laws regarding the sales of products containing THC.

2. Presumptions. Hemp THC Products must comply with the labeling requirements in M.S. § 151.72, subd. 5 and all other applicable labeling requirements. The City may presume, for the purposes of enforcing this Chapter, a Hemp THC Product being offered for sale or that is sold by a licensee has been tested by an independent lab as required in M.S. § 151.72, subd. 4 and that the information contained on the product label is accurate.

3. Purchase for Others. It is a misdemeanor violation of this Chapter for any person 21 years of age or older to purchase or otherwise obtain any Hemp THC Product on behalf of a person under the age of 21.

<u>4. Under Aged Persons. It is a petty misdemeanor for any person under the age of 21 to do any of the following:</u>

(a) To attempt to disguise their true age by the use of a false form of identification, whether the identification is that of another person has been modified or tampered with to represent an age older than the actual age of the person using that identification.

(b) To attempt to purchase Hemp THC Products.

5. Electronic Delivery Devices. Hemp THC Product Shops may not sell, give away, or otherwise furnish any electronic delivery device as defined in the Tobacco Product Shops Chapter of the Code.

310.08 Compliance Checks

The City may from time-to-time conduct unannounced compliance checks of establishments licensed under this Chapter and establishments selling CBD products. No person used in compliance checks may attempt to use a form of identification that misrepresents the person's age. All persons lawfully engaged in a compliance check must answer all questions about their age asked by the licensee or their employee, and produce any identification, if any exists, for which they are asked. The City will conduct a compliance check that involves the participation of a person at least 18 years of age, but under the age of 21 to enter the licensed premises to attempt to purchase the Hemp THC Products. Persons used for the purpose of compliance checks will be supervised by law enforcement or other designated personnel. Nothing in this Chapter will prohibit compliance checks authorized by state or federal laws for businesses manufacturing, storing, or selling Hemp THC Products under any applicable federal or state law. Persons used in compliance checks shall not be subject to the penalties and violations outlined in this Chapter.

310.09 License Actions

1. Basis for Action. The City may suspend or revoke a license issued under this Chapter for any of the following reasons:

(a) The applicant has been convicted within the past five years of any violation of a federal, state, or local law, ordinance provision, or other regulation relating to the licensed activity, or has had a license to sell Hemp THC Products revoked or suspended within the past five years;

(b) Fraud, misrepresentation, bribery, or incorrect statement contained in the application for license, or made in carrying on the licensed activity;

(c) Actions that are unauthorized or otherwise beyond the scope of the license granted;

(d) Violation of any federal, state or local regulation or provision related to Hemp THC Products;

(e) Failure to continuously comply with all conditions required as part of the license;

(f) Failure to comply with the applicable Zoning Chapters of the Code;

(g) Failure to pay an administrative penalty imposed by the Council; or

(h) The City discovers the license was mistakenly issued to a person, it will be revoked upon the discovery that the person was ineligible for the license under this Chapter.

2. Process. The City will provide a licensee at least 10 days' written notice of a hearing to be held before the Council on the potential suspension or revocation of its license. The licensee will be provided an opportunity to be heard at the hearing. If the Council acts to suspend or revoke the license, the City will provide the licensee a written notice of the period of suspension, or of the revocation. All sales of Hemp THC Products must cease during a suspension period or permanently upon revocation of the license.

310.10 Violation

Unless expressly indicated otherwise, a violation of this Chapter is a misdemeanor. The City may also impose administrative penalties as provided in the Appeals and Administrative Citations Chapter of the Code. Any administrative penalties may be imposed by the Council, or by administrative citation, and will be collected in accordance with this Code. Nothing in this section may prohibit the City from seeking prosecution as a misdemeanor for any alleged violation of this Chapter.

Section 2

That the Fridley City Code be hereby amended by updating Chapter 209, Fees as follows:
