Call to Order:


The meeting was called to order by Dr. Ralph Wiegman with a quorum present.

- I. Review Minutes – The last public health meeting was held May 9, 2022. Brenda Tirado motioned to approve minutes, seconded by Cassandra Roberson. All were in favor.
- II. Review of Quarterly Reports – The 3rd Quarter Report was reviewed by the committee and staff.
- III. Air Quality North Texas Presentation – Nick Van Haasen discussed the various sources that contribute to ozone formation and the health effects of ground-level ozone. Also, ozone monitoring sites and ozone design value trends were presented. He explained the two classifications of particulate matter and the harmful effects for public health and the environment. Tips were given on how we can take action to improve our air quality daily, as well as resources and list of programs we can join.
- IV. Air Quality Initiatives – Cindy Mendez discussed other initiatives that the city is working on such as the Air North Texas Partnership through the North Central Texas Council of Governments, using more electric vehicles and having charging stations throughout the city, increasing monitoring for Leak Detection at Gas Well Sites three times per year, participating in a regional cohort Greenhouse Gas Inventory, and Sustainability Planning.

V. Committee Comments – No comments were made by committee.

Adjournment – With no other questions or comments, Brenda Tirado motioned to adjourn. The motion was passed with all present voting yes. The meeting was adjourned at 7:52 pm.
