#### **MINUTES**

#### **CALL TO ORDER**

Chairperson Jeff Copeland called to order the City of Grand Prairie Finance and Government Committee convened at 2:33 p.m. on Tuesday, September 7, 2021, in the City Council Briefing Room, 300 West Main Street, Grand Prairie, Texas. The following persons were in attendance:

#### **STAFF PRESENTATIONS**

1. Purchasing: Best Value Criteria and Evaluations

Senior Buyer, Anda Upchurch, presented information on Best Value Criteria and Evaluation of bids. She discussed the various criteria used to make selections, as well as the process involved, including the formula used for scoring vendors and bids. Once bids are open, the Buyer instructs the evaluation team, usually the 'using' Department, to score each bid using the provided criteria. The scoring forms are then returned to the Buyer. The Vendors may protest the recommendation, and Ms. Upchurch also outlined the process. Ms. Upchurch also discussed Ratifications in case of emergencies, and Rejections, for example, if all bid prices exceed expectations.

Thirty year treated water purchase contract with the City of Midlothian with automatic 5-year renewals with initial volume rate of \$2.620 per 1,000 gallons with initial annual daily average demand being 1.33 MGD and initial maximum day demand is 2.0 MGD. Raw water rate will be \$1.25448 per 1,000 gallons

Public Works Director, Gabe Johnson presented information for Item 13. The new contract will replace the previous one, which included outdated information. He noted this Item

will be on the September 21, 2021, City Council Agenda.

Mr. Gabe Johnson presented information for Item 14. He noted that this Item is the second part of a previously approved Item. Item 14 is regarding additional easement for Stadium Drive.

Councilperson Cole Humphreys moved to approve Item 14, as presented. Councilperson Kurt Johnson seconded the motion. The motion passed 3-0.

Purchase of state mandated water well capping, plugging wells 13, 16, 19, 22, and 24, and pump and motor removal services at well 24 from Advanced Water Well Technologies in the amount of \$472,097.58 with a 5% contingency of \$23,604.88 for a total amount of \$495,702.46 through a Cooperative agreement with BuyBoard

Mr. Gabe Johnson presented information for Item 15. He stated that wells are rarely used and doing so creates issues with water chemistry. Wells are also expensive to maintain. More volume comes from Dallas. With upgraded water lines and pump station, the City will have more flexibility. The State of Texas has also mandated that the wells must be capped and not used other than in emergency situations.

Human Resources Director, Lisa Norris, presented information for Item 16. She stated that Item 16 is related to Item 4 on the Consent Agenda. Ms. Norris explained that Item 16 will ratify the current contract due to the cost exceeding the limit specified in the contract. The contract will end this month, but the ratification is needed to fulfill the current contract through this fiscal year. It will not be renewed.

Ms. Lisa Norris presented information for Item 17. She stated that Surgery Plus bundles costs of procedures and surgeries, which saves the City and employees money. The ratification is needed to fulfill the amount for the previous fiscal year, as well as approve a change order for the current fiscal year. Payments are now being made through purchase orders, which will help with tracking and notification when the limit is approaching. The new process should limit ratifications in the future.

Transportation Services Senior Traffic Engineer, Karyl DeVries, presented information for Item 18. Ms. DeVries stated that Item 18 addresses the engineering aspect of the project. The cost of the entire CMAQ (Congestion Mitigation and Air Quality) project is \$3,500,000. \$2,700,000 will be paid with state and federal funds. The amount specified in Item 18 is for professional engineering services that is a direct cost to the City.

Senior Building and Construction Projects Manager, Andy Henning, presented information for Item 19. Mr. Henning distributed renderings of the project to Committee members. Mr. Henning stated that Item 19 is regarding the added parcel of land created when the main entrance to Epic Central was relocated south. The amount specified in Item 19 will include the shell construction for the restaurants, as well as signage and wayfinding, including the large marquee sign. Mr. Henning clarified that \$4,750,000 is for the shell construction, and \$1,250,000 is for signage and marquee. He further

clarified that \$4,750,000 was in the current budget as a place holder for the shell structure for the original four planned restaurants. Ms. Cheryl De Leon, Budget Director Kathleen Mercer, and Treasury and Debt Manager, Brady Olsen, offered additional information on funding sources and a breakdown of the funding.

Mr. Gabe Johnson presented information for Item 21 and Item 22 in one discussion. Items 21 and 22 are regarding house purchase projects for storm water use. Historically, it is more cost effect to purchase the house rather than repair the issue, which is erosion in both issues for Items 21 and 22. City Attorney, Megan Mahan, stated that a policy is in place for house purchases.

Transportation Services Director, Walter Shumac, presented information for Item 23. This project is Phase 3 of the "Turnback Project." The specified section of Jefferson Street is currently asphalt and will be replaced with concrete. The project is necessary for Jefferson Street to withstand the redirected, heavier truck traffic. Mr. Shumac clarified that the requested \$543,175 is for professional engineering services. North Central Texas Council of Governments (NCTCOG) and Texas Department of Transportation (TxDOT) will fund construction costs.

Item 26 is requesting the funds be moved from Sports Corp to the City's CIP budget. Ms. Megan Mahan clarified that when the Committee approves an Item, any associated contract is also approved.

**RECOMMENDED ACTION:** Approve

#### **ANALYSIS:**

As we've grown the program offerings throughout our library system in the past several years, and reorganized staff to support this program emphasis, due to a lack of space, the program staff at the Main Library share office space in the Archive Room. As a result, the room is not ideally configured for optimum work, storage, and collaboration space. The space is dark, dated, ill-configured and lacks the basic cabinets and shelving needed to store the vast number of supplies and material the programmers use on a daily basis. The remodel includes adding worktables, a fourth workstation, better lighting, a wall dividing program and archive space, cabinets, enclosed shelving, reset ceiling fans and HVAC vents, windows, electrical and computer cabling. The Main Library program team conducts more than 1,500 programs and events, which are attended by more than 90,000 people a year. This is a busy crew working out of what is essentially a storage room now.

Komatsu Architects, who were most familiar with the Main Library's architecture, conducted the engineering and design and created the construction documents.

This project was approved during the FY2021-2022 budget process.

#### **ANALYSIS:**

Staff has determined that the tennis and pickleball courts at Friendship Park need outdoor lighting to better meet the demand of our citizens and users. Musco Lighting provided a BuyBoard price quote of \$94,211 to perform the work. Musco Lighting is a nationwide premier sports lighting company. The proposal includes a 25-year warranty, which exceeds all other sports lighting suppliers and the LED lighting will use up to 50% less energy compared to a standard lighting system.

Chapter 271.102 of the Local Government Code authorizes local governments to participate in a cooperative purchasing program with another local government or local cooperative organization. In place of competitive bidding, items and services may be purchased through such agreements as the sponsoring entity or agency has already bid the agreements. The City of Grand Prairie has master interlocal cooperative agreements with various entities, including BuyBoard.

The BuyBoard can save money by pooling the impressive purchasing power of its members, which include hundreds of school districts, municipalities, counties, other local governments, and nonprofits across Texas. They use the power of numbers as leverage to get better prices with the same vendors we use now.

This item was presented to the Finance and Government Committee on October 5, 2021 and received a recommendation for approval by City Council.

The Texas Commission on Environmental Quality (TCEQ) is requiring the City of Grand Prairie to begin field verification of all storm drainage point outfalls within a period of 5-years as part of its minimum control measure (MCM) agreement with TCEQ to control harmful discharges into the waters of the US. The City currently has a total of 1450 storm drainage outfall points to be inspected.

This contract provides for the first year of this outfall inspection and inventory effort. Plummer Associates will inspect 280 storm drainage outfall points as part of this contract providing for each outfall point detailed pictures, assessing the structural, erosion and sedimentation conditions, observing and documenting any potential environmentally hazardous discharges and providing notification of any immediate attention required to protect the cities storm drainage system and stormwater quality.

The contract study is anticipated to begin in October 2021 with completion anticipated in February 2022.

On April 6, 2021, the City Council awarded the Construction Manager at Risk (CMAR) contract to Hill & Wilkinson General Contractors for pre-construction services in the amount of zero dollars (\$0). The award provided for CMAR services including development of project estimates, preliminary construction schedules, value engineering proposals and constructability review during the completion of the design phase.

Current Change Order/Amendment No. 2 in the amount of \$111,953.02 is divided as follows: \$59,090.36 for site design/landscape coordination and site electrical infrastructure work associated with the introduction of a permanently located emergency generator to serve the Housing and Municipal Court buildings.

\$52,862.66 for installation of a new below-grade waterproofing system at the Municipal Court building along the length of the north façade and partial west building façade. The new waterproofing system was determined to be required once demolition of the existing parking lot and sidewalks around the Municipal Court building was completed revealing a waterproofing system in place that was both severely degraded and containing asbestos.

Change Order/Amendment No. 1 in the amount of \$3,873,421 was approved by City Council on May 4, 2021, and represented the Phase 3 City Hall Municipal Campus GMP for the scope of work defined in the Rouch Architects Construction Documents package as competitively bid by Subcontractors to Hill & Wilkinson. Costs above and beyond the Hill & Wilkinson portion of the project addressed in Change Order/Amendment No. 1 included previously approved Construction Manager pre-construction fees (\$0) and a 5% owner-controlled contingency (\$193,671); security allowance (\$25,000); low voltage allowance (\$25,000); plus, a franchise utility work allowance (\$50,000), all of which totaled the overall project budget at the time of \$4,167,092.

Items applicable to performance by the Construction Manager at Risk (CMAR) will be incorporated into the current Hill & Wilkinson General Contractors contract for a revised total contract in the amount of \$3,985,374.02.

#### **ANALYSIS:**

Parks, Arts and Recreation has worked with Dallas County and Dallas Area Agency on Aging for nearly the past 35 years offering funding for a senior meal program and for senior transportation to the nutrition site. During the past years, staff has been working with the agency to enhance and expand the program for our citizens, 60 years of age and older.

This item was presented to the Finance and Government Committee on October 5, 2021 for review and recommendation to City Council for approval.

#### FINANCIAL CONSIDERATION:

The program receives a partial reimbursement of costs from the Dallas Area Agency. Total costs for the senior meal program are \$193,597 (combined Congregate Meal \$163,582 and Home Delivered Meal \$30,015) with a budgeted reimbursement of \$163,101. The remaining costs of \$30,496 are funded from a cash requirement of \$13,599 from the City, estimated program income, and in-kind staff services. Total costs amount for the transportation program are \$64,250 with a budgeted reimbursement of \$20,247. The remaining costs of \$44,003 are funded by in-kind staff services.

The city is responsible for product, labor, operation, and transportation costs upfront. Staff estimates serving 24,000 meals (20,400 Congregate) & (3,600 Home Delivered) and providing 13,000 trips during FY 2021/2022. Reimbursement will be processed through Congregate Meals Grant Fund (FY 22 Grant) and Special Program for the Aging (FY22 Grant).

#### **ANALYSIS:**

The purchase of an Irrigation Control System at Prairies Lakes Golf Course will replace the current system that is rusted and nonfunctioning. The new controllers will operate through radios and are similar to Tangle Ridge's current Rainbird System, streamlining parts and operations for both golf courses.

Chapter 271.102 of the Local Government Code authorizes local governments to participate in a cooperative purchasing program with another local government or local cooperative organization. In lieu of competitive bidding, items and services may be purchased through such agreements as the agreements have already been bid by the sponsoring entity or agency. The City of Grand Prairie has master interlocal cooperative agreements with various entities including BuyBoard.

The BuyBoard is able to save money by pooling the impressive purchasing power of their members, which include hundreds of school districts, municipalities, counties, other local governments, and nonprofits across Texas. They use the power of numbers as leverage to get better prices with the same vendors we use now.

The national contract #611-20 will expire May 23, 2023.

#### **ANALYSIS:**

The award winning Ruthe Jackson Center opened in December of 2002 and its business model consists of hosting corporate, community, social and wedding events. Staff has determined that a refresh of the interior space is needed to continue to stay competitive in response to changing décor and style landscapes for these types of events. This is the third refresh of the interior space since its opening in 2002. In 2010, the original carpeting was replaced in the entire building. In 2018, the main ballroom was painted, refreshed and all original lobby furniture was replaced.

Proposed RJC improvements will include the following:

- Replacement of all carpet & tile in lobby, ballrooms, and main hall areas.
- Paint & refresh all interior lobby and main hall areas, including replacing ceiling tiles.

#### **ANALYSIS:**

The State Infrastructure Board (SIB) offers a revolving loan program to fund qualified transportation projects in the state. Staff believes the city's turnback project would qualify for this loan. Based on our research, the board could offer a lower interest rate on this loan than what is available in current the bond market. Staff believes this could lead to additional savings by a lower interest cost. This application would allow staff to begin discussions with the SIB on the borrowing cost to acquire funding for the turnback project. If staff find it to be in the best interest of the city to fund the project via the SIB, an additional item will be presented to Council for approval of the loan.

The application is attached as exhibit A.

#### FINANCIAL CONSIDERATION:

There are no costs associated with the application. If the loan is favorable, there would be subsequent debt service costs associated with its repayment.

#### **BODY**

A RESOLUTION OF THE CITY OF GRAND PRAIRIE, TEXAS, AUTHORIZING THE FILING OF AN APPLICATION FOR FINANCIAL ASSISTANCE FROM THE STATE INFRASTRUCTURE BANK; AUTHORIZING THE CITY MANAGER TO ACT ON BEHALF OF THE CITY OF GRAND PRAIRIE IN ALL MATTERS RELATING TO THE APPLICATION

WHEREAS, the State Infrastructure Bank, operated by the Texas Department of Transportation, is a revolving loan fund; and

WHEREAS, the City of Grand Prairie (the "City") deems it proper and in the best interest of the City to apply for a loan from the State Infrastructure Bank in an amount up to \$13,000,000 to be used for the turnback project; and

WHEREAS, the City is qualified to apply for and obtain financial assistance from the State Infrastructure Bank for this purpose;

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF GRAND PRAIRIE, TEXAS THAT:

Section 1. That the City Council believes that it is in the best interest of the City to apply for a loan from the State Infrastructure Bank in an amount up to \$13,000,000 to finance the turnback project

Section 2. That the City Council hereby authorizes the City Manager to execute an application for financial assistance from the State Infrastructure Bank and to submit the application, together with all required documentation, to the Texas Department of Transportation for consideration.

Section 3. That the application to be submitted is attached hereto as Exhibit A and made a part hereof for all purposes.
