Tony Shotwell and Board members requested that a resolution amending the Economic Development Grant Agreement between the City of Grand Prairie, Texas, and the Grand Prairie Local Government Corporation clarifying the procedure for the disposition of certain income received by the Grand Prairie Local Government Corporation pursuant to the agreement.

Secretary Cole Humphreys motioned to approve item number two (Golden Chick Plat), in addition, to a resolution amending the Economic Development Grant Agreement between the City of Grand Prairie and the Grand Prairie Local Government Corporation clarifying the procedure for the disposition of certain income received by the GPLGC according to the agreement. A RESOLUTION AMENDING THE ECONOMIC DEVELOPMENT GRANT AGREEMENT BETWEEN THE CITY OF GRAND PRAIRIE, TEXAS AND THE GRAND PRAIRIE LOCAL GOVERNMENT CORPORTION TO CLARIFY THE PROCEDURE FOR THE DISPOSITION OF CERTAIN INCOME RECEIVED BY THE GRAND PRAIRIE LOCAL GOVERNMENT CORPORATION PURSUANT TO THE AGREEMENT.

WHEREAS, City is authorized by Article III, Section 52-a of the Texas Constitution and Texas Local Government Code Chapter 380 to provide economic development grants to promote local economic development and to stimulate business and commercial activity in the City; and

WHEREAS, the City makes grants to GPLGC from time to time pursuant to the referenced authority and for the authorized purposes; and

WHEREAS, the GPLGC wishes to clarify the procedure for the disposition of certain income received by the GPLGC pursuant to the Agreement.

NOW, THEREFORE, in consideration of the foregoing, and on the terms and conditions hereinafter set forth and other consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to add a new Section 5.2 to Article V to read in its entirety as follows:

5.2 Pursuant to Transportation Code Section 431.107, the City is entitled to receive any income that is received by the GPLGC that is not needed to pay the corporation's expenses or obligations. However, prior to the transfer of any income to the City in excess of expenses and obligations, the City Council will review whether none, a portion, or all, of the funds will remain

with the GPLGC to be spent by the GPLGC solely for the Grant Purpose and under the same terms and conditions of the Agreement.

ECONOMIC DEVELOPMENT GRANT AGREEMENT AMENDMENT BETWEEN THE CITY OF GRAND PRAIRIE AND THE GRAND PRAIRIE LOCAL GOVERNMENT CORPORATION

This **Amendment** to that certain Economic Development Grant Agreement dated ______, 20___ (the "Agreement"), is entered as of the Effective Date by and between the **City of Grand Prairie** ("<u>City</u>"), a Texas home rule municipality, and the **Grand Prairie Local Government Corporation** ("<u>GPLGC</u>"), a Texas non-profit local government corporation established by City pursuant to Subchapter D of Chapter 431, Texas Transportation Code (the Texas Transportation Corporation Act or the "<u>Act</u>"). The City and GPLGC are hereafter referred to herein collectively as "<u>the Parties</u>" or individually as "<u>Party</u>."

RECITALS

WHEREAS, City is authorized by Article III, Section 52-a of the Texas Constitution and Texas Local Government Code Chapter 380 to provide economic development grants to promote local economic development and to stimulate business and commercial activity in the City; and

WHEREAS, the City makes grants to GPLGC from time to time pursuant to the referenced authority and for the authorized purposes; and

WHEREAS, the GPLGC wishes to clarify the procedure for the disposition of certain income received by the GPLGC pursuant to the Agreement.

NOW, THEREFORE, in consideration of the foregoing, and on the terms and conditions hereinafter set forth and other consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to add a new Section 5.2 to Article V to read in its entirety as follows:

5.2 Pursuant to Transportation Code Section 431.107, the City is entitled to receive any income that is received by the GPLGC that is not needed to pay the corporation's expenses or obligations. However, prior to the transfer of any income to the City in excess of expenses and obligations, the City Council will review whether none, a portion, or all, of the funds will remain with the GPLGC to be spent by the GPLGC solely for the Grant Purpose and under the same terms and conditions of the Agreement.

ANALYSIS:

The FY 2022-2023 budget includes additional funds approved for property suitable for the location, relocation, and/or expansion of businesses with the City and meets Program requirements. Funds have also been included for any maintenance of existing properties or professional services the Local Government Corporation needs to engage.

FINANCIAL CONSIDERATION:

The total budget for FY 2022-2023 is \$17,340,000 and will be adjusted, as needed, based on future property acquisitions.
