CALL TO ORDER

President Toth called meeting to order at 6:01 pm

I. Approval of Minutes of January 23, 2023, meeting

President Toth and Commissioners reviewed the previous meeting minutes. Commissioner King move to approve the prior meeting minutes and Commissioner Bhular 2nd the motion to approve the minutes.

II. Selection and Ratings of Applications

President Toth polled all the Commissioners to ask if they could review the Public Service Agent (PSA) applicants and give a thumbs up or down on the approvals or rejections of each application. Mr. Cornelius advised the Commissioners that they must review and grade each application separately and then we can discuss the ratings afterwards. Commissioner Dudley asked if Jewel's PSA had a Houston address? Mr. Cornelius stated yes. Commissioner Dudley asked if all the PSAs applied by the deadline. Mr. Cornelius advised yes, the department sent out a couple of reminder emails to the PSAs and they all applied by the deadline. President Toth didn't think Lo's Jewel Foundation doesn't meet the criteria. Commissioner Harper was concerned about where Lo's Jewel Foundation was

OTHERS PRESENT: Nadia Bhular, wife of Amjad Bhular donating their money to. Commissioner Dudley wanted to verify what the agency has done before. Commissioner Harper was concerned about their 10c. Mr. Cornelius advised the Commissioners that the 10c for the PSA was verified but found that the listed base location is a rent by-the-hour space in Grand Prairie but not an actual permanent physical building being occupied by the agency. President Toth asked if the board agreed to dividing \$18,000 evenly between the 3 qualified PSAs and all agreed. Commissioner Toth asked the board if there were any other questions and then moved to adjourn the meeting. President Toth asked if he could come into the office to discuss the CDBG questionnaire on the PSA guidelines. Mr. Cornelius advised to reach out to him to set an appointment as it is very transparent, and they can compare what Federal and local guidelines are for the PSAs.

III. Required Open Meetings Training Video Certification

All Commissioner have confirmed that they have completed the required training certification.

The meeting was adjourned at 7:05 pm.
