2. Duane Strawn introduced himself as the Grand Prairie Parks, Arts, and Recreation Director. He thanked the commission for their service. He then introduced Councilman Greg Giessner.
3. A summary of the presentation by Councilman, Greg Giessner is included below:

Councilman, Greg Giessner spoke today about Bond Proposition A. This proposition is the issuance of \$75 million general obligation bonds for promoting economic development within the city and the imposition of a tax sufficient to pay the principle of and interest on the bonds.

This bond will give the city the ability to go after land acquisition, redevelopment, and other economic development projects that will work to continually revitalize the City of Grand Prairie and increase revenue streams within the City.

General Obligation (GO) Bonds, similar to home loans, are used to finance city projects that cost more than available cash. GO bonds require voter approval. Grand Prairie has a AAA rating from Standard & Poor's, which is the highest possible bond rating and allows the City to pay lower interest rates on bonds.

The last voter approval bond issue was in 2001 for \$76 million for streets, signs, and storm drainage. Bond debt is repaid over time, usually 20 years. Airhogs Stadium and the Summit paid off 7 years early. The police/fire facility will be paid off approximately 7 years early. This is not expected to raise property taxes due to the increased revenue streams that come from this economic development. In Grand Prairie the property tax rate has not increased in 29 years. In fact it has decreased a couple of times.

If this proposition is approved by voters, buying land & building infrastructure for eligible projects, constructing facilities that may need revitalization, financing future projects, and awarding grants or loans to development projects will be made possible.

Special Election will be held on May 1st, 2021 - \$75 Million Economic Development Bonds

Information about this will be mailed to the historically known voters and will be posted online. A few of the restaurants the City hopes to bring to Grand Prairie, include Vidorra, Stir, and Luke 9.

4. Updates from Chris Ginapp - All Parks and Recreation facilities in Grand Prairie are following the Governor's lead and we are now highly recommending masks, but not enforcing them. The Summit and Play Grand Adventures opened on Monday, March 1st. The Summit had over 700 members return the first week.

Nutrition Update from Jackie Gunderson – 1,075 meals were served in February. We were able to give multiple hot meals to all nutrition members on Friday, March 12th along with an emergency meal. However, due to the ice storm we did not serve meals that week (February 15th-19th).

5. The goal of this item is to create a statement that informs the senior population of Grand Prairie of what the Commission on Aging is and what they do.

The Commission on Aging would like to respectfully recommend a new mission statement to the City Council:

"The Commission on Aging seeks to promote, facilitate, and enhance the quality of life for Grand Prairie seniors by offering solutions and recommendations of programs and services to our City Council."
