# Resilient and Diverse Economy

- Tax base has grown by at least 4.5% every year since 2012
- 2021 Sales tax year-to-date receipts are 10.56% higher than the prior year.
- 2020 1% higher than 2019
- While the tax base may lack a driving anchor, its diversity causes it to be extremely resilient.
  - When retail falls, warehousing picks it up, etc.

# Historical Worst-Case Scenarios

### Sales Tax

- For the worst month of Covid lock-downs (April), revenue was only down 14% (compared to prior year).
- For the 15 months of Covid, only 5 months have seen declines from the prior year.
- Overall year-to-date growth at 10.56%
- Last meaningful declines in Great Recession
  - ▶ 4% fall in '09, 2% decline in '10

# Historical Worst-Case Scenarios

### Property Tax

- Property values still increased in 2020 even with Covid
- Last meaningful declines in Great Recession
  - 1.8% fall in '09, 3% decline in '10
- ▶ No decline greater than 3% since at least 1999.

## Takeaways

- When hit with some of the most economic disruptive forces we've seen, the City's economy is resilient enough to overcome the challenges.
- F&G has played a huge role in maintaining budgetary flexibility and sufficient reserves.
- F&G and Council have played a huge role in diversifying the tax base.
- City staff would never recommend a budget or expense that would impose an unnecessary risk to our finances.

#### **ANALYSIS:**

Moving forward, we would like provide F&G our quarterly investment report in the agenda packet. This is the same legally required report you have been receiving in administrative updates. The report outlines where the City's cash and investments are held throughout the year.

In general, as market rates decrease in the short term, staff continues to build a laddered portfolio, filling in any gaps. Laddering bonds allows flexibility to invest in different credit and interest rate environments and provide regular liquidity for operating needs. We continue to anticipate low interest returns in the coming year as the Fed keeps a rate close to 0.

#### FINANCIAL CONSIDERATION:

The city budgeted \$4 million in investment returns for the FYE 2021, and we are on target to hit that projection.


#### **INVESTMENT RECAP**

The attached investment recap summarizes all activities in the City's investment portfolio from October 1, 2020 to June 30, 2021. The report shows a year-to-date increase of \$54,612,000, helped by some of the federal funds we received this quarter.

The book value and market value of each type of investment is also shown on the report. At June 30, 2021, the city had an unrealized loss (market value minus book value) of \$1,290,529 on its securities largely due inconsistent recovery of the market. This loss is not reflected in any of the above totals.


#### Portfolio by Type of Investment

Chart 1 presents the portfolio by type of investment. Approximately 20% of the portfolio is invested in Local Government Investment Pools; the remainder is invested in US Agencies, Treasuries or Municipal Bonds. The investment policy guidelines indicate not more than 50% invested in pools and 25% in each individual government agency. This reflects a recent general strategy of placing more investment funds in longer term instruments.




#### **Portfolio by Maturity**

Chart 2 presents the portfolio by maturity. Per policy, no investments exceed 36 months.




#### Weighted Average Maturity

Chart 3 shows the weighted average maturity (WAM) for the last twelve months. As of June 30<sup>th</sup>, the WAM was 347 days. We'd like to stay closer to this range over time.




#### **Interest Report**

Chart 4 compares the interest income budget, interest received, and ending accrued interest. The primary difference in this amount is due to the timing of when interest is received and reported. Interest received is on a cash basis, as is the budgeted amount. Interest earnings and accrued interest are on an accrual basis.



#### Yield Compared to U.S. Treasury and Texpool

A metric more indicative of the portfolio performance is the overall expected yield-to-maturity, as shown in Chart 5. This metric is benchmarked against average monthly yield of the one year U.S. Treasury Bill and the average monthly yield on Texpool accounts. Since the strategy at the City is a buy and hold to maturity, the yield-to-maturity rate represents the final expected results. This yield can vary if a bond gets called early; therefore, we have a cap on callable securities at no more than 50%. As the market has stayed suppressed, we anticipate our spread to decrease over time.



#### **INVESTMENT ACTIVITY & PROSPECTIVE STRATEGY**

As shown on the attached schedule, it was an active quarter with approximately \$108 million in purchases made and \$55 million maturing this quarter, excluding pool transactions. Yields for new purchases remain unattractive, yet higher than the pool returns.

In the upcoming quarter (July 2021-September 2021), holdings with par value of \$51 million are maturing. The yields on those holdings have a median larger than the current market, so we may expect continued diminished returns in the coming year. Additionally, we will receive \$84 million in bond proceeds, raising our portfolio to close to \$500 million.

In general, as market rates decrease in the short term, staff continues to build a laddered portfolio, filling in any gaps. Laddering bonds allows flexibility to invest in different credit and interest rate environments and provide regular liquidity for operating needs. We continue to anticipate low interest returns in the coming year as the Fed keeps a rate close to 0. We may see a small spike over the next couple of months, but the long term outlook is still fairly bleak.

  - Requires a minimum of three quotes (2 HUBs and I GP vendor), OR

#### MINUTES CITY COUNCIL FINANCE AND GOVERNMENT COMMITTEE July 13, 2021

The City of Grand Prairie Finance and Government Committee convened at 2:30 p.m. on Tuesday, July 13, 2021, in the City Council Briefing Room, 300 West Main Street, Grand Prairie, Texas. The following members were in attendance:

#### **STAFF PRESENTATIONS**

1. Internal Audit FY21 3rd Quarter Report

Audit Director and Interim Chief Financial Officer, Cathy Patrick, presented information on FY21 3<sup>rd</sup> Quarter Report, including completed projects, projects in progress, and on-going projects. Ms. Patrick clarified that the Audit Department's responsibility is to verify if the documentation provided (e.g., from Departments, hotels) is correct, and to make recommendations, with direction by Deputy City Manager, Cheryl De Leon.

Ms. Patrick stated that the prioritized Audit Workplan will be presented to the Finance and Government Committee in December. After a discussion, it was determined that Lynn Creek Marina should achieve two consecutive years of positive findings before being placed on a biyearly audit schedule. A brief discussion took place regarding potential amendments to contracts.

Ms. Patrick noted that the EnerGov implementation is expected in August of this year, and will involve Public Works, Planning, Inspections, and Engineering. Ms. Patrick also discussed the Capital Assets Project. Going forward, 'clean' data will be entered into the new financial system. Ms. Patrick also stated that the new ERP software will replace Lawson with a new financial and human resources system. An RFI was sent out, and they are reviewing the information.

Ms. Patrick mentioned the Finance Department survey conducted in June. The Finance Department held a team-building retreat on Monday, July 12. She also discussed Procurement Card reviews.

Ms. Patrick stated that the American Rescue Plan is still being adjusted by the Federal Government, and there is not yet a reporting format.

Deputy City Manager Cheryl De Leon discussed the criteria for items included on the Consent Agenda, and she noted that any member of the Finance and Government Committee can request an item be pulled from the Consent Agenda to be presented for individual consideration. Councilperson Kurt Johnson requested Item 5 and Item 6 be pulled from the Consent Agenda and presented for individual consideration.

Councilperson Cole Humphries moved to approve Items 2-4 and Items 7-10 on the Consent Agenda, with Items 5-6 pulled for individual consideration and discussed in Executive Session. Councilperson Kurt Johnson seconded the motion. The motion passed 3-0. Ayes: 3 Nays: 0 Abstentions: 0

#### **ITEMS FOR INDIVIDUAL CONSIDERATION**

11. Contract with Pyro Brand Development LLC for Brand Development of EpicCentral in the

amount of \$128,000, plus a contingency amount of 5% for a total project cost of \$134,400

Deputy City Manager Cheryl De Leon presented information for Item 11. The goal is to make EpicCentral one of the top five entertainment venues in Dallas-Fort Worth. Item 11 is about branding, not marketing. An RFP was done, 15 proposals were received, and the selection team selected the top five companies. Ms. De Leon noted that the selection team was comprised of several persons from Parks, Arts and Recreation, as well as other departments. She explained the scoring process, and the reasons why Pyro Brand Development was chosen (e.g., diverse workforce, great team, creative ideas). After four interviews with each company, Pyro Brand Development was selected. She further stated that the marketing piece will be a separate contract. Marketing may be done with Pyro Brand Development, or with another company.

Councilperson Cole Humphreys moved to approve Item 11 as presented. Councilman Kurt Johnson seconded the motion. The motion passed 3-0, with no abstentions. Ayes: 3 Nays: 0 Abstentions: 0

Ordinance amending the FY2020/2021 Capital Improvement Projects Budget; Contract with The Broussard Group (TBG Partners, Inc.) in the amount of \$49,500 and approve a 5% contingency of \$2,475, for a total cost of \$51,975 for design services for PlayGrand Adventures – Tranquil Adventures; Construction Manager at Risk (CMAR) Contract with Hill & Wilkinson General Contractors (H&W) for pre-Construction services for PlayGrand Adventures – Tranquil Adventures in the amount of \$0.00 and approve a Construction Service Fee of 5% to be applied at a later time to the actual approved construction costs for the work; Contract with Whirlix Design, LLC in the amount of \$132,306 per BuyBoard agreement for playground equipment; and Contract with Site Source, Inc. in the amount of \$45,151 per BuyBoard agreement for site shade and amenities

Director of Parks, Art & Recreation, Duane Strawn, presented information for Item 12. He stated that Item 12 was comprised of three parts: Design contract, construction management, and playground equipment that needs to be ordered because of the long lead time. He also recapped the PlayGrand Adventures-Tranquil Adventures, explaining it is a more quiet, less stimulating, secure area, especially beneficial for children on the Autism Spectrum. Mr. Strawn stated that once the final maximum cost is determined, he will return to the Finance and Government Committee to present an amended contract. The goal is to be open by Spring Break 2022.

A brief discussion took place regarding the origin of the idea, and the necessity to include this type of space for Grand Prairie citizens. Mr. Strawn also clarified that each of the areas/pods are a separate phase. Item 12 is the second phase. Mr. Strawn will send conceptual drawings to the Finance and Government Committee members.

Councilperson Cole Humphries moved to approve Item 12 as presented. Councilperson Kurt Johnson seconded the motion. The motion passed 3-0, with no abstentions. Ayes: 3 Nays: 0 Abstentions: 0

13. Construction Management Agreement with Arch-Con Corporation (Arch-Con) in the amount

of \$38,910,167 for construction of the dual brand hotel and convention center within the overall EpicCentral project; owner-controlled contingency in the amount of \$1,089,833 and a budget allowance of \$350,000 for potential price escalation of construction materials for a total funding request of \$40,350,000

Senior Building and Construction Project Manager, Andy Henning, presented information for Item 13, which is related to the hotels and conference center. Concord Hospitality was originally the development partner, but they were unable to secure financing timely. Council voted for the City to fund the project, which includes two hotels and the conference center. Arch-Con was selected as the general contractor based on experience and lower cost. It was clarified that Item 13 does not include the underground garage. Mr. Henning also stated that the City always supplies the general contractor with contact information for local sub-contractors and they are encouraged to use them, when possible.

Councilperson Cole Humphries moved to approve Item 13 as presented. Councilperson Kurt Johnson seconded the motion. The motion passed 3-0, with no abstentions. Ayes: 3 Nays: 0 Abstentions: None

14. Ordinance amending the FY 2020/2021 Capital Improvement Projects Budget; Change Order 1 with The Nay Company for the construction of Water Utilities Metal Fabrication Shop in the amount of \$252,630

Director of Engineering and Public Works, Gabe Johnson, presented information for Item 14. The design build was approved by Council in September 2020. However, since that time, prices have increased. Item 14 is asking for additional funds primarily for construction materials.

Councilperson Kurt Johnson moved to approve Item 14 as presented. Councilperson Cole Humphries seconded the motion. The motion passed 3-0, with no abstentions. Ayes: 3 Nays: 0 Abstentions: 0

15. Ordinance amending the FY 2021 Red Light Safety Fund; Price agreement for the purchase of police technology and services from Axon, Inc., through a national interlocal agreement with Sourcewell, at a first-year cost of \$625,000. This agreement will be for one year, with the option to renew for nine additional one-year periods, totaling \$14,650,150 if all extensions are exercised; Authorize the City Manager to execute the renewal options with aggregate price fluctuations of up to \$50,000 so long as sufficient funding is appropriated by the City Council to satisfy the City's obligation during the renewal terms

Support Services Manager for the Police Department, Ryan Simpson, presented information on Item 15. Mr. Simpson stated that Axon, Inc., provides equipment for the Police Department (e.g., body cameras, dash cameras, tasers). The current contract with Axon, Inc., will expire soon. Item 15 is regarding a one-year agreement, with an option to renew nine additional one-year periods. The cost includes hardware upgrades and price protection throughout the life of the contract at no additional cost. At the end of the 10-years, the City will own the equipment. The City (Police Department) will also receive an equipment issue in the 10<sup>th</sup> year. A portion of the cost for Item 15 will come from the 'Red Light' fund, but going forward, the cost will be split between the <sup>1</sup>/<sub>4</sub> cent crime tax and the General Fund.

City Attorney, Megan Mahan, noted that Item 15 is a contract renewal. It was also clarified that the first two years of the contract, the payments will be lower. However, once the Public Safety Building is paid for, more funds will be available, and the payments will go up. Deputy City Manager, Cheryl De Leon, explained that if funds are not available in future years, prioritization will be done, and other funding sources may be used.

Councilperson Kurt Johnson moved to approve Item 15 as presented. Councilperson Cole Humphries seconded the motion. The motion passed 3-0, with no abstentions. Ayes: 3 Nays: 0 Abstentions: 0

#### **RECOMMENDED ACTION:** Approve

#### **ANALYSIS:**

On October 13, 2020, the City Council approved a construction contract with Felix Construction Company in the amount of \$7,899,537.00 for Southwest Sector Pump Station Phase 2; 5% construction contingency in the amount of \$394,977; Materials testing with Alliance Geotechnical in the amount of \$51,708.40; in-house labor distribution in the amount of \$39,500 for a total of \$8,385,722.40.

Between the bid date and the end of 90-day price hold period, steel prices rose approximately 24%; steel prices continued to escalate and rose additional 20% between the hold period and the contract execution date; this resulted in 44% rise in steel prices. Suppliers are only required to hold their prices for a typical 30-day period. Contractor has provided original and revised purchase orders for rebar, hydro tank, fence, and other miscellaneous structural metal as support documentation. The City's project consulting engineer tracked the steel indexes from 90 days after bid to the contract execution.

Amendment/ Change Order No.1 in the net amount of **\$50,778.09** provides for a cost increase of raw steel material impact (\$52,943.31); underdrain modification (\$1,569.19) and additional quantities of 36" drilled pier shafts (\$1,402.50) for a **total increase of \$55, 915**; it also provides for a cost **decrease of (-\$ 5,136.91)** for miscellaneous quantity reductions. The cumulative total of change order No.1 is \$61,051.91 and the net increase is **\$50,778.09**.

Construction schedule remains unchanged for a final completion on June 19, 2022.

#### FINANCIAL CONSIDERATION:

State statutes require City Council approval of a change order when the cumulative cost of the change order exceeds \$50,000. With approval of this change order, the City Manager will be able to approve the change order to a cumulative value of \$50,000 without additional Council approval. Also, the City,

as an owner, reserves the right to increase the amount of the work to be performed in each construction contract by an amount not to exceed twenty-five (25%) percent of the original bid.

Funding in the total amount of \$50,778.09 is available in Water Capital Projects Fund (500592) W.O. 01810503 (Southwest Sector Pump Station) Contract 432412 Contingency.

#### **ANALYSIS:**

Based on the goal of improving facility security by creating one public entry to the overall City Hall complex, the recently completed renovations of City Hall East included transaction window positions that two Water Utility Customer Service staff members occupy. Because of that, the current Water Utility Customer Service walk-in lobby is no longer utilized. The elimination of the existing lobby and multiple transaction windows creates an opportunity to achieve additional office space that is currently a critical need.

On April 6, 2021, City Council approved an initial FF&E budget allowance for the Water Revenue Department renovations project in the amount of \$65,000 as a placeholder for the overall project cost. This actual contract value of \$81,006.52 represents an increase in cost due to the significant impact that the design and construction industry is seeing in regard to material price escalation due to the availability of labor and materials.

Chapter 271.102 of the Local Government Code authorizes local governments to participate in a cooperative purchasing program with another local government or local cooperative organization. In lieu of competitive bidding, items and services may be purchased through such agreements as the agreements have already been bid by the sponsoring entity or agency. The City of Grand Prairie has master inter-local cooperative agreements with various entities including OMNIA Partners and NCPA. Wilson Office Interiors, through their network of manufacturer's cooperative contracts offers the furniture, fixtures and equipment the City requires. Those cooperative contracts in the case of this proposed FF&E order are as follows:

	Amendment/Change Order No. 2 to the Interlocal Agreement with Dallas County in the additional amount of \$100,000 for Rock Island Road Bridge, MCIP 40812 at Bear Creek in the City of Grand Prairie

#### **RECOMMENDED ACTION:** Approve

#### **ANALYSIS:**

The original agreement approved by the Grand Prairie City Council on January 24, 2017 for the total project cost of \$300,000 provided Dallas County paying for half of the preliminary design not to exceed \$150,000 for replacement of the existing Rock Island Road Bridge at Bear Creek from the existing two lanes to a proposed four lane divided bridge design. The City and County are considering the options of building the full four lane bridge or a two lane bridge from the full design that will allow taking the existing bridge out of service with the remainder of the bridge being constructed at a later date. Upon taking the existing bridge out of service the City will annex that remaining portion of Rock Island Road including the bridge. As per the agreement, the City of Grand Prairie is the lead for the Rock Island Road Bridge project with Dallas County for the preliminary design work, with the City of Grand Prairie being reimbursed by Dallas County for their share.

On February 6, 2018 a professional contract for engineering services was awarded to Kimley Horn and Associates by the City of Grand Prairie (18-7578) in the amount of \$293,500. This original scope was based on a baseline hydraulic model being provided to begin the hydraulic analysis. The scope was also based on analyzing the 100-year storm event for the hydraulic analysis. Kimley Horn determined that the limits of the 2016 Preliminary model did not include the Rock Island Road bridge. Through two coordination meetings, it was decided that Kimley Horn would develop a baseline model by combining the 2016 Preliminary model and the 2017 Current Effective model. Analysis of the 500-year storm event was also brought up during the coordination meetings as a requirement for Dallas County Flood Control District No. 1 and the City of Irving. Because of these additional items, the scope of services includes additional engineering analysis and coordination to create a baseline hydraulic model and determine the impacts of the 500-year storm event. The additional \$50,000 request is to fund this additional work.

Amendment/change order 1, approved by City Council on December 11, 2018 (18-8484) to the Interlocal funding agreement with Dallas County in the additional cost of \$50,000 (Split by the City and Dallas County) was for a revised total amount of \$350,000 (\$175,000 for the City of Grand Prairie and \$175,000

from Dallas County) was for additional professional work required for the preliminary design.

The current Amendment/change order 2 to the Interlocal funding agreement with Dallas County in he additional cost of \$100,000 (Split by the City and Dallas County) is for a revised total amount of \$550,000 (\$275,000 for the City of Grand Prairie and \$275,000 from Dallas County) will fund the additional professional work required for the preliminary design.

#### FINANCIAL CONSIDERATION:

No funding is required with this resolution. Consultant contract amendment/change order No. 3 with Kimley-Horn Associates is on the August 3, 2021 Finance and Government Committee agenda and Council Agenda.

#### A RESOLUTION OF THE CITY OF GRAND PRAIRIE, TEXAS, AUTHORIZING THE CITY MANAGER TO INTER INTO A PROJECT SPECIFIC FUNDING AGREEMENT AMENDMENT 1 WITH DALLAS COUNTY FOR ROCK ISLAND ROAD BRIDGE, MCIP 40812 AT BEAR CREEK IN THE CITY OF GRAND PRAIRIE, TEXAS

**WHEREAS**, the City of Grand Prairie is designated as the LEAD AGENCY for the project and will provide the Project Manager; and

**WHEREAS,** Chapter 791 of the Texas Government Code and Texas Transportation Code Section 472.001 provides authorization for local governments to contract with each other for the performance of governmental functions and services, as well as joint funding of road construction or improvements of road and street projects; and

**WHEREAS**, Grand Prairie will be responsible for \$50,000 of the additional amount required for the preliminary design costs. WHEREAS, pursuant to Dallas County Commissioners Court Order 2017-0483 dated April 04, 2017, the County and the City entered into a Funding Agreement for the implementation of transportation improvements on the Rock Island Road Bridge at Bear Creek, MCIP Project 40812; and

WHEREAS, pursuant to Dallas County Commissioners Court Order 2019-0200 dated February 02, 2019 authorized the First Amendment to the Funding Agreement with the City of Grand Prairie for the implementation of transportation improvements on the Rock Island Road Bridge at Bear Creek, MCIP Project 40812; and

WHEREAS, Chapter 791 of the Texas Government Code and Texas Transportation Code Section 251 provide authorization for local governments to contract with each other for the performance of governmental functions and services, and joint funding of road or street projects; and

**NOW THEREFORE,** this Second Amendment is made by and entered into by the City and the County for the mutual consideration stated herein.

#### I. PURPOSE

City and County both mutually agree that the FA as amended, shall remain in full force and effect, except as modified below.

#### II. AMENDED PROVISIONS

- A. Article II "Incorporated Documents" of the FA shall be amended by deleting the current language and replacing it with the following:
  - 3. "Current Cost Estimates and Funding Sources, which is attached hereto and incorporated herein by reference as Attachment "B-2"."
- B. Article VII. "Funding" of the FA is hereby revised in its entirety to read as follows:

Notwithstanding any provision in the Master Agreement, this FA, any amendment thereto, or any other agreement between the Parties regarding this Project, the total Project cost is estimated to be Five Hundred Fifty Thousand Dollars and no cents (\$550,000.00), as shown in Attachment "B-2". The County's total obligation to this Project for Preliminary Design is to provide funding in the amount not to exceed Two Hundred Seventy Five Thousand Dollars and no cents (\$275,000.00).
- 2. The County in-house Project Delivery costs may include, but are not limited to, preliminary scoping and research, special services, site inspection meetings, and preliminary coordination.
- 3. The City will have a total obligation to this Project for Preliminary Design is to provide funding in the amount not to exceed Two Hundred Seventy Five Thousand Dollars and no cents (\$275,000.00).
- 4. Should the final cost of the total Project exceed the initial and anticipated Project costs, City agrees to either reduce the scope of the Project, or to seek additional funding to facilitate its completion. In either event, City shall be solely responsible for all such costs in excess thereof, and County shall bear no additional responsibilities beyond those contemplated herein."
- C. Article VIII. "Miscellaneous" of the FA shall be and is hereby revised by adding the additional language:

"<u>No Joint Enterprise/Venture</u>. The City and County agree that neither party is an agent, servant, or employee of the other party. No joint enterprise/venture exists between the City and County."

#### III. EFFECT OF AMENDMENT

This Second Amendment shall not change or waive any contractual provisions, clauses or conditions of the original FA, as amended, unless otherwise provided for herein. The original FA, including any and all incorporated or referenced documents and any and all exhibits, attachments and amendments that by their terms have been incorporated into any of the foregoing documents, are collectively referred to herein as the FA. In the event of any conflict between the original FA and this Second Amendment to the FA, this Second Amendment shall control. All provisions of the FA as well as any duly authorized amendments or extensions, including this Second Amendment shall remain in full force and effect throughout the term of the FA.

#### **RECOMMENDED ACTION:** Approve

#### **ANALYSIS:**

A publicly published Request for Qualifications (RFQ) process for Architectural design services was issued by the City on February 14, 2018 in which responses were due on March 7, 2018. The RFQ sought a professional design team of architects, engineers and all other necessary consultants to shape and implement the City's vision for EpicCentral. The RFQ required the selected design team to be innovative, construction-cost sensitive and work as a seamless and effective partner with the City of Grand Prairie and its development consultation team.

The Request for Qualifications was very well responded to with eighteen (18) submissions being received consisting of all of the best architectural firms both locally and regionally. The eighteen (18) submissions were reviewed by the City Manager's Office, Legal, Economic Development, City staff and the development consultation team. Submissions were shortlisted to six (6) design teams and interviews took place on March 28, 2018. Following the interviews, the selection committee felt the Merriman Anderson Architects team clearly stood out above all others due to their recent similar and successful project experience; their innovative design thoughts proposed and presented for EpicCentral; and a project design approach that was demonstrated to be flexible and inclusive of all City stakeholders as necessary.

MAA has submitted multiple additional service fee proposals totaling a net increase of \$557,650 to their previously approved design and construction services fee. These additional service proposals address:

- 1) Redesign of exterior patio landscaping and shade structures to coordinate with final waterfront restaurant tenant design layouts
- 2) Design of expanded equipment/control room for the water, light and projection show
- 3) Design of architectural site lighting around all retail restaurant pads and entry alleyways
- 4) Design team coordination with site interactive exhibits and water, light and projection show
- 5) Redesign of stairway access location in underground garage
- 6) Design team construction administration services for hotel project

An initial contract in the amount of \$45,975 was approved by the City on September 14, 2018 (Purchase Order 338360) and represented an initial conceptual design scope of work.

**Change Order/Amendment No. 1 in the amount of \$650,000** was approved by City Council on December 11, 2018 (18-8498) and represented conceptual design completion and schematic design services for all elements associated with the new EpicCentral hotel, convention center, retail and entertainment destination project.

**Change Order/Amendment No. 2 in the amount of \$2,746,108** was approved by City Council on October 15, 2019 (19-9413) and represented completion of design and construction services for all portions of the EpicCentral project existing at the time.

**Change Order/Amendment No. 3 in the amount of \$1,076,900** was approved by City Council on April 6, 2021 and represented reprioritization of construction drawing package issue dates based on adjustments to coordinate with the ongoing planning of construction sequencing, design of added waterfront restaurant adjacent to the event lawn, updated project phasing exhibits to assistant in subcontractor construction pricing and design of two new restaurants created on added land parcel resulting from relocation of Park Central entry drive.

Change Order/Amendment No. 4 in the amount of \$557,650 will be incorporated into the current Merriman Anderson Architects contract for a revised total contract amount of \$4,787,675.

Above and beyond the MAA design contract value of \$4,787,675, a previously approved design contingency of \$126,933 and a reimbursable expense amount of \$162,025 are also included in the EpicCentral overall design funding of \$5,076,633 of which the above five (5) numbers total.

Design services associated with the dual brand hotel project are not covered by this contract value, only construction administration services for the dual brand hotel project.

This item was taken to the Finance and Government Committee on August 3, 2021 for their review and recommendation for approval.

#### **RECOMMENDED ACTION:** Approve

#### ANALYSIS:

Opening in 2004, Grand Prairie Memorial Gardens consisted of 5 gardens offering 3,820 spaces. In the Fall of 2018, City Council approved Phase II development which created additional gardens consisting of approximately 2,500 spaces.

With the expansion of the additional gardens, an extension of the perimeter wall is needed to enhance the design of these spaces. Additionally, upon inspection of the existing wall, it was determined that replacement of certain sections was necessary due to an unavoidable ground structural failure.

In November 2020, CMO approved a professional services contract with Salcedo Group, Inc. for professional engineering services. Plans were developed for the Grand Prairie Memorial Gardens perimeter wall to include the base bid and an alternate bid as described below:

Alternate Bid Demolition and replacement of approximately 75 linear feet of existing perimeter wall and replace as shown on plan, specifications and addendums.

Proposals for RFB #21100 were received at the office of the Purchasing Manager on June 17, 2021, for the construction of the perimeter wall and replacement of the failing existing wall sections. One proposal was received. After review of the proposal, staff identified several areas that needed clarification and expansion. The decision was made to reject the bid; revise the specification and readvertise under a new bid number.

Notice of bid #21147 was publicly advertised and distributed to vendors. Two bids were received as shown on attachment A.

The low bid received from Fast General Contracting meets specifications and is recommended for award.

This item was presented to the Finance and Government Committee on August 3, 2021 and received recommendation for approval by City Council.

#### FINANCIAL CONSIDERATION:

Funding for the Grand Prairie Memorial Gardens Perimeter Wall Improvements project is available by approving an ordinance transferring and appropriating \$387,450 from the unobligated fund balance in the Cemetery Operating Fund (3190) to the Cemetery Capital Project Fund (316310), WO #021133(03) (Grand Prairie Memorial Gardens Perimeter Wall Improvements).

#### **ANALYSIS:**

The senior and physically challenged para-transit program began in 1988 with the purchase of one (1) van. Since that time, the program has grown to over 55,900 trips annually with an active fleet of Twelve (12) transit buses. The Transit Division of the Transportation Services Department operates various types of programs for these citizens. These programs include:

#### **NO CHARGE TRIPS**

- Nutrition Trip Program--Provides transportation to Dallas County Health and Human Services Nutrition Program at 2975 Esplanade Grand Prairie, Texas
- Medical/Dental Trip Program--Provides transportation to medical/dental appointments.
- Dialysis treatments Grand Prairie Dialysis, Tarrant Dialysis (GP), Fresenius GP Dialysis and DaVita Dialysis Grand Prairie (Clinics)
- Parkland Hospital Conover Dr. Grand Prairie and Harry Hines, Dallas (Clinics)
- o Arlington Hospital- Arlington Memorial Hospital (Clinics)
- Provide transportation to the S. Westmoreland/Illinois DART light rail station on a daily/weekly basis for Clients that have appointments at the Veterans Hospital (VA) in Dallas.
- Provide trips to the Trinity Railway Express (TRE) for Clients that have appointments in Ft. Worth or Dallas.
- Grocery Trip Program—Provide group transportation to the grocery store on a weekly basis.
- o School Program--Provides transportation to local colleges such as TCCC.
- Provides trips to work, only in Grand Prairie.

Current request is to conduct a public hearing for public input regarding The Grand Connection and associated funding requests and approve a resolution authorizing the City Manager to submit grant applications for fiscal year 2022. Grant applications will be submitted to the Federal Transit Administration (FTA) for **\$570,712** for Capital, \$262,000 for Operating and \$32,950 from Transportation Development Credits (TDC) Texas Department of Transportation (TXDOT) for \$170,584 The City will provide \$385,099 from the City's General Fund, \$20,000 from Dallas County. The total proposed budget for The Grand Connection in 2022 is \$1,441,345 which includes Operating costs of \$870,633 Vehicle (3) Replacements of \$450,000 and Maintenance of \$120,712.

The City's contribution to the Grand Connection for FY 2022 is \$385,099. FTA is allowing the City of Grand Prairie to use toll credits for expenditures, no Capital match is needed. We have secured a grant in the amount of \$262,000 for Operating expenditures under the 5310 programs from Federal Transit Administration (FTA) and \$570,712 in Capital expenditures under 5307 and the 5310 programs, \$170,584 from the Texas Department of Transportation TXDOT.

The Grand Connection is asking for \$385,099 for FY22 from the City's General Fund. In fiscal year 2022 we will be replacing three older vehicles in our fleet that are beyond their economic life (Capital Replacement Vehicles). By passing this resolution, the City Council authorizes the City Manager to submit the necessary grant applications for FTA, and TXDOT funding.

Texas Department of Transportation (TXDOT) in the amount of \$170,584, to aid in the financing of operating assistance projects pursuant to Section 9 of the Urban Mass Transportation Act of 1964, as amended.

**SECTION 2.** That, the City Manager is authorized to execute and file with such application an assurance or any other document required by the U.S. Department of Transportation effectuating the purpose of Title VI of the Civil Rights Act of 1964.

**SECTION 3.** That, the City Manager is authorized to set forth and execute affirmative minority business policies in connection with the project's procurement needs.

#### **RECOMMENDED ACTION:** Approve

#### **ANALYSIS:**

In 2012, Dallas County engaged Kimley-Horn (KH) to provide a Bridge Scour and Bridge Condition Assessment Study. The study noted that erosion presented a significant risk to the bridge's substructure. Since funding was not immediately available at the time to implement the Study's preferred technical alternative of replacing the bridge, an interim erosion mitigation measure was proposed. In 2013 Dallas County engaged KH to design the interim erosion mitigation measure to protect the bridge's header banks and abutments against further erosion and to structurally reinforce the bridge bents. The City of Grand Prairie (City) and Dallas County (County) requested KH to perform the tasks necessary to develop the preliminary design to replace the existing bridge with a new bridge.

The ultimate typical street section for Rock Island Road will be four-lane divided. The proposed crossing at Bear Creek will be two, twin bridges matching the 4-lane divided typical section and was anticipated to be approximately 320 feet long. A hydraulic study was performed on Bear Creek as a part of the preliminary design to determine the actual length and elevation of the bridge structures. The preliminary design for both (twin) bridges will be provided in the contract. The City and County will phase the implementation of the ultimate road and bridge improvements by just building one of the two proposed bridges. The length of embankment and roadway improvements beyond the ends of the new bridge was limited to the shortest distance that would allow the roadway to tie back into the existing two- lane roadway with mitigated impacts to the floodplain of Bear Creek. This phase of the project also included evaluation of potential impacts to current and proposed Dallas County Flood Control District No. 1 and Trinity Rail Express (TRE) infrastructure in the immediate area of the proposed bridges. Preliminary design for the demolition of the existing bridge, approaches, and header banks will be provided to improve existing channel geometry and to reduce stream velocities and other erosive concerns in the immediate area of the proposed bridges. The scope of this project did not include any analysis or erosion mitigation alternatives associated with the existing TRE bridge and its structural channel lining. Preliminary design of City utility crossings and coordination with franchise utilities was also included as a part of this scope.

The new bridge and future bridge will require new embankments within the existing floodplain to serve as the proposed bridges' header banks and roadway approaches to the bridge. Coordination with the U.S. Army Corps of Engineers (USACE), the Federal Emergency Management Agency (FEMA), the City of Grand Prairie, the City of Irving, the Trinity Rail Express (TRE), and the Dallas County Flood Control District No. 1 was performed. It is anticipated that the project will fall under a Nationwide Permit 14 (NWP-14) for linear transportation projects and an individual permit will not be required. Only the preliminary jurisdictional determination and Endangered Species Act (ESA) compliance fell under this original contract scope. Permit development and USAGE coordination will be developed in the final design phase under a future scope of services.

Hydraulic modeling and design for this project was based on the Preliminary FIRM model provided by Halff and Associates on behalf of Dallas County and the City of Grand Prairie. This is a joint project with the City of Grand Prairie and Dallas County. For this project, the preliminary design contract is with the City of Grand Prairie and the future final design contract will likely be with Dallas County. We understand that the City of Grand Prairie will remain the lead managerial agency for this project throughout preliminary design.

On January 24, 2017 the City Council approved an Interlocal Agreement with Dallas County to fund the preliminary design in the amount of \$150,000 with agreement for Dallas County to provide matching funding in the amount of \$150,000 for the total amount of \$300,000. The original contract with the Consultant in the amount of \$293,500 was with the City of Grand Prairie and to be reimbursed by Dallas County for their share.

On February 6, 2018 a professional contract for engineering services was awarded to Kimley Horn and Associates by the City of Grand Prairie (18-7578) in the amount of \$293,500. The original scope was based on a baseline hydraulic model being provided to begin the hydraulic analysis. The scope was also based on analyzing the 100-year storm event for the hydraulic analysis. Kimley Horn determined that the limits of the 2016 Preliminary model did not include the Rock Island Road bridge.

Through two coordination meetings, it was decided that Kimley Horn would develop a baseline model by combining the 2016 Preliminary model and the 2017 Current Effective model. Analysis of the 500-year storm event was also brought up during the coordination meetings as a requirement for Dallas County Flood Control District No. 1 and the City of Irving. Because of these additional items, the scope of services includes additional engineering analysis and coordination to create a baseline hydraulic model and determine the impacts of the 500-year storm event.

On December 11, 2018 the City Council approved an Amended Interlocal Agreement with Dallas County to fund the additional hydraulic analysis and agency coordination work needed to amend the preliminary design in the amount of \$50,000 to provide a total amended amount of \$175,000 from the City with agreement for Dallas County to provide matching funding in the amended amount of \$175,000 for the total amount of \$350,000.

The contract amendment #1 with the Consultant in the amount of \$38,400 was with the City of Grand Prairie and to be reimbursed by Dallas County for their share.

On December 11, 2018 the City Council approved Contract amendment #1 to the professional engineering and surveying services Contract with Kimley Horn and Associates for the additional hydraulic analysis and agency coordination required to develop the hydraulic baseline model and coordinate the work with the affected agencies for the Rock Island Road Bridge at Bear Creek in the amount of \$38,400.

On July 6, 2020 the City approved Contract Amendment #2 to the professional engineering and surveying services Contract with Kimley Horn and Associates for a contract time extension from the original contract

termination date of January 1, 2020 to a new contract termination date of June 30, 2021.

During the course of the contract work it was determined that fully developed watershed flows should be used in the additional hydraulic analysis for the preliminary design. Fully developed watershed flows were not available so Kimley Horn was asked to develop the fully developed flows for the project design. Also additional alternatives for bridge designs were required to mitigate the adverse impacts of the new bridge to the Bear Creek 100-year and 500-year flood level, velocity and loss of floodplain storage. Kimley-Horn was asked to include evaluating impacts to the TRE bridge upstream and provide design armoring to help mitigate current and anticipated channel erosion damages due to anticipated increased velocities upstream of the project. Kimley-Horn was asked to update the proposed bridge buildout section to include provision for the future regional 16-foot wide trail to be built with the future north two-lane bridge. Additional work is required to analysis and provide no valley storage loss to the 100-year and 500-year floodplains due to the project and to review and assess the US Army Corps of Engineers 404 permit requirements for the amended project.

**The current proposed Change Order Amendment #3** in the total amount of \$200,400 provides for the additional Hydraulic Analysis and Design Modifications required to complete the preliminary design of the project.

The 30 percent design for this project is anticipated to be complete October 15, 2021. With approval of the current Amendment/Change Order No. 3 the grand total contract amount will be \$532,300.

#### FINANCIAL CONSIDERATION:

Funding for the Amendment (Change order) No.3 to professional engineering and surveying services Contract with Kimley Horn and Associates for hydraulic analysis and design modifications of Rock Island Road Bridge at Bear Creek, in the amount of \$200,400, is available by approving an ordinance transferring and appropriating from the unobligated fund balance in the Street Capital Projects Fund (400192) to WO #01808303 (Rock Island Rd. Bridge at Bear Creek (with Dallas County).

#### Contract Amendment No. 3 Preliminary Design Services for Rock Island Road Bridge Replacement at Bear Creek Additional Hydraulic Analysis

#### Project Understanding

The City of Grand Prairie, Texas has requested a proposal for additional professional services associated with additional hydraulic analysis. The additional scope of services is outlined below:

#### Scope of Services

#### 1. <u>Hydrologic Analysis for Fully Developed Flows</u>

\$ 18,900 Hourly/Reimbursable

The City of Grand Prairie requires the analysis of fully developed flows, and Kimley-Horn had included analyzing the Bear Creek hydraulic model based on fully developed flows for the Rock Island Road project scope dated February 26, 2018. However, fully developed flows were not provided with the baseline hydraulic model, and a hydrologic analysis and developing fully developed flows for Bear Creek was excluded from this project scope because the project improvements should not impact the flows and the fully developed flows were to be provided. To complete the *Baseline Hydraulic Model for Rock Island Road Bridge at Bear Creek* Memorandum, dated April 2, 2019, and continue with the project design, the fully developed flows were compiled from sources provided by the City of Grand Prairie to determine a steady flow file consistent with the upstream and downstream limits of the 2019 Baseline hydraulic model. The fully developed hydraulic results were added to meet City of Grand Prairie criteria and summarized within the Preliminary Memorandum titled *Preliminary Fully Developed Flow Analysis for Rock Island Road at Bear Creek*, dated October 28, 2019.

The budgeted fee for this task is based upon approximately **80 hours** of labor. We will not proceed with performance of services beyond the hours budgeted with written authorization by the City.

Amount of Task Complete to Date: \$18,900

#### 2. Proposed Hydraulic Modeling

\$ 25,800 Hourly/Reimbursable

The Rock Island Road project scope dated February 26, 2018 included proposed improvements to be analyzed with up to three hydraulic alternatives under Task 4.1.3. To mitigate adverse impacts to the Rock Island Road project site, the Engineer has thus far evaluated 6 hydraulic alternatives. Hydraulic alternatives evaluated thus far are listed below:

- 320' wide Bridge with 3H:1V side slopes for Ultimate Condition
- 320' wide Bridge with 3H:1V side slopes for Interim Condition

- 220' wide Bridge with 3H:1V side slopes for Ultimate Condition
- 220' wide Bridge with 3H:1V side slopes for Interim Condition
- 220' wide Bridge with 4H:1V side slopes for Ultimate Condition
- Preliminary 220' wide Bridge with 2H:1V side slopes for Ultimate Condition

The budgeted fee for this task is based upon approximately \$8,000 per hydraulic alternative analyzed.

The budgeted fee for this task is based upon approximately **120 hours** of additional labor. We will not proceed with performance of services beyond the hours budgeted without written authorization by the City.

Amount of Task Complete to Date: \$25,800

#### 3. Supplemental Hydraulic Analysis

#### \$58,800 Hourly/Reimbursable

Engineer will provide additional time to complete the scope of services outlines under Task 4 in the agreement dated February 26, 2018. The initial effort associated with the development of the existing conditions model and proposed improvements required a significant level of development.

Engineer will evaluate hydraulic impacts for various bridge lengths. Engineer will update the proposed southern bridge within the hydraulic HEC-RAS model of Bear Creek to account for the addition of a proposed trail. Engineer will revise channel grading and armoring to protect updated bridge width. Engineer will evaluate impacts of lining the channel bottom of Bear Creek with 2H:1V side slopes for the Interim and Ultimate conditions. Proposed improvements/grading will extend upstream of Rock Island Road until the downstream face of the existing TRE bridge concrete channel. A concrete channel bottom will also be evaluated underneath the proposed bridges. A cut/fill analysis will be performed in AutoCAD Civil 3D to evaluate valley storage in Bear Creek. A total of two (2) additional hydraulic alternatives will be completed in attempt to mitigate impacts at and upstream of the project location.

Engineer will evaluate the existing TRE bridge width and bounding downstream cross section based on limited data within the 2019 Baseline hydraulic model and update model to reflect existing conditions within the revised existing and proposed hydraulic models. These modifications will not be based on survey data, record drawings, or detailed information of the existing TRE bridge.

Engineer will prepare one (1) proposed Floodplain Workmap for each of the two (2) additional hydraulic alternatives. Engineer will prepare one (1) presentation summarizing hydraulic results from the two (2) additional hydraulic alternatives. Engineer will prepare Opinion of Probable Construction Cost for the two (2) additional 2H:1V hydraulic modeling alternatives.

The budgeted fee for this task is based upon approximately **265 hours** of additional labor. We will not proceed with performance of services beyond the hours budgeted without written authorization by the City.

Amount of Task Complete to Date: \$39,000 Amount to be Performed: \$19,800

#### 4. Revised Preliminary Design

*\$ 58,000 Hourly/Reimbursable* 

Engineer will provide additional time to complete the scope of services outlined under Task 5 in the agreement dated February 26, 2018. Additional time for revisions beyond originally accepted alternatives to accommodate other options required by hydraulic analysis.

The following items will be incorporated into the preliminary design of these improvements:

- 16-foot wide regional trail (on north bridge)
- Adjustments to the proposed south bridge to accommodate the regional trail
- Channel improvements including floodplain discharge, water surface, velocity and storage impacts.
- Additional right of way requirements
- Updated typical section for the ultimate twin bridge layout with dimensions

The budgeted fee for this task is based upon approximately **255 hours** of additional labor. We will not proceed with performance of services beyond the hours budgeted without written authorization by the City.

Amount to be Performed: \$58,000

#### 5. <u>Supplemental Valley Storage Analysis and Permitting</u>

\$ 31,000 Hourly/Reimbursable

The project will be analyzed for meeting no valley storage loss for the ultimate 100-year and 500year flood events which includes areas outside of ROW. The mitigation areas will be added to the design plans, and field notes and sketches for the additional ROW or easements required for the project and design of any drainage swales or areas to provide no valley storage loss for the ultimate 100-year and 500-year flood events will be provided. A Trinity River Corridor Development Certificate (CDC) application requesting an Exemption to the CDC Process will be prepared and submitted. This scope assumes that an Exemption will be granted. A City Floodplain Development Permit will be prepared and submitted.

The budgeted fee for this task is based upon approximately **140 hours** of additional labor. We will not proceed with performance of services beyond the hours budgeted without written authorization by the City.

Amount to be Performed: \$31,000

#### 6. <u>Environmental Investigation / Section 404 Permitting Summary</u> \$ 7,900 Hourly/Reimbursable

The existing/proposed bridge structure has the potential to cross jurisdictional waters of the U.S. regulated by the U.S. Army Corps of Engineers (USACE) Fort Worth District. The full extent of potential impact to waters of the U.S. as a result of the project is unknown at this time. Kimley-Horn will prepare a Section 404 Permitting Analysis Summary Memorandum based on current regulation and preliminary project design details for ultimate conditions with two bridges. This memorandum will summarize potential USACE permitting scenarios for the proposed project and will include the following information:

• Specific permitting category based on the proposed design and limits of impact under Section 404 of the Clean Water Act that would trigger USACE permitting;

- Details on which USACE permitting scenario may apply to the project including the following:
  - Conditions for utilizing a Nationwide Permit (NWP) without notification to the USACE being required;
  - o Triggers that would require a NWP with notification to the USACE;
  - o Triggers that would require an Individual Permit (IP) with notification to the USACE;
  - A general summary of next steps and/or future studies that may be necessary in the USACE permit application and review process, if applicable;
  - Estimated timing/schedule for obtaining USACE approval for the different permitting scenarios, if applicable; and
  - Estimated jurisdictional waters of the U.S. mitigation costs if mitigation appears to be required based on preliminary impacts calculations.

Kimley-Horn will attend two (2) meetings with the USACE Fort Worth District to discuss details of the project and identify the appropriate permitting scenario based on information presented. We understand the meetings will occur in advance of the submission of any permit application (if required) and the meetings will be scheduled by the City.

The budgeted fee for this task is based upon approximately **35 hours** of additional labor. We will not proceed with performance of services beyond the hours budgeted without written authorization by the City.

This Task does not include pursuit of a No Permit Required letter, Approved Jurisdictional Determination (AJD), or Department of Army permit; however, Kimley-Horn can assist with these services, if warranted by the Client, for an additional fee.

#### Amount to be Performed: \$7,900
