Title:

Public hearing and final reading of an ordinance amending the Greeley Municipal Code by extending the effective automatic termination date of the "Downtown Open Consumption Area"

Summary:

In response to an effort to limit the spread of the COVID-19 virus, the State issued orders that closed or limited the operation of nearly every form of gathering of persons, including retail stores and restaurants. As the spread of the virus slowed and health care providers were able to manage patient care at less than capacity levels, the State relaxed its orders on physical distancing to allow a staged and measured reintroduction of the movement of its residents by allowing the limited reopening of stores, offices, restaurants, and certain public spaces. Re-opening guidance was provided to limit interactions between persons, promote cleaning and disinfection of touch points, and requiring face coverings, taking temperatures of employees and patrons and other measures.

In June, in response to a request from Downtown restaurants to facilitate the consumption of alcohol in a limited seating area on and near the 8th and 9th Street Downtown Plazas to attract patrons in a manner compliant with State orders, the City Council adopted a limited Open Consumption ordinance for the Downtown. Among its provisions, the ordinance included an automatic revocation date of September 12, 2020, in line with the then State Orders.

As the State's management of the COVID virus has met some success in limited its spread, there are indications the Governor may extend its permissions for outdoor gatherings beyond the earlier September date. Wishing to continue its efforts to provide a flexible outdoor dining and drinking space, downtown businesses have requested that the City likewise extend the effective period for the allowance of the Downtown Open Container area.

Council has expressed a willingness to consider such an extension, but has also asked for some feedback from downtown businesses and residents concerning the experience with the Open Container provisions since it was enacted in June. Staff reached out to the Downtown Development Authority to lead the effort to get area feedback for this review. As summary of the comments received as of the date of this report is attached.

Comments received include:

- Objection to the Open Container permission in the designated area, expressing dissatisfaction and inconvenience related to residents, customers and patrons due to the street closures (particularly 8th Street), greater presence of transients, loitering, nuisance behaviors, and waste;
- 2. Support to allow the Open Container permission to continue as a way to support restaurant and beverage establishments with one of four street closure options:
 - a. As is, with the continued closure of the 8th and 9th Street plazas during the period that open container consumption of alcohol is allowed (preference of the majority of the downtown businesses polled by the DDA);
 - b. Open the 8th Street Plaza, keep the 9th Street Plaza closed during this period (would necessitate moving 1 picnic table from a parking stall space);
 - c. Open the 8th and 9th Street Plazas from Monday Thursday; close both streets from Friday midday to Monday morning (these hours would allow the gates to be closed by staff during regular work hours. One picnic table on 8th Street and 7 tables on the 9th Street plaza would need to be removed by the Downtown Promotional Association. Any cars parked in the area would still be able to exit from the open earess).
 - d. Keep 9th Street closed 24 hours a day/ seven days a week, and only close 8th Street all day Fridays, Saturdays, and Sundays.

At its August 25th Special meeting, the Council introduced the ordinance extending the open consumption ordinance to October 13, 2020. The action to close the plazas is handled administratively, so no language is necessary in the ordinance regarding this aspect of the use of the plazas. Instead, following public comment, staff can take general direction from the Council concerning preferences for the opening or closing of the area in the Downtown within the area within which open consumption is allowed.

Legal Issues:

Due to the pending automatic sunset of the existing ordinance on September 12th, the ordinance amending the deadline has been drafted to be effective immediately upon publication, rather than the customary "5 days following publication".

Other Issues and Considerations:

To extend the open consumption deadline as directed by Council and also provide for a more responsive way of terminating the ordinance if State orders are issued that limits the consumption of alcohol in the public rights-of-way, staff suggests an additional amendment. Specifically, the amendment would cause the termination of the Open Container provision if the State Executive Order terminating permission for the consumption of alcohol in rights-of-way occurs earlier.

- A motion to amend Section 6.16.271 (d) of the ordinance to read:
 This section shall be automatically repealed upon expiration of Section II. Q of the State of Colorado Executive Order D 2020 011, or at 12:01 a.m. on October 13, 2020, whichever is earlier, unless extended by Council;
 - Once the amendments are adopted: A motion to adopt the amended ordinance and publish in full.
- 2. Separately, advise staff of any preference for the full or partial opening of the 8th and 9th Street plaza streets for the duration of the Open Consumption period.



"Downtown Open Consumption Area" is that area beginning and including the sidewalk right-of-way extending from the west curb line of 8th Avenue to and including the sidewalk right-of-way to the east curb line of 9th Avenue, and between and including the sidewalk right-of-way and from the north edge of the sidewalk right-of-way of 8th Street to and including the sidewalk right-of-way to the south edge of the sidewalk right-of-way on 9th Street, also including the area known as the Chase Plaza, and, including that portion of sidewalk on the west side of 8th Avenue from the 9th Street Plaza south 200 feet.

Not many patron have actually utilized the accommodations set in place. The Greeley Chophouse has its own patio seating in which customers use. Right Coast Pizza does use its own patio seating as well. Brix brewery does have a fair amount of clientele, but also use their own patio and play area. The factor of the street being closed and parking being blocked off is more of a deterrent towards our local businesses than an attraction. As a resident myself, and speaking for many other residents among the plaza, we're the ones that suffer for an ordinance that hasn't faired well at all. I can't speak for the 9th street plaza, because that's where all the bars and nightlife exist, so i imagine those facilities are actually utilized, but the 8th street plaza shut down is only hurting residents, patrons and Downtown business. Mayor Gates, City Council, and City Staff-

Thank you for once again making a huge effort to support the downtown businesses with the recent consideration of extending the open container ordinance for downtown. In a discussion with Councilmen Butler, he thought it would be helpful for me to reach out and discuss the success that I have seen with the open consumption area.

As with anything, it definitely took some time for the open consumption area to catch on, but once it did, it has really helped to increase our customer numbers while providing more space and a safer environment. Though I cannot say definitively (because of the way we code drinks in our system), my guess would be that 30%-40% of our Friday-Sunday customers are utilizing the outdoor seating and courtyard with 10%-20% on the weekdays. We have had several instances where our room was at capacity (50%) and we were able to give customers the option of outdoor seating.

On the flip side, I have not seen or heard of any issues pertaining to the street closures or the open container. It seems to me the transient community in the park has continued to stay in the park. We (Tower 56) has not seen anyone bringing their own alcohol into the plazas and as far as I know, there have been little issues if any with over intoxication. I have noticed on several occasions that when work or commercial vehicles have needed access to the closed streets... they had access with no problems. From my perspective, it has been nothing but positive.

With several more weeks/months of beautiful Colorado weather, with the return of college students, and the momentum the two plazas have been gaining, I would love to see the ordinance extended.

As always... I would GLADLY discuss this with anyone over the phone or in person. Feel free to reach out with any questions.

On that note, I would invite the City Of Greeley City Council to view the 8th & 9th Street plaza, any day of the week, morning, afternoon, & evening, to see just what this "Field Of Dreams" mentality, has produced. Closing off the Plazas, didn't help from 1985-2002(until the Plazas were reopened) & August 21, 2020, the result is still painfully evident. I would also ask that you TALK to the individual business owners, tenants, property owners who reside downtown Greeley, I believe you will find there to be a consensus here.



I am a resident on 9th St, one of the streets that is closed off for the Open Container Area, and it has been brought to my attention that the event may be extended. I am writing to discourage the event from continuing, as it has not only had a negative impact on my life, but it has not been conducted how we were first told it would be.

My first grievance with the event is how it has impacted my ability to get food and groceries delivered to my place of residence. Due to the road being continually shut off, delivery is no longer a viable option and it is something I had been reliant on before the event started. I have no transportation on my own, so I must make a 4 mile walk with groceries until the road opens back up.

The second reason is the fact that statements made on the original posted paper, the one that was on the front of my apartment door, were not upheld. It was said that there would be no live music, yet I have witnessed live music outside since. There is a mask mandate, yet I see more people without them, than I do with them. It was told that tables were going to been regularly cleaned, and I saw old spaghetti get left out under a table for three days. All hand cleaning stations were wrapped up and covered for almost a week. There was human vomit and feces in the connection between 8th st (where the jazz music plays) that had just been left to decay. It gives the impression that sanitation and the safety of those who attend or live here are not a concern.

I understand that the event was created to draw in a crowd and bring money into local business, but it has had more of a negative impact on the cleanliness of the area and the lives of those who live here.

Hello Mayor Gates & Council,

As requested, we have gathered as much feedback as possible for your upcoming decision on the Open Container 60-day extension on the plazas in downtown. Because your email boxes are no doubt filling up, I will spare forwarding all of the individual emails and instead summate the information as concisely as possible. For each street I have indicated the number of total businesses or properties owners. Residents are difficult to contact/track as we often do not have contact information for them. Please let me know if you have any questions.

31-8th Street Businesses:

- 12 supportive
- 2 against

23-9th Street Businesses:

- 13 supportive
- 0 against

10- Adjacent 8th/9th Avenue Businesses:

- 5 supportive
- 1 against

Approx. 23 Property Owners (representing 35 properties):

- 11 supportive (representing 20 properties)
- 2 against (representing 5 properties)

Residents (est. 15-20?)

- 3 supportive
- 3 against

A few quotes from these businesses and property owners:

- "If it is helping at all then we should keep doing it"
- "The open consumption zone seems to be working OK now with minimal disruption to downtown business and residents and I am in favor of a 60-day extension as a way to support our downtown restaurants."

- "I am all in. If this is helping the restaurants and bars, lets continue. It isn't hurting me in any way, and might be helping (no way to really know)."
- "We need to draw people back to downtown Greeley. We need more sales tax revenues since Covid has hurt things so badly. I favor the open container extension, provided people act like responsible adults."
- "Closure of the plazas has not impacted our business. We have no concerns with the extension and want to support restaurants and bars as much as they can."
- "If it helps the restaurants and bars, it's what we need to do."
- "We are totally supportive and this may encourage us to open our business again sooner."

One suggestion for compromise that a resident wanted me to share for 8th Street:

"We wondered if a good compromise for those residents and businesses who are concerned about weekday parking would be to keep the picnic tables out (not on the street) but reopen the street without open container during the weekdays. Then from Friday through Sunday close the streets and reimplement open container. To be honest we have not seen a ton of people availing themselves of the open container during the week (with the exception of Brix on Weds trivia but I think Tommy could accommodate everyone on the extended patio). But if the only choice is to extend the full street closures we wouldn't be opposed to that."

It is the position of the DDA to fully support the extension as the negative impacts have been minimal and the benefit has been meaningful to our restaurants and bars, even with quieter daytime usage. Please let me know if you would like me to send pictures and videos that show the outdoor seating being well utilized (pictures really do tell different stories depending on who is taking them!). Our hope too is that with temperatures (hopefully) cooling in the next couple months that the public will be even more inclined to take advantage of this outdoor seating opportunity.

Good luck with the decision tomorrow and thanks for all you do for downtown!
