



November 2020 Tax Renewal Initiatives Discussion – Survey/ Polling Results and Next Steps

Background:

During the March 10, 2020 Work Session, the City Council was presented with information regarding potential ballot measures related to renewals of existing tax initiatives as a part of the November 2020 ballot – the Food Tax and the Keep Greeley Moving Tax.

Existing Tax	Description	Current Expiration
Food Tax	The Food Tax, which is a sales tax of 3.0% on groceries only, was originally approved by voters in 1990 and has remained at the same rate for each five-year renewal since that time. The purpose of the Food Tax has been and remains focused largely on the repair and/ or replacement of public buildings, recreational facilities and streets.	December 31, 2021 • Renewal would typically be sought in November 2020
Keep Greeley Moving	Greeley voters first approved the Keep Greeley Moving (KGM) Tax in 2015 for a period of a seven-year 0.65% sales (food exempt) focused on street related improvements and repairs.	 December 31, 2022 Renewal would typically be sought in November 2021

At that time, the recommendation was made by the Citizen Budget Advisory Committee (CBAC) and City Staff to seek renewal of both the existing Food Tax and Keep Greeley Moving Tax on the November 2020 ballot. The recommendation to seek renewal of the Keep Greeley Moving

tax one year earlier than normal was intended to enable staff to start developing master plans that will identify the prioritized capital needs within the areas of facilities, transportation, culture parks and recreation, over a five to ten year period. The development of this information would be critical to informing a community-wide discussion by 2025 of what changes to the existing sales tax structure may be needed to support the community's infrastructure.

At that time, the CBAC provided its recommendation to the City Council with which staff concurred.

Following a presentation and discussion of the information, it was the consensus of the City Council:

- To move forward with the steps to place the Food Tax and Keep Greeley Moving Tax on the 2020 ballot; and
- That there will no longer be an automatic transfer related to the current capital plan for Keep Greeley Moving.

In furtherance of the City Council's consensus, the City released a Public Polling and Outreach Consultant Services Request for Proposals through which Strategies 360 – a Denver based firm – was secured. Surveying/polling of 500 registered Greeley voters – which was made available via landline, SMS and mobile – occurred between May 29 and June 3. A copy of the polling results are attached and will be reviewed by Strategies 360 representatives during the June 23 Work Session.

In addition to polling support of the two existing tax renewals, the polling also followed up on a proposal presented to City Council in 2019 regarding the potential dedication of a new sales tax for the acquisition and maintenance of natural areas and trails in Greeley. While City Council at the time did not support placement of a new tax on the November 2019 ballot, it did direct staff to continue working towards developing more information related to a potential tax. The information secured through this polling provides a baseline for support of such an initiative for future consideration.

It is important to note that the CBAC and Staff recommendations were made prior to the onset of and impacts from COVID-19. Based on those impacts and the polling results, the City Council may want to direct staff to move forward with preparing ballot language and a communications plan for the renewal of the Food Tax only as a part of the November 2020 ballot.

The tentative timeline for the setting of November 2020 ballot language is provided below:

 - b. Renewal of the 0.65% Keep Greeley Moving Tax (sales tax on all retail goods food exempt) for a seven-year period to expire in 2029?








METHODOLOGY


- Strategies 360 conducted a citywide survey of 500 registered voters.
- Interviews were conducted May 29 June 3, 2020.
- This mixed-mode survey included interviews on cell phones, landlines, and online via MMS invitations.
- Respondents could opt to take the survey in English or Spanish.
- The margin of error for a survey of 500 interviews is ±4.4% at the 95% confidence level. The margin of error for other subsamples may be higher.
- Other sources of error not accounted for by the stated statistical margin of error include, but are not limited to, question wording, question order, coverage bias, and response bias.











Views on generic infrastructure spending after arguments on both sides*





OUTREACH & EDUCATION MESSAGES (CONT.)

KGM record

In less than five years since it was approved by Greeley voters in 2015, the Keep Greeley Moving tax has allowed the city to repave, reconstruct, and improve nearly 142 miles of streets and 38,000 feet of sidewalks.

Food tax history

Greeley's tax on food purchases like groceries was originally approved in 1990 and has been renewed by voters five times since then. For most of the past three decades, it has been the city's only funding source for infrastructure repairs.

Losing ground


These voter-approved taxes have funded critical infrastructure projects in Greeley, but we're losing ground every year because of the rising cost of construction and aging infrastructure. Renewing these existing taxes now will help the city keep up with repairs

Parks & Rec

In addition to street repairs, Greeley's tax on food purchases has helped the city update and improve many of the city's parks, rec centers, trails, such as Island Grove park and the Union Colony Civic Center—improving the quality of life for all Greeley residents.

MESSAGE RECOMMENDATIONS

- Emphasize growth to highlight the importance of Food Tax and KGM revenue for keeping up with the city's infrastructure.
- Remind taxpayers that even though this is an unprecedented time, conducting street repairs sooner rather than later costs less than waiting until they're more expensive to fix.
- Reassure the community that the city is a responsible steward of taxpayer money by reminding them that a citizens committee will oversee spending and spending information will be accessible to the public.
- Generally speaking, there's no need for complex message segmentation when communicating with the public—the top messages are well-received across the board.








Should the city choose to pursue infrastructure tax renewal, it would help street crews make much-needed repairs and improvements to Greeley's streets. By doing basic street maintenance now, taxpayers will save money in the long run. Taking care of these repairs sooner rather than later can keep them from becoming more expensive to the taxpayer and more time consuming for repair crews.




