### 1.. Old Business

- Aesthetic Review Committee (ARC).
  - Champion: Mr. Nicols
  - Relevant City Offices
    - o Mr. Daniels, Planning and Zone discussion report.
    - Mr. Kennedy, City Manager. Mr. Hurley reports that Mr. Kennedy is not in favor of an ARC. Would like a compromise. Update?
  - The Issue: There does not appear to be any standard regarding the overall "look" of projects undertaken on commercial and City properties which leads to a hap Hazzard, and often unsightly results. There needs to be some sense of continuity. In several cases, the results is an actual safety issue.
  - Review of questions identified during the last meeting. Do we still concur?
    - Where would this group fall in the review process? The consensus is that this would be the first stop for any new permit or project.
    - o What City agency would this fall under? Planning and Zoning.
    - Who would comprise this committee; citizen volunteers, city employees, or a combination of both?
      - The city will decide how the function would be staffed while we focus on the scope and guidelines for this function.
      - We will develop the standards and process for the city to then implement.

- What does the new 20-year plan for the city say about an overall design/aesthetic standard? Per Mr. Hurley, the 20-year plan calls for a review committee. Will include the exact wording in the next minutes.
- Consensus that this issue involves two separate programs.
  - City projects which do not go through the normal permitting review process such as concrete pads in the park, etc.
  - o Commercial and municipal building projects that do.
- Need to establish what the esthetic vision for the city is!
  - When you think of Charleston, Savannah or St Augustine, a specific image comes to mind. What is that image for Green Cove Springs?
  - o We should propose one for the city to react to if one does not exist.
  - O Guidelines for the AEC to base its decisions on need to be developed that reflect the vision for the city, and codified so that decisions are not arbitrary.
    - **Each** member is to bring draft guidelines and a vision for the city to the next meeting.
