DETERMINATION REGARDING CONDUCTING TOWN OF HIDEOUT PUBLIC MEETINGS WITHOUT AN ANCHOR LOCATION

The Mayor of the Town of Hideout hereby determines that conducting a meeting with an anchor location presents a substantial risk to the health and safety of those who may be present at the anchor location pursuant to Utah Code section 52-4-207(5) and Hideout Town Ordinance 2020-03. The facts upon which this determination is based include: The seven-day rolling percent and number of positive COVID-19 cases in Utah has been over 30.93% of those tested since July 28, 2022. The seven-day average number of positive cases has been, on average, 739 per day since August 3, 2022.

A RESOLUTION ADOPTING A CERTIFIED TAX RATE FOR FISCAL YEAR 2022 -2023

WHEREAS, Utah State Code, 10--5-112 mandates that before June 30 of each fiscal period, or, in the case of a property tax increase under Sections <u>59-2-919</u> through <u>59-2-923</u>, before September 1 of the year for which a property tax increase is proposed, the governing body shall by resolution or ordinance adopt a budget for the ensuing fiscal period for each fund for which a budget is required under this chapter; and

WHEREAS, State law further mandates that the budget officer of the governing body shall certify a copy of the final budget and file the copy with the state auditor within 30 days after adoption; and

WHEREAS, The Town Council desires to increase the certified tax rate by 28.03 percent; and

WHEREAS, Utah State Code requires that, commensurate with such a tax increase, the Town held a Truth in Taxation public hearing, and the date set for said hearing is August 11, 2022; and

WHEREAS, the Utah State law requires that town budgets be adopted by resolution or ordinance,

NOW THEREFORE, BE IT RESOLVED by the Town Council of Hideout, Utah that: <u>SECTION 1, CERTIFIED TAX RATE ADOPTED.</u> The property tax rate required for the Fiscal Year 2022-2023 adopted budget is as follows:
