DETERMINATION REGARDING CONDUCTING TOWN OF HIDEOUT PUBLIC MEETINGS  
WITHOUT AN ANCHOR LOCATION

The Mayor of the Town of Hideout hereby determines that conducting a meeting with an anchor location presents a substantial risk to the health and safety of those who may be present at the anchor location pursuant to Utah Code section 52-4-207(5) and Hideout Town Ordinance 2020-03. The facts upon which this determination is based include: The seven-day rolling percent and number of positive COVID-19 cases in Utah has been over 17.75% of those tested since November 2, 2021. The seven-day average number of positive cases has been, on average, 1649 per day since November 7, 2021.





**CERTIFICATION OF THE 2021 GENERAL MUNICIPAL ELECTION RESULTS,  
HELD NOVEMBER 2, 2021**

I, Alicia Fairbourne, Town Clerk of Hideout, County of Wasatch, State of Utah, do hereby certify that the following is a full, true and correct abstract of the statement of votes cast for the General Municipal Election held on November 2, 2021.

**SUMMARY**

With a total of 349 registered voters in Hideout; 161 ballots cast; and 46.13% voter turnout, the following are the results of the 2021 Municipal Election for Mayor, two 4-year term City Council Seats, and two 2-year term City Council seats.

In the race for **Mayor**:

**Philip J Rubin** received 151 votes (94.38%)

**Candidate Withdrawn** received 9 votes (5.62%)

Resulting in Candidate Philip J Rubin being elected to the four-year term of Hideout Mayor.

In the race for **Hideout Council (4 Year Term), Vote for two:**

**Chris Baier** received 137 votes (52.69%)

**Ralph Severini** received 123 votes (47.31%)

Resulting in both candidates being elected to fill the two open seats.

In the race for **Hideout Council (2 Year Term), Vote for two:**

**Bob Nadelberg** received 126 votes (48.84%)

**Carol Haselton** received 132 votes (51.16%)

Resulting in both candidates being elected to fill the two open seats.
