

Regular Council Meeting Minutes

This meeting was held in person with remote attendees present.

- **<u>1.</u>** CALL TO ORDER Mayor Buesinger called to order the Regular Council Meeting at 6:31 P.M.

3. REPORTS TO COUNCIL

3.A. **Police Report:** Captain Lane said that there were 286 calls for service in November, 163 being business checks, 88 public relations, and 11 traffic violations.

Captain Lane stated that the Flock camera installation was a success; all are functional.

Captain Lane said that in preparation for the cold weather homeowners should secure their sheds and outdoor buildings to prevent animals and people from seeking shelter there.

- 3.B. Building Official Report: There were no outstanding items to report.
- 3.C. Engineer Report: Engineer Vasquez said that they continue to review new construction plans. He stated that the **1209 Pine Chase Drive** inspection resulted in identifying some saplings and dead trees for removal.

Engineer Him stated that the **Wirt Road Safety Project** is still under review by the City of Houston and Harris County. He said that he has been communicating with Mr. Laguna on the design of the sidewalk and the need for updated utility surveys. Engineer Him said that Harris County Commission did not put the item on the November agenda, but had responded that they hoped to include it in the December meeting agenda.

Councilmember Carey asked about the asphalt patch on **Pine Creek Lane**. Engineer _____ said that the patch will be redone after the construction at 12 Pine Creek Lane is complete, limiting the amount of heavy equipment driving over it.

Robert Byrne, ____ Bridle Spur Lane, asked about the status of the erosion control project at 1310 Ridgeley Drive as he believes it to be complete. Wants to know about pipes?

4. DISCUSSION

4.A. Discussion of Tree Ordinance Limitations

City Administrator Blevins said that she would like for the Council to review the tree ordinance. She stated that there are a lot of calls from citizens and council members asking if their neighbor has a permit to remove a tree and why it is being cut down. Administrator Blevins said that she appreciates the awareness of neighbors and wants to make sure that the ordinance protects the trees in the City.

Administrator Blevins said that the \$25 fee for a tree removal permit does not cover the cost of the arborist to inspect after removal. She stated that the City relies on the property owner to report the number of trees remaining after a removal. Administrator Blevins said that for new homes there are inspections required before and after construction.

4.B. Discussion of Artificial Turf Applications in Front Yard

Administrator Blevins said that the City discourages property owners from installing artificial turf in the front yard, but there is no ordinance prohibiting it. She stated that the turf would not be allowed in the right-of-way.

Engineer Him said that the permeability of the artificial turf is dependent on the base material and if a waterproofing layer was installed.

Council Member Gordy said that standards should be developed for back yard installations as well.

4.C. Discussion of the delayed lighting renovation project for the city hall building budgeted in FYE 22 and its effect on the FYE 23 Budget

City Administrator Blevins said that the order for the light fixtures as part of the City Hall interior renovation has been delayed. She stated that the carpeting and painting has been completed. Administrator Blevins said that she spoke with the City auditor and recommends leaving the budgeted \$23,911 for the lighting upgrade in the fund balance to be carried over into 2023.

5. DISCUSSION AND POSSIBLE ACTION

5.A. Discussion and Possible Approval of the City of Hilshire Village, Texas Ordinance Number 827-2022 providing for the holding of a General Election on May 6, 2023

Motion made by Mayor Pro Tem Maddock, Seconded by Council Member Carey.

_____ said the election is for council member positions three (3), four (4), and five (5).

Voting Yea: Council Member Gordy, Council Member Crawford, Council Member Carey, Mayor Pro Tem Maddock

The motion carried 4-0.

5.B. Discussion and Possible Approval of a payment plan to the Texas Comptroller of Public Accounts for sales taxes received erroneously

Motion made by Mayor Pro Tem Maddock, Seconded by Council Member Carey.

Administrator Blevins said that a Hilshire Village citizen had paid \$21,596.64 of sales tax to Hilshire Village which should have been paid to the City of Houston. She said Hilshire Village has to pay that money back but there is an option for installments of \$459 per month. She stated that the City is already in another payment plan for undue sales tax from another entity with a remaining balance due of \$2,931.53.

Voting Yea: Council Member Gordy, Council Member Crawford, Council Member Carey, Mayor Pro Tem Maddock

Motion carried 4-0.

5.C. Discussion and possible approval of a Village Fire Department Budget Transfer or Amendment to cover overtime for personnel for an emergency that might arise between now and December 31, 2022.

Mayor Buesinger said that there is no action necessary on this agenda item. He stated that the Fire Commission was able to schedule an emergency meeting and had representation from each member city. Mayor Buesinger said that the commissioners approved a transfer of \$20,000 from the Salaries and Healthcare Fund to cover overtime expenses.

6. <u>CLOSED EXECUTIVE SESSION</u>: The Council did not convene into an executive session.

7. REPORTS TO COUNCIL

7.A. **Fire Commissioner's Report:** Mayor Buesinger said that the department is fully staffed and _____ is training under Fire Marshal Kattner. He stated that the two (2) ambulance chassis have been ordered and delivery is expected mid to late spring.

Mayor Buesinger said that the contractor has taken responsibility for the incorrect installation of the fire station roof. He stated that the roof will be replaced in sections to limit operational disruptions, and the project will not start until all materials have been received.

Mayor Buesinger stated that the commission approved for a coating to be applied to the annex roof including caulking around the windows to cost \$20,000.

Ambulance wait times trending down, _____ Hospital has the quickest admit time.

Mayor Buesinger said the next fire commission meeting is January 25, 2023.

There were comments and questions from the audience regarding the Village Fire Department which were not discussed publicly per advice by Attorney Bounds.

- 7.B. **Mayor Buesinger's Report:** Mayor Buesinger thanked the City Council for their volunteered time and dedication.
- 7.C. **City Administrator's Report:** Administrator Blevins said that there is an additional invoice to be added to the Consent Agenda, it is from HDR Engineering and she reminded them of the deadline for council agendas.

Administrator Blevins stated that the Lift Station Generator will have the meter installed tomorrow by CenterPoint and should be functional before the freeze. Council Member Gordy said that he thinks there is room for a sliding gate to protect the equipment while allowing easy maintenance access. Engineer Him said that he would confer with colleagues but believes there needs to be a three (3) foot clearance between the equipment and fencing for air flow. 7.D. **City Treasurer's Report:** Administrator Blevins provided the Council with check registers. There were no comments or questions.

HDR Engineering, Inc. (HDR) is pleased to submit this report on engineering related issues from November 11, 2022 to December 16, 2022.

- 1. On-Going Services (10336207):
 - a. 8005 Anadell Street -
 - On December 2, 2022, HDR received a Drainage Plan for 8005 Anadell Street. The drainage plan is currently being reviewed for comments.
 - b. 1311 Friarcreek Lane -
 - On December 15, 2022, HDR reviewed and returned comments for the Drainage Plan for 1311 Friarcreek Lane.
 - c. 1315 Friarcreek Lane -
 - On December 15, 2022, HDR received a Drainage Plan resubmittal for 1315 Friarcreek Lane. The drainage plan is currently being reviewed for comments.
 - d. 1326 Glourie Drive -
 - On November 29, 2022, HDR reviewed the As Built Drainage Plan and provided an As Built Drainage Inspection for 1326 Glourie Drive. The inspection failed and comments were returned on December 1, 2022.

- e. 1126 Guinea Drive -
 - On December 16, 2022, HDR reviewed and returned comments for the Drainage Plan for 1126 Guinea Drive.
- f. 1210 Hilshire Villa Drive
 - On December 16, 2022, HDR reviewed and returned comments for the Drainage Plan for 1210 Hilshire Villa Drive.
- g. 1209 Pine Chase Drive
 - On December 9, 2022, HDR, City Staff, Council Member Maddock and Resident Mr. Bill Bristow conducted a meeting to visit the drainage easement near 1205 and 1209 Pine Chase Drive.
 - The existing conditions of the easement area were walked and reviewed by the meeting attendees to address drainage concerns noted by Mr. Bristow. Discussion was made to identify what existing features were of concern regarding a potential drainage/flooding issue. It was concluded that the area was to be maintenance by removing items identified such as an existing palm tree, saplings and any dead landscaping subject to coordination with the residents at 1205 and 1209 Pine Chase prior to removal.
 - Based on the meeting discussion, it is recommended that City Staff coordinate landscaping services to improve the area as noted and to notify and coordinate with the residents at 1205 and 1209 Pine Chase prior to commencing any scheduled maintenance.
- h. 1131 Wirt Road -
 - On December 1, 2022, HDR received a Drainage Plan for 1131 Wirt Road. The drainage plan is currently being reviewed for comments.
- i. Pine Chase Grove Water Meters -
 - HDR continues efforts to coordinate with the City of Houston to provide guidance on options to improve the appearance and safety of the Pine Chase Grove easement area.
- j. Wirt Road Safety Project/ Interlocal Agreements -
 - HDR has been coordinating with Landtech, Inc. (Survey Subconsultant) on the survey work for this project. Due to the end of year holidays and prior commitments, the survey work for this project will be conducted at the

beginning of the year. Landtech will coordinate with 811 (Call Before You Dig) to get existing utilities marked in the ground before they conduct the survey.

- HDR has received record drawings information from AT&T and CenterPoint Electric & Gas. HDR is still waiting on record drawings information from Verizon and Comcast, if any. This information will be incorporated with the survey data in order to prepare the drawing backgrounds.
- HDR has also been coordinating with Mr. Jose Laguna (COH InterAgency Coordinator) on the tentative schedule for the Wirt Road Sidewalk Improvements Preliminary Plans, anticipated on early February 2023, to begin design coordination efforts accordingly.
- On December 8, 2022, HDR followed up with Ms. Weona Dean (Harris County Engineering) regarding the status of the Interlocal Agreement (ILA) between Harris County and Hilshire Village. The ILA was not included in the November 29, 2022 Commissioners Court Agenda as initially planned due to some issues on their end; however, they are aiming to place it in the December 13, 2022 Agenda, or the January 10, 2023 Agenda at the latest.
- Similarly, on December 8, 2022, HDR followed up with Mr. Patrick Nguyen on the status of the ILA between the City of Houston and Hilshire Village. Mr. Nguyen noted that it is still under review by the City's Legal Department and he will follow up with any updates.

ORDINANCE NUMBER 745

AN ORDINANCE AMENDING CHAPTER 7 OFFENSES AND NUISANCE OF THE CODE OF ORDINANCES OF THE CITY OF HILSHIRE VILLAGE, TEXAS, BY REPLACING ARTICLE NO. 7.700 IN ITS ENTIRETY, AND DELETING AR-TICLE 3.700, TREE PROTECTION, OF CHAPTER 3, BUILDING AND CON-STRUCTION IN ITS ENTIRETY. ESTABLISHING RULES AND REGULATIONS CONCERNING TREE PRESERVATION; PROVIDING A PENALTY IN AN AMOUNT PROVIDED FOR IN SECTION 1.106 OF THE CITY'S CODE OF OR-DINANCES FOR ANY VIOLATION OF ANY PROVISION OF THIS ORDI-NANCE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN-CONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVER-ABILITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS:

Section 1. The Code of Ordinances of the City of Hilshire Village, Texas (the "Code"), is hereby amended by replacing Article 7.700 under Chapter 7 Offenses and Nuisance in its entirety, to provide as

follows:

ARTICLE 7.700. - TREE PRESERVATION

Sec. 7.701 – Purpose and Definitions

1. The purpose of this article is to preserve the Tree canopy and continue the wooded character that has been the hallmark of the city since its founding while protecting owners' rights to utilize and enjoy their property by:

- a. establishing minimum Tree requirements,
- b. requiring careful site planning and the protection of Trees,
- c. controlling unnecessary Tree removal,
- d. requiring Tree replacement, and
- e. prohibiting indiscriminate cutting or clearing of Trees.

2. Properties used for commercial purposes are exempt from Section 7.701 1(1a) and 1(1b) of this article.

Sec. 7.702 – Definitions

As used in this article, the following words, terms, and phrases shall have the meanings ascribed to them in this section:

Approved Tree List shall mean a list approved and maintained by the city that lists species of Trees that are approved for meeting the minimum tree requirement described in this article.

Building shall mean any structure with a roof and enclosing walls that is used or intended for supporting or sheltering any use or occupancy.

Circumference or Diameter shall mean circumference or diameter measured at a point on a Tree four and one-half feet (4½) above the surrounding ground level. The equivalent Circumference or Diameter

may be used for measurement purposes. Tree Diameter in inches x 3.14 = Tree Circumference in inches. (For example, 6" Diameter X 3.14 = 18.84" Circumference). To measure a Tree that forks or has two boles or stems at or below four and one-half feet (4½'), only the Circumference or Diameter of the larger bole or stem shall be measured.

Critical Root Zone shall mean the area of a Tree that is within a circle centered on the trunk location, with the circle's Diameter being one-half of the sum of the longest and shortest drip line Diameters.

Subject Site shall mean any particular lot, tract, or parcel of land that is subject to the building permit process or otherwise invokes the regulations established in this article.

Tree shall mean a woody, perennial plant typically having a single stem or trunk, growing to a considerable height and bearing lateral branches at some distance from the ground.

Tree Removal Permit shall mean a permit issued by the city for the removal of a Tree.

Sec. 7.703 – Minimum Tree Requirement

- (1) Each lot shall have one (1) Tree that is eight inches (8") or greater in Diameter for every 2,000 square feet of lot area (excluding any land in the Harris County Flood Control District or utility easement), rounded to the nearest whole number (see Table 1). Trees in the Harris County Flood Control District or in a utility easement will not be counted.
- (2) If a lot has less than the number of Trees described in the preceding subsection, the owner shall keep the number of Trees larger than three inches (3") in Diameter, counting from the largest Diameter to the smallest Diameter, that are on the lot (excluding any land in the Harris County Flood Control District or a utility easement) at the time a Tree Removal Permit is sought or the provisions of this article are otherwise invoked.
- (3) A lot owner who is applying for a permit issued under the building permit process of the City's Code of Ordinances for the demolition of, construction of, or addition to any Building, or installation of a swimming pool shall, regardless of the number or size of the Trees existing on a lot prior to issuance of a permit, plant such additional Trees as may be necessary to meet the minimum tree requirement described in subsection (1) above if the owner is:

(a) constructing a new or replacement Building,

(b) constructing an addition[s] or extension[s] to an existing Building that increases the square footage of the Building by 40% or more, or

(c) installing a swimming pool.

Sec. 7.704 – Preservation and Protection of Trees

- (1) It is unlawful to remove any Tree that is eight inches (8") in Diameter or greater without first obtaining a tree removal permit from the city for each Tree to be removed.
- (2) It is unlawful to remove a Tree that is less than eight inches (8") in Diameter without first obtaining a tree removal permit from the city if:
 - (a) such Tree is required to meet the minimum tree requirement for the lot as described in section 7.703(2), or

(b) such Tree was planted as a replacement for a previously removed Tree.

- (3) It is unlawful to intentionally cause serious damage or death to any Tree that is eight inches (8") in Diameter or greater. Intentionally severing the main trunk or large branches or large roots, girding, poisoning, carving, mutilating, touching with live wires, piercing with nails or spikes, crushing or exposing the roots, or digging or drilling any hole or trench larger than three cubic feet (3 ft³) within the Critical Root Zone, unless no other suitable location is possible, may be considered acts intended to cause serious damage or death to the Tree.
- (4) Before beginning demolition or construction, appropriate protection for all Trees shall be in place. Appropriate protection shall mean, at a minimum, a fence four feet (4') in height and composed of a material which is strong enough to prevent vehicles, materials, debris, dirt and other demolition or construction refuse from pil-ing up within the Critical Root Zone. Where possible, the fence shall be a minimum of six feet (6') away from the base of the Tree at all points to prevent damage to the Tree. If the location of a tree is less than six feet (6') from the foundation of the building or the property line, the protective fencing shall be located as far as possible from the base of the tree.

- (a) The applicant's lot will, after removal of the Tree, satisfy the minimum Tree requirement as described in section 7.703(1),
- (b) The Tree is diseased, dying or dead,
- (c) Construction is planned in the area where the Tree stands,
- (d) The Tree creates a hazard that is or is likely to cause damage to property or danger to the public health, safety, or welfare, or
- (e) Good arbor management practices indicate removal will be beneficial to surrounding Trees.
- (2) If the previous subsection is satisfied, the city will issue a Tree Removal Permit if a lot owner completes the following steps:
 - (a) Executes the city's Tree Removal Permit application, which includes a certification that, upon removal of such Tree, either the lot will continue to satisfy the minimum tree requirement as described in section 7.703(1) or the lot owner will comply with Section 7.706 below regarding Tree replacement. If concurrent Tree Removal Permits are sought, the minimum tree requirement must be satisfied after all Trees are removed.
 - (b) Pays the application fee as adopted by city council. The application fee shall be waived by the city if the applicant shows that the Tree to be removed is diseased, dying or dead or if, after removal of a Tree, the lot has more than the minimum Tree requirement in section 7.703(1).
- (3) The city shall have a reasonable amount of time, but not less than 3 business days, to review the application. The city may require an owner to provide certification by an arborist that the criteria in subsection (1)(b), (d) or (e) exist.
- (4) Removal of a Tree without a Tree Removal Permit shall not constitute a violation of this article if immediate removal is necessary to protect against a serious and imminent risk to health, safety, or property as a result of an emergency and, because of such emergency, the lot owner could not obtain the Tree Removal Permit, provided that, as soon as reasonably possible after such Tree removal, the lot owner submits a Tree Removal Permit application without the fee and demonstrates that such emergency existed.
- (5) The city may require a lot owner to remove any Tree that is damaged, dead or dying, and that the city deems a danger to person or property. The owner shall have fourteen days (14) after receipt of the notice to remove the Tree.
- (6) Removal of a Tree shall be performed by the lot owner or by a reputable Tree removal company, and the owner shall ensure that the Tree removal work is adequately covered by bond or insurance.

Sec. 7.706 – Replacement of Trees

- (1) If, after loss of or removal of a Tree, a lot does not or will not satisfy the minimum tree requirement as described in section 7.703(1) or (2), as applicable, then the lot owner shall, within 120 days after loss of or removal of such Tree, properly plant a replacement tree from the Approved Tree List. The replacement Tree shall be at least three inches (3") in Diameter measured at six inches (6") above the grade for each lost or removed Tree. A tree intended as a replacement tree shall not be planted in the Harris County Flood Control District or in a utility easement, but nothing in this article is otherwise intended to prohibit the planting of trees in the Harris County Flood Control District or a utility easement.
- (2) With the approval of the city's arborist, a lot owner may plant additional species that are not on, but are similar in size to those that are on, the Approved Tree List. If the city's arborist does not approve, the owner may appeal by submitting a written request to city council. Property owners are encouraged (but not required) to plant Trees native to the Texas Gulf Coast.
- (3) In situations of financial hardship, the city will have flexibility in obtaining outside help with re-forestation.

Sec. 7.707 - Tree Survey

(1) Every permit issued under the building permit process of the City's Code of Ordinances for the demolition of, construction of, or addition to any Building, or the installation of a swimming pool shall include a Tree survey. Permit applicants must obtain and complete the proper forms, available in the city office, to show compliance with this article.

- (2) The permit holder will make every effort to maintain the distribution of existing Trees. However, if the design, layout, plans, or construction of the proposed Building cannot avoid the removal of any Tree that is eight inches (8") in Diameter (25.12" in Circumference) or larger, then the permit holder shall be required to replace each removed Tree with a Tree from the Approved Tree List. Each replacement Tree shall have a minimum caliper of three inches (3") in Diameter (9.42" in Circumference).
- (3) The Tree survey shall be prepared by a person with expertise to prepare such a document, such as an architect, engineer, arborist, or surveyor.
- (4) The Tree survey shall accurately reflect, at a minimum, the following information:
 - (a) The actual location (i.e., trunk location), Diameter, and type of each Tree on the Subject Site which is eight inches (8") in Diameter (25.12" in Circumference) or larger,
 - (b) Building or structure outlines, parking areas and other paved surfaces, fences, utilities, and other improvements existing or to be constructed,
 - (c) The location of Tree protection fences,
 - (d) A scale, north arrow, name, address, phone number and profession or occupation of the person who prepared it, and the name of the permit applicant, and
 - (e) Identification of the real estate development and a description of the Subject Site and its location.
 - (f) The location and square footage of utility and flood control easements, and the square footage of the lot excluding utility and flood control easement square footage.

Sec. 7.708 - Final Inspection and Issuance of Certificate of Occupancy

At final inspection under every building permit that includes a Tree Survey, the city's inspector shall inspect and confirm compliance with the Tree survey and planting of required Trees, if any. No certificate of occupancy shall be issued until the minimum Tree requirement has been met but, if the certificate of occupancy is to be issued between May and September and the owner has agreed to meet the Minimum Tree Requirement, a provisional certificate of occupancy may be issued until such time as the owner has complied.

Sec. 7.709 - Destruction of or Damage to Trees on Public Property

In addition to the violation of any criminal law dealing with destruction of public property, it shall be unlawful to remove, destroy, kill, or damage any Tree located on any public property in the city except when necessary in furtherance of the public health, safety or welfare. This section shall not prevent the city or any public utility from performing necessary maintenance or repair activities that may affect Trees located within easements or on public property.

Sec. 7.710 - Exemptions from Requirements of this Article

- (1) The provisions of this article shall not apply to Trees removed or trimmed within an easement for public or private utilities by the easement's owner, or the owner's employee or authorized contractor, or by the utility provider or its authorized contractor, if the trimming or removal of such Trees is required to properly use or maintain the easement. This article shall also not apply to Trees removed or trimmed by the city or its authorized representative or by the utility provider or its authorized contractor on any public property or within any public right-of-way, including, but not limited to, drainage easements and roadway easements.
- (2) If this article would require a Tree to be planted from May through September in any year, the planting may be delayed until October of that same year.

Sec. 7.711 - Enforcement

- (1) The city has the authority and right to inspect any property to ensure compliance with this ordinance.
- (2) The city may require any lot owner to prove that the owner is in compliance with this ordinance.

- (3) The city may withhold, revoke, or suspend any Tree Removal Permit or building permit if any condition or requirement of this article or such permit is not fulfilled.
- (4) The city may order an immediate stop to the removal of any Tree, any activity that is likely to cause serious damage or death to any Tree, or any demolition or construction of a Building, if such activity is being done in violation of this ordinance.
- (5) The city has the authority to hire a tree inspector for advice in conjunction with enforcing this ordinance.
- (6) Anyone that intentionally, knowingly, recklessly, or with criminal negligence violates any of the provisions of this article shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined in an amount as provided for in the general penalty provision in Chapter 1, Section 1.106, of the City's Code of Ordinances. Each day during which such violation shall exist or occur shall constitute a separate offense. The owner of any property where any violation of this article occurs and any agent, contractor, builder, architect, individual or entity that assists in the commission of such offense shall be guilty of a separate offense and, upon conviction thereof, shall be punished as above provided.

Sec. 7.712 - Appeal

Anyone whose request for a building permit, Tree Removal Permit, or certificate of occupancy has been denied due to the interpretation or application of this article may appeal that decision to the city council by filing a written notice of appeal with the city. The city council shall provide the applicant an opportunity to present evidence and arguments demonstrating that the applicant has complied with this article and is entitled to a permit or certificate of occupancy, and that the city erred in refusing to issue the requested permit or certificate of occupancy. If, at the conclusion of the hearing, a majority of the city council determines that the applicant is entitled to a permit or certificate of occupancy, the city shall issue one. Otherwise, the city's denial shall be affirmed.

<u>Section 2</u>. Any person who shall intentionally, knowingly, recklessly, or with Criminal negligence violates any provision of this Ordinance, shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$2,000. Each day of violation shall constitute a separate offense.

<u>Section 3</u>. To the extent there may exist any conflict or inconsistency between the terms of any two ordinances of the City, the more restrictive of the two documents shall prevail and shall be interpreted and enforced according to its own terms.

Section 4. In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Hilshire Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

AN ORDINANCE OF THE CITY OF HILSHIRE VILLAGE, TEXAS, PROVIDING FOR THE HOLDING OF A GENERAL ELECTION ON MAY 6, 2023, FOR THE PURPOSE OF ELECTING THREE (3) COUNCILMEMBERS, PLACE THREE, FOUR, AND FIVE FOR A FULL TERM OF TWO (2) YEARS AND PROVIDING DETAILS RELATING TO THE HOLDING OF SUCH ELECTION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS:

Section 1. In accordance with the general laws and Constitution of the State of Texas, a General Municipal Election is hereby called and ordered for the first Saturday in May, 2023, the same being the 6th day of said month, at which general election all qualified voters of the City may vote for the purpose of electing three (3) Council Members, place three, four and five for a full term of two (2) years. The City Secretary is hereby directed to post on the City bulletin Board notice of the dates of the filing for the general election by December 19, 2022 (Form AW 1-15). The City Secretary is further directed to post the date and location of the election for officers and the requirements and deadline for filing for candidacy for each elected office of the City continuously on the City's internet website.

Section 2. No person's name shall be placed upon the official ballot as a candidate for any of the above-mentioned positions under the General Municipal Election unless such person has filed a sworn application, as provided by Section 141.031 of the Texas Election Code, with the City Secretary of the City at the City Office, located at 8301 Westview, Houston, Texas 77055, not later than five o'clock (5:00) p.m. on Friday, February 17, 2023. The City Secretary shall note on the face of each such application the date and time of its filing. Such application shall include the office the candidate is seeking.

<u>Section 3.</u> The present boundaries of the City constituting one election precinct, the polls shall be open for voting from seven o'clock (7:00) a.m. until seven o'clock (7:00) p.m. at the following polling place, and the following are hereby appointed officers to conduct the above-described election at said polling place:

ELECTION OFFICER

Presiding Judge to be appointed at a later date

The City Secretary is hereby authorized and directed to provide a copy of this Ordinance and the other written information required by Section 32.009 of the Texas Election Code to each judge as required by said Section.

The presiding Judge shall have the authority to appoint one (1) alternate Presiding Judge and the necessary clerks to assist in the holding of said elections, but in no event, shall the Presiding Judge appoint less than two (2) clerks. Unless otherwise required to act in the capacity of Presiding Judge, the Alternate Presiding Judge shall also serve as clerk of the election. The Presiding Judge and the Alternate Presiding Judge shall also serve as the early voting ballot board for such election; the Presiding Judge of the election precinct shall also serve as the presiding officer of such board.

<u>Section 4.</u> The City Secretary is hereby appointed clerk for early voting and the appointment of a deputy clerk or clerks for early voting by the City Secretary shall be in accordance with Section 83.031 *et seq.* of the Texas Election Code at the following early voting polling place:

Said clerks shall keep said office open during the hours that the City Secretary's main office is regularly open for business, that is, from nine o'clock (9:00) a.m. until five o'clock (5:00) p.m. on each day for early voting by personal appearance which is not a Saturday, a Sunday, or an official state or federal holiday, beginning on Monday, April 24, 2023, and continuing through Tuesday, May 2, 2023. In addition, said clerks shall keep said office open from seven o'clock (7:00) a.m. until seven o'clock (7:00) p.m. on Monday, May 1, 2023, and Tuesday, May 2, 2023. Said clerks shall not permit anyone to vote early by a personal appearance on any day that is not a regular working day for the clerk's office and, under no circumstance, shall they permit anyone to vote early by personal appearance at any time when the such office is not open to the public. The above-described place for early voting is also the clerk's mailing address to which ballot applications and ballots voted by mail may be sent. The early voting clerk, in accordance with the provision of the Texas Election Code, shall maintain a roster listing each person who votes early by personal appearance and each person to whom a ballot to be voted by mail is sent. The roster shall be maintained in a form approved by the Secretary of State.

<u>Section 5.</u> Paper ballots and the "Express Vote BMD Terminal" voting system shall be used for early voting by personal appearance and for voting on Election Day. Early voting by a method other than by personal appearance shall be by paper ballot. All expenditures necessary for the conduct of the elections and the purchase of materials, therefore, are hereby authorized. Compensation for all election officials is hereby established at no more than the maximum amounts permitted under Section 32.091 *et seq.*, Texas Election Code.

<u>Section 6.</u> The City Secretary is hereby authorized and directed to furnish all necessary election supplies to conduct such elections.

<u>Section 7.</u> The candidate receiving the highest number of votes shall be declared elected to such office or position.

Section 8. The order, in which the names of the candidates are to be printed on the ballot for the general election, shall be determined by a drawing by the City Secretary, as provided by Section 52.094 of the Texas Election Code. The City Secretary shall post a notice in their office of the date, hour, and place of drawing. Such notice shall remain posted continuously for seventy-two (72) hours immediately proceeding the scheduled time of the drawing, and personal notice shall also be given to any candidate who makes a written request for such notice and furnishes to the City Secretary a self-addressed, stamped envelope. Each candidate involved in the drawing, or a representative designated by him, shall have a right to be present and observe the drawing.

Ordinance No. 827-2023 Approved _____

Section 9. Notice of these elections shall be given in accordance with the provisions of the Texas Election Code and returns of such notice shall be made as provided for in said Code. The Mayor shall issue all necessary orders and writs for such elections, and returns of such elections shall be made to the City Secretary immediately after the closing of the polls.

This letter is to notify you that the City of Hilshire Village was previously overpaid \$21,596.64 in local sales and use taxes. We discovered that a taxpayer erred and reported local taxes based on their home address rather than reporting to the address where their business is located. Since the local taxes were reallocated to the correct taxing jurisdictions, it must now be repaid to the State.

The city is currently in a payback arrangement due to a previous overpayment with an outstanding balance of \$2,931.53 as of the February 2022 allocation and is paying \$212.00 per month through March 2023 with a final payment of \$175.53 in April 2023. This does not include the additional \$21,596.64 mentioned above.

The options to repay the erroneous amount are as follows:

- \Box 1) Full reimbursement by onetime check *,
- \square 2) Apply all monthly collections to the overpaid amount until the amount has been repaid, or
- □ 3) Enter into a 47- month payback agreement where an additional monthly deduction of \$459.00 will be deducted for 46 months with a final deduction of \$482.64. Additionally, future significant audit or onetime payments may be applied toward the repayment amount to reduce the length of the payback and notifications of those applications will be sent as they occur.

* If you choose option 1, "full reimbursement by onetime check," the payback amount should be adjusted by the 2% service fee. Multiply the payback amount by 2% (.02), subtract the 2% amount from the payback amount, then pay the adjusted amount.

In all likelihood, this amount would not be realized. Any needed OT would probably be significantly less. However, it WERE \$20k, the costs to each respective city (at worst) is:

Spring Valley \$3,250 Hunters Creek \$4,450 Hedwig \$3,700 Hilshire \$600 Bunkerhill. \$3,800 Piney Point \$4,200

These are insignificant \$ amounts for each respective city and represent very small percentages of each respective city's annual current budget.

All 6 cities are relying and expecting the services of the VFD to continue at the highest levels during any significant event.



Regular Council Meeting Minutes

This meeting was held in person with remote attendees present.

1. CALL TO ORDER

Mayor Buesinger called to order the Regular Council Meeting at 6:30 P.M.

- **1.A.** Invocation was given by Council Member Gordy.
- 1.B. Pledge of Allegiance

1.C. PRESENT

Mayor Buesinger Council Member Gordy Council Member Crawford Council Member Carey Mayor Pro Tem Maddock Council Member Schwarz

Also present were: City Attorney Bounds, City Engineer Him, City Engineer Vasquez*, City Building Official Taylor, Spring Valley Police Captain Lane, Village Fire Chief Foster, Fire Commissioner Presswood, Alternate Fire Commissioner Cooper, City Administrator Blevins, City Secretary Stephens, and City Clerk Ray.

*Present remotely.

2. Bill Swann, 1302 Bridle Spur Lane, said that there was a bill passed in the last legislative session regarding solar panels that might conflict with the City's current ordinance. He said that the City of Spring Valley has amended its ordinance to comply and asked that the City Attorney review the bill language.

Ron Presswood, 8202 Burkhart Road, said that he is exercising his right to an open discussion of agenda item 8.A. under the Texas Government Code as his position as Fire Commissioner is the topic of discussion.

Brian Muecke, Hedwig Village, said that a letter was circulated which includes allegations against Village Fire Chief Foster. He stated that Chief Foster responded to the allegations in a six (6) page document to the Villages and did not receive a reply. Mr. Muecke said that Chief Foster subsequently retained an attorney who issued a letter on his behalf, which Mr. Muecke read aloud.

Allen Carpenter, Spring Valley, stated that he has been a Spring Valley Council Member for 13 years, Mayor Pro Tem for the last 12 years, has served as Fire Commissioner for 13 years, being the entire tenure of Chief Foster, and has been the Commission Chair twice. He said he feels an obligation to speak on the behalf of his Fire Chief, who works for the Fire Commission, not the Cities. He said it is contradictory to have a resolution in support of the Fire Department and a closed executive session regarding the Fire Commissioner. Mr. Carpenter stated that the Council, not the Mayor, has the right to appoint the city's fire commissioner. He said that Hilshire Village owes an apology to the Fire Chief for the accusations in the letter, some of which he said were decisions made by the Fire Commissioners.

John Cooper, 1214 Ridgeley Drive, said that he has been the Alternate Fire Commissioner for the last two and a half months. He stated that he has spent time at the Fire Department and the employees are happy. He said that no one except Fire Commissioner Presswood should give a directive to the Fire Chief per the Interlocal Agreement, that the Fire Commissioner speaks on behalf of the City. Mr. Cooper said that gossip is being spread without giving the opportunity to respond with facts, and it is likely going to be subject of a libel lawsuit, which the citizens will be paying for. He said that if Commissioner Presswood is removed from the commission then he should also be removed because he doesn't want to be a part of it.

Robert Byrne, 1305 Bridle Spur Lane, stated that recently there has been information allowed to enter the public domain that accuses the Village Fire Chief of lack of transparency, mismanagement of the department's budget and resources, inaccurately reporting operations and misappropriating funds. He said that this has been taken out of context in an effort to undermine the character and employment of the person in charge of directing operations that protect lives and property. He stated that his past experience as c Council Member and fire commissioner has allowed him to have personal knowledge that rebukes the allegations in the letter. He suggested that the Council have conversations with Commissioners and Fire Chief Foster to address the accusations before taking any action. Mr. Byrne said that the Council's understanding of the Interlocal Agreement, the actions of the governing commissioners and how the Fire Chief receives orders and takes action on those orders is critical.

David Foster, Village Fire Chief, said that he has been with the Village Fire Department for 12 years and for 43 years he has been putting on his uniform with the sole intent to protect residents and property. He said that his administrator received a letter from Hilshire Village with serious allegations which are easily proven to be false including that he stole \$20,000. He said he understands there is a movement between three (3) of the Memorial Village Mayors to terminate his employment and stated that he is 61 years old and will have difficulty finding another fire chief job especially with a letter like this in the public. Chief Foster said that if an investigation is needed, he thinks it would be fair to have the State Patrol and State Rangers get involved.

Bill Bristow, 1233 Pine Chase Drive, said that he is interested in updates on the drainage channel at 1209 Pine Chase Drive. He stated that he is interested in the agenda discussion regarding items in the front yard. Mr. Bristow asked that a summary discussion be had after the executive session for the public to hear. He also stated that he still has trouble hearing the speakers and asked that the City make arrangements for him or he will

contact the State of Texas to make a complaint.

Michael Autenrieth, 7903 Hilshire Green Drive, said that he encourages the Council to get to the bottom of the issues with the Fire Chief. He also stated that the ordinance prohibiting parking between the hours of 1:00 A.M. and 5:00 A.M. has unintended consequences. He said that an amendment should be made to allow for circumstances when City Hall is not open, and you cannot purchase a parking pass.

3. REPORTS TO COUNCIL

3.A. Police Report: Police Captain Lane said that there were 214 calls for service last month, 89 being business checks, 61 public relations, and 12 traffic stops. He stated that there was six (6) burglary of motor vehicle incidents. The night shift patrol was able to locate and identify the suspects and is working with surrounding agencies on those cases.

Captain Lane said the new Flock cameras for Pine Creek Lane, Friarcreek Lane, and Hickory Shadows are scheduled to be installed in late November.

3.B. Building Official Report: Building Official Taylor said that residential construction has been steady, and job site violations are being addressed. He stated that the inspectors will continue to monitor the sites weekly.

Building Official Taylor said that BBG Consulting has merged with SAFEbuilt, a national group. He stated that the City's inspectors and leadership will remain the same.

3.C. Engineer Report: Engineer Vasquez said that his observation of the vegetation around the drainage channel at **1209 Pine Chase Drive** did not cause concern. Engineer Him said that he will schedule a meeting with Mr. Bristow to discuss the area and determine any necessary action.

Council Member Carey said that the new drainage pattern from the construction at **7907 Hilshire Green Drive** is highlighting the issue of the street not draining properly.

Mayor Pro Tem Maddock asked if the **City of Houston water quality** issue has been resolved. Engineer Him said that the sample test results have come back at normal levels. He also stated that the City is getting new contacts for the City of Houston Public Works Department.

4. REPORTS TO COUNCIL

4.A. Fire Commissioner's Report: Commissioner Presswood said that the fire station roof needs to be replaced, and during the construction, the vehicles will need to be stored elsewhere. He said the repair of the roof on the back of the building has estimates that are above the budgeted amount, but the commission is looking at alternatives such as a coating on the roof with a 20-year warranty. Robert Byrne, a fire department committee member, said that they met with the architect, general contractor, subcontractor, and HVAC contractor to make a plan

for the roof to be repaired at the expense of the general contractor and his subcontractor. He stated that the work is estimated to start in the middle of December with as minimal impact to operations as possible.

Commissioner Presswood said that four (4) of the six (6) Memorial Villages have approved the **Bunker Gear** replacement costs. He stated that the original request was for \$150,000 but the quote came in at \$121,000. Commissioner Presswood said that there is \$50,000 allocated to bunker gear in the 2023 Budget, and approximately \$70,000 will be transferred from the Ambulance Revenue Fund. Council Member Gordy asked if this purchase would replace all of the bunker gear suits, and if the new suits have any carcinogenic materials. Commissioner Presswood said that the department has 13 sets of the newer generation which don't need to be replaced at this time. He said in the new gear the PFA material is encapsulated.

Commissioner Presswood said that the department is over budget by less than one (1) percent and the Fire Chief is taking actions to limit spending for the rest of the year.

Council Member Carey said that the budget does not appear to include contingencies for unexpected disasters. Council Member Crawford asked if there were any anticipated major expenses for this year. Commissioner Presswood answered, "Not that I am aware of."

- **4.B.** Mayor Buesinger's Report: Mayor Buesinger apologized for missing the last council meeting, he was out of town on a business meeting. He did not have any items to report.
- **4.C. City Administrator's Report:** Administrator Blevins said that the property owner of 1209 Pine Chase Drive has been asked to trim the vegetation around the drainage channel. She said that there was a **water line break** caused by Verizon right-of-way work which has been repaired and the City will be reimbursed. Administrator Blevins stated that a late arrival invoice from Inframark was added to the consent agenda.

Council Member Carey said that there was a flickering streetlight on Archley Drive. Secretary Stephens asked for the pole number to report to CenterPoint for repairs.

4.D. City Treasurer's Report: Administrator Blevins presented the fund balance statements. She said that the second half of the American Rescue Grant in the amount of \$103,000 was received. Administrator Blevins said that the newly opened TexPool account is earning interest. She stated that the City is now fully protected with positive pay on all accounts to prevent fraud attempts. This process requires online verification of physical checks and electronic payments issued before the funds are released.

5. DISCUSSION

5.A. Discussion of front yard obstructions

Secretary Stephens said that the document presented is a summary of different types of items that could be in a front yard.

Mayor Pro Tem Maddock said that recreation in front yards should be allowed as long as it doesn't create an eye sore, specifically large items.

Bill Bristow, 1233 Pine Chase Drive, said that the sports equipment should be brought out when in use and then put back away. He said that when he was younger, they played in backyards.

Attorney Bounds said that some cities have ordinances against fixed structures with exceptions of basketball goals, or requirements that they are in the backyard, while others don't restrict these items at all. He said that sound and lighting are also concerns.

Council Member Carey said that basketball goals are an exception, but other things need to be temporary or in the backyard.

Council Member Gordy said that the reason this came up is because of the batting cage at Pine Chase Grove. He stated that when COVID had everyone at home families were spending more time in their front yards with play equipment. He said basketball goals and rope swings are not as unappealing as the batting cage.

Mayor Pro Tem Maddock said the demographics of the City are changing, and more young families are moving in.

Council Member Schwarz said that it seems like the size of the batting cage is the issue.

Robert Byrne, 1305 Bridle Spur Lane, said that the Planning and Zoning Committee previously discussed this issue, and he would share what they had prepared.

Discussion and Possible Action to Approve recommendations by the Villages Mutual Insurance Cooperative Board for 2023 Insurance Carriers being Blue Cross Blue Shield (Medical, dental, life and long-term disability), and Superior Vision (Vision) for the City of Hilshire Village's Employee Benefits

Motion made by Council Member Gordy, Seconded by Council Member Crawford.

Administrator Blevins said that the 2023 Budget took in account a rate increase.

Voting Yea: Council Member Gordy, Council Member Crawford, Council Member Carey, Mayor Pro Tem Maddock, Council Member Schwarz

Motion carried 5-0.

7.B. Discussion and Possible Approval of Resolution Number 2022-239 showing support of the Village Fire Department Employees

Motion made by Council Member Gordy, Seconded by Mayor Pro Tem Maddock.

Commissioner Presswood asked that an amendment be made to strike the words "fiscal responsibility" from the Resolution.

Bill Bristow, 1233 Pine Chase Drive, said that he appreciates the Village Fire Department and everything they do for the City.

Council Member Gordy amended his motion to approve Resolution Number 2022-239 with the words "and fiscal prudence" stricken, seconded by Mayor Pro Tem Maddock.

Voting Yea on the amended motion: Council Member Gordy, Council Member Crawford, Council Member Carey, Mayor Pro Tem Maddock, Council Member Schwarz

Motion carried 5-0.

8. CLOSED EXECUTIVE SESSION:

8.A. Recess to closed meeting to deliberate the appointment, evaluation and duties of a public officer, the Fire Commissioner, as permitted by Tex. Gov't Code 551.074.

Ron Presswood, Fire Commissioner, exercised his right to an open session per TEXAS GOVERNMENT CODE Sec. 551.074. PERSONNEL MATTERS; CLOSED MEETING. (b).

Mayor Buesinger asked Commissioner Presswood if he had hired legal

representation. Commissioner Presswood answered, "No". Mayor Buesinger said that he received a letter that appeared to be drafted by an attorney.

Mayor Buesinger said that the Village Fire Department's 2023 Budget was presented at the same time as a request for approval of amendments to the 2021 and 2022 Budgets for overages. He stated that he was surprised by these amendments and their causes. Mayor Buesinger said that there was considerable discussion about why the City was not informed earlier. He said that the City has the highest property tax rate of the Memorial Villages and has to plan the budget very carefully as there is not a large commercial area to bring in sales tax revenue.

Mayor Buesinger stated that he attended a Village Fire Department Commission meeting along with other Memorial Village Mayors, where the topic of discussion was budget exceedance in the case of a major event. He said that the meeting did not result in any action, but his interpretation of the message from the commissioners to the department was not to worry, the cities would find a way to fund it. Mayor Buesinger said that he did not think it was in the fire commissioner's authority to approve transfers or increases in the budget. He stated that he later received a call from a Memorial Village Mayor asking about a letter issued by Commissioner Presswood. He said the attorney from Hunters Creek wrote a response to the Village Fire Department that the letter is in conflict with the Interlocal Agreement. Mayor Buesinger said that because of these issues a new direction is needed and therefore is nominating himself as the fire commissioner for the City.

Council Member Carey asked what letter was issued by Commissioner Presswood. Attorney Bounds said that the letter is dated October 5, 2022. Secretary Stephens displayed the letter on the screen in council chambers. Mayor Buesinger said that the letter appears to give the Fire Chief the authority to spend necessary funds possibly exceeding the budget which is not what the Interlocal Agreement says.

Council Member Carey asked what happens if there is an emergency situation. Mayor Buesinger said that the Council will be notified and will conduct an emergency meeting. Council Member Carey asked if the Home Depot is burning down, they will have to meet? Attorney Bounds said the budget should be prepared to include situations like that. Mayor Buesinger said that the Interlocal Agreement states that if the budget is exceeded then it needs to be approved by all six (6) cities. Mayor Buesinger said that minor emergency funds need to be built into the budget, and it doesn't seem to be happening that way.

Council Member Gordy said that the Council was not informed as early as they should have been when the budget overages started, and a change in commission representation was made because of that lack of communication. He stated that the City has a very tight budget, and the Council works hard to maintain the fund balance. He said that there was no time to prepare for these amendments, a failure at the commission level to report to the City. Council Member Gordy said that when the City requested a copy of the budget in excel format it was refused. He stated that he has spent a lot of time at the Fire Department volunteering to help with the construction of the fire station and can tell that it is organized, but he has a concern

with the way the budget is managed.

Mayor Pro Tem Maddock said when the line of communication is not working, you shorten the line of communication. He stated that Former Mayor Whiting was appointed the fire commissioner and was very involved. Council Member Schwarz asked if the other Memorial Villages are having the same conversation. Mayor Buesinger said that other city leaders are present and attending virtually.

Council Member Crawford said that the letter issued by Commissioner Presswood is not in line with the Interlocal Agreement which is what should be referred to for process and procedure in the case of an emergency. He said that he was confused about why the letter was issued in the first place, and the additional document provided tonight is new to him. Administrator Blevins said that she did not distribute the document regarding Chief Foster and that it was sent by accident to a Fire Department staff member. She said she called that person and asked that the email be deleted, but it was not. Attorney Bounds said that the document given to the Council tonight was not the original email that was sent, it had been changed.

Council Member Carey asked if there were enough funds in the current budget to cover a significant emergency. Council Member Crawford said at this point in the year and considering the usage of funds at this time there is not enough money for a major incident. Council Member Crawford said a contingency fund should be created. Attorney Bounds said that there is a certain spending power that administrators have in the case of emergencies and that an emergency meeting can be called within one (1) hour to authorize funds beyond that or to generate a plan.

Council Member Gordy said that this excess money was spent before it was brought to the Council and did not understand how that could happen.

9. DISCUSSION AND POSSIBLE ACTION

9.A. Discuss and act on items discussed in the closed meeting: Consider approval of a Resolution Number 2022-240 appointing a Fire Commissioner

Motion made by Mayor Pro Tem Maddock, Seconded by Council Member Gordy.

Bill Bristow, 1233 Pine Chase Drive, said the Council was elected to serve at all times and asked that anyone who is appointed or elected be in attendance at all meetings.

Commissioner Presswood said that the letter he sent as chairman was based on commission discussions that the Chief was concerned about staffing the second ambulance and exceeding the budget. He said he thought they were clear on the direction they were going. Commissioner Presswood stated that this and next year's budgets are zero (0) sum budgets and that in previous years the participating cities did not want a contingency account. He said that the reason that the Excel version of the budget was not provided is that there was a prior incident where the budget was changed and distributed which caused issues. It was decided by the

commission, not Fire Department Staff, that it would no longer be provided in that format.

Council Member Carey asked if the budget was prepared to accommodate for major fires. Commissioner Presswood said there are overtime funds, but they were depleted by staffing the second ambulance. Council Member Crawford asked if there is budgeting for disaster response beyond basic operations. Commissioner Presswood said it is a zero (0) sum budget.

Council Member Gordy said the commission should come back to the cities and request a budget amendment as issues arise. Commissioner Presswood said that if the budget is exceeded, at the next commission meeting it would be discussed and brought to the cities. Council Member Crawford said that he did not think the commission adhered to that process, the City was not informed until several months later. Commissioner Presswood said that during the pandemic the commission was faced with a lot of overtime but could not predict the effect it would cause and kept rolling the issue to the next meeting. He said the commissioners are in agreement that they should have gone to the cities for a budget amendment. Commissioner Presswood said that he did not write the letter he issued, but he read it and thought it was clear.

Allen Carpenter, Spring Valley, said that the budget amendment for overtime was significant due to staffing the second ambulance. He stated that the 2023 Budget has a permanent staff on the second ambulance. Fire Commissioner Carpenter said that the commission advised the Fire Chief to staff the second ambulance and then they would figure out the funding. He said that budget amendments are not made until the end of the year after the audit is complete. Council Member Gordy said that is not how Hilshire Village operates, and that is the root of the problem. Council Member Carey said that process needs to change. Council Member Gordy said that Spring Valley has the ability to collect revenue that Hilshire Village cannot. He said budget amendments hit the City harder than other Memorial Villages. Commissioner Carpenter said that although he is a Council Member for Spring Valley when he is at the fire station, he works for the Fire Department. Council Member Gordy said that the commissioners serve at the discretion of the Council and have more than one job to do. He said the City was informed of amendments late in the fiscal year and did not appreciate how it was presented Commissioner. Carpenter said that historically the Fire Department has run on an extremely lean budget. Administrator Blevins said that this is the first time she can remember that the Fire Department has come back for more money and that usually there is a transfer which is a normal practice. Commissioner Carpenter said that in the past the commission was able to use EMS revenue to cover overages, but because it was assigned to the capital improvement project there were no extra funds available. He stated that when Spring Valley has an overage they dip into their reserve, which is "huge".

Brian Muecke, Hedwig Village, said that there appear to be ulterior motives and not of the charitable variety. He said that he has not been to Hilshire Village since former Mayor Whiting and has never seen four (4) mayors present at a meeting. He asked if the Council had ever been informed of these documents and why there is a quorum of mayors with all eyes on Hilshire Village. He stated there are ulterior motives.

Amended motion was to approve Resolution Number 2022-240 appointing the Fire Commissioner to be Robert Buesinger

Voting Yea: Council Member Gordy, Council Member Crawford, Council Member Carey, Mayor Pro Tem Maddock, Council Member Schwarz

The motion carried 5-0.
