As always we are available whenever you have concerns.

- Be sure to lock all doors and windows in your home, when you are not on the premises.
- Lock your vehicle when it is unoccupied.
- Be cautious while in and around our school zones

HDR Engineering, Inc. (HDR) is pleased to submit this report on engineering related issues from January 12, 2024 to February 16, 2024.

- 1. On-Going Services (10361759):
  - a. 1201 Archley Drive -
    - On February 7, 2024, HDR reviewed and returned comments for the As Built Drainage Plan Resubmittal for 1201 Archley Drive. All previous comments/corrections were addressed by the engineer on February 1, 2024 and the drainage plan was approved with exceptions noted.
    - On February 8, 2024, HDR attended the pre-construction meeting for 1201 Archley Drive. The Contractor was made aware of the pertinent construction items for drainage as noted in the City Code of Ordinances.
  - b. 8206 Burkhart Road -
    - On February 15, 2024, HDR received a parking pad plan for 8206 Burkhart Road. The parking pad plan is currently being reviewed for comments.
  - c. 1311 Friarcreek Lane -
    - On February 15, 2024, HDR provided a cover inspection for 1311 Friarcreek Lane. The inspection is currently being coordinated for approval.

  - On February 15, 2024, HDR provided an as built inspection for 1310 Ridgeley Drive. The inspection passed with exceptions noted.
- k. 1131 Wirt Road -
  - On November 27, 2023, HDR received a Pool Drainage Plan Resubmittal for 1201 Archley Drive. The drainage plan is currently being reviewed for comments and awaiting additional information from the Contractor.
  - On December 8, 2023, HDR provided a Pool As-Built Inspection for 1131 Wirt Road. The inspection has passed with exceptions noted.

- 1. Hilshire Green Paving, Drainage & Utility Improvements -
  - The Geotechnical field work for the project has been completed and lab work is currently being performed for the field findings. The Survey for the project is anticipated to be completed by end of next week.
- m. Pine Chase Grove Water Meters -
  - City of Houston Public Works provided a site visit to review the potential relocation of the above ground meter transmitters and provided a report on January 22, 2024, to provide their findings of making the relocation. In coordination with City of Houston Project Manager, it was requested that the City of Hilshire Village verify the location of existing utilities to verify there will be no conflicts to allow for continuous placement of wiring. Pending verification, the City would confirm materials and has requested that the City of Hilshire Village provide excavation for the City of Houston Contractor to place the conduit and wiring for the rerouted meter transmitters.
- n. Street Pavement Point Repairs
  - HDR coordinated with three (3) general contractors to review the areas in the City requiring pavement point repairs and to provide quotation of the construction cost. The Contractors have provided quotes for review; however, HDR is currently reviewing the quotes for comments to have the Contractors revise to cover all aspects of the associated work. It is anticipated that the final quotes and recommendation be provided in the March 2024 City Council Meeting for review and approval.
  - HDR coordinated with CenterPoint Energy's construction team to review the two (2) existing point repair areas along Ridgley Drive (Ridgeley Drive and Archley north intersection and area near 1210 Ridgely Drive). The Contractor was able to complete the repairs of these locations on February 8, 2024.
- o. Wirt Road Safety Project/ Interlocal Agreements -
  - HDR has been coordinating with Mr. Patrick Nguyen (COH TDO), Mr. Shapoor Golshan (COH TDO), Mr. Embry Woods (COH TDO) and Mr. Jose Laguna (COH Interagency Coordinator) regarding the review of preliminary sidewalk plans previously submitted by HDR, including previous Traffic Impact Assessment (TIA) and traffic impact studies for the project area.
  - HDR has been coordinating to set a meeting with the COH Interagency Group to review and address comments from the COH and finalize the plans.
  - Mr. Laguna is following up with the COH Real Estate Group regarding the final disposition on the right-of-way issue across the School of the Woods.

### Letter From Interim Fire Chief Miller

#### A DEPARTMENT IN TRANSITION:

2023 saw some significant changes. Upon the departure of Chief David Foster from his service with the department, I was appointed to the position of Interim Fire Chief in February 2023. The administrative staff, officers, department members, board of commissioners, and city officials were all professional and supportive in the transition of leadership and moving the department forward.

The first order of business was to familiarize myself with various ongoing projects. These included the purchase of two new ambulances, annex/tower roof project, main roof installation issue, upcoming Insurance Services Office (ISO) inspection, firefighter turnout gear replacement, and emergency accountability radio purchase. My administrative staff was excellent at acclimating me to my new role.



It was important for our city leaders to meet their fire department's new Interim Fire Chief, so I attended each city's council meeting and introduced myself. Having previously worked as Emergency Management Coordinator, I already had a working relationship with many of the villages' administrative staff and department heads. I met with them all and let them know I was looking forward to a productive professional relationship. I was overwhelmed at how much support was offered to my staff and me.

A needs assessment was conducted to determine what was working efficiently and where we could improve. Major items assessed were:

- day-to day operations
- dispatch center
- department guidelines, policies, & procedures
- job descriptions & staffing
- station & apparatus maintenance
- department budget & capital replacement plan
- Investments, contracts, & vendors
- banking & accounting
- HR/payroll system
- EMS billing

We evaluated the feasibility of relocating fire department dispatch operations to MVPD. The cost was submitted to the VFD Board of Commissioners and is still being considered as a possible option.

New firefighter turnout gear was purchased to replace existing gear that was determined to be manufactured with a carcinogen. In May the department accepted two new ambulances. Thanks to a generous donation, we were able to purchase \$10,000 of gym equipment to replace some old, worn pieces. With the assistance of a consultant, we were able to easily navigate an ISO survey earlier in the year, and I am happy to report that the department maintains its Class 1 rating.

One major challenge throughout the year was the multiple budget amendments that were required to fund the department for the remainder of 2023. The amendments addressed shortfalls within the original 2023 budget and provide a solid framework for responsible spending in 2023. Additionally, during the budget workshop process this year, the budget format was updated, and line items were reorganized for 2024 so that the budget presentation is transparent and easier to follow.

The department moved forward with several much-needed changes in vendors and processes. AT&T's emergency responder network, FirstNet, is now our new cell service provider with more dependable coverage, especially in times of disasters/emergencies when they will provide portable cell locations. In August, we contracted with a new EMS billing provider, Emergicon. We're very happy with their customer service and their user-friendly client platform. In the latter half of the year, we began the implementation of new accounting software as well as HR/payroll software for better efficiency.

Our annual Family Day event took place in October. Employees' families were invited to check out the station, eat good food, and participate in activities and fellowship. Service awards were also presented to employees and celebrated with everyone

in attendance.

We acquired a drone, thanks to MVPD. We look forward to using it to assist emergency personnel, view disaster/damage from a safe distance, assist in search and rescue operations, aid in post-fire investigation, and assist with public relations projects.

These are just a few highlights from 2023 in our continued efforts to provide the best service to the citizens of the Memorial Villages. We consider it an honor to serve and look forward to having a wonderful 2024 as we continue to move forward.







#### Responses, Incidents, & Call Type




2023's total call volume was 2,426 incidents resulting in 4,250 responses.

# Average Response Time








# Call Types By Location



#### 3. REPORTS TO COUNCIL

#### 3.D. Fire Commissioner's Report

Interim Chief Miller has announced that Captain Swinner has returned to duty after recovering from an injury that had sidelined him last year. Captain Young has resigned from the department. Ladder 1 was involved in an accident with a van, resulting in a ruptured tire. A report on the incident has been filed.

The surplus ambulance has been sold, and the Fire Department has acquired a hand-me-down drone from the Memorial Villages Police Department. Croft and Johnson are currently undergoing training to obtain licenses for drone operation.

Major incidents in the area include a building fire in Houston and a house fire in Spring Valley. In December, Hilshire Village experienced three fire incidents and five EMS incidents, with an average response time of 5:43 minutes.

Projects at the fire station include the completion of the annex roof with touch-up work. Details are still being worked out for the main roof, and the previous contractor has offered reimbursement, allowing the department to hire someone else for the job as a change order.

A finance consultant began work on February 17th. Hydrant testing is going to start up again and will be completed in May. Tomorrow night, there will be a fire commission meeting.

#### 3.A. Police Report

Sergeant Menchaca provided a report indicating that in December, there were 872 calls, 750 business checks, 34 public relations engagements, and 14 traffic stops. On December 6th, a package theft occurred, but unfortunately, the video from the doorbell camera could not be obtained. Flock license plate reader cameras recorded 37,811 license plate reads in December.

Sergeant Menchaca mentioned that the on-board dash cams now include License Plate Readers (LPRs) that automatically record while driving. In the event of a hit, dispatch will be notified, and officers will receive notification on their cell phones.

The council did not raise any questions regarding the 2023 Racial Profiling Letter & Report.

#### 3.B. Building Official Report

City Secretary Stephens reported that there were no pending matters to discuss.

#### 3.C. Engineer Report

Engineer Him provided an update on plans currently under review.

Hilshire Green Paving, Drainage & Utility Engineer Him said that the scheduled survey is pending weather improvements and is expected to be ready in February.

**Pine Chase Grove Water Meters** Engineer Him reported that a meeting with City of Houston representatives had taken place, during which several topics were discussed. The City of Houston agreed to install bolts to secure the meter vault hatches. Hilshire Village has been granted permission to paint the hatches, and there are no objections to landscaping around the meter vaults. Re-grading the area is planned, and there is a request from the City of Houston to fence off the meter vaults during construction for protection from any heavy equipment. The relocation of control panels is possible, pending confirmation of any utilities in the way to run conduits. Calibration of the meters is supposed to occur annually by the City of Houston. Council Member Gordy advised to check when the last calibration was done.

**Pavement Point Repairs** Engineer Him said that CenterPoint representatives met with Engineer Vasquez to review the two areas of concern on Ridgeley Drive. CenterPoint agreed to schedule repairs to these areas.

Wirt Rd Sidewalk Engineer Him said that they are attempting to arrange a meeting

to discuss the comments from the City of Houston on the sidewalk design. These comments include keeping the sidewalk as straight as possible, exploring repairs to damaged curbs, and the City of Houston standard sidewalk width of six feet. Council Member Gordy is interested in updating the Harris County Commissioner with the project status, as well as discussing curb repairs with them. Engineer Him reminded the council that the ROW in front of the Hickory Shadows Park is owned by TxDOT and their approval is required if the sidewalk is to extend to the I-10 feeder road. Council Member Gordy highlighted the School of the Woods ROW as another consideration. He asked if there is a way to progress with the project while working on these conditions rather than postponing it further.

There was a leakage issue with the backflow preventer at Hickory Shadows, despite being adequately insulated. Quotes have been requested for both repairing and replacing the preventer, and these will be presented to the council for consideration.

#### 3.E. Mayor Buesinger's Report

Mayor Buesinger said that the fire department concluded the year with expenditures below the budget.

#### 3.F. City Secretary's Report

Secretary Stephens presented the Hilshire Village Annual Calendar highlighting the contract renewal periods with the local newspaper, the schedule for annual budget approval and audit, and various other community events and holidays.

#### 3.G. City Treasurer's Report

Secretary Stephens stated that the quarterly financial reports for the fourth quarter of fiscal year 2023 and the first quarter of fiscal year 2024 are included in the consent agenda.

AND, the Council recognizes that the Council retains the ultimate responsibility as fiduciaries of the assets of the City (Section 2256.005(f)).

#### **RESOLUTION NO. 2024-256**

A RESOLUTION OF THE CITY OF HILSHIRE VILLAGE, TEXAS FINDING THAT THE STATEMENT OF INTENT OF CENTERPOINT ENERGY RESOURCES CORP., D/B/A CENTERPOINT ENERGY ENTEX AND CENTERPOINT ENERGY TO CHANGE RATES FILING WITHIN THE CITY SHOULD BE DENIED; FINDING THAT THE CITY'S REASONABLE RATE CASE EXPENSES SHALL BE REIMBURSED BY THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; REQUIRING NOTICE OF THIS RESOLUTION TO THE COMPANY AND LEGAL COUNSEL.

WHEREAS, the City of Hilshire Village, Texas ("City") is a gas utility customer of CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Entex and CenterPoint Energy Texas Gas ("CenterPoint" or "Company") within the unincorporated areas of the Houston, Texas Coast, Beaumont/East Texas, and South Texas Divisions, and a regulatory authority with an interest in the rates and charges of CenterPoint; and

WHEREAS, the City is a member of Cities Served by CenterPoint Gas ("Cities") (such participating cities are referred to herein as "Cities"), a coalition of similarly situated cities served by CenterPoint that have joined together to efficiently and cost effectively review and respond to natural gas issues affecting rates charged in the Houston, Texas Coast, Beaumont/East Texas, and South Texas Divisions; and

**WHEREAS**, on or about October 30, 2023, CenterPoint filed with the City a Statement of Intent to Increase Rates seeking to increase natural gas rates by \$37.4 million annually and to all customers residing in the City; and

**WHEREAS**, Cities is coordinating its review of CenterPoint's Statement of Intent filing with designated attorneys and consultants to resolve issues in the Company's filing; and

**WHEREAS**, through review of the application, Cities' consultants determined that CenterPoint's proposed rates are excessive; and

**WHEREAS**, the Cities' members and attorneys recommend that Cities members deny the Statement of Intent; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS:

**Section 1.** That the rates proposed by CenterPoint to be recovered through its gas rates charged to customers located within the City limits, are hereby found to be unreasonable and shall be denied.

**Section 2.** That the Company shall continue to charge its existing rates to customers within the City.

**Section 3.** That the City's reasonable rate case expenses shall be reimbursed in full by CenterPoint within 30 days of the adoption of this Resolution.

**Section 4.** That it is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law and the public notice of the time, place, and purpose of said meeting was given as required.

**Section 5.** That a copy of this Resolution shall be sent to Keith L. Wall, CenterPoint Energy, at P.O. Box 2628, Houston, Texas 77252-2628, and to Jamie Mauldin, General Counsel to the Cities Served by CenterPoint Gas at Lloyd Gosselink Rochelle & Townsend, P.C., 816 Congress Avenue, Suite 1900, Austin, Texas 78701.

#### STAFF REPORT REGARDING CENTERPOINT ENERGY'S STATEMENT OF INTENT FILING

#### \*\*\*

On October 30, 2023, CenterPoint Energy Resources Corp., d/b/a CenterPoint Entergy Entex and CenterPoint Energy Texas Gas (CenterPoint or Company) filed a Statement of Intent to Increase Rates application with Houston, Texas Coast, Beaumont/East Texas, and South Texas Divisions. In the filing, the Company asserted that it is entitled to a \$37.4 million increase or a 5.8% increase over current adjusted revenues, excluding gas costs.

In November, the Cities Served by CenterPoint Gas (Cities) engaged the services of consultants to review the Company's filing. The consultants identified numerous unreasonable expenses and proposed significant reductions to the Company's request. Accordingly, Cities' attorney recommends that all Cities members adopt the Resolution denying the rate change. Once the Resolution is adopted, CenterPoint will have 30 days to appeal the decision to the Railroad Commission where the appeal will be consolidated with CenterPoint's filing for the environs and those cities that have relinquished their jurisdiction (i.e. Gas Utility Docket 15513) currently pending at the Commission.

Under the law, cities with original jurisdiction over this matter have 125 days from the initial filing to take final action on the application. Since the application was filed on October 30, 2023, all cities with original jurisdiction will need to adopt the resolution no later than March 3, 2024.

#### **Purpose of the Resolution:**

The purpose of the Resolution is to deny the rate application and consolidation proposed by CenterPoint.

#### **Explanation of "Be It Resolved" Paragraphs:**

1. This paragraph finds that the Company's application is unreasonable and should be denied.

2. This section states that the Company's current rates shall not be changed.

3. The Company will reimburse Cities for their reasonable rate case expenses. Legal counsel and consultants, approved by the Cities, will submit monthly invoices that will be forwarded to CenterPoint for reimbursement.

4. This section merely recites that the Resolution was passed at a meeting that was open to the public and that the consideration of the Resolution was properly noticed.

5. This section provides CenterPoint and counsel for the cities will be notified of the City's action by sending a copy of the approved and signed resolution to counsel.







#### ORDINANCE NO. 836-2024

#### AN ORDINANCE DESIGNATING PORTIONS OF RIDGLEY DRIVE FROM ITS INTERSECTION WITH MALLIE COURT SOUTH/EAST 100 FEET AS A NO PARKING ZONE; PROVIDING A PENALTY IN AN AMOUNT NOT TO EXCEED \$200.00 FOR VIOLATION OF ANY PROVISION IN THIS ORDINANCE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH, AND PROVIDING FOR SEVERABILITY.

WHEREAS, Texas Transportation Code Section 542.201 authorizes the City to enact and enforce rules regulating traffic that do not conflict with Texas's Rules of the Road; and

WHEREAS, Section 10-604(a) of the City's Code of Ordinances provides that "a person commits an offense if the person stops, stands or parks a vehicle, in a curb zone: 1) for a period of time longer than designated; (2) at a time prohibited by designation; (3) for a purpose other than that which is designated; or (4) at a place prohibited by designation"; and

WHEREAS, the City Council hereby finds and determines that it is in the best interest of the public that an additional portion of the area immediately adjacent to the roadway ("curb zone") of Ridgely Drive from Mallie Court to 100' South and east of Mallie Court be designated as a no parking area as provided by Section 10-605(a)(4) of the Code of Ordinances;

# NOW, THEREFORE, **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS**:

Section 1. The City Council hereby designates the curb zone on both sides of Ridgley Drive from its intersection with Mallie Court to 100 feet southeast of Mallie Court as a no parking area, as provided by Section 10-604(a)(4) of the Code of Ordinances of the City of Hilshire Village, Texas.

Section 2. The city secretary is directed to revise the Traffic Schedules maintained pursuant to Section 10.701 of the Code of Ordinances of the City of Hilshire Village, Texas, to reflect the amendments to the parking zones made by this Ordinance. The city secretary is further authorized to place signs in accordance with the provisions of this Ordinance.

Section 3. The city secretary is directed to provide to the city engineer, municipal court, and police department the revised Traffic Schedules.

Section 4. Any person, corporation or entity who shall violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$200.00. Each day in which any violation shall occur, or each occurrence of any violation, shall constitute a separate offense.

Section 5. All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

Section 6. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate

this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Hilshire Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

Section 7. This ordinance shall be effective immediately upon adoption and publication of this ordinance or a caption that summarizes the purpose of this ordinance and the penalty for violating this ordinance in every issue of the official newspaper for two days, or one issue of the newspaper if the official newspaper is a weekly paper, in accordance with Section 52.011 of the Texas Local Government Code.

# SUBTITLE C. PUBLIC SAFETY PROVISIONS APPLYING TO MORE THAN ONE TYPE OF LOCAL GOVERNMENT

CHAPTER 370. MISCELLANEOUS PROVISIONS RELATING TO HEALTH AND PUBLIC SAFETY OF MORE THAN ONE TYPE OF LOCAL GOVERNMENT

Sec. 370.007. JUVENILE CURFEWS PROHIBITED.

(a) Notwithstanding any other law, a political subdivision may not adopt or enforce an order, ordinance, or other measure that imposes a curfew to regulate the movements or actions of persons younger than 18 years of age.

(b) This section does not apply to a curfew implemented under Chapter  $\underline{418}$ , Government Code, for purposes of emergency management.

Added by Acts 2023, 88th Leg., R.S., Ch. 425 (H.B. <u>1819</u>), Sec. 6, eff. September 1, 2023.

#### **ORDINANCE NO. 742**

AN ORDINANCE OF THE CITY OF HILSHIRE VILLAGE, TEXAS AMENDING ITS CODE OF ORDINANCES CHAPTER 7 TO ADDING A NEW ARTICLE 7.800, JUVENILE CURFEW, ESTABLISHING DEFINITIONS, REGULATIONS, DEFENSES, AND PENALTIES FOR JUVENILES; ESTABLISHING FINDINGS IN SUPPORT; AND PROVIDING FOR SEVERABILITY.

\* \* \* \* \*

WHEREFORE, the City Council of the City of Hilshire Village, Texas has considered establishing regulations providing for a juvenile curfew within the City; and

WHEREFORE, the City Council finds it to be in the best interest of the health safety and welfare of the citizens of the City to adopt regulations regarding juvenile curfew as provided for in this ordinance; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS:

Section 1. The facts and matters contained in the preamble to this ordinance are hereby found to be true and correct.

Section 2. The Code of Ordinances of the City of Hilshire Village is hereby amended by adding to Chapter 7, Offenses and Nuisances, a new Article 7.800, Juvenile Curfew, with the new Article to read as follows:

#### "Article 7.800 – Juvenile Curfew

#### Section 7.801 – Purpose.

It is the express purpose of this Article to:

(1) Deter criminal conduct involving juveniles;

(2) Reduce the number of juvenile crime victims;

- (3) Reduce injury from accidents involving juveniles;
- (4) Reduce the additional time police officers are required to be in the field due to juvenile crime;
- (5) Provide additional and more effective means and options for dealing with gang-related violence and crime;
- (6) Reduce juvenile peer pressure to stay out late;
- (7) Reduce juvenile peer pressure to participate in violent or criminal activities;
- (8) Assist parents in the control of their children; and
- (9) Make the city a better community and a safer place to live and work, to raise a family, and to grow up.

#### Section 7.802 - Definitions.

The following words, terms and phrases, when used in this division, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Curfew hours shall mean:

- (1) 11:00 p.m. on Sunday, Monday, Tuesday, Wednesday, and Thursday and 12:00 midnight on Friday and Saturday until 6:00 a.m. of the following day; and:
- (2) 9:00 a.m. until 2:30 p.m. on Monday through Friday; provided however, the hours defined in this subsection (2) shall not be considered as curfew hours for minors not subject to compulsory school attendance pursuant to V.T.C.A., Education Code § 25.085, nor shall the hours defined in this subsection (2) be considered as curfew hours on days or during periods in which the school where the applicable minor is enrolled is closed, or classes for which the applicable minor is enrolled have been canceled under the order and direction of officials authorized to issue such orders and directives, or, if the applicable minor is a duly authorized home school student under applicable provisions of the state Education Code, on days or during periods in which such minor is not receiving educational instruction.

*Emergency* shall mean and include, but is not limited to, a fire, natural disaster, automobile accident, or any unforeseen situation requiring immediate action to prevent serious illness, bodily injury, or loss of life, or for the preservation of property.

*Establishment* shall mean any privately owned place of business to which the public has access or is invited, including, but not limited to, any place of amusement or entertainment.

*Guardian* shall mean a person who, under court order, is the guardian of the person of a minor or a public or private agency with whom a minor has been placed by a court.

Minor shall mean any person under 17 years of age.

*Operator* shall mean any individual, firm, association, partnership, entity or corporation operating, managing, or conducting the operation of any establishment. The term "operator" includes the members or partners of an association or partnership and the officers of a corporation.

*Parent* shall mean a person who is a natural parent, adoptive parent or stepparent of a minor, or a person at least 18 years of age who is authorized by the parent or guardian of a minor or by court order to have the care and custody of such minor.

*Police department* shall mean the city police department or any successor police department, and shall include any law enforcement agency working with the city through any interagency agreement.

*Public place* shall mean any place to which the public or a substantial group of the public has access and shall include, but not be limited to, streets and highways, and the common areas of schools, hospitals, apartment houses, office buildings, transportation facilities, restaurants, theaters, game rooms, shops, shopping centers, or any other place that offers for sale services, merchandise or entertainment.

*Remain* shall mean to linger, stay, or fail to leave premises, when requested to do so by a police officer or the owner, operator, or other person in control of the premises.

#### Section 7.803 - Offenses.

- (a) It shall be unlawful for any minor to knowingly remain, walk, run or stand, or operate or ride about in any motor vehicle or bicycle, in or upon any public place or on the premises of any establishment within the city during curfew hours.
- (b) It shall be unlawful for the parent or guardian of a minor to knowingly permit, or by insufficient control allow, a minor to remain in or upon any public place or on the premises of any establishment within the city during curfew hours.

(c) It shall be unlawful for the owner, operator, or any employee of an establishment to knowingly allow a minor to remain upon the premises of the establishment during curfew hours.

#### Section 7.804 - Defenses.

- (a) It shall be a defense to prosecution under Section 7.803 that a minor was:
  - (1) Accompanied by the minor's parent or guardian;
  - (2) On an errand at the direction of the minor's parent or guardian;
  - (3) In a motor vehicle involved in intrastate or interstate travel, and traveling through the city by a direct route between the point of departure and destination;
  - (4) Engaged in a lawful employment activity, or going directly to the employment activity or returning directly to the minor's residence from the employment activity;
  - (5) Involved in an emergency;
  - (6) On an errand made necessary by an illness, injury, or emergency;
  - (7) On the sidewalk abutting the minor's permanent residence or abutting the residence of a next-door neighbor of the minor's permanent residence if the neighbor did not complain to the police department about the minor's presence thereon;
  - (8) Attending a school, religious, government-sponsored or other civic activity supervised by adults and sponsored by an educational, religious, or governmental institution, civic organization, or other similar entity, or traveling directly to or returning from any such school, religious, governmental, or civic activity;
  - (9) Engaged in, participating in, or traveling to or from any event, function, or activity for which the application of section 7.803 would contravene the minor's rights protected by the United States Constitution including, but not limited to, First Amendment rights such as the free exercise of religion, freedom of speech, or the right of assembly; or

- (10) Married or had been married or had disabilities of minority removed in accordance with V.T.C.A., Family Code Chapter 31.
- (b) It is a defense to prosecution under section 7.803 that the minor has been directed by his parent or guardian to engage in a specific activity, or to carry out expressed instructions, during the time that the minor is actually engaged in fulfilling those directions or responsibilities.
- (c) It is a defense to prosecution under section 7.803 that the owner, operator, or employee of an establishment promptly notified the police department that a minor was present on the premises of the establishment during curfew hours and the minor refused to leave.

#### Section 7.805 - Enforcement.

- (a) Before taking any enforcement action under this division, a police officer shall ask the apparent offender's age and reason for being in the public place or establishment. The officer shall not issue a citation or make an arrest under this division unless the officer reasonably believes that an offense has occurred and that based on any response given, and other circumstances, no defense in section 7.804 is present.
- (b) In lieu of issuing a citation or making an arrest, the police officer may, based on the circumstances, issue a warning notice to the minor, who shall be ordered to go home by the most direct means and route. A copy of the warning notice shall be filed with the police department, and a letter shall then be promptly sent to the parent or guardian of the minor advising of the contact with the minor during curfew hours and requesting cooperation in the future.

#### Section 7.806 - Penalties.

- (a) Any person who shall violate any provision of this division shall be deemed guilty of a misdemeanor. Following the issuance of a citation for a violation of the curfew hours defined in section 7.802(2), the minor shall be returned to school. Any citation issued for violation of any provision of this division shall direct the parents or legal guardians of the minor to appear together with the minor in connection with the charge of a violation.
- (b) When required by V.T.C.A., Family Code § 51.08, as amended, the municipal court shall waive original jurisdiction over a minor who violates section 7.803(a) and shall refer the minor to juvenile court."

**Section 3.** In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Hilshire Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

#### A BILL TO BE ENTITLED

AN ACT relating to the repeal of the authority of political subdivisions to adopt or enforce juvenile curfews. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Article 45.045(c), Code of Criminal Procedure, is amended to read as follows: (c) This article does not limit the authority of a court to order a child taken into custody under Article 45.058 [or 45.059]. SECTION 2. Article 45.060(a), Code of Criminal Procedure, is amended to read as follows: (a) Except as provided by <u>Articles</u>] 45.058 [and 45.059], an individual may not be taken into secured custody for offenses alleged to have occurred before the individual's 17th birthday. SECTION 3. Section 51.02(15), Family Code, is amended to read as follows: "Status offender" means a child who is accused, (15)adjudicated, or convicted for conduct that would not, under state law, be a crime if committed by an adult, including: (A) running away from home under Section 51.03(b)(2); (B) a fineable only offense under Section 51.03(b)(1) transferred to the juvenile court under Section 51.08(b), but only if the conduct constituting the offense would not have been criminal if engaged in by an adult; (C) a violation of standards of student conduct as described by Section 51.03(b)(4); [a violation of a juvenile curfew ordinance (D) or order; [(E)] a violation of a provision of the Alcoholic Beverage Code applicable to minors only; or (E) [(F)] a violation of any other fineable only offense under Section 8.07(a)(4) or (5), Penal Code, but only if the conduct constituting the offense would not have been criminal if engaged in by an adult. SECTION 4. Section 38.003(a), Government Code, is amended to read as follows: (a) The judge of a county, justice, or municipal court, in accordance with Section 38.002, may award money from a judicial donation trust fund established under Section 38.001 to eligible children or families who appear before the court for a truancy [or curfew] violation or in another misdemeanor offense proceeding before the court. SECTION 5. Section 71.0352, Government Code, is amended to read as follows: Sec. 71.0352. JUVENILE DATA: JUSTICE, MUNICIPAL, AND TRUANCY COURTS. As a component of the official monthly report submitted to the Office of Court Administration of the Texas Judicial System: a justice court, municipal court, or truancy court (1) shall report the number of cases filed for: (A) truant conduct under Section 65.003(a), Family Code; and the offense of parent contributing to (B) nonattendance under Section 25.093, Education Code; and [(C) a violation of a local daytime curfew ordinance adopted under Section 341.905 or 351.903, Local Government Code; and]

(2) in cases in which a child fails to obey an order of a justice court, municipal court, or truancy court under circumstances that would constitute contempt of court, the justice court, municipal court, or truancy court shall report the number of incidents in which the child is:

(A) referred to the appropriate juvenile court for delinquent conduct as provided by Article 45.050(c)(1), Code of Criminal Procedure, or Section 65.251, Family Code; or

(B) held in contempt, fined, or denied driving privileges as provided by Article 45.050(c)(2), Code of Criminal Procedure, or Section 65.251, Family Code.

SECTION 6. Chapter 370, Local Government Code, is amended by adding Section 370.007 to read as follows:

Sec. 370.007. JUVENILE CURFEWS PROHIBITED. (a) <u>Notwithstanding any other law, a political subdivision may not</u> <u>adopt or enforce an order, ordinance, or other measure that imposes</u> <u>a curfew to regulate the movements or actions of persons younger</u> <u>than 18 years of age.</u>

(b) This section does not apply to a curfew implemented under Chapter 418, Government Code, for purposes of emergency management.

SECTION 7. Section 8.07(e), Penal Code, is amended to read as follows:

(e) A person who is at least 10 years of age but younger than 15 years of age is presumed incapable of committing an offense described by Subsection (a) (4) or (5) [, other than an offense under a juvenile curfew ordinance or order]. This presumption may be refuted if the prosecution proves to the court by a preponderance of the evidence that the actor had sufficient capacity to understand that the conduct engaged in was wrong at the time the conduct was engaged in. The prosecution is not required to prove that the actor at the time of engaging in the conduct knew that the act was a criminal offense or knew the legal consequences of the offense.

SECTION 8. The following provisions are repealed:

- (1) Article 45.059, Code of Criminal Procedure;
- (2) Section 341.905, Local Government Code;
- (3) Section 351.903, Local Government Code; and
- (4) Section 370.002, Local Government Code.

SECTION 9. A violation of a juvenile curfew ordinance or order may not be prosecuted or adjudicated after the effective date of this Act. If on the effective date of this Act a criminal or civil action is pending for a violation of a juvenile curfew ordinance or order, the action is dismissed on that date. However, a final conviction or adjudication for a violation of a juvenile curfew ordinance or order that exists on the effective date of this Act is unaffected by this Act.

SECTION 10. This Act takes effect September 1, 2023.

#### ORDINANCE NO. 837-2024

#### AN ORDINANCE OF THE CITY OF HILSHIRE VILLAGE, TEXAS, REPEALING IN ITS ENTIRETY ARTICLE 7.800 "JUVENILE CURFEW" OF CHAPTER 7 "OFFENSES AND NUISANCES" OF THE CODE OF ORDINANCES.

**WHEREAS,** the 88<sup>th</sup> Texas Legislature passed and approved House Bill 1819 repealing the authority of a political subdivision to adopt or enforce juvenile curfews; and

**WHEREAS,** the Village of City of Hilshire Village (the "City") has adopted and enforces a juvenile curfew found in Article 7.800 "Juvenile Curfew" of Chapter 7 "Offenses and Nuisances" of the Code of Ordinances known as the "Curfew Ordinance"; and

**WHEREAS**, the new law has gone into effect September 1, 2023, making the City's Curfew Ordinance unenforceable.

## NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS:

<u>Section 1</u>. Article 7.800 "Juvenile Curfew" of Chapter 7 "Offenses and Nuisances" of the City of Hilshire Village, Texas, is hereby repealed in its entirety.

Section 2. Effective date. This Ordinance shall become effective on September 1, 2023.

<u>Section 3</u>. Repeal. This Ordinance is intended to be cumulative and shall not repeal any provision of a previous ordinance or Village Code except to the extent that a provision is inconsistent and cannot be reconciled with this ordinance.

<u>Section 4</u>. Severability. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it is the intention of the Board of Aldermen that the invalidity or unconstitutionality of the one or more parts shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision other than the part declared to be invalid or unconstitutional; and the Board of Aldermen of the Village of City of Hilshire Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

#### ORDINANCE NUMBER 745

AN ORDINANCE AMENDING CHAPTER 7 OFFENSES AND NUISANCE OF THE CODE OF ORDINANCES OF THE CITY OF HILSHIRE VILLAGE, TEXAS, BY REPLACING ARTICLE NO. 7.700 IN ITS ENTIRETY, AND DELETING AR-TICLE 3.700, TREE PROTECTION, OF CHAPTER 3, BUILDING AND CON-STRUCTION IN ITS ENTIRETY. ESTABLISHING RULES AND REGULATIONS CONCERNING TREE PRESERVATION; PROVIDING A PENALTY IN AN AMOUNT PROVIDED FOR IN SECTION 1.106 OF THE CITY'S CODE OF OR-DINANCES FOR ANY VIOLATION OF ANY PROVISION OF THIS ORDI-NANCE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN-CONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVER-ABILITY.

# **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS:**

Section 1. The Code of Ordinances of the City of Hilshire Village, Texas (the "Code"), is hereby amended by replacing Article 7.700 under Chapter 7 Offenses and Nuisance in its entirety, to provide as

follows:

#### **ARTICLE 7.700. - TREE PRESERVATION**

#### Sec. 7.701 – Purpose and Definitions

1. The purpose of this article is to preserve the Tree canopy and continue the wooded character that has been the hallmark of the city since its founding while protecting owners' rights to utilize and enjoy their property by:

- a. establishing minimum Tree requirements,
- b. requiring careful site planning and the protection of Trees,
- c. controlling unnecessary Tree removal,
- d. requiring Tree replacement, and
- e. prohibiting indiscriminate cutting or clearing of Trees.

2. Properties used for commercial purposes are exempt from Section 7.701 1(1a) and 1(1b) of this article.

#### Sec. 7.702 – Definitions

As used in this article, the following words, terms, and phrases shall have the meanings ascribed to them in this section:

Approved Tree List shall mean a list approved and maintained by the city that lists species of Trees that are approved for meeting the minimum tree requirement described in this article.

**Building** shall mean any structure with a roof and enclosing walls that is used or intended for supporting or sheltering any use or occupancy.

**Circumference or Diameter** shall mean circumference or diameter measured at a point on a Tree four and one-half feet (4½) above the surrounding ground level. The equivalent Circumference or Diameter

may be used for measurement purposes. Tree Diameter in inches x 3.14 = Tree Circumference in inches. (For example, 6" Diameter X 3.14 = 18.84" Circumference). To measure a Tree that forks or has two boles or stems at or below four and one-half feet (4½'), only the Circumference or Diameter of the larger bole or stem shall be measured.

Critical Root Zone shall mean the area of a Tree that is within a circle centered on the trunk location, with the circle's Diameter being one-half of the sum of the longest and shortest drip line Diameters.

Subject Site shall mean any particular lot, tract, or parcel of land that is subject to the building permit process or otherwise invokes the regulations established in this article.

**Tree** shall mean a woody, perennial plant typically having a single stem or trunk, growing to a considerable height and bearing lateral branches at some distance from the ground.

Tree Removal Permit shall mean a permit issued by the city for the removal of a Tree.

#### Sec. 7.703 – Minimum Tree Requirement

- (1) Each lot shall have one (1) Tree that is eight inches (8") or greater in Diameter for every 2,000 square feet of lot area (excluding any land in the Harris County Flood Control District or utility easement), rounded to the nearest whole number (see Table 1). Trees in the Harris County Flood Control District or in a utility easement will not be counted.
- (2) If a lot has less than the number of Trees described in the preceding subsection, the owner shall keep the number of Trees larger than three inches (3") in Diameter, counting from the largest Diameter to the smallest Diameter, that are on the lot (excluding any land in the Harris County Flood Control District or a utility easement) at the time a Tree Removal Permit is sought or the provisions of this article are otherwise invoked.
- (3) A lot owner who is applying for a permit issued under the building permit process of the City's Code of Ordinances for the demolition of, construction of, or addition to any Building, or installation of a swimming pool shall, regardless of the number or size of the Trees existing on a lot prior to issuance of a permit, plant such additional Trees as may be necessary to meet the minimum tree requirement described in subsection (1) above if the owner is:

(a) constructing a new or replacement Building,

(b) constructing an addition[s] or extension[s] to an existing Building that increases the square footage of the Building by 40% or more, or

(c) installing a swimming pool.

#### Sec. 7.704 – Preservation and Protection of Trees

- (1) It is unlawful to remove any Tree that is eight inches (8") in Diameter or greater without first obtaining a tree removal permit from the city for each Tree to be removed.
- (2) It is unlawful to remove a Tree that is less than eight inches (8") in Diameter without first obtaining a tree removal permit from the city if:
  - (a) such Tree is required to meet the minimum tree requirement for the lot as described in section 7.703(2), or
  - (b) such Tree was planted as a replacement for a previously removed Tree.
- (3) It is unlawful to intentionally cause serious damage or death to any Tree that is eight inches (8") in Diameter or greater. Intentionally severing the main trunk or large branches or large roots, girding, poisoning, carving, mutilating, touching with live wires, piercing with nails or spikes, crushing or exposing the roots, or digging or drilling any hole or trench larger than three cubic feet (3 ft<sup>3</sup>) within the Critical Root Zone, unless no other suitable location is possible, may be considered acts intended to cause serious damage or death to the Tree.
- (4) Before beginning demolition or construction, appropriate protection for all Trees shall be in place. Appropriate protection shall mean, at a minimum, a fence four feet (4') in height and composed of a material which is strong enough to prevent vehicles, materials, debris, dirt and other demolition or construction refuse from piling up within the Critical Root Zone. Where possible, the fence shall be a minimum of six feet (6') away from the base of the Tree at all points to prevent damage to the Tree. If the location of a tree is less than six feet (6') from the foundation of the building or the property line, the protective fencing shall be located as far as possible from the base of the tree.

- (a) The applicant's lot will, after removal of the Tree, satisfy the minimum Tree requirement as described in section 7.703(1),
- (b) The Tree is diseased, dying or dead,
- (c) Construction is planned in the area where the Tree stands,
- (d) The Tree creates a hazard that is or is likely to cause damage to property or danger to the public health, safety, or welfare, or
- (e) Good arbor management practices indicate removal will be beneficial to surrounding Trees.
- (2) If the previous subsection is satisfied, the city will issue a Tree Removal Permit if a lot owner completes the following steps:
  - (a) Executes the city's Tree Removal Permit application, which includes a certification that, upon removal of such Tree, either the lot will continue to satisfy the minimum tree requirement as described in section 7.703(1) or the lot owner will comply with Section 7.706 below regarding Tree replacement. If concurrent Tree Removal Permits are sought, the minimum tree requirement must be satisfied after all Trees are removed.
  - (b) Pays the application fee as adopted by city council. The application fee shall be waived by the city if the applicant shows that the Tree to be removed is diseased, dying or dead or if, after removal of a Tree, the lot has more than the minimum Tree requirement in section 7.703(1).
- (3) The city shall have a reasonable amount of time, but not less than 3 business days, to review the application. The city may require an owner to provide certification by an arborist that the criteria in subsection (1)(b), (d) or (e) exist.
- (4) Removal of a Tree without a Tree Removal Permit shall not constitute a violation of this article if immediate removal is necessary to protect against a serious and imminent risk to health, safety, or property as a result of an emergency and, because of such emergency, the lot owner could not obtain the Tree Removal Permit, provided that, as soon as reasonably possible after such Tree removal, the lot owner submits a Tree Removal Permit application without the fee and demonstrates that such emergency existed.
- (5) The city may require a lot owner to remove any Tree that is damaged, dead or dying, and that the city deems a danger to person or property. The owner shall have fourteen days (14) after receipt of the notice to remove the Tree.
- (6) Removal of a Tree shall be performed by the lot owner or by a reputable Tree removal company, and the owner shall ensure that the Tree removal work is adequately covered by bond or insurance.

#### Sec. 7.706 – Replacement of Trees

- (1) If, after loss of or removal of a Tree, a lot does not or will not satisfy the minimum tree requirement as described in section 7.703(1) or (2), as applicable, then the lot owner shall, within 120 days after loss of or removal of such Tree, properly plant a replacement tree from the Approved Tree List. The replacement Tree shall be at least three inches (3") in Diameter measured at six inches (6") above the grade for each lost or removed Tree. A tree intended as a replacement tree shall not be planted in the Harris County Flood Control District or in a utility easement, but nothing in this article is otherwise intended to prohibit the planting of trees in the Harris County Flood Control District or a utility easement.
- (2) With the approval of the city's arborist, a lot owner may plant additional species that are not on, but are similar in size to those that are on, the Approved Tree List. If the city's arborist does not approve, the owner may appeal by submitting a written request to city council. Property owners are encouraged (but not required) to plant Trees native to the Texas Gulf Coast.
- (3) In situations of financial hardship, the city will have flexibility in obtaining outside help with re-forestation.

#### Sec. 7.707 - Tree Survey

(1) Every permit issued under the building permit process of the City's Code of Ordinances for the demolition of, construction of, or addition to any Building, or the installation of a swimming pool shall include a Tree survey. Permit applicants must obtain and complete the proper forms, available in the city office, to show compliance with this article.

- (2) The permit holder will make every effort to maintain the distribution of existing Trees. However, if the design, layout, plans, or construction of the proposed Building cannot avoid the removal of any Tree that is eight inches (8") in Diameter (25.12" in Circumference) or larger, then the permit holder shall be required to replace each removed Tree with a Tree from the Approved Tree List. Each replacement Tree shall have a minimum caliper of three inches (3") in Diameter (9.42" in Circumference).
- (3) The Tree survey shall be prepared by a person with expertise to prepare such a document, such as an architect, engineer, arborist, or surveyor.
- (4) The Tree survey shall accurately reflect, at a minimum, the following information:
  - (a) The actual location (i.e., trunk location), Diameter, and type of each Tree on the Subject Site which is eight inches (8") in Diameter (25.12" in Circumference) or larger,
  - (b) Building or structure outlines, parking areas and other paved surfaces, fences, utilities, and other improvements existing or to be constructed,
  - (c) The location of Tree protection fences,
  - (d) A scale, north arrow, name, address, phone number and profession or occupation of the person who prepared it, and the name of the permit applicant, and
  - (e) Identification of the real estate development and a description of the Subject Site and its location.
  - (f) The location and square footage of utility and flood control easements, and the square footage of the lot excluding utility and flood control easement square footage.

#### Sec. 7.708 - Final Inspection and Issuance of Certificate of Occupancy

At final inspection under every building permit that includes a Tree Survey, the city's inspector shall inspect and confirm compliance with the Tree survey and planting of required Trees, if any. No certificate of occupancy shall be issued until the minimum Tree requirement has been met but, if the certificate of occupancy is to be issued between May and September and the owner has agreed to meet the Minimum Tree Requirement, a provisional certificate of occupancy may be issued until such time as the owner has complied.

#### Sec. 7.709 - Destruction of or Damage to Trees on Public Property

In addition to the violation of any criminal law dealing with destruction of public property, it shall be unlawful to remove, destroy, kill, or damage any Tree located on any public property in the city except when necessary in furtherance of the public health, safety or welfare. This section shall not prevent the city or any public utility from performing necessary maintenance or repair activities that may affect Trees located within easements or on public property.

#### Sec. 7.710 - Exemptions from Requirements of this Article

- (1) The provisions of this article shall not apply to Trees removed or trimmed within an easement for public or private utilities by the easement's owner, or the owner's employee or authorized contractor, or by the utility provider or its authorized contractor, if the trimming or removal of such Trees is required to properly use or maintain the easement. This article shall also not apply to Trees removed or trimmed by the city or its authorized representative or by the utility provider or its authorized contractor on any public property or within any public right-of-way, including, but not limited to, drainage easements and roadway easements.
- (2) If this article would require a Tree to be planted from May through September in any year, the planting may be delayed until October of that same year.

#### Sec. 7.711 - Enforcement

- (1) The city has the authority and right to inspect any property to ensure compliance with this ordinance.
- (2) The city may require any lot owner to prove that the owner is in compliance with this ordinance.

- (3) The city may withhold, revoke, or suspend any Tree Removal Permit or building permit if any condition or requirement of this article or such permit is not fulfilled.
- (4) The city may order an immediate stop to the removal of any Tree, any activity that is likely to cause serious damage or death to any Tree, or any demolition or construction of a Building, if such activity is being done in violation of this ordinance.
- (5) The city has the authority to hire a tree inspector for advice in conjunction with enforcing this ordinance.
- (6) Anyone that intentionally, knowingly, recklessly, or with criminal negligence violates any of the provisions of this article shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined in an amount as provided for in the general penalty provision in Chapter 1, Section 1.106, of the City's Code of Ordinances. Each day during which such violation shall exist or occur shall constitute a separate offense. The owner of any property where any violation of this article occurs and any agent, contractor, builder, architect, individual or entity that assists in the commission of such offense shall be guilty of a separate offense and, upon conviction thereof, shall be punished as above provided.

#### Sec. 7.712 - Appeal

Anyone whose request for a building permit, Tree Removal Permit, or certificate of occupancy has been denied due to the interpretation or application of this article may appeal that decision to the city council by filing a written notice of appeal with the city. The city council shall provide the applicant an opportunity to present evidence and arguments demonstrating that the applicant has complied with this article and is entitled to a permit or certificate of occupancy, and that the city erred in refusing to issue the requested permit or certificate of occupancy. If, at the conclusion of the hearing, a majority of the city council determines that the applicant is entitled to a permit or certificate of occupancy, the city shall issue one. Otherwise, the city's denial shall be affirmed.

<u>Section 2</u>. Any person who shall intentionally, knowingly, recklessly, or with Criminal negligence violates any provision of this Ordinance, shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$2,000. Each day of violation shall constitute a separate offense.

<u>Section 3</u>. To the extent there may exist any conflict or inconsistency between the terms of any two ordinances of the City, the more restrictive of the two documents shall prevail and shall be interpreted and enforced according to its own terms.

Section 4. In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Hilshire Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.
