He said that although they could operate the shelter for \$88,500, he added funds to ensure the Warming Shelter would be staffed during the off season if there was bad weather. He said that he believed he could do that with \$92,000 \$93,000, if necessary. Councilor Denton moved to approve the allocation of \$93,000 from the General Fund for contractual operation of the city's seasonal Warming Shelter. Her motionwas seconded by Councilor Partin.
