ORDINANCE 2021-6: AN ORDINANCE CALLING FOR AN ELECTION IN THE CITY OF JOHNSON, ARKANSAS ON THE ISSUE OF A ONE PERCENT (1%) TAX UPON THE GROSS RECEIPTS OF HOTEL, MOTEL AND OTHER ACCOMODATIONS AND A ONE PERCENT (1%) TAX UPON THE SALE OF PREPARED FOOD AND BEVERAGES FOR ON OR OFF PREMISES CONSUMPTION, THE PROCEEDS OF BOTH WHICH SHALL BE DEDICATED EXCLUSIVELY FOR THE DEVELOPMENT, CONSTRUCTION, AND MAINTENANCE OF CITY PARKS; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES.
