CALL TO ORDER

NEW BUSINESS

1. Resolution No. 2020-39, A Resolution of Johnstown, Colorado, Summarizing Expenditures and Revenues for Each Fund and Adopting and Appropriating the Budget for the Calendar Year 2021- The Town Home Rule Charter requires the Council adopt the budget for the next fiscal year by ordinance or resolution on or before the final day of the current fiscal year. Motion made by Councilmember Lemasters to approve Resolution 2020-39, A Resolution of Johnstown, Colorado, Summarizing Expenditures and Revenues for Each Fund and Adopting and Appropriating the Budget for the Calendar Year 2021. Motion carried with a roll call vote.
2. Resolution No. 2020-40, A Resolution Levying General Property Taxes for the Year 2021, to Help Defray the Cost of Government for the Town of Johnstown, Colorado for the 2021 Budget Year – This resolution sets the mill levy for the General Fund operations. Motion made by Councilmember Young, seconded by Councilmember Mellon to approve Resolution 2020-40, A Resolution Levying General

Property Taxes for the Year 2021, to Help Defray the Cost of Government for the Town of Johnstown, Colorado, for the 2021 Budget Year. Motion carried with a unanimous vote.
