- A. Tree City USA application update. The advisor reported on the Arbor Day tree planting event and the status of the Tree City USA application which will be submitted to the Arbor Day Foundation for approval.
- B. Neighbors Encouraging Shade Trees (NEST) update-Tree Planting in Bryant Park
  The advisor reported that the Neighbors Encouraging Shade Trees request to use Tree Canopy Restoration Fund

Beach landscape inspection and renovation Powell informed the board that she met with the board advisor to review the beach landscape and went over some of the challenges at the site such as wrong plant-wrong place and irrigation issues. The board then discussed the possibility of Tree and Landscape Board members doing some minor maintenance as volunteers. The advisor will check to see if volunteers are allowed. The advisor told the board that Leisure Services has full time staff that pick trash and do some minor maintenance, Grounds Maintenance staff also does maintenance which includes tree trimming, and that the contractor is responsible for most of the maintenance including

trimming the Sable Palms. The board then discussed Sabal palm trimming.

New board member Priscilla Hallowell introduced herself to the board and informed the board that she is a master gardener and that she is looking forward to working with the board.
