- A property owner on North G St. paid over \$400,000 in fines and come into compliance to sell the property; the city received the funds.



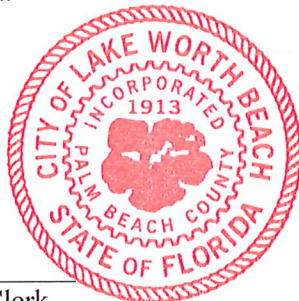
