

**MINUTES  
CITY OF LAKE WORTH BEACH  
REGULAR CITY COMMISSION MEETING  
CITY HALL COMMISSION CHAMBER  
TUESDAY, DECEMBER 16, 2025 – 6:00 PM**

The meeting was called to order by Mayor Resch on the above date at 6:06 PM in the City Commission Chamber located at City Hall, 7 North Dixie Highway, Lake Worth Beach, Florida.

- Vote by Mail ballots would be mailed on January 30 for the March 10, 2026 election; four informational town halls were being organized in January from 6 – 9 PM: 8<sup>th</sup> at the Haitian Peniel Church, 12<sup>th</sup> at the Osborne Community Center, 22<sup>nd</sup> at the Library and 28<sup>th</sup> at the Casino Ballroom as well as having the information on the City's website and social media


