B. South Palmway Median update.

It was suggested to do that a demonstration garden in the 500 block. The board tabled this topic to a date uncertain in order to concentrate on other priorities. Former Board member Monica Bilotti volunteered to take on this project as a member of the public. She informed the board that she did an informal poll of the residents on the 500 block by asking multiple residents if they were interested in the project. Nine out of ten residents that she spoke to supported the project. She showed the board her "vision boards" and plant lists. The board discussed possible funding and neighborhood support. Monica volunteered to reach out to the neighborhood association to gauge the interest of the entire neighborhood. Richard suggested to meet with the neighborhood association board of directors to get their support he also volunteered to assist Monica with this project. D. McGrew will reach

out to the association president to see about attending a board meeting to get their support before taking it to the association as a whole. The board agreed that hey were in support of this project. G. Timor agrees to attend the meetings as a representative of the board.

C. Tree Board community Outreach

The advisor D. McGrew informed the board that he was waiting on confirmation that the Tree Canopy Restoration Fund was changed from a Public Works account to Community Sustainability.
