TITLE:

Consideration of and request for official action regarding the re-opening plan for the City's Beach

SUMMARY:

The City staff is seeking consideration of and official action from the City Commission regarding the re-opening plan for the City's beach.

BACKGROUND AND JUSTIFICATION:

On March 20, 2020, Governor DeSantis issued Executive Order (EO) 20-70 directing the closure of beaches in Palm Beach County. In his subsequent EO 20-90, the Governor provided the authority to the Palm Beach County Administrator to enforce, relax, modify or remove the closure of beaches in Palm Beach County (subject to the parameters set for in EO 20-70). On May 8, 2020, the Palm Beach County Board of County Commissioners (BCC) considered the issue of re-opening the beaches. Subject to a follow-up meeting on May 15th, the BCC voted to re-open the beaches in Palm Beach County on May 18th with certain restrictions (i.e., Palm Beach County residents only; no beach concessions provided; and, consistent with the parameters of EO 20-70). In anticipation of the BCC's follow-up meeting on May 15th, City staff has prepared a plan for re-opening the City's beach (including the re-opening of the tenants' businesses at the beach and parking). The plan will be presented to the City Commission for its consideration. City staff seeks official action from the City Commission (motion and vote) on the beach re-opening plan and possible input to the BCC for their follow-up meeting.

DIRECTION:

Request for official motion and vote based on the considerations of the re-opening plan for the City's beach.





TITLE:

Consideration of issues and request for official action regarding the Governor's Executive Order for Phase 1 Re-Opening of Florida

SUMMARY:

This item seeks the Commission's consideration of issue(s) related to Palm Beach County entering Phase 1 of the State's Re-Opening Plan. Issue(s) to be considered include providing additional outdoor space to restaurants on private property and/or City-owned or maintained property (e.g., right-of-way or parking spaces). Based upon the Commission's consideration of the issue(s), staff is seeking official action (motion and vote) regarding the City's response to the Re-Opening process.

BACKGROUND AND JUSTIFICATION:

On May 4, 2020, Governor Ron DeSantis issued Executive Order (EO) 20-112 which authorized the Phase 1 Plan of Re-Opening the State of Florida. However, EO 20-112 excluded Palm Beach County (and Miami-Dade and Broward counties) from the Phase 1 Plan for re-opening restaurants, retail sales establishments, museums and libraries at limited capacities. Last week, Palm Beach County requested that the Governor authorize Palm Beach County to enter the Phase 1 Plan for restaurants, retail sales establishments, museums and libraries. The Governor granted that request in EO 20-120 (issued on May 9 and made effective at 12:01 a.m. on May 11, 2020). Further, Executive Order 20-120 also allowed barbershops and salons to re-open consistent with EO 20-112 and regulations established by the State Department of Business and Professional Regulation.

In anticipation of Phase 1 Plan of Re-Opening, many cities are looking at options of how to further assist those businesses authorized to re-open. The most notable area being considered is allowing (or relaxing restrictions on) restaurants to have (or increase) outdoor seating. The only restrictions in EO 20-112 on outdoor seating are the maintenance of the six foot distancing between parties and that parties cannot be larger than 10 persons. The City is likewise considering relaxing its outdoor café permits and Right-Of-Way permits (adjacent to City streets) processes to temporarily allow more outdoor seating on private and public property until the restaurants are authorized to re-open to full capacity. This includes allowing restaurants to use adjacent parking spaces for such seating areas. The restaurants who take advantage of this should be required to register with the City and maintain all ADA clearance requirements for walkways/sidewalks.

Based upon the Commission's consideration of the above issue and possibly others, staff is seeking official action (motion and vote) regarding the City's response to the Re-Opening process.
