Though I haven't seen the city charter in its entirety, I've heard that it is very long, and so it will require a thorough, careful review.

My goal if I were to be selected to be on the charter review board is to make recommendations for changes for the public to weigh in on. I believe the process ought to be as democratic as possible, with as many residents given the chance to voice their opinion as possible.

I have experience reading, creating and modifying organizational bylaws. I understand that the language in these type of documents can be very dry (and dull) at times. It requires a lot of patience and paying close attention to details and subtleties in language. I believe I have the patience and that my experience would help to serve the board well.
