SUMMARY:

On March 9, 2021, the City held a General Election for Mayor, Commissioner for District 1, Commissioner for District 2 and Commissioner for District 3; however, no candidate for the Office of Commissioner for District 2 received a majority of the votes cast to fill the office.

BACKGROUND AND JUSTIFICATION:

As required by the City's Charter, Article V, Section 4, a Run-Off Election shall be held two weeks after the General Election to elect a candidate to fill such office. According to Section 2-22 of the City's Code, ballots for City elections shall be done by resolution of the City Commission. Therefore, a resolution is required to set the ballot for the Run-Off Election.
