#### **WORK EXPERIENCE**

I have worked in state government, for FDEP and SFWMD, since 2000 as a water quality technician for SFWMD, compliance inspector for FDEP on SFWMD and USACE Everglades restoration projects, permit and compliance lead for SFWMD on large-scale Everglades restoration projects, and wildlife lead involving survey monitoring, permitting, protection measures, and agency coordination efforts on large-scale Everglades restoration projects and O&M projects District-wide.

I have served on the Board of Directors of the Treasure Coast Chapter of the Florida Association of Environmental Professionals and the Angler Action Foundation (formerly the Snook & Gamefish Foundation). Currently, I serve as President of the Friends of the Gale Academy of Environmental Science at Forest Hill High School and I am the Volunteer Coordinator for the Angler Action Foundation.

#### COMMUNITY INVOLVEMENT

The Angler Action Foundation, a local 501c3, is one of the organization that have adopted the Snook Islands Natural Area (inanition to the Jupiter Ridge Natural Area) through the PBC ERM adopt a Natural Area Program. As the Volunteer Coordinator for the Angler Action Foundation, I organize a database of approximately 700 volunteers to bring in funds and tackle local initiatives to improve ecosystems and support PBC and local municipalities. The Angler Action Foundation also manages the grant for the largest seagrass restoration effort, which is taking place within the Caloosahatchee River, along with more recent initiatives across Florida.

### 6. A - WHY DO YOU DESIRE TO SERVE ON THIS BOARD (FIRST PREFERENCE)

I believe my expertise and knowledge of the C-51 Basin, operations of the system, water quality monitoring experience, local knowledge of the Lake Worth Lagoon and Intracoastal Waterway, and inner chain of lakes (including Lake Clarke Shores) along with my history and commitment to anglers, health of the ecosystem, and being able to coordinate with stakeholders makes me a good fit for this board.

#### 6. B - WHY DO YOU DESIRE TO SERVE ON THIS BOARD (SECOND PREFERENCE)

I am concerned with the human health and safety aspects of the system, as my family (including two children) frequently recreate both east and west of the S-155 Spillway. Water quality is a concern from the basin and local runoff.

### 6. C - WHY DO YOU DESIRE TO SERVE ON THIS BOARD (THIRD PREFERENCE)

I have an interest in improving Spillway Park by looking into how the City of Lake Worth can bring back the fishing pier on the south side of the S-155 Spillway, which is one of the best snook fishing locations in PBC and the South FL coast. Working with SFWMD, FDEP, and the USACE and local stakeholders to collaborate will be key on how to best accomplish this at a flood control structure. I'd also like to see improvement to the park in general, including safety and better enforcement of fishing regulations.

I was Chair of the City Tree Board from 2004 to 2013 and brought ideas for many community projects to the table including the Annual Festival of Trees where we invited native nurseries, fruit tree nurseries, and environmental organizations to educate the public and provide low cost healthy landscape material for their yards. Other projects were the annual Shade Tree Giveaway at City Hall giving away 1300 trees to residents and neighborhood associations and encouraging the trees be planted in front yards to provide shady sidewalks. Also the Outstanding Neighborhood Tree Contest for residents to nominate their trees and produced a map showing the locations of the trees. In 2015 I organized the landscape plantings along the entrance to Snook Islands Natural Area and with the help of 100 volunteers we planted the entire area in one weekend using native trees and shrubs donated by local nurseries.

I've organized and participated in shoreline clean-ups.

Recently for about 2 years I volunteered at the Visitor's Information Center in the City Hall Annex and really enjoyed talking with residents and visitors.
