Per Mr. Hagar. I have inspected the site. We asked that the engineers shoot all of the storm drains. They have submitted in writing that what they built does meet the plans. The pond is larger than it had to be. Mr. Hagar submitted his letter into the record.

Harold Poe-1980 Montevallo Rd. Had a question regarding the zoning is R-5 or R-1.

Per Mr. Watson this is a final plat approval. So, the lots have already been installed. Under the old R-5 zoning regulations.

Mr. Poe stated his opposition to this subdivision due to it only having one entrance and one exit.

Joshua Dill 6451 Cromer Circle stated that he had contractors on his property without his consent moving dirt and pipes for this subdivision.

Per Mr. Hager the outlet for this water has always been routed to this area.

Mr. Wade Lawory stated he was not aware of Mr. Dills issues. His land should not be impacted.

Mike (General Contractor) 9265 HWY 41 South Stated the Mr. John Bruce approached him regarding a issue with the back yard. He had damned up the original ditch. I suggested he needed a pipe to channel the water.

Per Mr. Barnett you can take this issue into advisement. This board will not be able to resolve this issue.

Per Mr. Hager stated that he has been to this area. This is why they have taken a second look and extra measures have been taken.

Commissioner Isbell asked if the flow is in this area. Mr. Lawory stated yes. The water has always flowed in this area.

John and Joanna Bruce 6450 Cromer Circle are having issues with the water runoff.

Charles Kessler 3505 Bentler Rd. Engineers stated the applicant needed a larger retention pond which they did.
