10. Resolution 2021-10-05: Consider Waiving Standing City Streetlight Policy and Amending City Budget for related costs

CITY OF LEEDS RESOLUTION NO.: 2021-10-05

WAIVING STANDING PRACTICE/POLICY AND APPROVING A BUDGET ADJUSTMENT FOR THE INSTALLATION OF NEW RESIDENTIAL STREETLIGHT

WHEREAS, it has been requested that the City place a public streetlight along a City Street at the general location of Georgia Ave @ Albany; and

WHEREAS, considering that the City's standing policy is to not install, pay for, or otherwise sponsor neighborhood streetlights due to the related perpetual associated cost and expenditure of public funds, said policy would require a waiver in order for the subject request to be approved; and

WHEREAS, the estimated cost of such installation would approach \$2500 for installation and a continuing \$600 annually, and considering that such expenditures were not contemplated within the previously approved City Budget, a budget amendment and adjustment would be necessary in order for these payments to be properly credited.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Leeds that:

- 1. The Recitals above are true, correct, and included herein as if fully set forth.
- 2. The City standing policy, to not pay for nor to provide additional residential street lighting, is hereby waived in order to place a new streetlight/lamp at Georgia Ave @ Albany.
- 3. The City budget item (#80-4200) shall be amended to pay for, accommodate, and to perpetually maintain a new streetlight at Georgia Ave @ Albany.
- 4. The Mayor and staff shall have the full authority to do those things, perform those functions, make such decisions, and to sign necessary documentation in order to carry out and fully complete the actions so authorized herein.

WHEREAS, the City Police Department is in need of a vehicle for use primarily by the school resource officer; and

WHEREAS, the City School Board has agreed to share the costs related to the purchase of a vehicle for the City School Resource Officer; and

WHEREAS, the City Council wishes to provide authorization and approval of the vehicle purchase.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Leeds as follows:

- 1. The above Recitals are true and correct and included herein this Resolution of the City Council as if fully set forth.
- 2. Subject to the City School Board providing an appropriation of the related costs in the approximate amount of \$30,000.00, the authorization is hereby provided to make the purchase of a vehicle for the City's Police Department for the primary use by the School Resource Officer with the specifications of the vehicle being in the discretion of the Police Chief.

WHEREAS, the Finance Committee of the City has made a recommendation to authorize an interim audit to ensure the integrity of City finances.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Leeds that:

- 1. The Recitals above are true, correct and included herein as if fully set forth.
- 2. The requested interim audit is hereby authorized.
- 3. The related expense for the subject audit shall be paid from City funds as determined by the City Administrator.
- 4. The Finance Committee shall be in charge of both hiring the auditing firm and for the management of the subject audit.
- 5. The Mayor and staff shall have the full authority to do those things, perform those functions, make such decisions, and to sign necessary documentation in order to carry out and fully complete the actions so authorized herein.
