Subject: VIGILANT LICENSE PLATE READER PURCHASE PROPOSAL

The Leeds Police Department is proposing the purchase of a Vigilant Solutions Automated License Plate Reader (ALPR). ALPR technology is the future of intelligence-led policing. This system would provide 3 mobile cameras which would be affixed to the front of a patrol vehicle. These 3 cameras would capture a picture of every license plate that passed the listed patrol vehicle. Each license plate scan would be time stamped with GPS coordinates. As a license plate is scanned, it is simultaneously crossreferenced with all databases. The license plate will provide the system user a "hot-list alert" if the license plate sequence matches any database entry. Some examples of "hotlist" databases are: stolen vehicle, stolen tags, missing subjects, sex offenders, wanted felony suspects, silver alerts (missing senior citizens), and expired tags. The system also allows users to have the ability to input their own "hot" license plates. In this situation, the Leeds Municipal Court would be granted a user account so that each outstanding Leeds warrants could be entered into a "Leeds-warrants" hotlist. Officers could also assist investigators by inputting license plates that have been used in crimes throughout the city. The data collected by the mobile ALPR system is stored by Vigilant Solutions and retained indefinitely. Officers can conduct a license plate query on a license plate and determine the area that the vehicle was in at any given time. This is especially useful when trying to tie a suspect to an offense location.

The acquisition of this technology will allow the Leeds Police Department to keep our citizens safe and further our ability to apprehend and prosecute those that take advantage of our citizens. This system would pay for itself in a short period of time due to it's assistance with the ability to execute Leeds warrants and enforce traffic laws such as expired tags, not to mention the assistance with high level narcotic and currency smuggling operations.

During a 60-day trial period usage of this system, the Leeds Police Department was able to solve a multi-state vehicle burglary operation for the Mountain Brook Police Department by tracking down the suspect to a hotel room at the Hard Rock casino in Biloxi, MS. I was able to see a license plate scan on the suspect vehicle inside of the hotel parking deck scanned by a repo truck. The Mountain Brook Investigator was then able to contact the Hard Rock casino and trace the subject via surveillance footage. The suspect was from Kansas and traveled to multiple states breaking in to high-end vehicle. Without ALPR access, this string of crimes would have never been solved.

Also during the trial, Officers from Leeds and Moody Police Departments were involved in a vehicle pursuit with a suspect responsible for stealing cars from Adesa auto auction in Moody. The suspect was able to evade capture on the night of the pursuit. The vehicle was bearing a dealer license plate which does not return an owner or an address. I was able to query the license plate through Vigilant PlateSearch which returned multiple reads in the parking lot of an apartment complex in Birmingham. These scans were also from a repo truck. The information was passed along to the Moody Police Department to assist in solving their crime.

You may recall in January of 2021 when a female and her 2 young children were carjacked at gunpoint at the Circle K gas station in Moody. Shortly after this incident, the license plate of the victims vehicle was entered into a hotlist. A few hours later, Officers from the Rankin County (MS) interdiction unit received a "hotlist alert" when the victims vehicle passed their patrol cars on I-20/59. After a brief pursuit, the suspects were apprehended.

Without access to the Vigilant license plate readers and the Vigilant license plate database, none of these cases would have been solved. These are just 3 of the many crimes that ALPR technology solves every day. The acquisition of this product will allow Leeds to share and receive information from numerous agencies in central Alabama, as a large number of local agencies utilize this technology. For instance, the Hoover Police Department has over 70 Vigilant license plate readers. The Outlet Shops of Grand River has a stationary vigilant license plate reader. Once the Police Department acquires this product, officer and investigators will be able to see every vehicle that goes in and out of Grand River. If a "hotlist" license plate scans on the Grand River camera, all officers will be notified via email and text message in real time.

The total purchase price of this system is \$15,615.00. This price includes all Hardware, unlimited police and commercial license plate data (repo trucks), on-site installation, as well as on-site training and certification for the operating Officer. This product includes unlimited technical support via telephone. The hardware also comes equipped with a full 1-year warranty from the date of in-field commissioning.
