# AUTHORIZING LEASE RENEWAL FOR POLICE SUB-STATION AT SHOPS OF GRAND RIVER.

**WHEREAS**, in April of 2019, the City approved a lease of certain space located at the Shops of Grand River for the purpose of having a Police Substation located on that property; and

**WHEREAS,** there is a pending request by the Leeds Retail Center LLC to renew the subject lease based on the same terms until March 21, 2025; and

**WHEREAS**, the lease and its related terms and conditions have been determined to provide a general public benefit.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Leeds that:

- 1. The request to renew the current lease (Renewal Agreement attached) with the Leeds Retail Center, LLC until March 31, 2025, based on the same terms and conditions is hereby approved.
- 2. The Mayor and staff shall have the full authority to do those things, perform those functions, make such decisions, and to sign necessary documentation in order to carry out and fully complete the actions so authorized herein.

#### AMENDMENT TO LEASE

THIS AMENDMENT TO LEASE (this "<u>Amendment</u>") is made as of \_\_\_\_\_\_, 2022 (the "<u>Effective Date</u>"), by and between LEEDS RETAIL CENTER, LLC ("<u>Landlord</u>") and CITY OF LEEDS ("<u>Tenant</u>"), an Alabama municipal corporation, d/b/a LEEDS POLICE SUBSTATION.

#### WITNESSETH:

WHEREAS, Landlord and Tenant entered into that certain Lease dated April 12, 2019 (the "<u>Existing</u> <u>Lease</u>"), pursuant to which Landlord leases to Tenant approximately 1,686 square feet of leasable area known as Store No. 431 (the "<u>Demised Premises</u>") located in the shopping center known as the Outlet Shops of Grand River, Leeds, Alabama (the "<u>Shopping Center</u>"). The Existing Lease, as modified by this Amendment, is herein referred to as the "<u>Lease</u>". The Term of the Lease expired by its terms on March 31, 2022.

**WHEREAS**, in lieu of Tenant exercising its option to extend the Term for the first Option Term set forth in the Existing Lease, the parties desire to extend the Term and otherwise amend the Lease as hereinafter set forth.

NOW THEREFORE, in consideration of the mutual covenants and agreements herein contained, and other good and valuable consideration, the parties hereby agree to modify the Existing Lease as follows:

1. <u>Defined Terms</u>. All terms utilized in this Amendment which are defined in the Existing Lease and not otherwise defined herein shall have the same meanings ascribed to them in the Existing Lease.

2. <u>Extension of Term</u>. (a) The Term is hereby extended for the three (3) year period (the "<u>Extended Term</u>") commencing on **April 1, 2022** and ending on **March 31, 2025**; which extension shall be upon all of the terms, conditions and covenants contained in the Existing Lease, except as otherwise expressly set forth in this Amendment. Tenant agrees, notwithstanding anything to the contrary contained in the Existing Lease, (i) to continue Tenant's occupancy of the Demised Premises for the Extended Term in its existing "as is" condition, and (ii) Tenant shall have no right or option to further extend the Lease Term beyond **March 31, 2025**, except the Second Extended Term as set forth below.

(b) Notwithstanding anything to the contrary contained in the Existing Lease and provided that the Lease is in full force and effect, Landlord and Tenant hereby agree that the Term shall automatically be extended for the three (3) year period (the "<u>Second Extended Term</u>") commencing on **April 1, 2025** and ending on **March 31, 2028**; unless either party elects that the Term not be extended for the Second Extended Term and terminates the Lease effective **March 31, 2025** by giving written notice thereof to the other party by **November 30, 2024**. The Second Extended Term shall be upon all of the terms, conditions and covenants contained in the Existing Lease, except Tenant shall have no right or option to further extend the Term beyond **March 31, 2028**.

3. <u>Rent</u>. During the Extended Term and the Second Extended Term (unless terminated by notice under Section 2(b) above), Tenant shall continue to pay the Base Rent pursuant to the terms of the Existing Lease (i.e., the Base Rent shall be the amount of One Dollar (\$1.00) per annum) payable on each anniversary of the Commencement Date.

4. <u>Ratification</u>. Except as modified by this Amendment, the Existing Lease and all covenants, agreements, terms and conditions thereof shall remain in full force and effect and are hereby in all respects ratified and confirmed.

5. <u>Miscellaneous</u>. In the event of any conflict between this Amendment and the Existing Lease, the terms and provisions of this Amendment shall control. Each party represents that it did not deal with any broker or agent in connection with this Amendment, and each agrees to hold harmless the other party from and against any and all costs and expenses that arise out of a breach of such party's representation. This Amendment (a) shall be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns; (b) contains the entire agreement between the parties regarding the subject matter hereof and shall supersede any and all other understandings and agreements; (c) may be (i) executed in duplicate counterparts, each of which shall be deemed an original, but all of which, when taken together, shall constitute one and the same instrument; and/or (ii) executed and/or transmitted to the other party by electronic means (e.g., without limitation, by DocuSign and/or PDF), in which case such electronically signed and/or transmitted signed versions shall be deemed to be an original and shall have the same binding effect as original signatures once both parties have executed and received such execution signatures from the other party; and (d) shall in all respects be governed by and construed in accordance with the laws of the State of Alabama.

## **REPEALING AND REPLACE RESOLUTION 2022-02-03 TO IDENTIFY PROPER FUNDING SOURCE.**

**WHEREAS**, on February 7, 2022, the City Council approved various items of equipment and vehicles for the Police Department; however, the subject approval failed to include the proper funding source for the subject expenditures; and

**WHEREAS,** the correct funding source for the subject expenditures, as allowed by Resolution 2022-02-03, is the funding the City has received from the Coronavirus Aid, Relief, and Economic Security Act; and

**WHEREAS,** in order to clarify the issue properly, the authorizing resolution should be repealed and replaced with the correct authorizations.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Leeds that:

- 1. Resolution 2022-02-03 is hereby repealed and replaced with the approvals as contained herein.
- 2. The budget amendments as previously authored for the Police department for the purchase of shields and equipped police vehicles are hereby confirmed and ratified as approved.
- 3. The City Clerk shall adjust the City budget in such a manner as to allow for the use of confiscated funds, not to exceed \$25,000.00, to purchase ballistic shields.
- 4. The funding source for the equipped police vehicle purchases shall be those funds as are due to the City from the Coronavirus Aid, Relief, and Economic Security Act.
- 5. The Mayor and staff shall have the full authority to do those things, perform those functions, make such decisions, and to sign necessary documentation in order to carry out and fully complete the actions so authorized herein.

### AUTHORIZATION OF BUDGET AMENDMENT – FUNDING EQUIPMENT PURCHASES – POLICE DEPARTMENT

**WHEREAS**, it has been requested that certain ballistic shields and vehicles be funded to better equip the Police Department and to better provide public safety.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the City of Leeds, Alabama, as follows:

## TO: MAYOR AND CITY OF LEEDS

FROM: CHIEF PAUL IRWIN

**REGARDING:** BALLISTIC SHIELDS

I am proposing purchasing Ten (10) ballistic shields for our police department so each shift will have two (2) per shift, one (1) for SWAT/WARRANTS and one (1) for training.

The shields will be \$2,449.00 each and a total of \$24,490.00. This amount is drawn from the State of Alabama Bid List Master Agreement 999 210000000170 Line 9 which is a 44% discount from the retail price.

The funds for this purchase will be removed from the seizure funds awarded to the Police Department.



#### **RESOLUTION 2022-05-03**

WHEREAS, the City of Leeds Alabama (hereinafter at times referred to as City) is desirous of having certain improvements made on Interstate 20 within the City Limits of Leeds, in accordance with plans prepared by the Alabama Department of Transportation and designated as Project Number: IM-I020(365) Planing, Overlay, and Striping on I-20 from the East End of the Bridge over 1<sup>st</sup> Avenue North to the East End of the Bridge over AL-4(US-78) Exit 140.

WHEREAS, The Alabama Department of Transportation is now or may later be desirous of receiving Federal Aid for improvement of said highway; and

WHEREAS, The Federal Highway Administration, an agency of the United States of America, will not participate in any funding for the construction of said project until and unless the City will agree to certain requirements of the Federal Highway Administration. The City for the purpose of complying with requirements of the Federal Highway Administration in regard to its funding of improvements of the type and kind in this agreement provided for, does hereby pass and adopt the following resolution:

BE IT RESOLVED by the Council of Leeds, that the plans of said project including alignment, profile, grades, typical sections and paving layouts as submitted to this City and which are now on file in the office of the City Clerk are hereby approved and that the location of said project as staked out by the Alabama Department of Transportation and as shown by said plans referred to are hereby approved and the Alabama Department of Transportation, in cooperation with the Federal Highway Administration, is hereby authorized to proceed with the grading, draining, paving, and otherwise improving and construction of said project in accordance with said plans.

The City by and through its Council hereby grants to the Alabama Department of Transportation the full use of and access to the dedicated widths of any existing streets for the construction of said

project and hereby agrees to permit and allow the Alabama Department of Transportation to close and barricade the said project and intersecting streets for as long as necessary while the said project is being graded, drained, paved, and otherwise improved, and hereby agrees that the use of any street or highway for parking within an interchange area will not at any time be permitted.

The City hereby further agrees to adopt or pass such legally effective ordinances and/or laws as will permanently barricade and/or relocate certain intersecting streets as required by the State and to permanently deny or limit access at certain locations as required by the State along said improvements, all of which are more specifically stated as follows:

N/A - This project does not require permanent barricade or relocation of any	intersecting streets.

BE IT FURTHER RESOLVED by the City Council, that for and in consideration of the Alabama Department of Transportation in cooperation with the Federal Highway Administration, constructing said highway and routing traffic along the same through the City over said project, such City hereby agrees with the Alabama Department of Transportation and for the benefit of the Federal Highway Administration, that on the above mentioned project the City will not in the future permit encroachments upon the right of way; nor will it pass any ordinances or laws fixing a speed limit contrary to those limits provided for in Title 32, Chapter 5, Code of Alabama 1975, as amended, and other laws of Alabama; nor

will it permit other than parallel parking in areas where parking is permitted; nor will it allow the placing of any informational, regulatory, or warning signs, signals, median crossover, curb and pavement or other markings, and traffic signals without written approval of the Alabama Department of Transportation and the Federal Highway Administration, of the location, form and character of such installations. The traffic control devices and signs installed during construction, and those installed after completion of this project shall be in accordance with the latest edition of the national Manual on Uniform Traffic Control Devices and accepted standards adopted by the Alabama Department of Transportation of the State of Alabama and by the Federal Highway Administration. The City further agrees that subsequent traffic control devices deemed necessary by it in keeping with applicable statutes, rules and regulations to promote the safe and efficient utilization of the highway under the authority of Title 32, Chapter 5, Code of Alabama 1975, and all other applicable laws of Alabama, shall be subject to and must have the approval of the Alabama Department of Transportation of the State of Alabama and of the Federal Highway Administration, prior to installation and the City further agrees that it will enforce traffic and control the same under the provisions of Title 32, Chapter 5, Code of Alabama 1975, and other applicable laws of Alabama.

#### BE IT FURTHER RESOLVED by this City Council:

- 1. That the City agrees to perform all maintenance on crossroads, service drives, or relocated roads that are not designated Federal or State highways that are in the jurisdiction of the City.
- 2. That the City agrees to perform all maintenance on any existing road which has been replaced by a new road; or, if the existing road is not used, the City has the option of vacating same.
- 3. That the City agrees to perform all maintenance on interchanges to the theoretical crossing of the denied access line.
- 4. That the City agrees to perform all maintenance on grade separations along the roadway to the end of the bridge, or the denied access fence, whichever the case.

It is understood and agreed that no changes in this Resolution or Agreement shall in the future be

made without having obtained the prior approval of the Federal Highway Administration.

SUBJECT: Capital Improvement Fund 2020

Enclosed is a state warrant representing your municipality's share of the earnings from the Alabama Trust Fund for the fiscal year ended September 30, 2020, according to Amendment 856 of the *Alabama Constitution*. The amount distributed to the municipalities this year is \$17,541,415.78. Also included in this warrant is your municipality's share of the income to be distributed from the County and Municipal Government Capital Improvement Trust Fund, for the fiscal year ending 2020. The amount shared in this Trust Fund was \$25,131,192.44, of which one-half (\$12,565,596.22) is to be distributed to the counties and one-half to the municipalities.

Section 11-66-6, *Code of Alabama*, 1975, as amended, states that "each municipality shall upon receipt of its share deposit same in a special account and shall not commingle such funds with other revenues of the municipality. The share of each municipality shall be expended solely for capital improvements and the renovation of capital improvements determined by the municipal governing body. The governing body of each municipality may use such share to finance bond or warrant issues for capital improvements and the renovation of capital improvements of capital improvements and the renovation of capital improvements and may pledge such share to retire the principal and interest of such bonds or warrants".

Interpretations of the above referenced constitutional amendment and statute, or questions regarding the use of these funds should be directed to your legal counsel.

14. Ordinance 2022-05-01: Consider Establishing a Grand River Outlet Mall Entertainment District

#### CITY OF LEEDS ORDIANCE NO. 2022-05-01

#### ESTABLISHING A GRAND RIVER ENTERTAINMENT DISTRICT

**WHEREAS**, the Code of Alabama §28-3a-17.1 establishes procedures and requirements for the Council by resolution to establish Entertainment Districts.

**WHEREAS**, it has been requested that an Entertainment District for the Outlet Shops at the Grand River Mall area be established.

# NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEEDS, ALABAMA, AS FOLLOWS:

- 1. That a Grand River Outlet Mall Entertainment District is hereby established pursuant to \$28-3a-17.1, Code of Alabama, 1975 pursuant to the boundaries as shown on Exhibit "A".
- 2. That said District shall include businesses within said District boundaries with any retail liquor license authorized to sell alcoholic beverages for consumption on the licensed premises, subject to the proper licensing and designations issued by the Alabama Alcoholic Beverage Control Board.
- 3. That the Grand River Outlet Mall Entertainment District is created for that period of time Monday through Sunday for any duration.
- 4. That the subject approval and District hereby established be subject to those administrative rules and parameters as established by the City of Leeds Inspections Department from time to time for the general benefit of the Grand River Entertainment District.
- 5. The provisions of this ordinance are severable. If any provision is held by a court of competent jurisdiction to be invalid or unconstitutional, it shall not affect the validity or constitutionality of the remaining provisions, which are adopted separately and independently.
- 6. The terms and conditions of this Ordinance shall become effective immediately following its posting according to law.
