#### **RECOMMENDATION:**

Los Gatos Community Vitality and Economic Recovery Initiative

- a. Provide Direction to Staff on Parklet Barrier Options for the Town's Community Vitality and Economic Recovery Initiative.
- b. Authorize the Town Manager to purchase the necessary resources to implement the program up to \$750,000.

#### BACKGROUND:

On May 26, 2020, the Town Council held a special meeting to discuss options for a Community Vitality and Economic Recovery program for Los Gatos. Direction was provided to staff to remove parking from N. Santa Cruz Avenue and provide parklets and curbside/quick turn parking options to assist the businesses and community with access to the one another during the COVID-19 pandemic. Additionally, the Council provided direction for the staff to return with a resolution that streamlines business processes and modifies current provisions to allow business expansion and innovation opportunities during this time as well, which was adopted at the June 2, 2020 Town Council meeting.

#### DISCUSSION:

During the discussion on May 26, 2020, the Council provided staff with direction regarding the barriers that should be used to create the parklets in downtown. This included the use of

planters or other similar type materials rather than temporary construction materials such as krail as was used in 2019 during the one-way pilot on N. Santa Cruz Ave.

On June 1, 2020, an updated Public Health Order was issued by Santa Clara County Public Health allowing outdoor dining to commence on June 5, 2020, provided businesses follow the guidelines. In concert with this, staff has been working to identify a vendor and get a cost and delivery schedule for the parklet planter barriers. Planters will cost \$375,000 plus soil and plant material and ongoing maintenance costs. The quickest delivery for planters is 8 to 10 weeks.

Given that the businesses will need the outdoor dining space much sooner, staff is recommending that the Town takes the following phased approach:

- Provide k-rail as soon as possible throughout downtown, on N. Santa Cruz Ave, Main Street, University Avenue, and Village Lane along blocks that are primarily restaurants, with minimal sidewalk space. Staff has been working with the business community to identify the areas that need outdoor seating and are in the process of working on agreements with the businesses. This plan will blend with the Council direction to use all of the parking for parklets with the business needs for both parklets and parking.
- 2. As planters are ready for delivery, replace the k-rail with planters for a more visually appealing and inviting look. Staff will provide a map on Monday as a desk item that will demonstrate locations for k-rail in the first phase and planters in the future phase.
- 3. Then expand on the amount of parklet space based on the need for parking vs parklets and the current environment for shopping and dining guidelines, reserving clusters of curbside pickup/quick turn parking spaces.

This phased approach allows for significant amount of parklet space while meeting the Council direction to remain flexible to the needs of business. Another benefit of this approach is the flexibility that is built in as the parklets are formed now and adjusted in time. As the planters come in, if areas and spaces need to be adjusted, this can be incorporated in the work already being done and could provide additional support to the businesses as their models continue to evolve. Phasing adds an additional \$100,000 for the cost of k-rail. If this phased approach works for the Council, the total estimated cost for both k-rail and planters, plus maintenance would be \$600,000. Staff recommends Town Manager authority for additional funds up to \$750,000 to allow for staff to be flexible to changing needs at the speed of business.

Alternatively, the Town Council could opt for just the installation of k-rail only and forego the planters.

#### **DISCUSSION** (continued):

If keeping k-rail for the duration of the Community Vitality and Economic Recovery Initiative is desired, staff could address the aesthetics of the k-rail in a few different ways, as the Town Council directs:

- 1. The k-rail could either be painted in solid or multiple colors.
- 2. Businesses could be allowed to paint or decorate the k-rail outside their business, and any unassigned k-rail could be managed by the Town
- 3. Town staff could order wraps similar to those used previously with any range of designs printed on them.

#### CONCLUSION:

Discuss the options provided in the staff report and provide direction to staff on parklet barrier options for the Town's Community Vitality and Economic Recovery Initiative.

#### COORDINATION:

This report has been written in coordination between the Town Manager's and Town Attorney's Offices, and the Parks and Public Works, Police, and Community Development Departments.

#### FISCAL IMPACT:

Funding for this project has been allocated by the Council through the Capital Improvement Program Downtown Streetscape Project.

#### **ENVIRONMENTAL ASSESSMENT:**

This is not a project defined under CEQA, and no further action is required.





## PROPOSED DOWNTOWN PARKLETS N. SANTA CRUZ AVENUE AT HWY 9







N. SANTA CRUZ AVENUE AT ROYCE ST-BACHMAN AV
























## PROPOSED DOWNTOWN PARKLETS MAIN STREET AT SANTA CRUZ AV



Dear Mayor and Council Members:

Congratulations to you and staff for moving quickly to help town businesses in light of the ongoing need for social distancing, etc. While I wish very much that staff's proposed map of downtown parking, parklets, pickup spots, etc. had been part of the council packet for review, I applaud the concept of keeping street parking where desired by businesses (or where parklets don't make sense) and expanding parklets to commercial streets not mentioned in June 2 Council meeting. I ask that you consider the following when providing further guidance to staff:

- These new parklets are TEMPORARY; does it really make sense to invest in expensive planters?
  - Could the town provide more/better help to business with this money?
  - What will happen to these planters in the fall when parklets are dismantled?
  - Parklets should be dismantled before Thanksgiving to make way for parking for holiday shopping and (hopefully) indoor dining
- Could the town provide rented trees in very large pots or boxes to provide both ambience and shade in parklets?
- When reviewing the map of proposed parklets, please consider how much outdoor space is already available to a restaurant on or around its location; if there is already a significant amount of space for outdoor seating it may not need to be augmented
  - As staff notes, parklets can be expanded if needed, so if there are questionable areas on the map (especially areas not mentioned during June 2 meeting) please consider time for further review
  - The total amount of parking repurposed for parklets should not exceed the total approved at the June 2 meeting
  - If a business in Old Town wants parklets, then Old Town must open both of its parking lots during business hours (perhaps 8am-midnight)
- Please ensure that businesses do not block sidewalks, traffic lanes or bike lanes. Tables, signs and other objects should be carefully placed (and the less A-frame signs in narrow spaces the better!)
- Please continue to work with businesses to share the use of private parking lots when those businesses are closed

Hi Monica,

We reached out to the restaurants and merchants and the response has largely been that many of them need extra space and are fine with k-rail. We understand the k-rail last year was heavily criticized, but these are different circumstances. The Chamber can assist getting the message out through their typical outlets that these are an urgent and temporary solution. The businesses that need the space should simply coordinate with PPW, and PPW should help expedite the placement of the k-rail immediately. To the extent the businesses would eb allowed to decorate or paint the k-rail, we think that would help too.

Further, we do not support spending any funds on more permanent planters at any time down the road. By that time, we are expecting to be closer to normal operations and it would be a total waste of Town funds. Anyone looking for a more permanent solution should go through the original parklet pilot program. Maybe it would be wise to make that program more permanent in nature. The emergency funds can be reallocated back to the downtown/streetscape project later in the year.

As for marketing and outreach, as I mentioned in my last follow up email, I don't think we want to spend time/money on that effort at this time. Things are opening up quickly and we want to monitor that over the next couple of weeks before revisiting if a marketing and outreach campaign is necessary.

Hello Laurel and Arn,

For some reason I cannot send an email from the Town's site using my laptop, and lucky you, I happen to have both of your e-mails, haha!

If possible, could you send to the right spot for me, for tonight's meeting? If not, I understand. I know things often get a little worse before they get better, but this weekend finally put me over the edge.

At The Pastaria, after 24 years in town, we find ourselves in a holding pattern. Under normal circumstances we would just be patient, but we just don't have that luxury right now. I am hoping that tonight's meeting will result in something solid that we can begin to plan around. I agree, I would much rather have the same planters that are being used in the parklets. We received a bid for a parklet on March 13th. (We were not privileged enough to have a generous landowner foot the bill for one of these amazing parklets.) As we were weighing out whether or not we could afford to spend 80 thousand dollars on what we were told could be temporary (about 18 months), at which time we would possibly have to tear it out at our expense, or roll the dice and hope they would get to stay, Covid-19 SIP occured. Spending money on a gamble was off the table.

We have managed to keep plugging up the holes in our sinking boat, managed to keep 8 employees working and have even paid our rent in full for April and May, about to pay June, late. Our set up in the new location is narrow, and does not allow 6 foot distancing across, so we need to stagger, which nets about 6 or 7 tables in the dining room. Our old location had 11 tables, plus 2 outdoor tables, for about 1/3 of the rent, so you can imagine the situation we have gotten ourselves into. I agree, K rail is not the best or prettiest way to go, but for The Pastaria and a few of us on N. Santa Cruz, specifically North, Hanna's spot, we need something to help us have a couple of outdoor tables to survive in this current climate. We will take whatever crumbs are available if it nets a few tables more.

Sorry for the typos, I am hastily typing to get this in on time.

Proposal for reopening Downtown. Hello Neighbors! I know we're all concerned about keeping our shops and restaurants open during the SIP. The truth is that without customers, our merchants will struggle to stay in business. As we near Phase 3 of re-opening, I'd like to open a discussion on how we could re-open in a safe and viable manner that allows our restaurants and shops to regain their footing. No proposal is perfect and there are many issues in my proposal but i'd love to hear your thoughts. If enough of you view this as a viable proposal, i'll setup an online form that will allow you to register your interest (https://form.jotform.com/201557272039151) so we can present to the town council for consideration, discussion and refinement. As you can see, I'm proposing we shut N. Santa Cruz to automobile traffic and allow our restaurants and shops to setup outdoor dining and shopping. This additional space will allow for social distancing and also present a "European" approach to our main shopping and dining area. While DoorDash and other delivery services have provided a way for many businesses to remain open, the sad reality is that without real customers dining, drinking and shopping, many of our businesses will close. To accommodate both, delivery services can approach using side streets, park and then walk to restaurants for pickup. This allows N. Santa Cruz to become a huge area for shopping and dining, similar to when we close it for Fiesta de Arts and other town events. This would be a temporary setup until the SIP is fully removed and Covid is no longer a concern. Let me know what you think!
