

2. ACTION ITEMS

A. Approve Minutes from March 4, 2020 Gary Bode motioned to approve the minutes, and Ron De Valois seconded the motion.

<u>Action</u>

The minutes from March 4, 2020 were approved.

B. Request to take 17th Street Bids Directly to June 1 City Council Meeting with Public Works Committee Review via Email (Bid Opening is May 21, 11:00 a.m.) Banham stated request for bids will be advertised today and May 13 in the Lynden Tribune. Staff will review the submittals at the bid opening on May 21.

<u>Action</u>

The Public Works Committee concurred to recommend all bids received go directly to City Council to award the 17th Street Extension project.

C. Authorization to proceed with design of the Main Street Bridge for Intercept Ditch/Pepin Creek (Pepin Lite) Project.

Bode asked for consideration to be given for the project to be phased to reduce the traffic impact on this main route. The Committee discussed the options involving using City property. It was noted the pedestrian improvements on Benson Road are probably going to be a sidewalk rather than the shoulder widening mentioned in the R&E Report. It was also noted that the Main Street Bridge project will be funded by the Department of Commerce.

<u>Action</u>

The Public Works Committee concurred to authorize that staff proceed with the design of the Main Street Bridge for the "Pepin Lite" project. Additionally, the



Committee recommended that staff discuss with the design team the impact of road closure and ways to minimize this impact.

D. Request for RV Storage at Lynden Municipal Airport (Fred Silberman – 1362 West Park Street)

Banham stated that the City received a request for RV Storage at the Lynden Municipal Airport. The committee discussed the potential ramifications should storage be allowed and setting an undesired precedence.

The Public Works Committee concurred to recommend not allowing the storage of recreational vehicles on Airport property due to lack of space.

E. Six-Year Transportation Improvement Plan (2021-2026) to May 18th City Council to Set a June 1, Public Hearing Date

Banham presented the updated Six Year Transportation Plan (2021 – 2026) and the Committee discussed the changes.

<u>Action</u>

The Public Works Committee concurred to recommend forwarding the plan to the May 18th City Council meeting to set a June 1st Public Hearing date.

F. Authorization to proceed with sidewalk on the east side of Benson Road (from end of existing sidewalk to West Park Street). Additive bid item to repair sidewalk south.

The Committee discussed the replacement of the sidewalk on the east side of Benson Road. Banham stated this is an added item and will be constructed as using funding left over from the Line Road Pedestrian Improvements. Replacement of existing sidewalk will likely be priced as an additive bid item.

Action

The Public Works Committee concurred to recommend proceeding with the replacement of the sidewalk on the east side of Benson Road as budget allows.

3. INFORMATION ITEMS

A. Industrial Condensate – Riverview to Outfall

Banham stated that the construction has been delayed until 2021.

B. Judson Street Low Impact Development (LID)

Banham stated that the design contract was awarded to Reichhardt & Ebe Engineering & Herrera Environmental Consultants. The Judson Street LID Project covers Judson Street from 7th to 10th Streets and 8th, 9th and 10th Streets from Front to Judson. The project will be funded by a \$120K Department of Ecology grant and a match from Water and Sewer Funds improvements (\$24,000 Water / \$24,000 Sewer). Banham stated that staff intends to apply for construction grant funding in September to cover a first phase. If successful in receiving a grant, construction would likely occur in 2022.

C. Decant Facility

Banham stated that the construction is delayed until 2021. The Decant project is 75% funded by a Department of Ecology Grant.

D. Managed Aquifer Recovery

Banham stated that the staff is seeking funding from the Department of Ecology and has submitted a Streamflow Restoration Grant Application

E. Pepin Intercept Ditch

Banham stated a construction change order of \$50,000 was approved by Washington State Department of Transportation. This will finish out the balance of FHWA Funds supplemented with Street Arterial Funding (Fund 302).


F. West Front Street

Banham stated that staff intends to seek federal economic stimulus funding combined with utility funding for match. Due to Covid-19, further opportunity to pursue Whatcom County EDI grant funding is unlikely.

2. ACTION ITEMS

A. Covid-19 Monitoring Plan

Banham stated that there is currently no way for communities to monitor the presence of COVID-19 other than indirectly through information received on positive cases seen by medical personnel. He presented a proposal, provided by Exact Scientific Services, of a draft COVID-19 Monitoring Plan which included three different options for testing. One of those options is testing sewage samples for the presence of COVID-19. There is research being done in this area at a variety of locations, and City staff contacted Tacoma Public Works staff who are currently allowing samples to be taken for testing at its wastewater treatment facilities. Staff also received information on other testing being conducted nationwide and viewed EPA website information on wastewater testing. After reviewing this information and after discussions with local Department of Health and Ecology personnel, Banham thinks that supplying daily composite effluent samples to Exact Scientific Services would help assist researchers to establish a possible link between COVID cases and wastewater test results that could possibly serve as an early warning of health threats. He feels testing should begin as soon as possible to establish a baseline before planned COVID phases. All this work will be funded using federal CARES funding intended for cities to use in response to COVID.

The Committee also discussed other possible uses of additional testing at wastewater pump stations, and possibly at sites near the schools. This would require identifying good testing protocols but would allow more granular information on potential higher risk populations within the community. The Committee discussed having staff continue to explore these options to bring back a more comprehensive professional services agreement that would include some of these additional options to City Council.

<u>Action</u>

The Public Works Committee concurred to recommend that City Council approve a simplified agreement with Exact Scientific Services for COVID-19 testing of WWTP effluent and to continue to explore additional testing under a broader agreement not to exceed \$150,000 and to be funded with federal CARES funding.

The meeting was adjourned at 5:03 p.m.

Greetings to each of you!

Recently, Jason Jansen gave me a tour, if you will, of his newly-formed company Iceworxs ice vending machine located on the Guide Meridian near Lynden Lube. During that conversation we spoke about many things related to ice, including the changing model of ice sales. I was intrigued because I remember stocking the massive ice vending machine in the-then parking lot of Milt's Market and Rich's Texaco, now Lynden Lube and Chevron, and how popular, even for a town of 4,500, it was. It was also very, very labor intensive.

During that conversation, Jason and I discussed the feasibility of having one of his units located in the downtown area, both for Lynden customer convenience and as a passive, complimentary draw to downtown. The location at the Lewis Building, or liquor store/ 7th Street parking lot was discussed, and seemed to be the most logical location, as it is a place that a) already draws people looking for products that often require ice, and b) is in an area of the community where we are focused on creating reasons for people, especially locals, to intentionally go to.

As the sidewalk encroachment issue regarding signs, flower pots, dining tables, etc. waits to be addressed, the placement of a Iceworx vending machine presents a unique opportunity to create and get information regarding complimentary uses that do not fit current business models, but not unlike the soda vending machines that were located downtown in the past, which also you will likely see making a renaissance.

As businesses seek to reduce labor, and currently numerous consumers seek to avoid or minimize contact with others or entering businesses due to certain mandated requirements, Jason's vending units do fill numerous needs for local consumers, while still reaching the goal of having people purposely get into the downtown area.

As this use has not been in the Lynden area for some time, especially downtown, the City of Lynden will need to be involved, especially in the use of public space, just as it is, or soon will be, with sidewalk dining. After speaking with Scott, Gary Bode, and Steve regarding the concept, and Heidi and Ted already being familiar with the machine, the time for the conversation on how the City makes this happens is now at hand. Steve and Mr. Bode have made time on the PW agenda to discuss the avenues to proceed, however I am unsure how, when and where the Public Works Committee meetings are occurring, so I do not know how to best involve Jason in the conversation.

I have included Jason in on this email as he is obviously best suited to offer you accurate information regarding placement, size of the unit, requirements for operation, etc. With the 7th Street parking lot and adjacent sidewalks still to be finalized, and the Lewis Building itself undergoing extensive renovations, now it the time to have the discussion on how to make this happen. I believe that correctly placed, one of Jason's Iceworx machines will be an important traffic-generating component to creating a functioning downtown, just as is outdoor table seating and giant, beautiful flower trees.

Thank you all for your time, and if Steve or Mayor Scott could reply with how best to have Jason participate in this conversation, I would be most appreciative.

Public Works Department Memorandum

Date: April 2, 2020

Re: Proposed Amendments to the LMC re Appeal and Variance Procedures

City Planning and Public Works Staff have been investigating the benefits of using a Hearing Examiner for certain appeals and variance decisions. This comes because of several appeals in recent years that placed high time demands on the Planning Commission. The Community Development Committee (CDC) has already looked at this list. Because the list also includes administrative decisions made by the Public Works Department (Director and Building Official), we are bringing it to you for your review and comments before ultimately taking it to the full City Council. Attached are the specific public works decisions that will be considered.

Staff recommendations are based on the concept that appeals which are technical in nature and/or include specific legal parameters, such as an appeal to the calculation of a transportation impact fee, are processes best directed to a hearing examiner. Decisions which should be made within the context of the Lynden community and history of the City, such as the appeal of a short plat decision, are best reviewed in-house by the City Council or Planning Commission.




